Fremont's Dale Hardware: still family-owned, still in style, nearly 70 years later

When the name "Home Depot" comes up for the third time in an interview with Dale Hardware's owner Kyle Smith and director of store operations Tara Dunford, it's clear that the retailer has something to prove. Founded in 1955, the store began in the town of Centerville back when the area was still mostly farmland. Today, decades after Centerville was absorbed into the city of Fremont, there are two additional national hardware retailers in town. Despite this increased competition, locals continue to choose shopping at Dale, proof of its value to the surrounding neighborhoods. In its seventh decade of business and third generation of ownership, Dale Hardware is a testament to an era of charming family-run companies.

But the store is anything but quaint or outmoded. At 100,000 square feet, the place is magnificent and modern, impressive in its sheer scale. Shiny sets of power tools are displayed a short walk away from rows

and rows of new barbeque grills. The aisles hold an unfathomable number of plumbing fixtures, gardening equipment and miscellaneous home repair items. "We have 9500 SKUs of just nuts and bolts," Dunford said, adding that across the entire store, Dale's carries double the number of items compared to a national big-box chain. If customers are missing a component of IKEA furniture, for example, they can come find a match.

There are also other conveniences: the store's key section can handle advanced services like programming the chips on most vehicle keys, and for \$9.99 will re-key locks that customers bring in. In addition, there's custom window and door screen fittings ("For when your dog runs through it," Smith says,) and propane gas refills ("It's cheaper than a trade-in, where you lose what's left").

But perhaps the most amazing part of Dale Hardware is its plant department. The airy space features flowers, vines, edible plants and greenery

A Lifesaving Investment

Transformational fundraising initiative will provide world-class cancer care under one roof, close to home.

In 2017, Washington Hospital Health System (WHHS) and University of California San Francisco (UCSF) Health joined forces to establish the UCSF - Washington Cancer Center to provide Southern Alameda County residents access to the highest quality cancer treatment, research and technology, close to home.

In the seven years since, cancer has evolved dramatically in its complexity, making cancer treatment today much different than years past. At the same time, the cancer center has experienced a dramatic increase in patients, growing from 5,286 patients in 2016 to 13,845 patients in 2023 in combined outpatient clinic and infusion center visits. As a result, the cancer center has outgrown its current facilities, creating a need for additional space and resources to provide

more patients with the specialized, world-class cancer care it is known for.

An expanded 15,000-square-foot cancer center will allow patients to continue to benefit from a network combining the strengths, expertise and resources of both organizations. It will facilitate patient access to the latest advances in treatment and research, from surgery, to infusion therapy, to radiation oncology, to clinical trials, in one modern facility.

Strategic Development

In December 2021, Washington Hospital Healthcare Foundation (WHHF) initiated strategic conversations with Washington Hospital friends and supporters on a \$12 million philanthropic investment to build a new and expanded comprehensive cancer center. The growing needs of cancer care patients, combined

with strong community support inspired a campaign to transform the future of cancer care at WHHS.

Foundation Executive Director Sarah Gemski said developing the new UCSF - Washington Cancer Center will make comprehensive world-class cancer care accessible to the community and significantly improve the lives of the patients the cancer center serves. Patients will have expanded access to safe and comfortable quality services with 15,000 square feet of state-of-the-art facilities, multidisciplinary collaboration and an expansive network of leading specialists.

While the UCSF - Washington Cancer Center currently offers a full array of cancer protocols provided by a team of dedicated interdisciplinary physicians and staff, the current treatment and office space isn't adequate for growing patient needs. The newly expanded cancer center will bring everything together to help guide patients and their family members through a holistic cancer treatment journey.

Transformative Expansion

The expansion will be financed through a variety of fundraising sources with an overall funding need of \$22 million with a minimum of \$12 million to be raised in philanthropic giving. To date, \$10 million has been raised, leaving \$2 million to be

raised by fall 2024. Gemski said Hospital leadership, physicians and staff have all played a big role in reaching that \$10 million mark. The Foundation is reaching out to the community to raise the remaining \$2 million.

"Everyone at Washington Hospital understands being part of a community hospital and the importance of community is to support it," she explained. "It's one way we can ensure local continuity of care for our patients. We have really been blessed in this community with the level of support we have received, and I hope that will continue as we expand cancer services close to home."

The new UCSF - Washington Cancer Center will provide holistic and integrated care in a center nearly three times the size of current facilities. The goal is to open the expanded center in early 2026. Construction is slated to take just over a year. Key clinical and patient-centered service additions include:

- A collaborative network of interdisciplinary services for patients and their families, with 2,000-plus square foot of office space for clinicians.
- A clinical research program with expanding access to active clinical trials.

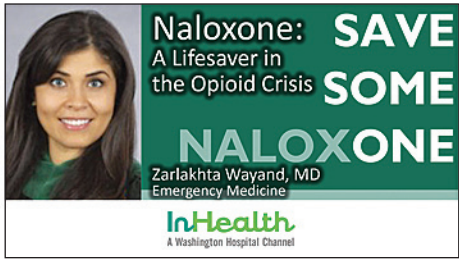

Washington Hospital Healthcare System Approved as Provisional Trauma Center

July 1 will be a momentous day in Southern Alameda County as the area’s long-anticipated trauma center will officially begin receiving patients that have sustained traumatic, life-threatening injuries. On June 5, Alameda County Health Emergency Medical Services Agency (AC Health EMS) conducted an on-site designation survey, finding Washington Hospital Healthcare System’s (WHHS) Level II Trauma Center is ready to begin operations. Yesterday, community leaders joined Hospital staff for a historic ribbon cutting ceremony at the Morris Hyman Critical Care Pavilion, near the Emergency Department where the trauma center is located.

Until now, severely injured people in the Tri-City Area had to be transported, often in rush hour traffic, to the nearest trauma center in Castro Valley or to Santa Clara County. Starting Monday, people who have been in a serious vehicle accident, fallen and sustained complex bone breaks or other major injuries, can receive lifesaving medical attention at Washington Hospital in Fremont.

“We are thrilled that after years of preparation and planning, Washington Hospital Healthcare System is well positioned to fulfill the need for a comprehensive new trauma program in Southern Alameda County—meeting the request of our growing community



members who made it possible through their steadfast support,” said WHHS Chief Executive Officer, Kimberly Hartz. “Achieving trauma designation is a significant milestone in our ongoing commitment to provide exceptional health care services to our patients and community, especially when minutes and seconds count.”

Trauma Timeline

The facilities at WHHS were developed to house a trauma center where patients will have immediate access to around-the-clock care including necessary testing, imaging, medications, blood, operating rooms, and post-injury rehabilitation programs provided in

modern, seismically safe facilities. The Master Facility Plan, launched in the early 2000s, included two modern trauma bays where the center will begin operations.

In June 2022, following an extensive, yearlong evaluation of the county’s existing trauma system, the AC Health EMS selected WHHS as the next designated Level II Trauma Center. Since that time, WHHS has undergone a systemwide effort to build their trauma program including facility reconstruction, staff training and trauma team development, institution of trauma protocols and procedures, and participation in consultative on-site visits and verification reviews. Provisional designation through

AC Health EMS and the trauma center opening represents a major milestone. Final designation will be verified through approval by the American College of Surgeons during a visit anticipated to occur in July 2027.

WHHS’ comprehensive trauma program includes an outreach component to train and educate community members on how to avoid traumatic injuries and help others in case of emergency. Choking first aid seminars are currently being held at local restaurants for food service workers and the public. Community members are encouraged to participate in free upcoming classes on fall prevention, hands only CPR, and Stop the Bleed programs among others. Dates and times will be posted on their website, whhs.com/events.

According to WHHS Trauma Medical Director Chet Morrison, MD, “We are here for critically injured people who need top-level care that is easily accessible at a well-equipped facility. The multidisciplinary team of skilled doctors and staff at Washington Hospital can treat their injuries and create a long-term plan for recovery. The Healthcare System appreciates the community’s support and is pleased to respond to their need and desire for a local trauma center of excellence.”

The application deadline is August 15, 2024. The Cowgirl Spirit Scholarship is awarded annually to a qualifying student who has demonstrated a “pioneer spirit and American brand of courage.”

“This scholarship is about honoring a young lady’s strength of character, commitment to her community, and desire to succeed in her own unique career path,” said Rowell Ranch Pro Rodeo board member Janet Lemmons.

Cowgirl Maggie Rowell played an integral role in starting our rodeo with her husband Harry more than 100 years ago,” Lemmons continued. “Our rodeo and this scholarship continue in the memory of those who have gone down the trail ahead of us, and for those who will come after us.”

The application form references a 1992 quote from well-known western actress Dale Evans Rogers to define cowgirl spirit. “Cowgirl is an attitude, really. A Pioneer spirit, a special American brand of courage. The cowgirl faces life head on, lives by her own lights, and makes no excuses. Cowgirls take stands. They speak up. They defend the things they hold dear. A cowgirl might be a rancher, or a barrel racer, or a bull rider, or an actress. But she’s just as likely to be a checker at the local Winn Dixie, a fulltime mother, a banker, an attorney, or an astronaut.”

Proceeds from the annual non-profit Rowell Ranch Pro Rodeo cowgirl picnic, rodeo, and related events support the scholarship program. Irvington Library Will Close July 31, 2024

The Irvington Library will close this summer. The last day of library service will be July 31, 2024. The Library is working in partnership with the City of Fremont to bring new library services to Irvington soon. Some of these innovative services will include two self-service book lockers in South Fremont, pop-up maker crafts, and a combined makerspace.

The decision to close the Irvington Library was made after careful evaluation of how to best serve the South Fremont community. The Library determined that the building, a temporary structure owned by the City of Fremont, has reached a point where it can no longer provide a sustainable space for library service. The City of Fremont intends to evaluate future recreation programming at the site.

The Irvington Library opened in 1971 and has provided service in the same building for over 50 years. Over the years, limited service has been offered within this temporary building. Since 1997, the Irvington Library has rarely been open more than one day a week. After the COVID-19 pandemic, it reopened as a

limited Makerspace with a small Tool Lending Library and a reduced book collection.

The Library appreciates the community support throughout the years. All library services will continue at the Centerville, Fremont Main, and Niles Libraries. While the Library is developing services for Irvington, library members are encouraged to use these AC Libraries in the Fremont area and be on the lookout for pop-up events outside the Irvington Library.

In addition, library members can download and stream eBooks, eMagazines, movies, music, and more 24/7 with an Alameda County Library card.

Remembering Union City’s Drive-In Movie Theater

For 32 years, the Union City Drive-In, located near Whipple Road and Interstate 880, was a familiar sight. To most Hayward and Tri-City residents it was a landmark and recurring entertainment

family destination. The popular Drive-In was opened originally on March 30, 1966 as a single screen drive-in. The opening program was Candice Bergen in “The Group” and Peter Sellers in “What’s New Pussycat?” Over the years the Union City Drive-In became a sprawling six-screen venue with a large round snack bar in the middle and a children’s play area onsite. The Drive-In closed March 31, 1998 and was immediately demolished. The event was marked by a farewell gala billed as “The Last Picture Show,” showing classics including the 1957 movie “I was a Teenage Frankenstein.” The Union Landing shopping and entertainment complex was soon built on the 104-acre former Drive-In property. The Union City Drive-In was a source of pride for Union City for decades. Its six

screens were more than any other nearby theater had and its huge, red and white marquee served as a massive welcome sign to moviegoers and everyone driving by. Over the years the Drive-In offered first-run blockbusters like Scarface, Footloose and Heavy Metal. The historic outdoor cinema is greatly missed by locals who remember warm summer nights watching movies there, content with their friends or families in their own cars. Teenagers stayed at the Drive-In for hours socializing from dusk to dawn watching horror movies and triple features. The closure of the Union City Drive-In was the end of an American dream, watching a movie in a car under the stars in Union City. The Union City

galore. MJ, the employee who helped to create the nursery over a decade ago, described her vision: “I want people to enjoy walking around, and hopefully they leave having a great experience,” she said, comparing the feeling to attending a Grateful Dead concert. “You gotta have a little bit of passion for the type of work I do,” she added. Expertise and customer experience are points of pride at Dale Hardware. “This isn’t like walking into one of those big-box hardware stores, where they hire any Joe that doesn’t know a wrench from a screwdriver,” wrote a local Google Maps reviewer. “At Dale, you[re] gonna get someone in electrical that knows electrical, someone in plumbing that knows plumbing.”

Smith and Dunford credit this superior service to a rigorous training program. Staff members aspire to become “Dale Aces” after meeting certain knowledge and experience thresholds. The goal is for customers to access advice on almost any imaginable home project. It can be tricky to preserve this local neighborhood atmosphere at a time when both the stores and the brands they carry have become increasingly consolidated. Since the 1960s, Dale Hardware has been part of the ACE Hardware cooperative, which allows stores to join together and collectively negotiate with suppliers. But because ownership remains independent, neighborhood ACE hardware stores have their own look and feel, based on local

tastes. On Saturday, June 29, to celebrate ACE Hardware’s 100th birthday, Dale is hosting a block party to showcase all sorts of products, family-friendly activities, and information. “It’s one of our biggest events of the year,” Dunford said. Over the years, the business has experienced many changes in consumer habits. The rise of huge neighboring apartment developments in Fremont means fewer complex do-it-yourself home projects. “A lot of people don’t realize you can fix something yourself,” Smith says, recalling how the times have changed since he was a boy and a go-to handyman at the store. And with online shopping, traditional retailers who cannot compete on price must now compete on convenience and service. Amidst these changes, Dale remains rooted in the belief that locally-owned businesses offer tremendous value: from small, day-to-day personalized service to the larger impact of giving back to a community. “Our money stays local,”

Dunford says, pointing to Dale’s “roundup” program that gives shoppers an opportunity to round up their cash register total for the benefit of local causes. “Small actions can add up,” Smith said, as Dale donates tens of thousands of dollars every year. As MJ put it, “It’s all in the soil. Everything grows successfully based on how you treat the soil.” She was talking about plants, but perhaps it’s sound advice for businesses and the communities they serve as well. **Dale Hardware Block Party**

WANTED: More Women in Politics

A recent article in the Chronicle noted that California seems to have fewer women in politics than in past years. California is known for sending women to Congress, yet those female politicians are now being replaced by men. The March 5 Primary seemed to set the trend.

California has elected more women to Congress than any other state. In the last four decades, 41 women have been elected to California seats. Since 1923, there were 46 to the House of Representatives and four to the Senate. Our former Bay Area Senator Barbara Boxer is the only female politician to have occupied a seat in both legislative bodies.

It is anticipated that in January 2025, women will most likely occupy 16 of the state's 52 House seats and neither of its Senate seats. This low number of women lawmakers is the same as in the year 2000. As a comparison, in 2009 there were 23 women lawmakers.

The Chronicle article by Shira Stein notes, "The fact that

political pioneer Senator Dianne Feinstein will be replaced by either Adam Schiff or Steve Garvey has generated a wave of headlines. Congress is slowly moving toward gender parity overall, but California is facing the likelihood that its ranks of female members of Congress will shrink as women's rights are being eroded.

Four of the five women leaving Congress at the end of the year—Sen. Laphonza Butler and Representatives Grace Napolitano, Anna Eshoo and Katie Porter—will be replaced by men. Retiring Representatives Adam Schiff and Tony Cardenas will probably be replaced by women.

People are not as attentive to women's representation "because you think the battle has been fought and won. Yet the reality is that women are still underrepresented." To quote Kelly Dittmar, director of research at the Center for American Women and Politics at Rutgers University, "Just because you have a woman like a Nancy Pelosi or a Kamala Harris doesn't mean you're at parity." The goal isn't that every woman who leaves Congress is replaced by a woman. The goal is to ensure that women's voices are at the table. Women's representation is "already starting at such a deficit. And as a result, every loss is acutely felt in a way that it is not the same for men."

When Nancy Pelosi was interviewed by the Chronicle, she

expressed that she wants the strongest possible person for California and that she supported Adam Schiff. She said, "We want it all. We want the majority, so we have a woman having a right to choose, so that we have childcare and family and medical leave and a child tax credit and all the things that affect women enabling them to be in the workplace." Adam Schiff told the Chronicle that he will fight for California's women. For the first time in over thirty years, two male Senators will represent California.

There is discussion as to why this is the trend. Women in leadership must not shut the door behind them. They need to leave the door open to bring more women into the political world. Solutions can be found in organizations, such as the NAACP, and Emily's List, that embrace leadership by women and work to elect women who support women's rights. There needs to be a mentorship group as with the League and AAUW to mentor younger women majoring in political science to take on leadership roles in their community.

If you are a leader in your community, consider public office. We have very few women on our city councils, in particular in the city of Newark. Let's see more women in public leadership!

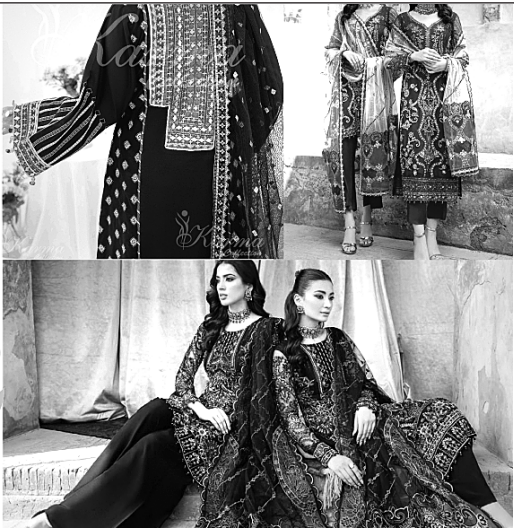

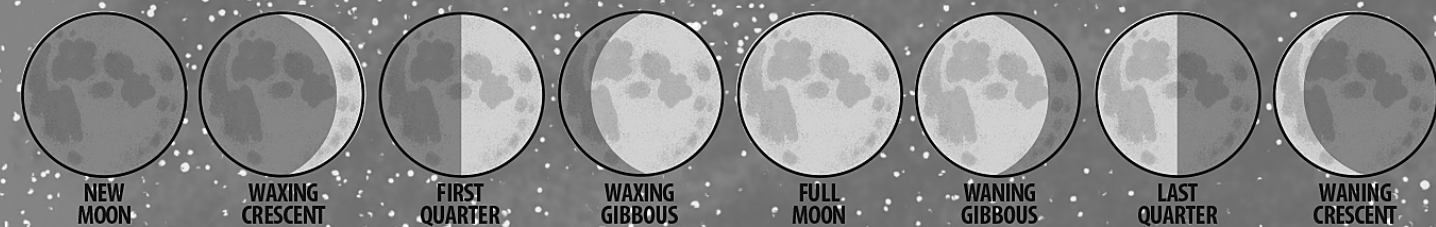

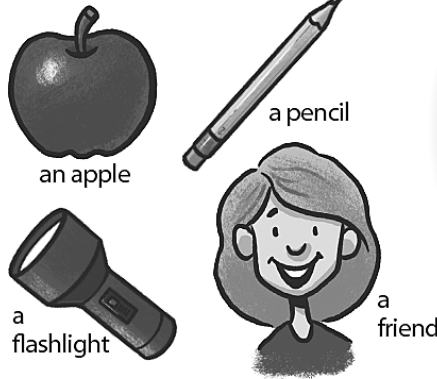
PHASES OF THE MOON



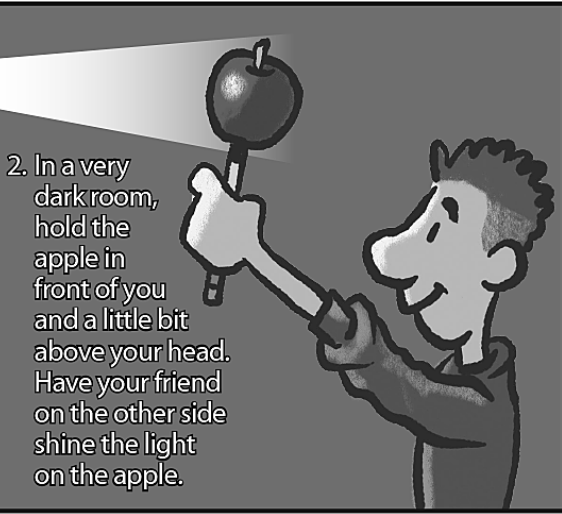

Stuff You'll Need:



1. Stick the apple on the pencil.
- The apple is the moon, and your head is Earth. The flashlight is the sun.

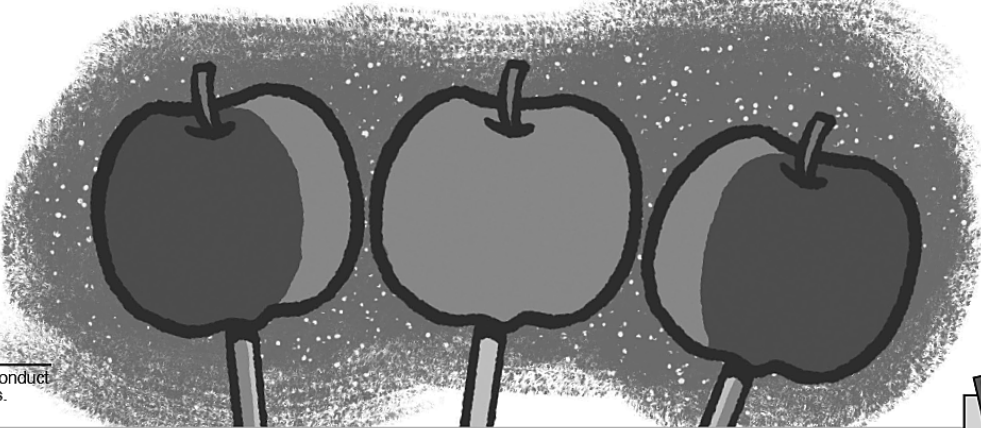


3. When you see only the dark side of the apple, this is like a new moon. When the sun is directly behind the moon and blocks the sunlight, that phase is called the new moon.

4. Stay in the same spot and turn your body slowly. Soon you will see a small part of the apple (moon) lit up. This is called a crescent moon.

5. Keep turning and you'll see more and more of the apple (moon) light up. At one point, one whole side of the apple will be in the light. This is the full moon phase.

6. Keep turning and you will see less and less of the apple (moon) lit up. When you can no longer see any of the apple (moon) lit up, you will have seen all the phases of the apple—er, moon!

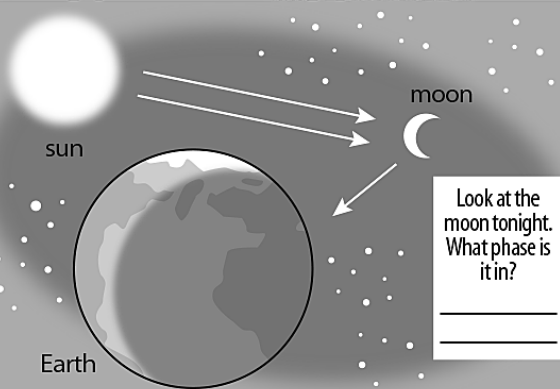

Road Closures Planned for 4th of July Parade on Thursday, July 4, 2024

The Fremont 4th of July Parade will take place on Thursday, July 4, 2024, from 10 a.m. to 12 p.m. in Downtown Fremont.

Fremont Police Department asks attendees to please refrain from bringing backpacks and large bags into the parade area. All bags are subject to search. In addition, UAVs (drones) will not be permitted to fly over the parade route or within the event venue. Only official parade participants with credentials will be allowed to enter the staging area and parade route.

Please plan ahead—several major roadways will be closed during the parade. All road closures will begin on July 4 from approximately 6 a.m. and roads are expected to reopen by 2 p.m. Please expect heavy traffic and delays in the area for the duration of the event.

Road closures are as follows:

- Paseo Padre Parkway (both directions full closure between Mowry Avenue and Stevenson Boulevard)
- Capitol Avenue (between State Street and Paseo Padre Parkway)
- Hastings Street (between Capitol Avenue and Mowry Avenue)
- Walnut Avenue (between Liberty Street and Civic Center Drive)
- Liberty Street (between Beacon Avenue and Capitol Avenue)
- Stevenson Blvd. (between Civic Center Drive and Paseo Padre Pkwy.)

Please note there is no public parking at the Fremont Main Library parking lot. The location will be used as a staging area for parade floats.

All Fireworks are banned in the City of Fremont

ALL FIREWORKS ARE ILLEGAL IN THE CITY OF FREMONT

Penalties for the possession and/or use of illegal fireworks range from \$1,000 to \$50,000.

We would like to remind residents that ALL fireworks are banned in the City of Fremont. Fremont’s public safety departments would like to remind Fremont residents, businesses, and visitors that the sale, possession, and use of all fireworks are banned

within the city of Fremont. This ban includes the “safe and sane” variety of fireworks that are legal in some other cities. The ban, in effect since December 1986, has helped reduce the number of injuries, wildland fires, and structure fires caused by fireworks in the City of Fremont.

Fire and Police resources will be on patrol in Fremont during the peak times of concern to maintain an active vigilance against wildland fires along our hillside and fireworks use. In California, possession of illegal fireworks is considered a misdemeanor, which is punishable by a fine, or by imprisonment in a county jail for up to one year. If you are found to be in possession of a sufficient amount of illegal fireworks, you may be guilty of a felony and punished by a fine and/or imprisonment in a state prison or county jail. Penalties for the possession and/or use of illegal fireworks range from \$1,000 to \$50,000. Parents may be held liable for any damages or injuries caused by their children’s use of illegal fireworks.

Fremont Police and Fire are anticipating a high call volume during the Fourth of July holiday season. We ask that community members help do their part to keep our city safe and only dial 9-1-1 during a true or potential emergency. To report non-emergency illegal firework use, call the Fremont Police

Department Dispatch Center at 510-790-6800 x3. Please be prepared to provide dispatchers with details, such as the specific location, description of involved persons, and any immediate danger to areas with dry brush and vegetation susceptible to fire. All firework calls will be prioritized with other pending calls for service.

From 4 p.m. on July 4 to 2 a.m. on July 5, community members are encouraged to report illegal firework activities via the Fremont App. Additional police resources will be monitoring and relaying information to field personnel. Complaints with specific details such as an address, and description of those involved will receive higher priority. For details on how to download the app, please visit www.fremontpolice.gov/fireworks.

Please be very alert during the Fourth of July holiday season and throughout the summer months with all outdoor activities, and when in or around dry vegetation. The combination of dry grass, low relative humidity, warm temperatures, and strong winds can quickly contribute to extreme fire behavior.

Gardeners can fare well at the County Fair

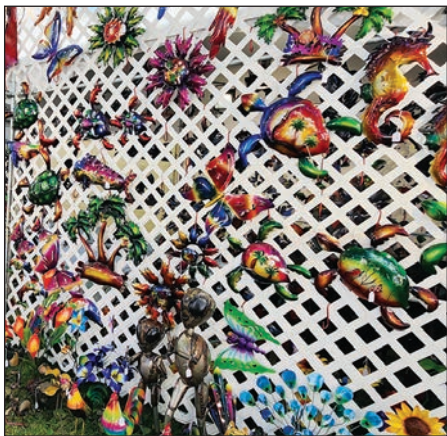

About 2,000 fairs are held in North America every year. Seventy-eight are in California and operated under the auspices of the Department of Food and Agriculture. The 2024 Alameda County Fair runs between June 14 and July 7. It has been held since 1912 on the 267-acre Alameda County Fairgrounds in Pleasanton. The Fair attracts many people for many different reasons. One particular group is gardeners.

Fairs may have been held as early as 500 B.C., often around religious or culturally significant dates. Many early fairs celebrated planting or harvesting crops and other agricultural aspects, a theme that would continue throughout history. The first known agricultural fair took place in Windsor, Nova Scotia and continues annually. The York Fair held in York, Maine in 1765 is thought to have been the first agricultural fair in what would become the U.S. A New England farmer, Elkanah Watson, held the first agricultural county fair in 1811 that resembles our modern-day concept of a county fair including livestock competitions for prize money.

Watson, the “Father of US Agricultural Fairs” worked with New England agricultural societies to hold county fairs. Almost every county in New England held a fair within ten years and by the end of the century almost every state and province followed suit. These fairs had diverse features to attract people with varying interests. Today, the Alameda County Fair has multiple music stages, horse racing, food vendors, livestock viewing, competition submissions, carnival rides and games, performances, and agricultural industry exhibits. It also has attractions for gardeners.

The Alameda County Fair has garden related contests for adults and youth. Amateur gardeners can submit a homegrown entry for competition during four periods throughout the fair. One entry



costs \$1; nine to 19 entries cost \$8, and more than 20 entries cost \$10. The categories include cut flowers, floral design, garden produce, potted plants, and a “rose show” entry of cut rose bouquets. There are a number of sub-categories which expand the competition. There are small cash prizes for the top three winners as well as sponsor-donated garden related gift cards for the Best of Show. There are also honey and preserved food competitions.

Education on the importance of farming is a major directive of the fair. There is a wonderful hall that houses staffed informational booths from non-profit organizations. Groups like the Alameda Bee Keepers Association, the UC Master Gardener Program of Alameda County, the Clean Water Program, the Alameda County Department of Agriculture, Weights, and Measures, Alameda County Resource Conservation District, and Alameda County Mosquito Abatement District all have information on how to better the environment starting in your own garden.

The Alameda County Fair has a large variety of vendors relevant to the home garden. Vrienden Umbrellas, a US company that sells high quality patio umbrellas offers a huge fair discount. Uncommon USA Inc. sells telescoping flag poles of up to 25 feet as well as numerous flags and accessories. Brass Etc. has a large selection of themed weather vanes and other hanging brass,



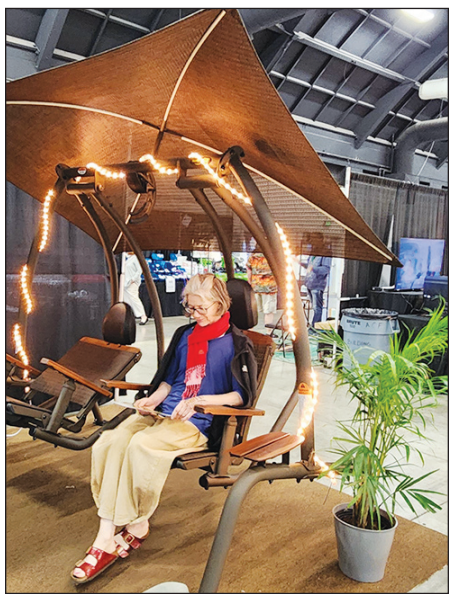
copper, and iron decorative items that can be displayed in the garden. Sunset Swings manufactures heavy-duty steel framed swings. Claudia's Imports features metal outdoor art work. TeleScopic stools sell lightweight collapsible stools perfect for taking a short break while working in the garden. There are outdoor kitchen displays as well as hat vendors with plenty of options suitable for gardening.

There are also opportunities to purchase plants. Plant Social Club based out of Lathrop sells interesting house plants at a reasonable price and shares their expert knowledge on how to best care for them. C&C Plants sells succulents, air plants, and creative handmade pots. There are also vendors that sell colorful wooden or knitted flowers. On July 7, at 5 p.m., the final day of the fair, there is a plant sale of the demonstration garden plants. Since everything must go, it's possible to get a

great deal. Plants are not the only living garden things the fair has to offer. Backyard chickens are available for purchase as well. These chickens are healthy and well cared for and will start producing eggs not long after they go to their new home.

It is nice to take a break in the garden demonstration area during a long day at the fair. There are a handful of lush professionally landscaped gardens in this large courtyard, which is encircled by massive trees. Many have soothing water features surrounded by vibrant flowers and rock features. It is the perfect way to spend your day at the fair and dream about your own garden and what it has to offer.

Clash of Clowns: World premiere explores the tension between two titans of early cinema

By all accounts, Charlie Chaplin was a monomaniac. The actor, director and writer was so dedicated to his cinematic vision that he often put his cast members through hundreds of takes of the briefest scenes. In the case of his 1952 film *Limelight*, he wrote an entire novella beforehand to immerse himself fully in the semi-autobiographical story.

The making of that film inspired Greg Lam to write *Chaplin and Keaton on the Set of Limelight*, a new play opening at Pear Theatre this week. The world premiere production finds its magic in the juxtaposition of Chaplin (played by David Scott) alongside another silent cinema legend, Buster Keaton (played by David Boyll). The play traces the evolution—and eventual clash—of the two comic geniuses’ views on the role of humor in art and life.

Limelight marks the first and only time Charlie Chaplin and Buster Keaton appeared together in the same film. Chaplin—the writer/director/composer/actor extraordinaire—plays a washed-up clown who forms a friendship with a suicidal ballerina. At the end of the film, his character reunites with an old comedian friend for a final performance. For the role, Chaplin called in Keaton, who had fallen on hard times and was getting by with work in Parisian circuses.

“There’s a moment in the play that made me say yes to directing it,” says director Sinohui Hinojosa, whose career has spanned both film and theater. “Charles is telling Buster, ‘I don’t see you making movies. I haven’t seen you in 15 years. I don’t know why you haven’t made anything.’ And [Buster] goes, ‘I’ve been around, Charlie.

You’ve been making movies. You could have called me at any point.”

For Hinojosa and the cast, such nuanced imaginings of the way Keaton and Chaplin might have really interacted on the set of *Limelight* are the great thrill of the play. “It was really this whole idea of them working together, and we don’t know that much about it. What was that dynamic?” Hinojosa explains.

Historians do know at least one major element of the moment: Chaplin was under intense political scrutiny by 1952, having been accused of communist sympathies following his controversial 1940 anti-war film, *The Great Dictator*. “From that point forward, it felt like Charles Chaplin wanted to make a statement with everything he did,” Hinojosa says. “It was no longer about being funny.”

As the Cold War mounted, the U.S. government cracked down on free speech—all in the name of national

security—throughout a time known as the Red Scare. Left-leaning artists like Chaplin faced the huge ethical dilemma of whether to censor and dilute their own voices to avoid blacklisting. Chaplin’s womanizing did not help his reputation.

“Charles Chaplin had really exceeded all the things he wanted to do, but he had a lot of problems because he’d created a lot of enemies,” Hinojosa says.

Into this tense environment walked Buster Keaton to film his scene. Known affectionately as the Great Stone Face for his deadpan demeanor, the actor simply did not approach his craft with the kind of self-importance Chaplin possessed. “One of the biggest issues was that Buster Keaton wanted to be funny,” Hinojosa says. “And you would think that’s why they brought him in—to be funny—but in some respects, he was too funny.”

This early 1950s disagreement over the nuances of humor in one film sequence

may seem obscure, but it has become the stuff of cinema legend because of all the larger debates about storytelling and agency that it symbolizes. The playwright deftly manages tough questions: Can an artist become too serious, too inflexible? On the flipside, does lightness have a role in politically dark times?

For his part, Hinojosa has enjoyed the heady task of directing the story of a notorious director. He is particularly fond of a moment in the play when a character called The Girl (played by Skylar Rose Adams) loses her patience with Chaplin’s tyrannical style, exclaiming, “Why won’t you let me act?!”

“So often you have people like Chaplin that come into the directing with the idea that they have the only idea,” Hinojosa says. “I’m working with an amazing group of actors here. ... I can’t have the only good idea in the room.” Together, through trial and error, he and the cast shared in the creation process.

“It literally has to be the polar opposite of what Chaplin would do,” he says of his approach.

One can’t help but wonder what Hinojosa would do if a modern-day comedian walked onto his set and started cracking jokes.

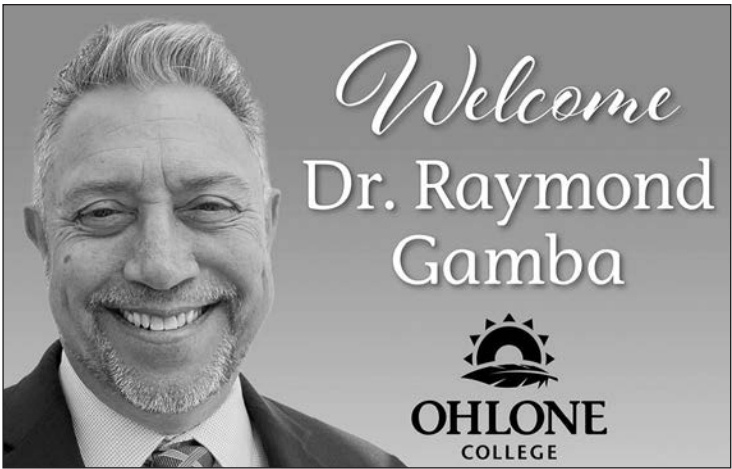
extends to thousands of students. You want them to feel safe, be heard, be respected, and succeed in any career or educational opportunity they seek."

All fireworks banned in the City of Fremont

Fremont's public safety departments would like to remind Fremont residents, businesses, and visitors that the sale, possession, and use of all fireworks are banned within the City of Fremont. This ban includes the "safe and sane" variety of fireworks that are legal in some other cities. The ban, in effect since December 1986, has helped reduce the number of injuries, wildland fires, and structure fires caused by fireworks in the City of Fremont.

Fire and Police resources will be on patrol in Fremont during the peak times of concern to maintain an active vigilance against wildland fires along our hillside and fireworks use. In California, possession of illegal fireworks is considered a misdemeanor, which is punishable by a fine, or by imprisonment in a county jail for up to one year. If you are found to be in possession of a sufficient number of illegal fireworks, you may be guilty of a felony and punished by a fine and/or imprisonment in a state prison or county jail. Penalties for the possession and/or use of illegal fireworks range from

\$1,000 to \$50,000. Parents may be held liable for any damages or injuries caused by their children's use of illegal fireworks.

Fremont Police and Fire are anticipating a high call volume during the Fourth of July holiday season. We ask that community members help do their part to keep our city safe and only dial 9-1-1 during a true or potential emergency. To report non-emergency illegal firework use, call the Fremont Police Department Dispatch Center at (510) 790-6800 x3. Please be prepared to provide dispatchers with details, such as the specific location, description of involved persons, and any immediate danger to areas with dry brush and vegetation susceptible to fire. All firework calls will be prioritized with other pending calls for service.

From 4 p.m. on July 4 to 2 a.m. on July 5, community members are encouraged to report illegal firework activities via the Fremont App. Additional police resources will be monitoring and relaying information to field personnel. Complaints with specific details such as an address, and description of those involved will receive higher priority. For details on how to download the app, please visit: fremontpolice.gov/fireworks

Please be very alert during the Fourth of July holiday season and throughout the summer months with all outdoor activities, and when in or around dry vegetation. The combination of dry grass, low relative humidity, warm temperatures, and strong winds can quickly contribute to extreme fire behavior.

Seeking Assistance for Unsolved Homicide

On Friday, July 22, 2022, at 10:57 p.m., the Newark Police Department received a report of an adult male in a coma at Eden Medical Center in Castro Valley. The individual, later identified by authorities as Sergio Grageda, a 24-year-old resident of Newark, was initially taken by friends to Washington Hospital Healthcare System in Fremont. Friends claimed that his injuries were sustained from a fall during a basketball game. Due to the severity of his condition, he was trauma-activated and transferred to Eden Medical Center. Medical personnel deemed the circumstances surrounding his injuries suspicious, as they did not align with the explanation provided by his friends. Tragically, Sergio passed away from his injuries on Friday, July 29, 2022.

The Detective Unit of Newark Police Department launched an investigation, which revealed that Sergio's injuries were linked to a physical altercation at Ash Street

Park in Newark. Earlier in the evening of July 22, 2022, at approximately 7:47 p.m., a passerby reported a group of juveniles involved in a fight at the park. Newark Police officers promptly responded and arrived at the scene within two minutes of receiving the call. Upon their arrival, officers did not observe any indication of a physical altercation. During their inquiry into the possible fight, officers encountered a large group of individuals gathered for a memorial service for a recent shooting victim. It was later determined that Sergio was present at this gathering and was involved in an altercation.

The investigation has encountered challenges due to a lack of cooperation from potential witnesses to the incident that led to Sergio's untimely death. The Newark Police Department is reaching out to the community for assistance in raising awareness of this case, in the hope that those with crucial information will come forward. The City of Newark extends our heartfelt condolences to the Grageda family.

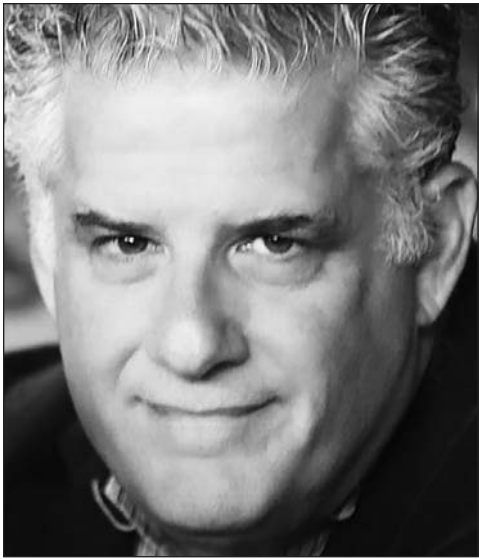

Mexican Charreadas, The Law & Animal Welfare

California boasts the nation's most comprehensive rodeo law, Penal Code 596.7, the result of 1999 legislation carried by Senator Don Perata (D-Oakland), and sponsored by Oakland-based ACTION FOR ANIMALS. The law was amended in 2007 to include the Mexican charreadas common throughout California (AB 1614, by Assemblymember Audra Strickland, R-Thousand Oaks).

Current law requires either an on-site or on-call veterinarian at every rodeo and/or charreada, and bans the use of electric prods in the holding chutes. The law further requires that animal injury reports be submitted to the State Veterinary Medical Board. These reports are Public Record, email enforcement.vmb@dca.ca.gov. The law needs

amending to require on-site veterinarians at ALL these events. The PRCA, racetracks, horse shows and endurance rides all require on-site veterinarians—so should all rodeos and charreadas.

Incredibly, NO charreada injury reports have been submitted to the Vet Board since 2007. Three of the charreada's nine scored events involve roping the legs of running horses. In the "steer tailing" event tails are routinely stripped to the bone ("degloved"), broken, even torn off. It appears that the charro community is unaware of state law. Please spread the word to help remedy this unacceptable situation.

Dear EarthTalk: Do you have any tips on how to deal with climate anxiety?

Also, don't be afraid to seek professional help, which can be crucial for those severely affected by climate anxiety. Therapists and counselors can provide coping strategies and emotional support.

The World Economic Forum emphasizes the importance of finding climate-aware therapists specializing in eco-anxiety. These professionals understand the unique stressors associated with climate change and can offer tailored support. By managing our anxiety and participating in collective action, we can contribute to a healthier planet and a more hopeful outlook.

Hayward enacts down payment assistance program

On June 6, 2024 the Hayward City Council approved the allocation of \$2 million to establish a down payment assistance program and revolving loan fund to assist both current and future low-income homebuyers.

Hayward is committed to assisting its residents with their housing needs. The City of Hayward has long identified homelessness and housing affordability as key issues in the community and has supported local efforts to address these issues.

The city’s goal is to expand access and choice for residents and protect their rights to quality homes that are affordable, safe and healthy. Down payment assistance is a very helpful tool to address barriers to homeownership for low-income families.

The down payment assistance will be provided in the form of a shared appreciation loan in an

amount not-to-exceed \$300,000. To be eligible, borrowers must be low-income, first-time homebuyers, and preference will be given to applicants that either live or work in the City of Hayward.

Additionally, to ensure that the down payment assistance program will also assist future households, a revolving loan fund will be established to provide down payment assistance loans to future eligible households from loan proceeds.

Safe Fourth of July in Union City

Union City welcomes your participation in providing a safe Fourth of July for all Union City residents. Please practice basic safety procedures in compliance with all laws. Only State Fire Marshal-Approved “Safe and Sane” fireworks, bearing the seal, are allowed in Union City.

1. Deploy fireworks at least ten feet away from any dwelling or structure.
2. Use fireworks under adult supervision and keep a hose handy.
3. Spent (used) fireworks should be disposed of by soaking

them in a bucket of water overnight, then double-bagging and placing them in your landfill cart. Fireworks are prohibited in the recycle and compost carts.

Additionally, please remember:

- “Safe and Sane” fireworks may only be used between 8 a.m. to 10 p.m., July 1 – 4 on your private property.
- If you intend to use “Safe and Sane” fireworks on property other than your own, you must have written approval from the property owner.
- Fireworks are not allowed east of Mission Boulevard, in city parks, on school property, or on city streets.

- Do not use illegal fireworks. Fireworks that explode or go up in the air are illegal. This includes firecrackers, bottle rockets, aerial shells, and mortars.

- Property owners can be fined up to \$1,000 if illegal fireworks are used from their property.

- Individuals possessing or using illegal fireworks may be fined up to \$1,000.

Let’s work together to stop the sale and use of illegal fireworks. To report individuals using or selling illegal fireworks, call the non-emergency police dispatch line at (510) 471-1365.

do with it. I started with smaller educational events for students and then moved on to leading larger projects and teams.”

Joshua’s connection to Ohlone College is deep and enduring. He describes the college as his “second home,” where he invested significant time and effort, driven by the dedication of the Ohlone community. This sense of belonging and support empowered him to pursue leadership roles and make a tangible impact.

Inspired by his childhood interest in politics and a desire to be an innovator, Joshua overcame his shyness and stepped out of his comfort zone. “I wanted to be a change-maker,” he shares. This determination led him to pursue opportunities that would shape his future, including his next steps as a new alum at UC Berkeley. Joshua plans to participate in the UCDC program, securing an internship in Washington, D.C., to further explore national politics while continuing to support Ohlone students as an Alumni Advisor for the Associated Students of

Ohlone College (ASOC). Joshua’s tenure as ASOC President has left a lasting impact on Ohlone College. He spearheaded key initiatives such as the Resilient Roofs Grants, providing essential funds to students facing homelessness and housing insecurity, and passed a record amount of legislation despite budget constraints. His leadership has set a high bar for future student government leaders. Reflecting on his experiences, Joshua acknowledges the challenges and triumphs of being a Person of Color in leadership. As the first Mexican/Latino ASOC President in recent history, he is proud to uplift and inspire other Latino students to pursue leadership roles. “I love the diversity of this college, and I believe that our Senate reflects that,” he says. Balancing professional and personal commitments is an ongoing challenge for Joshua, who emphasizes the importance of utilizing available resources, such as Ohlone’s free therapy services. His advice to aspiring leaders is simple yet profound: “You earn



respect from your peers when people see you putting in the work. Demonstrate your commitment, and you will be set.”

As Ohlone College celebrates graduation month, Joshua De Miguel’s message to future alumni is one of empowerment and pride: “Celebrate your story. Your unique background is a strength, not a weakness.”

ORDINANCE NO. 05-2024
AN UNCODIFIED URGENCY ORDINANCE OF THE CITY OF FREMONT TO TEMPORARILY ALLOW PAD-MOUNTED TRANSFORMERS TO BE INSTALLED FOR SPECIFIED DEVELOPMENT PROJECTS IN RESIDENTIAL DISTRICTS PURSUANT TO GOVERNMENT CODE SECTIONS 36934 AND 36937, TO TAKE EFFECT IMMEDIATELY UPON ADOPTION BY A 5/7 VOTE OF THE CITY COUNCIL, AND REMAIN IN EFFECT FOR A PERIOD OF TWO YEARS UPON A FINDING AND DECLARATION THAT IS REQUIRED FOR THE IMMEDIATE PRESERVATION OF THE PUBLIC PEACE, HEALTH OR SAFETY (2024-00194), AND MAKING FINDINGS OF CEQA EXEMPTION
THE CITY COUNCIL OF THE CITY OF FREMONT DOES ORDAIN AS FOLLOWS:
SECTION 1. FINDINGS
The City Council makes the following findings and determinations as part of this urgency ordinance:
1. The City's Utility Undergrounding Ordinance (UOU) codified in Fremont Municipal Code (FMC) Chapter 12.35 establishes the City's 38 undergrounding districts, and, along with Chapter 8.90 of the Zoning Ordinance, generally specifies that utility structures must be placed underground, with limited exceptions.
2. For locations with existing underground service, screened transformers are permitted subject to

localation requirements. In residential districts, the UOU allows pad-mounted transformers to be screened and located within a utility easement away from streets and open areas at rear-side yard locations. However, no above-ground transformers are currently permitted within front yards in residential districts.
3. There currently exists a shortage of available underground mounted transformers and without a transformer a building permit cannot be made final and this indefinitely delays the issuance of a certificate of occupancy.
4. The City has become aware of this supply shortage of underground mounted transformers based on information received from public utility representatives, multiple news sources, and parties issued building permits.
5. The City continues to experience strong permitting activity for home remodels, accessory dwelling units (ADUs), demolition and rebuilds.
6. There are multiple permits that require unavailable underground mounted transformers to complete their permitted work and occupy a residence, and there is no certainty as to when this supply shortage will subside.
7. The lack of availability of underground mounted transformers creates an urgent situation due to the inability to finalize permits for home additions and remodels, ADUs, and infill developments, and places households at risk of severe financial loss, loss of housing, and creates delays in construction projects that may become a nuisance if not completed.
8. Above-ground, pad-mounted transformers are readily available and authorizing their use will alleviate delays in completion of permitted work and building occupancy.
9. Allowing the use of above-ground, pad-mounted transformers aligns with the objective of the City's Housing Element of its General Plan to encourage actions to facilitate housing production, including ADUs, home remodels, and infill development.
10. This ordinance authorizing the use of above-ground, pad-mounted transformers in specific circumstances will provide necessary relief to building permit holders by facilitating the completion of permitted work during the shortage of underground mounted transformers, and allows sufficient time for the City to evaluate this shortage and propose a longer-term solution.
11. California Government Code Sections 36934 and 36937 allow a city council to adopt an ordinance as an urgency measure that takes effect immediately in order to preserve and protect the public peace, health, safety or welfare, where said ordinance contains a declaration of facts constituting the urgency and is passed by a four-fifths vote of a city council, or five affirmative votes of a seven-member city council.
12. Based upon the above-described facts and circumstances, the City Council finds that this ordinance is necessary as an urgency measure for preserving the public peace, health and safety, and therefore it may be introduced and adopted at the same meeting and shall take effect immediately if passed by at least five (5) affirmative votes.

SECTION 2. PROVISIONS
The City Council of the City of Fremont ordains that, for the duration of this ordinance, notwithstanding existing local law including but not limited to the Zoning Ordinance and Utility Undergrounding Ordinance, the following shall control:
When placement of a transformer within a preferred location as prescribed under City ordinances is not technically or financially feasible in the discretion of the Public Works Director or designee, above-ground, pad-mounted transformers will be permitted when properly screened and safely located within front yards for: (1) residential building permits for all home additions and remodels, single family demolitions and rebuilds, and ADUs, and; (2) developments with multiple dwelling units in residential districts for which a building permit has been issued as of the effective date of this ordinance."

SECTION 3. CEQA
The City Council of the City of Fremont finds that the proposed amendments to the Fremont Municipal Code are exempt from the requirements of the California Environmental Quality Act (CEQA), pursuant to, without limitation, each on a separate and independent basis, CEQA Subsection 15061(h)(3) [Review for Exemption in that it could be seen with certainty that there is no possibility that the proposed text amendments would have the potential for causing a significant effect on the environment, §15301 [existing facilities] in that the actions herein relate to individual projects otherwise already approved by the City of Fremont hereby declares that it would have passed this ordinance and its amendments, including for electrical service, and §15303 [small structures] in that the temporary allowance for pad-mounted utility transformers in safe and screened locations above ground in front yards within existing residential districts does not otherwise have the potential to cause a significant impact on the environment.

SECTION 4. SEVERABILITY
If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the remaining portions of this ordinance. The City Council of the City of Fremont hereby declares that it would have passed this ordinance and its amendments, including for electrical service, and §15303 [small structures] in that the temporary allowance for pad-mounted utility transformers in safe and screened locations above ground in front yards within existing residential districts does not otherwise have the potential to cause a significant impact on the environment.
SECTION 5. EFFECTIVE DATE
This ordinance shall take effect immediately upon adoption by the affirmative vote of at least five members of the City Council.
SECTION 6. DURATION
This ordinance shall remain in place for a period of two years from the date of passage.
SECTION 7. PUBLICATION AND POSTING
The City Clerk shall publish a notice indicating the adoption of this ordinance as required by law.

Upholding Youth Health:
Newark’s Imperative for a Strong Tobacco Retailer
Licensing Ordinance

Amidst the battle against tobacco-related illnesses and the proliferation of smoking among youth, local governments must adopt and uphold strong Tobacco Retailer Licensing (TRL) ordinances. The time has come for Newark—now the last jurisdiction in Alameda County—to take decisive action by adopting a robust TRL ordinance. Like all other Alameda County cities, Newark should consider banning all flavored tobacco products. Four

out of five youth smokers start with a flavored tobacco product. Flavors, including menthol, appeal to youth users by masking the harshness of tobacco.

According to students from Newark Middle School and Newark Memorial High School surveyed by Bay Area Strength through Activism in 2023, 80% say there is a tobacco retailer they can easily walk to from home. Nearly 3 out of 4 12th graders from Newark Unified School

District polled in the 2022-2023 California Healthy Kids Survey believe obtaining vapes is easy. By prohibiting the sale of tobacco near educational institutions or city parks and implementing regular compliance checks and penalties for failing to verify age, TRL ordinances can impede underage access to these harmful substances.

Critics may argue that imposing additional regulations on retailers places an undue

burden on businesses. However, the societal costs of tobacco use far outweigh any inconvenience to retailers. According to the Centers for Disease Control and Prevention (CDC), smoking-related illnesses cost the United States billions of dollars annually in healthcare expenses and lost productivity. By reducing smoking rates and preventing the onset of tobacco-related diseases, TRL ordinances can alleviate this

economic burden while fostering healthier communities.

The City of Newark needs to send a message that it prioritizes the well-being of its youth over the profits of tobacco retailers. The time for effective and meaningful legislation to impede youth access to tobacco products is upon us.

Under Suzanne's leadership, the City's Human Services Department has received many awards for its innovation and ability to build community partnerships, including the Community Partnership for Older Adults grant, Grantmakers in Aging, Diversity Award, and National League of Cities Cultural Diversity Award.

As an advocate for others, Suzanne dedicated much of her career to championing equity and inclusion, fostering and celebrating diversity, strengthening relationships for families, and enhancing the quality of life for all. Suzanne's list of accomplishments is vast, but most notably she will be remembered for the creation of Fremont's Family Resource Center. Over the last 25 years, thousands of community members from the Tri-City area have been provided access to

quality services as a result of her vision. Suzanne developed a long-term plan to support Fremont's aging population, which included the opening of the city's first Age Well Center 40+ years ago and in 2021 the second Age Well Center, in south Fremont. In recent years Suzanne has led efforts to develop compassionate programs, such as the Housing Navigation Center, to assist Fremont's homeless population.

Suzanne's dedication to consensus building has resulted in many strong

partnerships in the community, including her close work with faith-based organizations to develop the Safe Parking program and collaboration with the Afghan community, most recently highlighted through the development of the Afghan Refugee Fund. Ohlone names Lisa Cooper new women's water polo head coach

Ohlone College Dean of Kinesiology, Athletics and Performing Arts Chris Warden has announced the hiring of Lisa Cooper as the Renegades' new women's water head coach.

Copper comes to Ohlone after a successful 22-year career at Cal State East Bay (CSUEB) where she held the same position. She is one of the winningest coaches of any sport in CSUEB history with 346 career victories.

"I am really excited to coach at Ohlone and the opportunity to build a water polo program," said Cooper. "The campus and the pool are absolutely beautiful. There is a lot of water polo talent in and around Fremont. I am looking forward to establishing a place where local players want to come and play with the ultimate goal of transferring to a four-year university."

At CSUEB, Cooper was twice named Association of Collegiate Water Polo Coaches (ACWPC) National Division II Coach of the Year. She has also been named conference coach of the year, Collegiate III National Championship Coach of the year, and won CSUEB's only National Championship of any sports program this century.

Her 2024 squad compiled a 19-12 overall record and advanced to Western Water Polo Association (WWPA) conference championship game. Following the season, the women's water polo program was discontinued by the university.

"It is truly unfortunate that Cal State East Bay discontinued its water polo program," said Warden. "However, I am extremely excited to have Coach Cooper with us as a result of that change. I am very excited to work with Lisa to rebuild our women's program and to continue our great tradition of academic and athletic excellence."

Throughout her time with East Bay, Cooper coached over 50 NCAA All-Americans and over 170 Academic All-Americans. Her teams have consistently performed in the



pool and in the classroom. The squads also received Academic All-American Team Honors in 21 out of her 22 years as head coach.

Cooper has coached two NCAA Division II National Players of the Year as well as a Division III National Player of the Year while three of her athletes were named Conference Player of the Year.

Under Cooper in 2008, the Pioneers won their first-ever Collegiate III National Championship. The Pioneers (20-14) went 5-0 in the championships, including a four-overtime win against Cal Lutheran in the title match. The championship victory over Cal Lutheran was Cooper's 100th win as coach of the Pioneer women's water polo team and garnered her Collegiate III National Coach of the Year honors. In 2010, CSUEB changed from NCAA DIII to NCAA DII.

The 2008 championship was the first national championship for the Cal State East Bay intercollegiate athletic program in 20 years. The Pioneers had five All-Americans in 2008, including goalkeeper Ellie Wilhelmsen, who was named Collegiate III National Player of the Year. In 2018, Wilhelmsen became the first female water polo player inducted into the Pioneer Athletics Hall of Fame. In 2022, Kim Johnson became the second women's water polo player all-time to be inducted into the hall of fame.

Cooper is the former chair of the NCAA women's water polo committee, as well as the NCAA men's and women's rules subcommittee. She also served for many years as the coaches chair of the WWPA Conference.

Coach Cooper's philosophy combines both academic and athletic excellence. She believes her athletes are students first and foremost, and sees water polo as an integral part of their overall college experience. Cooper believes that the overall development of her athletes is of the utmost importance, and is taught through the life skills of teamwork, discipline, persistence, communication, and dedication.

A native of Perth, Australia, Cooper started playing water polo at the age of 14. She was a member of the Western Australian State Junior Team that won national championships in 1996 and 1998. Cooper also was a member of the Australian National Youth and National Junior Teams.
