Fremont locals return to reopened beauty parlor

LOCAL SPOT RETAINS LOYAL FOLLOWING WITH AFFORDABLE SERVICES

When Farrah Foroushani recalls the time her go-to salon, Doan's Hair and Spa, closed down because of a 2021 fire, it felt like a true catastrophe. Foroushani has been a loyal patron for nearly two decades—so loyal, in fact, that after being sent to Kentucky on a years-long work assignment, she continued to fly into Fremont to visit family and schedule monthly beauty appointments.

This August, the shop reopened in the same Walnut Avenue shopping complex, near a Smart & Final grocery store and several restaurants. "We knew we'd be back," said Tammy Cao, co-owner and wife of Doan Nguyen, who started the salon in 1997. "We love this area, and all the customers here."

The place looks brand new, but the clientele is not. "Don't think that I'm a veteran," Foroushani said, as Cao and sister-in-law Nikki Tran worked together to style her hair and paint her nails. "I met a lady who had another 10 years on me... She was so excited, for a whole week she was coming in every day...'I just miss it so much,' she told me."

Other customers seem to feel similarly. On a sunny Tuesday afternoon, two tidily-dressed ladies sat patiently for an interview at the shop's sleek new waiting area, singing the praises of their favorite beauty parlor.

"I've been coming since 1997," said Margaret de la O, explaining that she liked how Doan's offered a single convenient location for multiple services. "Everything's in one space, so you don't have to get in your car to go here and then there," she said.

"I've had everything done," chimed Phyllis Sheng, another Fremont resident with a quiet demeanor and an impeccable haircut. Sheng appreciates the establishment's cleanliness and familial atmosphere.

Doan's prices remain reasonable despite rising business pressures from increasing wages and costs. According to the spa menu, kids' haircuts start at \$15, while women's haircuts are \$30 and up. Regular manicures and pedicures are \$25 and \$30, with extra offerings for gel or acrylic nails and dip powders.

These rates seem like an especially good value when compared to high-end hair salons in larger cities like New York and Los Angeles, which can charge over \$500 for a cut and color, according to the Wall Street Journal. Throughout America, the consumer

Castro Valley celebrates Tony Gemignani's return

FANS LINE UP TO WELCOME 15TH SLICE HOUSE

The grand opening Slice House in Castro Valley by Tony Gemignani, was an emotional affair, marking the long-awaited return of the master pizzaiolo to the town where it all began.

It was over 30 years ago when a teenage Gemignani was first introduced to the business of pizza making at his brother's restaurant, Pyzano's Pizzeria, a family-friendly place known for its tasty food and cozy vibes. Gemignani would soon go on to become a professional pizza acrobat, and in 2007, became the World Champion Pizza Maker at the World Pizza Cup in Naples, Italy, the first American to do so.

Gemignani became an international sensation, winning global competitions — World Pizza Champion 13 times — and setting Guinness World Records. He has opened several successful pizza establishments, appeared on numerous cooking shows, written a handful of books and won many prestigious awards. But a return to Castro Valley was always on his mind.

In his grand opening speech on September 14, a tearful Gemignani thanked the loyal residents of Castro Valley for always believing in him. "I wanted to bring a pizzeria to Castro Valley in 2007, but they couldn't tell me if I'd be able to have a wood fired pizza oven. It's really hard to build here. As an independent operator there are so many obstacles. So I went to North Beach. But everyone kept asking me when I'd come back to Castro Valley."

After choking up a few times, Gemignani continued, "This is a special place. I think about my mom a lot when I'm in Castro Valley. She passed away a couple years ago, but I know she'd be excited to be here right now."

In fact, when he was a youngster, it was Tony's mom Eileen who perhaps ignited his passion for food as they baked together using fresh ingredients from their farm in Fremont. To honor her memory, Slice House Castro Valley will offer a special pizza called The True Italian — every Slice House features a flavor unique to that franchise group. It combines a NY thin crust with pesto, mozzarella, garlic, tomato, romano, oregano and garlic oil, and was one of Eileen's favorite pizzas at Pyzano's.

More than a hundred people lined up to welcome Gemignani back. Longtime resident Donna Lee was first in line. "I got here at 7am. Big fan of Pyzano's. I figured there'd be a lot of interest." Also in line was Valerie Hetherington, who was holding a copy of Gemignani's book, The Pizza Bible. "I'm hoping he signs page 134 because it was the first recipe I ever made…Pesto Basil Sauce!"

T-shirts, hats and books were given out to a lucky few, with Gemignani on hand to sign anything and everything.
Castro Valley native Michelle Korbas brought some laminated placemats to sign. "I am very excited to see Tony back in town. I have always been such a big fan of Pyzano's and all he did for the community. He used to host kids birthday parties where he would teach them all how to make their own little pizzas. These placemats are filled with photos that show some of those good times."

"It's full circle, it really is," said Gemignani with a smile. "The kids I gave dough to and made pizzas with when they were seven and eight, seeing them now so much taller and older. And seeing their kids. It's special."

Slice House Castro Valley will be the 15th location of the highly successful fast-casual pizza franchise, which began as a small storefront in North Beach, located right next to Tony's Pizza Napoletana (recently named 6th Best Pizzeria in the World 2024 by 50 Top Pizza). If people didn't want a sit-down meal they can take it to go, enjoying the same fresh doughy goodness at a more affordable price.

BART access to expand

EMOTIONS HIGH AS UNION CITY PREPARES TO SHUT DOWN BELOVED STREET

After more than 20 years in the ideation stage, a project that would expand access to BART in Union City is finally on the horizon. City officials are confident this decision will be beneficial. Residents, however, are less than impressed.

The city invited the community for an informational meeting on Saturday, September 14, where they revealed the plan to construct an at-grade pedestrian rail crossing over the Union Pacific Railroad tracks on the east side of the Union City BART station, effectively creating access to the station from both sides. Their hope, they say, is that the new implementation would improve access for residents in the Station District neighborhood to BART and nearby transportation and retail centers.

"This has been a very public ongoing dialogue," said city manager Joan Malloy about the project when residents questioned the city's diligence in informing them.

As part of the project, Union Pacific Railroad (UPRR) and the California Public Utilities Commission (CPUC) are requiring the closure of an existing at-grade crossing along the Oakland Subdivision rail line to allow the new pedestrian crossing at the BART east entrance. To the dismay of many, the City determined that closing the I Street crossing would cause the least disruption to pedestrian and vehicle traffic compared to other crossings evaluated.

"I live right by there, I need it to be open," one resident said.

City council candidate Lance Nishihira expressed concern over the city's announcement of the plan. Despite the city hosting previous meetings on the closure, many residents are either unaware or for various reasons do not or cannot attend. Nihishira pressed city representatives to commit to providing regular updates.

"Agencies like ours tend to do a lot of outreach, but sometimes people don't show up," he said.

City officials said they aim to keep the public informed about the next stages of the development.

The opening of the east entrance is expected to drive both housing and commercial development in the Station District, enhancing economic opportunities for all residents. Increased access to transit options like BART is expected to boost ridership on both trains and buses, create potential for new transit routes, and provide easier access to a future intercity passenger rail station near the new crossing. This station will serve Altamont Corridor

Unbiased Answers to Medicare Questions

Complimentary seminars Oct. 8 and 9

You're turning 65 and wondering which of the various Medicare options are best for you. Friends and neighbors have suggestions and tips, and the airwaves and online media are full of suggestions as to which plan would be best for you. How do you decide?

Washington Hospital's Health Insurance Information Service can help you navigate the bewildering array of options and suggestions. "Everyone on Medicare should review their current plans-both medical and drug coverageto check whether your plans cover your current needs, and to see what new options are available," says Kristi Caracappa, the Hospital's Health Insurance Information Service coordinator.

For example, does your current plan or the one you may be considering cover your current prescriptions? You may have new medications that aren't covered or one of your current prescriptions may have been dropped or changed to a different tier. Does the plan you are considering cover any medical equipment you may need? Have your health care requirements changed as a result of recent illnesses or an accident?

Caracappa will cover these and other issues and questions at two complimentary community seminars from 11 a.m. to noon on Tuesday, Oct. 8, and from 6 to 7 p.m. on Wednesday, Oct. 9. The in-person seminars will be held at Washington West, 2500 Mowry Ave.

At the seminar, Caracappa will discuss how and when to sign up for Medicare, options available to cover extra costs, how Medicare plans work in your local community and how best to choose a prescription drug plan that will cover your medications. She also will discuss Medicare, Medicare Advantage plans (Part C) and Medicare supplemental insurance enrollment options, any upcoming changes to Medicare and/or Part D, and answer questions about changes, choices and timing.

Caracappa encourages everyone who is Medicare eligible, including those who receive Medicare benefits because of a qualified disability, to review their plan each year before open enrollment. In addition to Part D which offers prescription drug coverage, Medicare Advantage plans (Part C) also should be reviewed annually. Part C plans are run by private insurers and can vary from year to year. Coverage may depend on which county you reside. Additional advantageous benefits may now be available.

The Hospital's Health Insurance Information Service is a free, unbiased

and confidential service for individuals, regardless of health insurance. The service can help with questions about individual and group plans, government-sponsored programs such as Medi-Cal or Covered California and, of course, Medicare and all its options.

"The service does not sell insurance or recommend specific policies," Caracappa adds. "We're here to help you understand the choices you may have, answer health insurance questions or direct you to a physician referral service." The service also provides information on insurance options following a job loss or job change, answering questions about changes in benefit coverage and COBRA. Caracappa can also explain what an advance health care directive is and how to complete one.

Tennis Champ Back on the Court Five Months After Double Knee Replacement

Grateful Patient Credits Innovative Surgery at Washington Hospital

Tennis champion Leslie Airola of Portola Valley has competed nationally and around the world for almost 30 years. But when at times, painful and swollen knees caused the U.S. Tennis Association Masters champion to struggle to finish a match and miss tournaments, she knew it was time to address her severe arthritis.

Airola, 68, a retired attorney, competed in junior tennis and at the University of California, Berkeley, where she was the No. 1 singles player. Eventually knee wear-and-tear caught up with her. She had knee surgery in her 40s and managed flare-ups of her bad knee with periodic cortisone and hyaluronic joint injections over the past 15 years. Last year, however, her good knee was starting to hurt, which made walking painful.

Several friends and tennis players who had knee replacement surgery highly recommended Alexander Sah, MD, medical co-director of the Institute for Joint Restoration and Research (IJRR) at Washington Hospital Healthcare System in Fremont.

Many were back to playing tennis, skiing and doing their regular activities. They called their knee replacement surgery life changing," says Airola. They all praised Dr. Sah, one of the most renowned knee replacement surgeons in California, and a pioneer in a minimally invasive technique that reduces pain, and fosters quicker mobility and recovery.

"I only saw Dr. Sah," Airola recalls. "I wanted a surgeon who was tried and true, and he seems to be the go-to doctor in my community. His reputation is stellar. When I asked around, most people said Dr. Sah did their surgery."

"I wanted a surgeon who would get me back to my level of activity. I didn't want to become a person who had no pain but only sat around." Airola also wanted to continue playing with her two grandchildren, 6 and 3. "When they say, 'Come on, Nonna, get on the slide with us,' I want to be able to do it."

Back on the Court Five Months After Surgery

After meeting with Dr. Sah and learning that both knees were severely arthritic and needed surgery, she had double knee replacement last February. Dr. Sah evaluates each person individually based on their motivation and fitness level, and made a plan for her.

Five months later, Airola competed in two international doubles tennis events in Europe. "My goal was to compete on a team that I was selected for in Luxembourg and Belgium in July. That goal was on my mind during rehabilitation. I said to myself: 'If I do the physical therapy exercises and follow through, I'll be able to go on the trip. That helped motivate me."

Airola, who was ranked No. 2 in the country last year in 65-and-over doubles,

not only competed in July, but won all four of her matches against younger players. After college, Airola had taken a few years off from tennis to go to law school and raise her two children, and returned in her 40s to compete.

While not everyone is a candidate for double knee replacement, it may be right for people who have good physical fitness, and are motivated in rehabilitation. "I wanted to get the surgery before I was in my 70s," she notes. "The longer you wait, the more muscle you lose. I had some trepidation about having both knees done at same time because I knew it was a harder recovery. But I'm a person who wants to get things done and get on with my life. I'm happy it worked out so well."

Joint replacement surgery at the IJRR incorporates advanced imaging and robotic-assisted techniques to facilitate a better result. Dr. Sah is among a handful of knee replacement specialists in the country who have developed specialized techniques and instruments to do the surgery using a smaller incision than traditional joint replacement. The scar is only 3 to 5 inches long, half the length of others. The thigh muscle is also unaffected.

Quicker Recovery, Faster Mobility

There are many advantages to this approach, according to Dr. Sah, including a faster recovery, less pain, quicker knee mobility, and shortened hospitalization. This innovative procedure is an option for patients who have health problems that make traditional replacement surgery

After three weeks, with support from family and friends and twice weekly at-home physical therapy provided by the Hospital, Airola was recovered enough to

go to outpatient physical therapy. "Rehab was difficult, but I was motivated and the pain medication allowed me to perform the exercises," she says.

Today, she's back to doing most activities, including playing doubles tennis regularly. Her goal is to begin to compete in singles matches, as well as doubles. Airola is also planning to play in a national competition in October.

The American Miracle

International tennis colleagues have dubbed her the American Miracle, saying they never heard of a double knee replacement or a patient return to the game so quickly. Airola attributes some of her success to doing physical therapy prior to surgery to prepare her knee. She continues to exercise at home, and works with a trainer for strength and flexibility coaching.

Her advice to others living with knee pain and considering replacement is one word: patience.

"Having patience, perseverance, and a goal are all important." She cautions, "But patience is key, and also having a good support system at home and with friends. Don't wait too long if you're experiencing a lot of pain, stiffness and interference with your activities. Have the surgery. You'll be glad you did."

price index shows that the prices of haircuts and other personal care services have risen over 27% in the last five years.

But value and consistency alone don't seem to fully explain the powerful affection that customers feel for Doan's. The business has done no advertising since reopening, shared Kalena Cao, who works alongside her sister Tammy. Some clients tried to book appointments before the new phone line was even set-

up. Without being asked, others

started a new Yelp listing for

the updated location. One even facilitated the interview with this very newspaper. The business is open seven days a week, and looking to hire a massage therapist to expand offerings.

What's the secret to such a

strong following? "When you find the right salon for you, with services you like, and you connect with the people, it's hard to replace them," Foroushani said. Doan's Hair and Spa exudes a calm, amicable atmosphere. The place feels clean and bright, with large airy rooms and a wide

assortment of beauty products. But more than anything else, there's a tone of familial camaraderie.

Many longtime employees returned to the store after it reopened, and their children, who sometimes visited as kids, are now grown up. Foroushani's daughter Mahsa, who's been to the parlor since she was a teenager, reminded her mother of the time Doan Nguyen spent hours dyeing Foroushani's hair platinum blonde for a Marilyn Monroe costume. Clients also remember the salon staff from decades ago: "I remember when the sister [Kalena] was still in high school," de la O laughed.

A good deal of time is spent listening and chatting during the quiet work of preparing facials or painting toenails. Clients seem to know that when they come, they will feel heard and taken care of.

'It's your time to just relax," de la O said, adding, "You go away and come back happy."







New Construction

The project includes reducing the road from four lanes to three, installing curb extensions at intersections, adding bike lanes, upgrading ADA access with new curb ramps, replacing sidewalks, repairing potholes and creating on-street parking with protective barriers for cyclists. Roadways will also be resurfaced and restriped, with sustainable landscaping added along the sidewalks. These

improvements are aimed at encouraging slower, safer driving while promoting a walkable, pedestrian-friendly downtown. Construction has begun and is expected to continue through Summer 2025.

History Matters

The Battle of Baltimore, September 12-14

On August 24, 1814, the White House and the Capitol were torched in a British invasion force commanded by Rear-Admiral George Cockburn. It was the lowest point in the War of 1812—until a battle in Baltimore restored America's confidence and birthed a national anthem.

Nineteen days later—on September 12th—British troops launched a land-based/naval ambush on Fort McHenry, a pentagon-shaped military fortress constructed in 1798 and named after a former Secretary of War.

Rockets poured down on the stronghold, illuminating a huge American banner overhead. The merciless bombardment lasted more than twenty-four hours, but the obstructions in the harbor—and Maryland's steadfast militia—held the British fleet away from the guns' most effective range. Two days later, the flag maker Mary Pickersgill replaced the tattered streamer.

Meanwhile, a young lawyer named Francis Scott Key, who was aboard a prison ship nearby, and attempting to negotiate the release of American hostages, was so moved by the site, that he composed a poem which celebrated the country's deliverance. He depicted "the rockets' red glare;" "the bombs bursting in air," and rejoiced in the fact that "the flag was still there." Later, the poem was set to a British drinking song, "To Anacreon in Heaven," and morphed into "The Star-Spangled Banner."

The Capture of Atlanta

In August of 1864—after more than four years of civil war—the weary President

Abraham Lincoln felt overwhelmed. His campaign for reelection appeared to be hopeless; the Union forces were stuck in a bloody quagmire, and it seemed clear to his political lieutenants that the public would gladly vote for the likely Democratic nominee, General George B. McClellan.

And so Lincoln wrote a note that foretold a bleak future for the United States:

This morning, as for some days past, it seems exceedingly probable that this Administration will not be re-elected. Then it will be my duty to so co-operate with the President elect, as to save the Union between the election and the inauguration; as he will have secured his election on such ground that he can not possibly save it afterwards. — A. Lincoln

He carefully folded the document, and when his Cabinet members arrived in his office—today's Lincoln Bedroom—he made an unusual request. He asked them to sign the outside of the paper without reading its contents. This "Blind Memorandum" would bind them all to the same grim task.

Then, on September 2, after a long siege by General William T. Sherman, the Atlanta surrendered to the Union's forces. Sherman triumphantly wrote to Lincoln, "Atlanta is ours, and fairly won." This victory—along with the extreme and defeatist platform adopted by the Democratic Party at its 1864 convention—helped to revitalize Lincoln's political fortunes. He won an overwhelming victory in November, and only then read to his Cabinet the memorandum they had endorsed.

Eagle Scout gives seniors a place for purpose

HIGH SCHOOL SENIOR HELPS AGE WELL CENTER AND SUPPORTS AFFORDABLE MEAL PROGRAM

Inesh Inpanathan, a 17-year-old senior at American High School in Fremont, used his Eagle Scout project to make a meaningful impact on the lives of older adults. By constructing planter boxes for the Age Well Center in Fremont, he created a new resource for seniors to grow fresh produce, contributing to the center's affordable meal program.

Inpanathan's decision to build planter boxes came after visiting the Age Well Center with his family to discuss potential projects. Originally, the idea was to build a sign for the center, but Monica Gloria, the center's manager, suggested a more impactful project: raised garden beds for the seniors.

"We went to the Age Well Center and asked to build them a sign," Inpanathan said. "But Miss Gloria said they needed planter boxes instead, so we helped with that."

The Age Well Center, a gathering place for adults aged 55 and older, offers a wide

range of services, including fitness programs, volunteer opportunities and a popular low-cost meal plan. With the new planter boxes, the center can grow its own vegetables, helping lower meal costs while offering seniors a chance for active engagement.

"Food is about more than just sustenance," Gloria said. "It's about community." The meals at the Age Well Center are more than just a way to eat affordably—they're also a chance for seniors to connect with one another. The new planter boxes provide them with an opportunity to stay physically active, contribute to the meal program and experience the process of growing plants from seed to harvest.

Inpanathan and his team built the planter boxes out of redwood, ensuring they would be sturdy and long-lasting. Although the project wasn't without its challenges—some of the original measurements were off, requiring adjustments and extra support—

Inpanathan's problem-solving skills, developed through years in scouting, helped him overcome those issues. "We had some trouble with the cuts at first, but we worked through it and made sure the boxes were strong," he said.

For Inpanathan, this project was more than just fulfilling a requirement for his Eagle Scout rank. It was a way to give back to a generation that is often overlooked. His father Vignes Inpanathan, a software architect from Fremont, believes this project showcases the growth his son has experienced through scouting.

"Scouting has helped Inesh become more independent and develop a sense of responsibility," Vignes Inpanathan said. "He's learned skills that are useful in life and made a real impact with this project."

The planter boxes have already inspired several seniors to volunteer, and the garden is quickly becoming a community project. Gloria, who has been at the center for over a

decade, sees the planter boxes as more than just a functional addition—they're a tool for fostering purpose and connection among the seniors.

"Having the planter boxes here gives our seniors a chance to volunteer, feel purposeful and give back by maintaining the plants," Gloria said.

Now, with the planter boxes fully installed and growing vegetables, the Age Well Center is reaping the benefits of Inpanathan's hard work. The garden has become a focal point of the center's mission to provide for both the physical and emotional well-being of its seniors. As Inpanathan prepares to officially earn his Eagle Scout rank, the planter boxes stand as a lasting reminder of his contribution to the community.

"What Inesh has done is really impactful for us," Gloria said. "It's not just about building something, but about creating something that lasts and continues to benefit people in the long run."

Peas on Earth please!

HOW TO GROW AND COOK TASTY PEAS

Pea plants (Pisum sativum), belong to the family Fabaceae and are cool weather legumes that are grown for their pods and seeds, called peas. The tender shoots of the plant are edible as well. Different varieties produce different kinds of pods. While both snow and sugar snap peas have edible pods, sugar snap pods are thicker, and their pea size is also bigger. "Shelling peas" are collected from the pod.

Peas grow best when grown during cool-weather periods. They can be planted in fall for a winter harvest and in early spring for a summer harvest. This allows some gardeners to plant peas more than once a year, although planting in spring may shorten the harvest window due to warming weather.

When planting peas, choose the variety based on the type of space your garden has to offer. Bush type pea varieties are about two feet tall and have a shorter and earlier production period. They don't really need support, but I like to put a tomato cage around them to keep their branches away from the ground. This helps with air circulation and can keep pests away. The vining types are much taller and can reach four to six feet or more, have a higher yield and produce for a longer time. They also require taller and sturdier support structures. Depending on variety and planting time,

peas take about 60-70 days before pods are ready for harvest. Once they start producing, one can expect to harvest the pods every few days. For a continuous supply grow them every few weeks.

I have not found much difference in starting seeds indoors versus directly sowing them outside. I soak the seeds overnight and sow them in pairs, snipping out the weaker as they start to grow. Bush varieties perform similarly when planted either in containers or the ground, but I almost never plant vining varieties in containers as they can become unwieldy. While peas are nitrogen fixing plants, I have had to fertilize them at least twice during the growing season, preferring a low nitrogen fertilizer for quick feeding.

Pea plants are affected by a few diseases and pests. Powdery mildew and spider mites have affected my plants the most. Powdery mildew generally appears as yellow spots on the upper surface of older leaves, spreading gradually to the undersides. A combination of conditions like warm and dry days with cooler nighttime temperatures and humidity can cause powdery mildew. Selecting resistant varieties, planting in unshaded areas and avoiding excess fertilizing are some ways to get ahead of powdery mildew. To dislodge spider mites, spray the plants with a garden hose, especially on the undersides of the leaves and wash the dusty areas and walkways with a forceful jet of water. Spider mites like hot, dry and dusty conditions, and hosing off the plant helps keep it cool and clean as well.

Doing this during the early part of the day allows moisture to evaporate. Horticultural oil and insecticidal soap can be effective on mite eggs. Infested plant disposal, regular de-weeding and cleaning up debris reduces host and overwintering sites for pests.

Harvest time for pea pods depends on the type. Harvest snow peas when pods are about three to four inches long, and when the peas inside start to show their presence. Sugar snap peas are ready when the pods are young, crunchy, have filled up and make the "snap" sound. Shelling peas are ready as soon as the peas have filled up the space inside the pod and look well developed. Pods should feel firm, and peas should be at the expected size.

Cook or process the peas for storage soon after harvesting as they can overmature quickly. My favorite way to eat peas is raw. Sugar snap and snow peas make great additions to salads and in vegetable trays. They can also be enjoyed as a side-dish sauteed with onions, tomatoes, ginger, garlic and spices. Shelled peas can be added into stews or blended into soups. When I am in the mood for indulging, I use them in samosa and paratha stuffing. Shelled peas can last a long time frozen. Let's have peas!

Easy peasy peas pilaf

This recipe uses one cup of white basmati rice that has been soaked for 20 minutes and two cups of water. In a wok or heavy bottom pan, add a teaspoon of melted ghee and as soon as it heats up, add a pinch of cumin

seeds, a couple of bay leaves and one to two cracked open pods of cardamom. Once the cumin seeds have started to sputter, turn the heat to low, add two cups of water and bring it to a boil. Add a quarter cup of shelled peas and salt to taste and turn the heat back up. Drain the rice and add to the boiling water. Cook rice according to the instructions on the package. One can use vegetable stock in place of water. Skip ghee if not desired. This recipe makes one to two servings.

Peas and paneer dish

For a quick meal, use any store-bought curry or tikka masala sauce. This recipe uses half pound cubed paneer, two cups of sauce and quarter cup shelled peas. In a heavy bottom pan, add in the sauce, cubed pieces of paneer and shelled peas. Dilute the sauce with water or vegetable stock depending on the thickness desired. Cover the pan and allow it to simmer for about ten minutes on low heat. Garnish with finely chopped cilantro and serve with rice or roti. This recipe makes one to two servings.

Golf sensation enters his freshman year

ASTON LIM REFLECTS ON SUMMER ACHIEVEMENTS AND PREPARES FOR HIGH SCHOOL GOLF

Union City native, Aston Lim, has had an incredible golf journey competing at a great level. Now he is entering his freshman year at 14-years-old on the boy's team at James Logan High School.

This past summer, Lim has played at several tournaments across the country placing well at several of them. His top finishes since March this year include champion at American Junior Golf Association (AJGA), All-Star at Quail Creek at the Quail Creek Country Club and Resort in Robinson, Illinois held July 3-5, 2024 for boys age 12-15 with a score of 69-70-69 (-7). He was also champion at the Southern Alameda County Middle Athletic League (SACMAL) Middle School League Championship at Redwood Canyon Golf Course in Castro Valley in May for middle school boys with a score of -1. Another championship title was earned by Lim at the United Stated Kids Golf (USKG) San Francisco Tour at the Bay View Golf Club in Milpitas in April with a score of 71 (-1). He earned a close second place at AJGA Junior All Star at Meadowbrook Country Club in Mount Pleasant, Wisconsin also in May with a score of 74-68-74. Aston's personal record (PR) is a 66 which is -6, with seven birdies and one bogie on that score.

"To represent Union City golf on a national stage feels amazing because whenever I go to tournaments, and they announce where I'm from, a lot of people have never heard of this city before. So, it's great for me to put the city on the map," said Aston.

Aston's first ever AJGA tournament first place win was at the Quail Creek Country Club All-Star tournament. After an exciting 2nd place in Racine, Wisconsin in May 2024, Aston was disappointed to find himself outplayed in July 2024 at Mahoning, Ohio finishing at 22nd place. Many were impressed with his resilience, as they watched him plan, practice and put into play what he needed to be at the top.

"I compete with the best of the best in the country in the AJGA," added Aston. "Winning my first AJGA tournament let me know that I'm able to compete at a really high level and gave me even more points to keep elevating to qualify for even bigger tournaments."

Each year, a player is only allowed to compete in five AJGA tournaments. The tournament usually consists of over 200 boys from ages 12-15 competing. The initial field size is usually over 200 players. However, only the top 60 players who applied are allowed into the tournament based on the

Rolex Golf World Ranking. After the 2nd day of competition, about 40% of the field will be cut based on the scores from the first two days. In the final round, scores from all three days are tallied to reveal the champion.


On the first day at Quail Creek Country Club, Aston finished third. On the second day, he took first place with a one stroke lead. On the final day, July 5, Aston took a decisive lead of five strokes scoring 70-69-70 (-7) to earn his first AJGA title which he was not expecting until his senior year of high school.

"My Quail Creek win is the most memorable moment of my career because I finally got an AJGA golf bag that only the winners get and it solidified my position in this sport," said Aston.

His family and coaches are very proud of him and glad to see his years of honing his skills come to fruition at such an early age. He was able to meet Tiger Woods in 2023 at the Tiger Woods Junior Invitational.

"Tiger Woods said during a speech at his invitational that 'Nothing is ever going to be given to you and that you have to work for everything," said Aston.

Aston will be competing in other local tournaments like JTNC and JJGANC until

the season starts at James Logan. He is most looking forward to competing in the AJGA Invitational in Louisiana this October, which he qualified for by winning the AJGA tournament in Illinois this past summer, giving a great honor to Aston.

"Being sponsored by certain golf companies gives him a certain swagger and confidence when competing at large tournaments," said Aston's father Adrian Lim.

When Aston started winning bigger tournaments it helped him get sponsored. He is currently sponsored by Adidas and Mizuno, who give him free gear to play in. Adidas sponsored him this past June and Mizuno sponsored him in October 2023. Some of the perks of being sponsored is that Aston receives invitations to those company sponsored tournaments and the golf gear he gets supplied with help cut down the costs of the expensive sport.

"Coach KenYetta Agregado – my middle school and now also high school coach – has helped me mentally and physically getting me ready for this next phase of my career," shared Aston. "To win the invitational in

Louisiana would be incredible because some of the golfers that will be there are ranked first in the nation."

The James Logan boy's golf season, which competes at the Division 1 level, begins in April 2025 and Aston is more than prepared to begin his high school career. Aston's goal is to go on to play college golf at one of the top universities in the country like Stanford, Chapel Hill or Vanderbilt. There are many college scouts from top schools present at the AJGA tournaments watching Aston to see how he performs and if he would be a good fit for their school. Golfers in AJGA tournaments are grouped together by skill set, and because Aston is among the top, he has scouts from many colleges watching him.

This is rare for a high school freshman to already have this type of national attention surrounding him so early in his career. Aston wants to choose a college not only for golf, but for its academic reputation. After graduating college, he plans to go pro. Aston is in prime position to make history not just for himself, but to be the first major golfer to represent Union City on a national level.

The Great Divide

Historical references allude to a "Great Divide" under many different circumstances. For instance, a Continental Divide often refers to geographical watersheds that feed rivers and streams that flow from mountains to oceans. In this context, the Continental Divide of the United States of America is used as reference to the direction and ultimate destination of water to the Arctic Ocean, Pacific Ocean, Gulf of Mexico, Great Lakes or Atlantic Ocean. Since the snow pack and terrain of mountains is typically the source of this flow and can present significant obstacles to travel, the meaning of the term extends beyond hydrographic references.

There are many great divides besides geography and water resources. In politics, divides can be seen in philosophical differences of who governs and their authority to govern, the role of religion, culture, participation by an electorate and, if elections are held, who should be included in the electorate. The Civil War [1861-1865] is an example of a notable great divide of U.S. history. A basic definition of who would participate and what the future of our union would be was at the root of that critical conflict.

In our country, strength is seen through representation; elected representatives make determinations through examination of the effects of proposed and existing legislation. They determine whether proposed rules of behavior are for the benefit of their constituents. The system depends on an informed electorate, informed representatives and willingness to compromise, modify and use rational thought to solve common problems. At its heart, the free flow of information and a lucid analysis, including pros and cons of a proposal, are critical for success.

Different philosophies of governance are a question of faith in humanity. For some there is little hope for common rule; ignorance and stupidity are considered one and the same. But, I believe there is a difference. While stupidity and its behavior can only be corrected to an extent through training and repetition, ignorance is simply lack of knowledge and introduction of tools to apply it. If we, as a people, are simply ignorant, there is hope toward correcting our behavior and community engagement. Along with knowledge, civility and attention are necessary ingredients. This can apply to a plethora of circumstances. For instance, driving a motor vehicle, riding a bicycle or as a pedestrian (i.e. pull over

for emergency vehicles, understand flashing traffic lights and attention to red lights at an intersection, common courtesy), paying attention to those around even if engrossed by music on an ipod or rude behavior while talking on a cell phone in the grocery store, to

The great divide of our personal lives is not always as difficult to solve as traversing a huge mountain range. It takes attention and knowledge that can reach across communities. Not only can awareness and information create a better atmosphere on a micro scale, but attention to decisions of our representatives can make a big difference in the quality of life

Expanding awareness of the great divide to the political scene can also reap big rewards. It is heartening to see public response to proposals for growth and development, especially when discussion is thoughtful and coherent. Recently, a group of concerned citizens attended a Historical and Architectural Review Board meeting in Fremont to comment on a proposed gateway development of the Henkel site. Developer and citizen comments were well presented and represented knowledge of the property and its importance to visitors and residents of the Niles District. Acknowledgement of efforts by the developer was included with criticism; this was not a raucous "us versus them" discussion, rather a sensible exchange of ideas. The result was a decision based on citizen concerns; reason, knowledge and civility crossed a great divide of form and function that did not fit the community.

If the same pattern can be used in all future discussions and behavior, we, like many early explorers trying to find a practical path through mountain ranges, may find portage when facing future Great Divides.

Union City BART access expansion project moves forward

Express (ACE) trains, connecting Sacramento, the Bay Area and the Central Valley, with future connections to California's High-Speed Rail.

URGENCY FINDINGS The City Council makes the following urgency findings:

The California Building Standards Commission adopts a complete set of new building codes in three-year cycles based on the latest international and national model building codes and these regulations are referred to as the California Building Standards Code codified in California Code of Regulations

The California Building Standards Code, including the California Building Code, contains general building design and construction requirements relating to fire and life safety,

structural safety, and access compliance.
In 2022, the City of Fremont ("City") adopted, and has in effect, the 2022 California Building Standards Codes with certain administrative and technical amendments based or Fremont's local conditions.

The City also adopted a Neighborhood Preservation Ordinance ("NPO"), codified in Chapter 8.60 of the Fremont Municipal Code that establishes a nuisance abatement program to advance the comfortable enjoyment of life and property of the residents of Fremont. The NPO requires that the owners of property within the city sustain property maintenance best practices to protect the livability, appearance, property values and economic stability of the city and protect the public from health and safety hazards that result from the

neglect and deterioration of property.

The NPO makes it unlawful for any property owner to maintain or to allow his/her property to be maintained in a condition that is detrimental to public health, safety, or general welfare or in a condition which violates any code or ordinance adopted by the City including the requirements of the California Building Standards Code.

The NPO provides that where the City determines that a property is maintained as a nuisance, the City shall provide the property owner an opportunity to take corrective action or appeal the determination of nuisance disputing the factual or legal basis of the The NPO provides that an appeal of the

specific abatement of nuisance determination takes place before a sole hearing officer designated by the city manager. The City's appeals procedure, setting appeals before a sole hearing officer, was challenged in the matter Temple of 1001 Buddhas v. City of Fremont, Court of Appeals, First Appellate District, Case No. A167719, on the grounds that the procedure was preempted by section

1.8.8 of the California Building Code. 10. In Temple, the First District Court of Appeals affirmed the City's finding that the property

owner violated Fremont's Zoning Code set forth at FMC Title 18 and violations of the International Property Maintenance Code at Chapter 15.45 of FMC Title. The First District Court of Appeals also determined that section 1.8.8 of the California Building Code preempts the City's appeals process for enforcement determinations based on violations of Fremont's Building

such appeals. 12. Consequently, the City must establish a local building appeals board, by amending its municipal code, to meet the requirements of section 1.8.8 of the California Building Code and the decision of the First District Court of

Proper sorting makes a difference

When prohibited materials such as food scraps are placed in the recycle bin/cart, the improper sorting can degrade the quality of recyclable materials and increase sorting and collection costs due to the additional effort needed to remove these materials. Moreover, valuable resources are lost, and more waste is generated when clean recyclables are mixed with prohibited items, which then must be sent to landfills

Union City residents and businesses can play a significant role in reducing prohibited materials in recycling. Remember that the best recycling intentions are wasted when prohibited materials are placed in the recycle bin/cart. When we recycle the right things the right way, we not only help our community comply with State and local recycling laws, but we help our economy and the environment by ensuring quality recyclables can be recovered and delivered back into the economy instead of sent to landfills.

You can become an expert recycler by following these simple tips:

Keep recyclables empty, clean and dry. Rinse/wipe food residue and empty liquids from your plastic, glass and metal containers so they can be recycled into their highest and best use. Keep it loose. Do not bag

recyclable materials. Plastic bags can get tangled in or damage sorting equipment at the Materials Recovery Facility where recyclables are sorted.

Know what is accepted in the recycle collection program and only place these items in the recycle bin/cart. Don't be a "wishcycler." Throwing an item that you hope is recyclable into the recycle bin/cart does not mean it will get recycled.

Acceptable recyclable

materials include: Clean cardboard (flattened); Paper, mail, newspapers and magazines; Metal pots and pans; scrap metal up to 10 lbs; Shredded paper (in paper bag); Metal bottles and cans; Clean aluminum foil; Glass bottles and jars; Plastic containers labeled #1 and #2.



MAYOR LILY MEI DELIVERS PROCLAMATION AT FREMONT CITY COUNCIL MEETING

On Tuesday, September 17 Fremont Mayor Lily Mei delivered a proclamation for United Against Hate (UAH) Week at a regularly scheduled city council meeting. It will be observed from September 21 through September 27, 2024.

"The City of Fremont supports the efforts of Compassionate Fremont, the Tri City Interfaith Council, and the City of Fremont Human Relations Commissions to stand with other cities in the Bay Area to eliminate hatred and intolerance," Mei said.

The proclamation states that "policies and rhetoric" have contributed to bigoted views and divided communities across the country, even in historically progressive areas like the Bay Area. San Francisco law enforcement in January of this year expressed concerns over rising hate crimes in the state, saying it's an issue that is going under reported.

United Against Hate Week was established in 2017, when six Bay Area cities coalesced and distributed 5,000 UAH posters in an effort to end prejudiced hate and unite local communities. In addition to planned events, the organization posts guides for how people can help to end hate in their communities.

On September 14, 2024, California State residents joined hands as dedicated volunteers of the global non-profit organization Dr. Shri.
