# Young volunteers help feed the homeless



Paul Webster and Justin Valenzuela are determined to end homelessness in Fremont, Newark, and Union City. Thus, they co-founded Renegade Feedings, a group of young volunteers distributing meals and hygiene supplies to unhoused people in the Tri-City area.

Webster first contacted Valenzuela for help In February 2019. "Paul saw I was always posting on social media, talking about giving back and trying to help out," Valenzuela remembered, "he reached out about doing a community barbeque."

Their idea quickly evolved. They decided to bring the meals to encampments where people lived. They got help from friends, acquired donations and funding, and started collaborating with organizations and local food banks. Renegade Feedings was the result.6

### **Childbirth and Parenting Help During Unusual Times**

With COVID-19 Precautions, Maternal Child Education Moves Online

Everywhere we turn, businesses and organizations are making changes to be able to provide services for guests while maintaining COVID-19 precautions. Hospitals are no exception. Expectant parents would normally want to tour a birthing center and take classes to find the preparation, education and support they need to feel comfortable.

At Washington Hospital, the good news is the programs and the Birthing Center tours are still available via Zoom and online video programs. And, the Hospital's Maternal Child Education Center (MCE) staff is available by telephone and email to answer questions and provide information and assurance to new parents.

Programs range from preparing for childbirth and prenatal yoga to breastfeeding support, and new classes for expectant fathers and grandparents. There is also a support group for new parents. Shayna Mann, MCE office manager notes, "We encourage all new parents to take the virtual Birthing Center tour and join the other programs to help them get ready for their new baby." Mann continues, "It's helpful for those who may have never been to our Hospital and aren't sure what to expect. Our programs provide information new parents need and cover questions their physician may not have yet covered."

The MCE staff includes childbirth educators and a lactation nurse. "While in-person programs may not be available right now, our online and video programs—along with staff being available for consultation—fill the gap," she says. "It's important that new parents have

access to the information they need to feel supported."

# Programs include: Prenatal Smart Start (Website video)

Through an online free video, learn how pregnancy affects your body, about healthy nutrition during pregnancy and exercises to prepare your body for labor. Most importantly, learn about common discomforts (and remedies) versus danger signs that would indicate alerting your obstetrician. The MCE staff recommends this program for the first 8 – 10 weeks of pregnancy.

### **Preparing for Childbirth (Zoom)**

This class is intended for couples in the last trimester of pregnancy, offering detailed information about many labor preparation topics including: signs and

symptoms of labor, stages of labor, relaxation and breathing techniques, the coach's role, variations in labor, analgesics and anesthetics, cesarean birth, postpartum recover tips and the basics of breastfeeding. This class is recommended for women in their third trimester.

### **Becoming New Parents (Zoom)**

This one-time, three-hour workshop for expectant parents in the third trimester offers sensible tips, demonstrations and information on caring for your new baby.

### Birthing Center Tour (Virtual tour on website)

Get an introduction to the birthing experience at Washington Hospital with an online tour. Learn what to expect when you arrive for your labor and delivery.

### Prenatal Yoga (Zoom)

This hour-long class, offered four times a week, can improve sleep, reduce stress, increase flexibility and decrease lower back pain. The staff recommends

beginning the class in the early stages of pregnancy.

### **Prenatal Breastfeeding (Zoom)**

This class will help new mothers feel more confident in meeting breastfeeding goals, whether this is a first child or a new sibling in a larger family. The one-time class will go over milk production, how to know if your baby is full, infant weight gain, and other common challenges.

### New in January! Understanding Fatherhood (Zoom)

This class is designed to guide new fathers on their journeys from their partner's pregnancy to birth and beyond.

### **Grandparents Class (Zoom)**

To help with the complexities of modern parenting, today's parents have more information, more products and more rules than previous generations. This class is intended to offer suggestions on how to be supportive while learning about infant care and safety.

### Baby & Me (Zoom)

A free, informal support group for moms and babies from birth to walking. The group meets from 11 a.m. to noon every Monday, Wednesday and Friday. Join as often as you like to discuss the joys and trials of living with your new baby. No registration required.

# New Procedure Offers Hope for People with Carotid Artery Disease

# Minimally Invasive Procedure at Washington Hospital Reduces Risk for Stroke

Washington Hospital is the first hospital in the East Bay to offer a new vascular procedure that can reduce the risk for stroke in some patients. Transcarotid artery revascularization – or TCAR – is a minimally invasive procedure used to open up arteries that have become blocked due to carotid artery disease.

"Carotid artery disease causes a narrowing of the carotid arteries – the two major arteries that carry oxygen-rich blood to the brain," explained Dr. Gabriel Herscu, a local vascular surgeon and member of Washington Township Medical Foundation who is one of two vascular surgeons at Washington Hospital who can perform the new TCAR procedure. "Plaque builds up inside the arteries and eventually over time creates blockages. Smoking, diabetes, high blood pressure and high cholesterol are all risk factors."

People with carotid artery disease have a much higher risk for stroke, which can lead to disability and even death. Stroke happens when a blood vessel that carries oxygen and nutrients to the brain is either blocked or

ruptures. According to the American Stroke Association, stroke is the fifth-leading cause of death in the U.S.

Up until recently, there have been two major treatment options aimed at opening up the carotid arteries – which are located on either side of the neck – and preventing stroke, according to Dr. Herscu.

"Carotid endarterectomy has been the gold standard," he noted. "With that surgical procedure, we open up the blocked carotid artery and clean out the plaque. But not everyone is a good candidate for this surgery. It's major surgery and if the patient's overall health is not good, they may not be physically up for it."

The second option for patients who aren't good candidates for a carotid endarterectomy is carotid angioplasty and stenting. This procedure is typically done through an artery in the groin.

"A stent is placed over a wire," Dr. Herscu described. "The stent is a metal cage that opens up the artery. The procedure is effective, but there is a significantly higher risk of stroke. The most recent guidelines from the Society for Vascular Surgery recommend against it except as a last interventional resort – when there are no other options."

### **TCAR Provides a New Option**

In the past few years, TCAR has emerged as another option for people who aren't good candidates for a carotid endarterectomy. It is a less invasive hybrid procedure, according to Dr. Herscu.

"With TCAR, we make a small incision at the base of the neck and place a stent directly into the carotid artery." He continued, "TCAR uses a reverse flow system so that blood flow is temporarily reversed during the procedure. That causes any debris or plaque that breaks away during the procedure to flow away from the brain. This debris is what increases the risk of stroke during traditional stent placement."

Dr. Herscu and Dr. Sarah Wartman began performing the new procedure at Washington Hospital a few months ago. TCAR is still a second choice treatment, but Dr. Herscu said someday it could become the standard.

"TCAR is less invasive with less pain and faster recovery times," he added. "We are able to do it with a local anesthetic and sedation, so patients don't need to be put on a ventilator, and they generally go home the day after surgery. It still has a slightly higher risk of stroke than a carotid endarterectomy, but much less than traditional stenting."

Dr. Herscu credits the leadership at Washington Hospital for working with specialists like him to bring these types of leading-edge procedures to the community hospital.

"Washington Hospital is one of only a few nonacademic hospitals that have jumped on board," he said. "It's because the Hospital and the physicians who work there have built a culture that continually strives for the highest quality of care. The Hospital has invested in the best equipment and staff. This procedure requires the highest level of teamwork from talented nurses and anesthesiologists to be successful, and we have that at Washington Hospital."

# Music at the Mission "An Afternoon at the Opera"

The virtual concert series offered by Music at the Mission continues in December with "An Afternoon at the Opera," featuring Michael Graham, cello, and Bill Everett, double bass.



If you're looking for the diva opera singer headlining the program, look no more. There isn't one. "The concert title grew out of the central piece on the program, Rossini's Duetto for bass and cello. While a duo for instruments, it is in his operatic style, and very much like an operatic duo," explained Everett, who also serves as pre-concert lecturer.

"While Gioacchino Rossini was known almost entirely for his operas, the duo is a rare gem of chamber music. Written very much for a salon or house concert setting, he retains his operatic style. I think of this as the perfect piece for this format, bringing an afternoon at the opera to your living room."

Rossini is joined on the program by Bartok, Bach, Deak, and Chaplin. (Yes, Charlie Chaplin, who involved himself in every aspect of filmmaking, including composing music.) The Bach Cello Suite no 1 on the program is much like the Rossini in that it is "not really

meant for the concert stage, but more for small gatherings. Written as dances, these were the party music of the 17th Century," notes Everett.

"One of the great developments in classical music in the last hundred years is the blurring of the lines between concert music and folk music, says Everett. "No composer had a greater influence on this movement than Bela Bartok. Not satisfied with simply looking for ideas from the folk music of his native Hungary, he set out to catalogue, record and study every aspect of it. The duos, originally for two violins, are perfect examples of his admiration for this folk music."

And then, there's the contemporary classic, "BB Wolf" by Jon Deak. "I think of the works of Jon Deak as sort of mini operas. He combines music with elements of the theatrical. In the case of 'BB Wolf,' having a single musician (myself in this case), perform the roles of both bass player and actor." Everett wouldn't give too much away about the story, but it involves a certain Grimm fairy tale character.

"The Essanay studio in Niles was home to a young Charlie Chaplin. We decided to pay homage to Fremont's early silent film roots with a performance of one of Chaplin's most famous songs, 'Smile.' We also decided to enhance the performance with a little filmmaking of our own," said Everett. "You'll have to tune in to find out."

The virtual concert runs approximately 50 minutes and is available online for 48 hours. Watch as many times as you wish! And watch it when you wish. The Pre-Concert Talk is available now for free. Following the concert is "ZAP!" a lively Zoom AfterParty hosted by emcee David Bonaccorsi.

# Hayward Police Department Police Within the Community

The national conversation surrounding policing led to the City Council directing two projects: a Public Safety Community Engagement Project, and a corresponding Internal Police Department survey. The Public Safety Project received a large amount of feedback regarding concerns and personal experiences from the Hayward community, which will be used in future discussions.

Hayward PD staff members worked alongside professional consultants, from August to October 2020, to conduct surveys and conversations about public safety. Over 1,700 Hayward residents responded. Though 60% felt that the relationship between the community and Hayward PD was overall positive, others listed racism as a main safety concern. More specifically, over-policing, personal negative experiences, trust, systemic racism, and intergenerational trauma were discussed. In terms of funding, 55% supported reducing and redistributing the police budget, while 60% supported the establishment of a committee to dictate funds reallocation. These heavy issues led to participants emphasizing the need for neighborhood cohesion and safety to be in alignment with one another. As a complex and diverse community, Hayward residents and Hayward PD are determined to address these concerns.

The primary objective of the Hayward PD Internal Department Engagement Survey was to hear from fellow law enforcement employees - sources of stress and their perspective of criticism of policing. Questions ranged from whether employees think that Hayward PD needs more training on cultural sensitivity and diversity to other areas for improvement. Responses indicated that some employees feel demoralized and unsupported, but there is a desire to build on positive connections with the community.

Among other issues, the hiring process is heavily being analyzed. There are several phases of the hiring process, including an extensive background check, medical examination, polygraph test, and psychological examination. The Hayward PD 2019/2020 Year End Review report states, "HPD requires a psychological examination before almost all classifications can be hired.' With this in mind, the Hayward PD considers the hiring process to be a crucial step to ensure that the department has the most qualified and capable candidates.

Both sworn and professional personnel are required to attend an 8-hour Crisis Intervention Training (CIT). The curriculum covers stigmas surrounding intellectual disabilities, substance abuse disorders, and mental illnesses. Sr. Crime and Intelligence Analyst Lesley Hayes states, "Although the COVID-19 pandemic forced the cancellation of classes from April through July, we have been consistently sending two officers to every class held." Integrating Communications, Assessment, and Tactics (ICAT) training is also provided to strengthen public and officer safety by giving officers communication alternatives to settle conflicts peacefully and productively. De-escalation skills are taught so officers can use non-verbal communication and active listening with people who may be agitated or non-compliant. All training courses are part of a quarterly mandated training for sworn personnel.

Further discussion of other departmental changes and additions include more crisis training as part of the "Stepping Up Initiative," a national movement which offers counties assistance to diminish the number of mentally ill people placed in jail. The carotid restraint technique was also permanently prohibited in June 2020 from the Hayward Police Use of Force Policy in response to the killing of George Floyd.

Staying proactive and community-based discussions, especially considering current social and political circumstances, is a significant priority for Hayward PD. In times of great uncertainty and fear, the community and Hayward PD hope to work together and strive to rebuild relationships and, most importantly, hope.

### A journey of unexpected turns

There is a fascinating connection between Starla Breshears (cellist of the Little Stars Trio) and the world-renowned cellist Christine Walevska. The connection is a superb 1/8-size cello made by the 19th-century luthier Auguste Sebastien Philippe Bernardel. The whole story, which spans some 60 years, was covered in the L. A. Times and a version appeared in the October 9, 2020 issue of The Week.

Walevska's father was a dealer in fine instruments, and he presented his daughter with an exceptional 1/8-size Bernardel cello in 1953 when she was 8 years old. The child fell in love with the instrument and never again had to be

urged to practice. When she was ready to move on to a 1/4-size cello, the Bernardel



went back to the shop. Some years later the cello was stolen from the shop and disappeared.

Fast forward 60 years. Starla Breshears' father, a piano teacher in Chico, is looking for a really good 1/8-size cello for his daughter and learns of one from a Los Angeles music store that rents for \$150 a month. He calls, but the store owner says he will only rent the instrument to an exceptional student and would have to hear Starla play. The parents and three young children pile in the car and drive to Los Angeles, where Starla is handed the cello and proceeds to play for two hours. The cello goes home with

Starla's mother starts looking on the internet, trying to find out more about the Bernardel cello, and she comes across a

story about Walevska's stolen instrument. They take pictures of the cello and email Walevska, asking whether this could be the same instrument. Eventually Walevska connects with the Breshears family and, after hearing Starla play, suggests they keep quiet about the cello until Starla is ready for a larger one. At that time Walevska will notify the Los Angeles police that the instrument has been found.

The legal hassles around confirming that the instrument was indeed Walevska's were a hurdle, but eventually Walevska and a (now playing a 1/4 size cello) Starla got the chance to meet. In the end, Walevska was reunited with her childhood cello, and Starla found a new mentor.



## Young volunteers help feed the homeless

Usually the organization has "10 core people and a lot of other volunteers," Valenzuela said. "We use to get 30 volunteers before the pandemic." Feeding people is one part of the group's efforts. They also want to educate people about the stigmas of homelessness. "Anyone can become homeless," Valenzuela said. "All it takes is one event and it could change your life," Webster, added.

Homelessness has increased so dramatically that many of the unhoused residents that Valenzuela helps grew up in Fremont. He said people in encampments often tell volunteers they never saw homeless people in Fremont when they were

Like many people living in Fremont today, Webster and Valenzuela come from financially stable families. Neither are pointedly rich, but it would be hard to still live in Fremont without stable, financial resources.

Webster remembers that his mother, a social worker doing drug and alcohol counseling, use to take in unhoused people into their home when he was a child. "I've seen lives being changed in this household," Webster said. "People come back, families that use to live here. They give her hugs and tell her how much they appreciate her. I don't think she understands how much it has helped."

Valenzuela, lives with his parents and talks with his family about how they might use their affluence and stability. "We do have a lot of stuff in our life," Valenzuela said, "We live in a privileged area. What are some ways we can redirect what we have to help everyone?"

He doesn't see this idea as revolutionary. Valenzuela said he wanted to go back to a time, ideologically, when you could "knock on a neighbor's door, ask for an egg." To educate people and recruit volunteers, the group has a strong social media presence. They post pictures and short documentaries online.


Renegade Feedings also invites people to join them in preparing food. A few days before each distribution trip, volunteers meet outside Webster's house. They prep food and talk about the impacts of homelessness.

Webster thinks that, for the unhoused, little things add up quickly. "You don't have access to water... Jobs require hygiene," Webster said as an example. "Hauling gallons of water to an encampment is difficult. After days of not taking a shower, you can't keep a job. If you lost the last job, Renegade Feedings is trying to make sure you get the next one."

Valenzuela stressed that establishing trust with the people they help is important to the group. They spend a lot of time chatting with the people

they serve. "Having this relationship where... if a person needs help (with something specific) they can ask us," Valenzuela said. "Especially during this pandemic, talking with them helps a lot."

Webster and Valenzuela have gotten help from The Viola Blythe Community Service Center and



from Newark's Mayor. In Fremont, the group lent their time in tandem with the mobile hygiene unit. They hope to get more assistance from Fremont city officials in the future. "We've been getting help from community members, other grassroots organizations, chefs and people donating things we need," Valenzuela said. Valenzuela admitted they haven't done enough to connect with city officials in Union City and said they would like to increase their presence there.

Beyond direct help to their small group, Webster and Valenzuela would like to see the cities strengthen their support systems. They want policy changes, mental health resources, substance abuse recovery options, and housing resources. "We can't just have the big cities tackle homelessness," Valenzuela said.

Only one member of Renegade Feedings is over 30. Their youth probably gives them drive, but aging and everyday life have undone many, well-intentioned revolutions. Webster plans to do this all his life. "People go on vacation to rest," Webster said. "My rest is hanging out with unhoused people and giving them resources. To me, this is rest."

Renegade Feedings will have a food prep meeting on December 24 and a food distribution event on Sunday, December 27.

# Filipino Catholics celebrate Simbang Gabi

Simbang Gabi is observed by Filipinos all over the world in anticipation of Christmas and to honor the Blessed Virgin Mary. The Filipino Catholic community gathers for nine consecutive mornings in a series of Advent Novena masses in spiritual preparation for the coming of Jesus Christ on Christmas Day.

Today, in the Philippines, advent masses are held outdoors to accommodate the crowds, a practice begun in 1587 in Mexico when the Pope gave permission to Diego de Soria, a Mexican friar, to hold outdoor mass to accommodate large crowds. With the establishment of Catholicism in the Philippines, Filipinos called the nine masses Simbang Gabi, or 'evening mass' because early rising farmers, desiring to go to mass, had to do so in the dark, (around 4 a.m.) before heading to the fields. Since then, Simbang Gabi has become a customary practice for devoted Filipino Catholics as a symbol of unity, charity, and spirituality.

Simbang Gabi brings traditional Filipino treats, including bibingka (a type of rice cake) and puto bumbong (a purple-colored sticky rice cake), often sold outside the church for people to enjoy. After mass, Filipino families and parish members typically gather for more socializing and sharing of stories. The last mass of Simbang Gabi is called Misa de Gallo, meaning 'rooster mass' because the whole family wakes with the rooster to attend.

At Christmas Eve evening, traditional Filipino families share a midnight feast called 'Noche Buena.' The Noche Buena is a big, open house celebration with family, friends and neighbors dropping by to wish everyone a Merry Christmas!





# UN calls on humanity to end 'war on nature,' go carbon-free

As an extreme year for hurricanes, wildfires and heat waves comes to an end, the head of the United Nations challenged world leaders to make 2021 the year that humanity ends its "war on nature" and commits to a future free of planet-warming carbon pollution.

With new reports highlighting 2020's record-breaking weather and growing fossil fuels extraction that triggers global warming, U.N. Secretary-General Antonio Guterres delivered yet another urgent appeal to curb climate change. It was tinged with optimism but delivered dire warnings, as the UN gears up for a Dec. 12 virtual climate summit in France on the 5th anniversary of the landmark 2015 Paris climate agreement.

"The state of the planet is broken," Guterres said in a speech at Columbia University.
"Humanity is waging war on nature. This is suicidal."

"Apocalyptic fires and floods, cyclones and hurricanes are increasingly the new normal,"

In a report, the World Meteorological Organization said this year is set to end about 1.2 degrees Celsius (2.2 degrees Fahrenheit) warmer than the last half of the 1800s, which scientists use as a baseline for warming caused by heat-trapping gases from the burning of coal, oil and natural gas. Most trapped heat goes into the world's seas, and ocean temperatures now are at record levels. It also means 2020 will go down as one of the three hottest years on record.

"There is at least a one-in-five chance of it temporarily exceeding 1.5 degrees Celsius by 2024," WMO Secretary-General Petteri Taalas said. The Paris climate accord set a goal of not exceeding 1.5-degree (2.7 degrees Fahrenheit) warming since pre-industrial times.

A new analysis by Climate Action Tracker scientists who monitor carbon pollution and pledges to cut them said public commitments to emission cuts, if kept, would limit warming to about 2.6 degrees Celsius (4.7 degrees Fahrenheit) and possibly as low as 2.1 degrees Celsius.

Guterres saw hope in promises by more than 100 countries that by mid-century they will not be adding more heat-trapping gases to the atmosphere than trees and technology can remove, along with shorter term pollution cuts. China and U.S. President-elect Joe Biden have pledged net zero carbon emissions.

"I firmly believe that 2021 can be a new

kind of leap year – the year of a quantum leap towards carbon neutrality," Guterres said.

But he said the two U.N. reports Wednesday "spell out how close we are to climate catastrophe."

When countries spend trillions of dollars to recover from the pandemic-triggered economic slowdown, Guterres said they must do so in a way that emphasizes clean energy.

Nations should stop funding and subsidizing fossil fuels, he said. And countries need to fulfill their Paris promise to spend \$100 billion annually to help poorer countries develop cleaner energy.

Guterres said there's no way the world can curb the climate change "without U.S. leadership" and urged students and other Americans to do "everything you can" to get their governments to curb emissions more quickly.

One of the new reports found countries would need to cut production of oil, coal and natural gas by 6% each year by 2030 to keep global temperatures from rising more than 1.5 degrees Celsius. Instead, a review of eight major fossil-fuel producing nations showed they plan to increase production by 2% annually. That means twice the amount of carbon-based fuel would come onto the market than feasible to keep the Paris goal within reach.

Governments in the Group of 20 major and emerging economies have so far committed more money to prop up fossil fuel sectors than to boost the rollout of renewable energy, the report found.

Co-author Ivetta Gerasimchuk of the International Institute for Sustainable Development said investing in oil, coal and gas no longer makes economic sense because renewable energy is becoming cheaper than fossil fuels. But, she said, "We see that instead of governments letting these fossil fuel projects die they resurrect them from the dead."

The WMO's report found global warming is worsening in all seven key climate indicators, but the problem is increasing human suffering in an already bad year.

"In 2020, over 50 million people have been doubly hit: by climate-related disasters (floods, droughts and storms) and the COVID-19 pandemic," the report said. "Countries in Central America are suffering from the triple-impact of hurricanes Eta and Iota, COVID-19 and pre-existing humanitarian crises."

"Human activities are at the root of our descent towards chaos," Guterres said. "But that means human action can solve it."

# New CalRecycle leader eyes overhaul of deposit-refund system

California Gov. Gavin Newsom has appointed a new head of the state's troubled recycling agency, who has pledged to overhaul its troubled bottle deposit system that has worsened during the pandemic.

Newsom appointed Rachel Wagoner, 46, a veteran legislative staffer and registered Democrat, to the job, which includes coordinating the state's efforts to clean up from record-setting wildfires.

Wagoner will take over an agency struggling to respond to the recycling troubles. Many of California's recycling centers, which are not owned or operated by the state, have closed in the past six years. Last year, RePlanet closed all 284 of its locations and laid off 750 workers.

That's made it harder for consumers to participate in the deposit-refund system for beverage containers. People pay an extra 5 cents for bottles that can hold up to 24 ounces and 10 cents for bottles over 24 ounces. They can get that money back if they recycle the empty cans or bottles.

Nine other states have a similar system. But most are run by the beverage industry instead of state government. Wagoner said California should consider that approach, favoring a system that offers an incentive for companies to design their products with recycling in mind.

"I definitely think that should be on the table as a potential solution," she said. "We really need the producers and the manufacturers to be at the table and designing their products for the next life and the life after that."

The American Beverage Association said it is "committed to working with the Governor, Director Wagoner and lawmakers to strengthen and modernize California's recycling system."

"We want to get every bottle and can back so they can be turned into new ones and not end up in the environment," the statement said.

Part of California's problem has been China's reluctance to accept waste from the U.S., severely limiting the market for recyclable materials. But Wagoner says she views that problem as an opportunity "to bring those jobs back to the state of California."

"We need to create that economy here," she said. "Not only recycling those materials but creating the new, innovative products that can use those recyclable materials."

Jamie Court, president of the advocacy group Consumer Watchdog, has criticized CalRecycle in the past for not adequately policing the bottle deposit system. He praised Newsom for picking Wagoner to lead the agency.

"This is an important sign that the governor is serious about cleaning up CalRecycle and also a harbinger of hopefully a transition to a new system that puts California back on top in terms of bottle and can redemptions," Court said.

Wagoner said her first priority will be leading the cleanup from wildfire season, which set a record by burning more than 6,250 square miles (16,180 square kilometers) – an area larger than Connecticut.

The fires destroyed roughly 5,600 homes. CalRecycle contracts with companies to clean up what's left, working alongside the Department of Toxic Substance Control to remove hazardous materials. The agency is lining up contractors for the work and hopes to begin cleaning by Dec. 1.

The appointment of Wagoner still requires confirmation by the state Senate, but that could be just a formality given she spent 10 years as chief consultant for the Senate Committee on Environmental Quality before joining the governor's staff last year. The job pays \$186,389 a year.

# California unveils smartphone virus tool as cases surge

California Gov. Gavin Newsom on Monday announced a voluntary smartphone tool to alert people of possible coronavirus exposure as cases surge higher, new restrictions are imposed and many people said they won't heed the pleas to stay home.

The tool – which has been used on a pilot basis on some state university campuses – doesn't track people's identities or locations but uses Bluetooth wireless signals to detect when two phones are within 6 feet (1.8 meters) of each other for at least 15 minutes, officials said.

California's 40 million residents can opt in to the system starting on Thursday. When someone who has activated the technology tests positive for the virus, that person will receive a verification code from state health officials that can be used to send an anonymous alert to other users who may have been exposed over the past 14 days.

"The more people that participate in it, the more that opt in, the more effective this program can be," Newsom told reporters. "We are hoping there will be enough to make this meaningful."

Sixteen other states, plus Guam and Washington, D.C., have already made available the system co-created by Apple

and Google, though most residents of those places aren't using it. The tool has been used on a pilot basis on University of California campuses, where 250,000 people opted in for notification of virus exposure.

The technology comes as coronavirus cases are exploding in California and more than 80 percent of the state's residents are under orders not to leave their homes for at least the next three weeks except for

essential purposes.

Over the past two weeks, California has reported a quarter of a million positive virus cases. The 7-day average for new virus cases on Monday neared 22,000, a

50 percent increase over the prior week, state data shows.

More than 10,000 people were hospitalized in California Monday with COVID-19, including more than 2,300

in intensive care, Newsom said.

Newsom's administration issued the stay-at-home rules shuttering restaurant dining, salons and playgrounds in Southern California and a large swath of the state's Central Valley agricultural region after more than 85% of beds in intensive care units were occupied in those regions.

Five San Francisco Bay Area counties voluntarily joined the rules, saying they didn't want to wait until their ICU capacity dropped too low to take action.

Those restrictions will last until Jan. 4, a week longer than the state's timeline.

Ten months into the pandemic, most of the state is now back to where it started with the stay-at-home rules.

But unlike in March, when the pandemic was in its infancy and California was the first state to impose such rules, fewer people are likely to obey them.

Some business owners said they would keep their doors open and several law enforcement agencies have said they have no plans to enforce the rules and are counting on people to voluntarily wear masks and practice physical distancing to protect themselves and their families.

Californians will be able to activate the new 'exposure notification' tool in their iPhone settings or on Android phones by downloading the CA Notify app from the Google Play store. Many residents will get a notification Thursday inviting them to participate.

## Do "self-cleaning" elevator buttons really work?

Without rigorous independent studies, experts say it's hard to verify claims of "self-cleaning" or "antiviral" surfaces that have popped up during the pandemic.

But they also say you shouldn't worry too much about how well such features really work.

COVID-19 is an airborne disease. Research suggests it would be difficult to catch the virus from surfaces like an elevator button.

"You get it through what you breathe, not through what you touch," said Emanuel Goldman, who studies viruses at Rutgers University.

Studies showing the virus can survive several hours on plastic or metal surfaces do not mimic real-life conditions, said Dr. Dean Winslow, an infectious disease specialist at Stanford Health Care.

Companies are selling antibacterial and antiviral elevator button or door handle covers. But building or office managers looking to protect employees or tenants would be better off buying hand-sanitizing stations instead, Winslow said.

And anyone wanting to avoid the virus should continue taking regular public health precautions: mask-wearing, social distancing and avoiding indoor events, bars, dining and gyms.

Routine hand washing is also recommended, whether there's a pandemic or not, Goldman said.

### Property tax relief for smallest businesses

A resolution that all real property including possessory interests not more than \$10,000 be exempt from property taxation was approved on December 8 by Alameda County Board of Supervisors. Previously, businesses with \$2,000 or less in real property, including possessory interests were exempt from property taxation. Taxpayers will still have to complete a Business Property Statement (571 L) annually, but if the assessment is not more than \$10,000, they will not be taxed.

"This smart, fiscally sound policy will be particularly helpful to our small businesses who have been so severely impacted by COVID-19," said Alameda County Assessor Phong La. "I am thankful to the board of supervisors for recognizing the assistance this will provide for small businesses who will be impacted by this change."

### **Edmunds: Some of the** best cars cost less than \$399 per month

The COVID-19 pandemic initially slowed car sales, but now many new-car buyers are making more expensive purchases than ever before, according to sales data from Edmunds.

The average transaction price for a new car in the third quarter of 2020 was slightly above \$39,000, with payments averaging just under \$570 per month. That's a price increase of about \$2,000 from 2019.

But a monthly payment approaching \$600 just isn't in reach for many shoppers. With this in mind, we sought to find a number of new vehicles that could be had at a more attainable \$399 monthly payment.

Factoring in today's average annual percentage rate (4.6%), a popular loan term (72 months) and a lower-than-average down payment amount of \$4,000, a vehicle with a manufacturer's suggested retail price of \$29,000 will match that monthly payment target.

We've compiled a list of vehicles that can be financed for less than \$399 a month using the above parameters. Remember that with a little research, you can easily secure a deal for less than MSRP. Note that while we will include destination and handling charges in the prices below, sales tax and fees are not included and can vary by location.

### **2021 KIA FORTE**

Small sedans are no longer the drab, soulless econoboxes of yesteryear. The Kia Forte, for example, is a sharp little four-door with lots of features and personality. Redesigned for 2019, the Forte has all the latest driver conveniences and safety features, as well as a cabin with a sporty design aesthetic and highquality materials. The base engine gets the job done, but buyers looking for a sportier edge should check out the GT model, which features a more powerful engine and unique transmission options.

Recommended trim: EX (\$24,055). Unless you want the GT's turbocharged engine, the EX is the way to go. It has almost every feature the Forte offers, yet it doesn't cost an arm and a leg. Using the parameters above, payments on a Forte EX will be roughly \$320 per month.

### **2021 HONDA INSIGHT**

Think of the Honda Insight as an electrified Civic. The two match up pretty closely in terms of size, price and equipment, and both have plenty of passenger and cargo room. The Insight's hybrid powertrain is the primary differentiator. While it isn't as quick as the Civic in a straight line, the Insight consumes far less fuel. Depending on trim, the Insight earns 48-52 mpg in the EPA's combined cycle, while the

turbocharged Civic gets 33-36 mpg combined. The Insight is also slightly newer and benefits from a next-generation infotainment system.

Recommended trim: EX (\$25,765). The EX is only a little more expensive than the base LX and adds features such as Apple CarPlay and Android Auto functionality, a touchscreen infotainment system and blind-spot monitoring. Payments on an Insight EX using our calculations will run just under \$350 per month.

### **2021 KIA K5**

The Kia K5 is the latest version of Kia's midsize sedan, formerly known as the Optima. The K5 is notable for its sleek and sophisticated sheet metal and near-luxury cabin. Many interior surfaces are covered in soft-touch imitation leather or convincing facsimiles of open-pore wood and textured aluminum. The K5 presents a strong value statement, with nifty features including wireless smartphone compatibility and ventilated seats available at a price that is commensurate with more lightly equipped rivals.

Recommended trim: GT-Line (\$26,355). The midtier GT-Line gives the K5 a sporty look and feel while adding desirable creature comforts. A pair of option packages can outfit the GT-Line with even more goodies, and it's one of the only models available with all-wheel drive. Payments on a K5 GT-Line with our parameters will run about \$355 per month.

### **2021 MAZDA CX-5**

The Mazda CX-5 is one of our favorite compact crossovers. Though a little smaller on the inside than its primary competition, the CX-5 makes up for that with an eye-catching design and interior materials that rival what you'll find in luxury SUVs. It's also fun to drive, with excellent handling and sharp steering. Performance aficionados with a flexible budget should snag one of the models powered by the optional turbocharged engine.

Recommended trim: Touring (\$28,110). The CX-5 Touring adds a lot of features for the money and opens the door to the budget-friendly yet comprehensive Preferred SV package. Monthly payments on a CX-5 Touring with our calculations check in at just under \$385 per month.

EDMUNDS SAYS: Although the average car payment is now an eye-popping \$570 per month, shoppers don't have to spend that much to get a great car. In fact, some of Edmunds' top-rated sedans and crossovers can be snagged for far less.

## Can I stop wearing a mask after getting a

**COVID-19 vaccine?** 

No. For a couple reasons, masks and social distancing will still be recommended for some time after people are vaccinated.

To start, the first coronavirus vaccines require two shots; Pfizer's second dose comes three weeks after the first and Moderna's comes after four weeks. And the effects of vaccinations generally aren't immediate.

People are expected to get some level of protection within a couple of weeks after the first shot. But full protection may not happen until a couple weeks after the second shot.

It's also not yet known whether the Pfizer and Moderna vaccines protect people from infection entirely, or just from symptoms. That means vaccinated people might still be able to get infected and pass the virus on, although it would likely be at a much lower rate, said Deborah Fuller, a vaccine expert at the University of Washington.

And even once vaccine supplies start ramping up, getting hundreds of millions of shots into people's arms is expected to take months.

Fuller also noted vaccine testing is just starting in children, who won't be able to get shots until study data indicates they're safe and effective for them as well.

Moncef Slaoui, head of the U.S. vaccine development effort, has estimated the country could reach herd immunity as early as May, based on the effectiveness of the Pfizer and Moderna vaccines. That's assuming there are no problems meeting manufacturers' supply estimates, and enough people step forward to be vaccinated.

## **MTV Entertainment** commits \$250 million to diversify reality

MTV Entertainment Group says it's making a \$250 million commitment to spur reality production over the next three years by companies owned and operated by women and people of color.

ViacomCBS' MTV Entertainment, which includes MTV and VH1, will provide funding, staff and other support to foster new ideas that will "fuel the unscripted content needs" of now and in the future, according to an announcement Thursday.

Advocates of increasing diversity in the entertainment industry say progress requires more women and people of color in decision-making positions.

The initiative builds on MTV Entertainment's unscripted record, including early reality show "The Real World," by creating ownership opportunities "for its diverse partners," the company said.

Lashan Browning and Adam Gonzalez, reality producers who were tapped last year to steer the initiative, will form their own production ventures with a MTV Entertainment equity investment, according to the announcement.

Browning was part of the start-up team for Oxygen and was a producer for "Love & Hip Hop Atlanta" and "Cartel Crew." Gonzalez was a producer on VH1's "Teyana & Iman" and "America's Next Top Model."







# Homegrown Garnishes Add Flavor. Nutrition. and Eye Appeal to Meals

Make your meals just a bit more special with homegrown garnishes. You invest time and money growing, purchasing, and preparing quality ingredients. But do not stop there. Add a nutritional and decorative flair as you plate your meal by adding a garnish of homegrown herbs.

Parsley is a traditional garnish that is usually left behind on the plate. But the dark green leaves should not be ignored. This herb is high in Vitamin C and A, has cancer and inflammatory disease fighting qualities, and promotes heart health. A perfect fit for your healthful eating goals. Although the curly varieties add texture to

your plantings and plate, you and your guests may find the milder flavor of the flat leafed variety more palatable. All this and it helps freshen your breath too.

A sprig of mint looks good next to or on top of most desserts. Its cool flavor will help settle your stomach - an asset when we overindulge. Like parsley, it is high in Vitamin C and A and helps in the fight against cancer and inflammatory diseases. In addition, it relieves breathing problems.

The best part: both are easy to grow right in your kitchen window. Start by purchasing healthy plants from your local garden center or the produce section of your grocery store. Plant them in separate containers or together with other herbs in a larger pot. Either way, make sure the container has drainage holes and a saucer to protect the windowsill or furniture it sits upon. Gently loosen any tangled or girdling roots before planting your herbs in a well-drained quality potting mix. Plant them at the same depth they were growing in their original pots.

Grow these and other herbs in a sunny window. Add a grow light to boost productivity or grow your garden in lower light locations. New LED plant lights are now more affordable and use less energy. Water the soil thoroughly after planting and whenever it is slightly dry. Be sure to pour off any excess water that collects in the saucer to avoid root rot. Another option is to add pebbles to the saucer, elevating the container above any excess water that remains.

Use kitchen shears or pruners to harvest the herbs. Cut mint just above a set of leaves and parsley at the base of the stem. Trim the sprigs as needed to dress up your holiday meals.

Your guests will be thrilled and more likely to take a bite of these healthful garnishes when they discover you grew them yourself.





### **European-US sea level** tracking satellite sends 1st readings

**AP WIRE SERVICE** 

A newly launched European-U.S. satellite designed to continue a decades-long record of tracking global sea levels has sent back its first measurements, NASA said Thursday.

The Sentinel-6 Michael Freilich satellite was launched Nov. 21 from Vandenberg Air Force Base, California and controllers spent several weeks activating instruments and making sure operations were normal.

The first measurements provided information on sea surface height, wave height and wind speed off the southern tip of Africa.

Josh Willis, project scientist at NASA's Jet Propulsion Laboratory, said in a statement that "the data look fantastic."

Named for a late NASA official who had a key role in developing space-based oceanography, the satellite's main instrument is an extremely accurate radar altimeter that bounces energy off the sea surface.

Space-based sea level measurements have been uninterrupted since the 1992 launch of the U.S.-French TOPEX-Poseidon satellite.

The rate of sea level rise has doubled since then to 0.16 inch (4 millimeters) per year, almost entirely due to the combination of meltwater from land-based glaciers and ice sheets and the fact that seawater expands as it warms, NASA said.

TOPEX-Poseidon familiarized the public with the concept of ocean surface topography with data turned into brightly colored graphics of the globe showing warming and cooling water marking weather-influencing El Nino and La Nina conditions.

TOPEX-Poseidon was followed by a series of satellites including the

Sometime this month, Sentinel-6 will be moved higher from an initial orbit to its operational orbit, where it will trail Jason-3 by 30 seconds so scientists can cross-check the data to ensure continuity. When that is assured, Sentinel-6 will become the primary satellite.

In addition to NASA, the mission involves the European Space Agency, the European Organization for the Exploitation of Meteorological Satellites, the European Commission, France's National Center for Space Studies, and the U.S. National Oceanic and Atmospheric Administration.



### LETTER TO THE EDITOR

In 2016 I was diagnosed with Hodgkins Lymphoma, which is cancer of the Lymphatic System, our infection control. I didn't miss a day of teaching at Ballet Petit or taking classes. At our Nutcracker 2017, I was able to stand before guests and tell them my scans came back clear. Life went on.

In mid-January 2020, I found a huge lump on my neck. I was now Stage 4, had masses in many places, and was up for drastic chemo again in February, with stem cell transplant in mid-April.

Then COVID-19 hit, and I was terrified I would not get a bed for transplant. Furthermore, an April 7 scan showed one area in my lung was not improving. I was given a special detour treatment to address it, which luckily also cleared the rest of the masses.

In June, I did the regimen to harvest my own stem cells. My cells were collected and frozen, waiting for transplant day. They call our transplant day our second birthday, as it quite literally is.

On July 17, I received massive doses of chemo, unlike anything I could imagine, 10x the normal beastly doses. My hair fell out for the second time in 2020, the third time in my life. But on July 23, the quietest part of the process, my stem cells were returned to me and tasked to do their magic. The two-week waiting game began.

Nine days later, I was discharged! My stem cells had not only gotten to work, they got busy very quickly. I was only in the hospital for 18 days, far less than expected. The doctors joked that the ballet was what gave me such strength and determination.

The first thing I did when I got home was sleep. On Day 2, I took an on-line ballet class! It was so

hard. My body was weak, but I didn't care. On Day 4, I took another. It got easier. By Day 6, I was regaining my strength. I was back to taking four online classes a week out of San Francisco, Berkeley, and New York City.

During my 2016-17 illness, I had been able to keep my usual routine of teaching and taking classes. But I didn't know how complex the Stem Cell Transplant process would be.

When Ballet Petit went on Zoom, I made appearances, but my wonderful and caring staff took over and let me progress through what I had to do. I still took classes, but teaching young dancers was too much to handle. Plus, I didn't want my unpredictability to add to their challenges. Life was hard enough for kids, with distance learning and missing their friends.

But the night of my transplant I had an idea that would not let me rest. In my hospital bed, jacked up on steroids, my mind was on overdrive. Ballet Petit had to have a Nutcracker. Could we do a show on Zoom? What would it take? The next day I surveyed my staff between blood draws, sleeping, and trying to eat again. We decided to go for it.

Covid has changed how we live, work, and play. Yet in spite of Covid, closures, cancer, chemo, cells not cooperating, then cooperating...we hang tough and power through, especially for those we love and for the things we love to do.

# Mental health awareness forum

On Thursday, December 10, the City of Fremont held a virtual youth mental health and wellness forum. Experts discussed mental health challenges among local youth before and during the pandemic.

Dr. Lawrence Yang, Associate Professor of Social and Behavior Sciences at NYU, presented results of a survey conducted with Fremont students. He highlighted that Fremont Unified School District (FUSD) has 60% Asian students, and that Asian cultures tend to under-use mental health resources. Although every family is different, high academic pressure and expectations of familial loyalty can put additional stresses on students in Asian families.

In a survey of FUSD students, 70% of respondents said they would feel uncomfortable telling others they had a mental health challenge. They said they would rather talk to friends, parents, or doctors rather than school counselors.

However, over 80% said they would want to help their friends who had a mental health challenge. Notably, students who believed negative stereotypes about mental illness (such as "people with a mental illness will have more trouble getting jobs"), were less likely to report that they would seek help for themselves or offer help to friends.

Fremont Youth Wellness Ambassadors Aditi Morumganti, Tanisha Deep, Carina Yuen, and Tushita Sinha shared a video project they had created to raise awareness of mental health struggles. They discussed the awkwardness they see among their peers when the topic of mental health comes up. "We should feel empowered not only to acknowledge our mental health but to take care of it," said Morumganti.

"When my peers and I are supported by loved ones and professional help, we are able to be the happiest best versions of ourselves," said Carina Yuen.

Attendees at the forum also viewed the short film "Blossom," the story of a teen dealing with depression, asking for help.

Dr. Anu Patel, clinical child psychologist at Kaiser, shared how her department approaches child mental health and how they have transitioned to telehealth services during the pandemic.

At the end of the forum, the two experts and the youth ambassadors answered questions submitted by the audience. Dr. Yang answered a question about the goal of the survey – to decrease stigma and increase awareness and availability of help for mental health challenges to students can get help before their condition worsens. Dr. Patel encouraged youth to speak with their medical doctor first if they are worried about sharing mental health concerns with their parents.


# Behind the Scenes at Las Posadas

# Step-by-Step Guide to Networking

What is the best use of time if you are hoping to land a job? Should you be perfecting your resume or scouring job ads? Should you be polishing your LinkedIn profile or networking? Should you spend most of your time pressing the "Submit" button to online job ads?

You might be surprised to know that many career professionals recommend that you are better off spending most of your time networking and only 20 percent or so of your time responding to online ads and recruiters. The reason for this advice is simple: genuine connections matter more than ever, even in this social media age. Perhaps you have heard about people who found out about jobs through a friend or landed a job because an insider put in a good word for them. These are people who took advantage of their connections and advanced their careers in the process.

Do not panic when you hear the word "connections" or "networking." You might think that you do not know any influential people or that you are too shy to approach people. Never fear – I have created a step-by-step plan to guide you through the process of networking. Instead of feeling intimidated by the notion of networking, think of the process as "building relationships." You do not have to become best friends with the people in your

network, but you do have to think about the process as getting to know people.

### Step 1: Make a List of All **Possible Contacts**

Start with people you know very well, such as your friends and family. Let us call this group your A-listers. Next, write down the names of people whom you might not be close to, but could get in touch with easily, such as friends of friends, professors, teachers, and high school friends you lost touch with. These are your B-listers.

Last, note the people whom you do not know but are potential contacts for you, such as fellow university alumni, and Facebook or LinkedIn contacts. One possible goldmine for contacts is your university alumni association that might be able to point you to fellow alumni who would be willing to talk with you. These are your C-listers. This will be a preliminary list. Aim to add to this list as your network grows.

### **Step 2: Update your LinkedIn** profile and resume

Before contacting anyone, make sure your LinkedIn profile and resume are in great shape.

### **Step 3: Make contact**

Start by reaching out to your A-listers via phone, e-mail, or LinkedIn. Your A-listers are a safe bet – they will not turn you down, so they are a good group to start practicing on. If you are feeling adventurous, you can move onto the

Don't start off your email by saying "I need a job." Networking is about building relationships through goodwill. Instead of thinking about what others can do for you, offer to do something for them instead. Perhaps you could send them a helpful resource or connect them to someone who could be of help to them. Another thing you could do is express enthusiasm for their company or industry and ask if they would be willing to do an informational interview.

Be mindful that the standard greeting of "Hi! Hope you are well!" doesn't apply anymore. During COVID-19, many are not well. People may be stressed, worried about a loved one, or worried about themselves. But reaching out to someone to check in on them and to let them know you are thinking of them is a kind gesture that would be appreciated.

Modulate your expectations – you might not get a reply right away. Please do not take it personally if you do not hear back. Responding to your query might understandably not be of top priority to those who are stressed out.

If you are lucky to land some time with your contacts, use the platform they are

comfortable with, whether it's Skype, Facetime, Zoom, or GoToMeeting. Be proactive and take the responsibility for creating the invite and sending it out ahead of time. You can also send a polite and enthusiastic reminder the day before the meeting. A nice gesture would be to send them a coffee gift card to cover the cost of your virtual coffee.

### Step 4: Follow up with a thank-you note

Write a short email to thank the person who has taken the time to talk to you. Consider offering some help or assistance in your thank-you email.

These four steps will get you on the road to becoming a super networker. However, there is so much to be written about on this topic of building relationships that I will give more tips in my next column. Stay tuned to learn how to reach out to the C-Listers as well as expand your network. Keep safe and keep building relationships.

### Park It

After a distinguished career of 47 years at the East Bay Regional Park District, including the past 10 years as its general manager, Robert E. Doyle has announced that he will retire at the end of December.

Doyle got an early start in the parks and natural resources field. While still in high school, he served as president of Save America's Natural Environment (SANE), a youth group in Contra Costa County that worked to acquire and to preserve Las Trampas Ridge and Black Diamond Mines and to expand Mount Diablo State Park.

Later, he was a founding board member of Save Mt. Diablo, Inc., a nonprofit land trust and conservation organization whose name describes its mission. As the board president, he increased the organization from 1,000 to 5,000 members, negotiated acquisition of 5,000 acres for Mt. Diablo State Park, and hired the organization's first full-time staff. Doyle still found time to earn a bachelor's in management from St. Mary's College.

At East Bay Regional Park District, Doyle rose through the ranks. He began his park district career in 1973 as a park ranger at Tilden Regional Park near Berkeley. He also worked at Kennedy Grove, Miller-Knox, Point Pinole, and Black Diamond. Ultimately, he was promoted to resource analyst and later trail specialist. He became chief of land acquisition and trail planning in 1986, then spent 20 years as an assistant general manager, leading land acquisition, trail planning and interagency and advanced planning. He was appointed the park district's general manager by the district board in 2010.

In the time since he became chief of land acquisition, Doyle's efforts have doubled the park district's size, including 20 new parks. The district now comprises 73 regional parklands totaling 125,000 acres in Alameda and Contra Costa Counties, hosting 25 million visits per year.

Doyle's many other accomplishments during his career with the park district have included:

- Conceiving and developing a multi-use regional trail master plan for Alameda and Contra Costa counties for what is now a nationally recognized multi-use urban trail system
- Expanding the district's Regional Parks Foundation to champion private fundraising in support of park access for disadvantaged youth
- Embracing multicultural outreach efforts, including well-attended

- multi-cultural Wellness Walks, and the Multicultural Advisory Committee comprising leaders from the Bay Area's diverse cultural communities. The effort has given multicultural groups a voice in the direction of the district's outreach efforts, and a sense of participation in district decisions
- Development of youth outreach programs such as Kids Healthy Outdoor Challenge, a school-based program serving tens of thousands of children per year
- Obtaining more than \$100 million in local, state, and federal grants for trail and land projects
- Helping to author the park district's 1988 \$225 million Bond Measure AA and its 2008 extension, \$500 million Measure WW, both of which included funds for other local park and recreation agencies
- Advocating for more than five years to advance the California State Park and Water Bond to the June 2018 ballot, working with legislators, park leaders, and other constituents to become advocates for a badly needed measure
- Serving as lead negotiator for development of a partnership with East Contra Costa County Habitat Conservancy, which has added more than 12,500 acres to the park district

Among many awards and recognitions for his service to the park district and public, Doyle received the prestigious Cornelius Amory Pugsley Award in 2018, conferred by the American Academy for Park & Recreation Administration.

The park district's elected board of directors is conducting a nationwide search to select a new general manager. "This has been a great adventure for me," Doyle said. "For a kid who had a passion for parks to be able to preserve for public enjoyment so many beautiful East Bay open spaces."

Doyle also is gratified that the district has been able to continue its operations despite the challenges of the pandemic, terrible wildfire season, and climate change impacts. Because of the pandemic, the district has lost more than \$7 million in income, while at the same time public use of the parklands has surged districtwide. So, it has been a challenge for the staff to safely manage all park and trail use. Doyle noted. "Nevertheless, we've been able to provide a valuable public service at a time when it is badly needed," he said.

Doyle's post-retirement plans include continuing involvement in parks and recreation issues, but also hiking, traveling, kayaking, and generally "enjoying the fruits of my labor."

"It's strange to be leaving after all these years," he said, "but it's been a great ride."

Sometimes political change is highly visible and relatively straightforward. An example in this election cycle is at the federal level where a new administration is about to assume the presidency and executive functions, altering much of the country's direction of the last four years. Even though millions of federal employees - management and line workers - will remain, when an entirely new team of top leadership is installed, the difference is often direct and obvious.

In our local communities, many elected city councils are not going through such drastic changes. By design, institutional memory and continuity is retained as elections rotate through members rather than rely on wholesale change during a single election cycle.

However, a significant departure from continuation of the status quo can come through one or a combination of factors: electorate dissatisfaction, councilmember aspiration to a different role or term limits. In Fremont, a noteworthy change has occurred at the city council as Vinnie

Bacon reached a term limit and attempted to move up the political ladder to become an Alameda County supervisor. What makes this change unique is the role he played as councilmember and spouse of a fellow councilmember of the same city council.

As a staunch environmentalist, Vinnie's input was valuable in city policies, but typically echoed by his wife, Vice Mayor Jenny Kassan. The effect was a two-person voting bloc that, although not definitive in outcome, was not a healthy situation. Using different last names does not change the dynamic of married family life. In any event, since Fremont has fully transformed to a district representation model, two people living in the same district would be unable to serve simultaneously unless one was elected to a city-wide position as mayor and the other served a district. This could also lead to an uncomfortable situation if that district was involved in a competition or dispute with another district. If resolution depended on council action, it would be difficult to avoid inference of favoritism by the

In place of this unusual husband-wife situation, a new member of the council, Teresa Cox, offers a completely different perspective and offers additional breadth to the council. Representing District 6 (Irvington District), Teresa has an interesting resume that will expand council deliberations. As an African-American woman with impressive credentials including a degree in nuclear engineering and MBA in Business Administration, Teresa adds expertise and experience in national and global affairs, service on the Ohlone

Community College Board of Trustees and extensive corporate management to the Fremont City Council.

Each member of a city council holds a critical position in the daily lives of their electorate. It is at the local level that the most numerous, visible and substantive changes can occur. Those serving as elected employees, do so for friends and neighbors. There is little opportunity to duck responsibility or hide behind a staff, instead spending their time attending "important" meetings while masking impotence with flowery oratory. Councilmembers are acutely aware that when confronted by contentious debates and decisions, there is nowhere to hide. They must make difficult choices and, along with their constituents, face the consequences. As difficult as this may be, there are civic-minded individuals motivated to serve in this role. It is a wonder that they persevere and their efforts should be applauded. In order to achieve the best outcome, it serves a city well to elect a diverse council with a variety of perspectives. This will augment the transformation that inarguably accompanies the passage of time.

# Jim Burris and Ahhhhz Win FCAC Arts Achievement Award for 2020

When Singer/Director/Coach Jim Burris heard that he and his a capella group AaaahZ had won the Fremont Cultural Arts Council's 2020 Arts Achievement Award, Jim Burris' response was "I can't believe it! I'm just so surprised!"

Even after twenty-seven years of donating his time and energy to create live Las Posadas performances, it came as a shock that people knew and appreciated his years of service. "I honestly never imagined this would happen."

The 2019 winners were Kristen Del Rio and her host, "Mission Coffee and More" owner Gael Stewart; they had seemed equally stunned. As Kristen looked down at her award she said quietly "I never thought anyone noticed!"

When asked why, if not for recognition, Jim Burris and the

members of his Aaaahz chorale have donated so much time and talent to events like Las Posadas, Burris' response was simple. "For us, theatre and music are passions. I think I always knew that about myself. When I was seven I saw a sign advertising auditions for The Music Man. I begged my mother to let me audition. It never occurred to her that I might be cast, but I was!

"I was a sickly, asthmatic kid in a Wisconsin farm town, but in my school, there was a wonderful theatre program. I'm still grateful for my high school music director. She gave me something I could be really good at and encouraged me. I got my degree in educational theatre, including voice and percussion. Eventually I began directing training theatre because I like giving people a chance to succeed at something they never thought they could do."

After moving to Fremont in the early nineties, Burris set up a training theatre called
New Harmony, where he met and bonded with several like-minded theatre and music lovers who joined him in forming a succession of performance groups.

"We all became close, long term friends. When COVID is past, we plan to go back to rehearsing together, then donating our performances for good causes, the same as we always have, but Las Posadas in Fremont is special for us. We've always received such a warm welcome here, so even though some of us have moved from Fremont, each year, when Christmas is on the way, we

The ceremonial oath of office and installation were administered during the meeting for the re-elected mayor and new/re-elected councilmembers, each elected to a four-year term.

This was Fremont's first district-based election for District 5 and District 6. The City of Fremont welcomes Mayor Lily Mei, At-large; Teresa Keng, Council District 1; Raj Salwan, Council District 5; and Teresa Cox, Council District 6.

### **Voters Approve Measure WW**

City of Union City's local ballot measure, Measure WW, has been approved by voters in the November 3 general election. The results from the election were certified by the Alameda County Registrar of Voters and confirm that Measure WW, a 5 percent utility users' tax, has passed with 56 percent of the vote. The measure needed over 50 percent of voter approval to pass.

The utility users' tax will be levied on electricity, gas, and video and telecommunication services and is expected to take effect in Spring 2021. Funds from Measure WW will provide about \$5.5 million in additional funding that can be used to preserve essential city services. Senior and low-income residents are eligible to receive exemptions from the tax, and the city is currently developing an application process for eligible residents to receive this exemption. To get updates to the application process, visit www.unioncity.org/measureww.

Measure WW is part of an ongoing effort by the city council to address a long-term structural General Fund deficit, which is the council's top priority in their five-year strategic plan. In recent years, the city has cut millions of dollars from its budget resulting in major service reductions to public safety, parks and street maintenance, recreation services, and administration.

### **Charles Wesley Ruth**


Resident of Fremont

### Rodeo Legislation Authors Needed

Professional Rodeo Cowboys Association (PRCA) claims there are some 10,000 rodeos held annually in the U.S., almost none of which require on-site veterinarians to care for injured animals. The PRCA has done so only since 1996, after five animals suffered and died at the 1996 California Rodeo/Salinas. State legislators are now deciding upon which bills to carry in the 2021 session. Three need an author:

1. Amend state rodeo law, Penal Code 596.7, to require an on-site veterinarian or Registered Veterinary Technician (RVT) at all rodeos--the "on call" option is not working, and animals are suffering needlessly

2. Ban the Mexican-style rodeo's brutal "steer tailing" event (already outlawed in Alameda and Contra Costa

counties)
3. Ban the rodeo's
non-sanctioned "wild cow milking contest," children's "mutton busting" event, and all animal

### **Union City City Council**

### December 8, 2020

• At its December 8 regular virtual meeting, Union City City Council adopted a resolution declaring the results of the general municipal election held November 3, 2020. Re-elected Mayor Carol Dutra-Vernaci (third term) and District 1 Councilmember Gary Singh both took the oath of office and were officially installed. Councilmember Pat Gacoscos was appointed vice-mayor, and assignments made to various boards and commissions (effective January 1, 2021).

### **Consent Calendar:**

- Purchase and sale agreement for a city-owned townhouse at 4361 Agena Circle in Union City.
- Extend the Union City Transit and Paratransit operations and maintenance agreement with MV Transportation for six months beyond the current contract termination date of December 31, 2020, to June 30, 2021.
- Authorize filing of applications with the Metropolitan Transportation Commission (MTC) for allocation of funds for the operation of Union City Transit and Paratransit for fiscal year 2020-2021.
- Appropriate funds for the purchase of one electric replacement paratransit vehicle from A-Z Bus Sales through the CalACT/MBTA statewide vehicle contract, for \$212,054.
- Appropriate funds for the purchase of three gasoline replacement paratransit vehicles from A-Z Bus Sales through the CalACT/MBTA statewide vehicle contract, for \$227,158.
- Authorize Union City Transit to continue temporary service adjustment in response to COVID-19.
- Appoint individuals to serve on the Arts & Culture Commission, Human Relations Commission, Park & Recreation Commission, Planning Commission and Senior Commission.
- Renew service agreement with Kroll Associates, Inc for a not-to-exceed amount of \$125,000.

### **City Manager reports:**

• Economic and Community Development Director Carmela

Campbell presented a report about the Permanent Local Housing Allocation Program (PHLA) funds. Council then adopted a resolution authorizing application and receipt of these funds.

- Union City will receive a first-year allocation of \$253,953, and an estimated total allocation up to \$1,523,610 during the initial five years of the program. Funding will support the existing CAREavan program. CAREavan's mission is to aid community members dealing with homelessness by providing them a safe place to park overnight and, as funding is available, providing additional social services to move individuals and families towards permanent housing or address other social service needs.
- City Manager Joan Malloy presented an information-only General Fund Fiscal Outlook. Measure WW, the 5% Utility Users' Tax (UUT), passed with 56.88% of the vote. The City is preparing its biennial budget and while the passage of the UUT alleviates some of the short-term pressures on the General Fund, it does not eliminate them all together. Measure WW will replace the loss of about \$4.3 million in annual Public Safety Parcel Tax revenue which will sunset on June 30, 2021.
- On August 4, 2020, the City Council was presented with a ten-year financial outlook that reflected the impact of COVID-19 on revenues, the loss of the parcel tax on June 30, 2021, the loss of the ½ cent sales tax in April 2025, and no replacement revenue measures approved by voters. The current negative impact of COVID-19 on sales tax and transient occupancy tax (hotel tax) revenues combined with the expiration of the ½ cent sales tax, pose a significant challenge to the City's long-term fiscal stability.
- Staff recommends planning to place a measure on the November 2022 General Election to prevent the impacts from a fiscal cliff in 2025. To this end, in 2021 the City Council will establish a community advisory and oversight committee to plan future ballot measures and oversee the expenditures of the UUT.



### California zoo reports 2 birds stolen, need special care

Two birds were stolen from a zoo in Fresno, California over the weekend, officials said.

A lesser sulphur-crested cockatoo and a Nicobar pigeon were taken from Chaffee Zoo's Australian Asian Aviary on Sunday around 4:30 a.m., The Fresno Bee reported. Both birds are of advanced age and in need of special care.

Our bird zookeepers and entire team are deeply concerned for the safety of both of these animals," general zoo curator Lyn Meyers said. "We do not know the condition of either bird and we hope to get them back quickly so that our veterinary team can examine them and continue the care they require."

Security footage shows someone cutting the lock from the aviary doors, capturing the two birds and putting them into a duffel bag before leaving, authorities said. The motive for the theft is unknown.

The International Union for Conservation of Nature's Red List of Threatened Species lists Nicobar pigeons as near threatened and lesser sulphur-crested cockatoos as critically endangered. Both species are legal to own and the zoo has notified local veterinary hospitals and

### **Contract to extend fire** and emergency response services

City of Newark and Alameda County Fire Department (ACFD) have entered into a five-year agreement for continued fire and emergency response services. ACFD has been providing services to the city since 2010. While the new contract will continue the existing relationship on mostly similar terms, provisions were added to address some of the parties' concerns that developed over the years. These updates include:

• Expansion of the responsibilities and frequency of the Executive Management Oversight Committee (EMOC), including an obligation of the fire chief to consult with the EMOC before the board of supervisors take any action that would result in costs greater than \$50,000 to the City of

- More defined contract language on retiree health care liability, including equal treatment in Other Post-Employment Benefits (OPEB) calculations based upon the share of allocated staff for each contracting agency.
- The continued operation of all three fire stations in the City of Newark, staffed by three personnel per shift, as well as two positions at City Hall that administer fire inspections, prevention, and code compliance.
- A required, ongoing response time standard to arrive on scene after dispatch within 6 minutes at least 90 percent of the time.

City Manager David J. Benoun noted: "We appreciate ACFD's dedication and professional service to the Newark community and we look forward to continuing our successful partnership."

### New bottle bill to transform beverage recycling system

Seeking to transform California's deteriorating beverage container recycling system, Senator Bob Wieckowski (D-Fremont) introduced new legislation on December 7 that would shift responsibility for the program from consumers to distributors. The new streamlined stewardship program would be modeled after Oregon's system, which promotes Extended Producer Responsibility (EPR).

Under the new bill, distributors of beverages must form a Beverage Container Stewardship Organization. The organization must then submit a plan and budget for the redemption and recycling of beverage containers to be approved by CalRecycle. Wine and distilled spirits bottles would also be included in the new program; they are currently exempted despite generating 900 million bottles per year.

'We cannot continue to ignore that our beverage recycling system is crumbling before our eyes, nor can we ignore the growing frustration of consumers who are unable to redeem value for their recycling efforts," said Wieckowski. "We need to put customer convenience first. Instead of consumers subsidizing the system, my bill will put money back into the hands of consumers, who are currently shouldering the load of our antiquated program."

### Ask Rusty – Will my **UK pension affect my** social security?

Dear Rusty: I lived and worked in the United Kingdom before coming to the US at age 45, which qualified me for a UK State Pension worth the equivalent of about \$740 USD per month. Since moving to the US, I have contributed to the US Social Security system for 14 years and my estimated US Social Security benefit is \$1,643 per month. I have heard about something called "WEP" and must be honest and say I don't fully understand. Can you provide some advice or references so I can understand what happens to these sums when I retire? I don't have any other pension income, so understanding these numbers is important. FYI, I hold both US and UK passports and will retire in the US.

Signed: Blessed from the UK

Dear Blessed: The "WEP" provision you refer to is known as the "Windfall Elimination Provision." It affects anyone who is eligible to collect Social Security benefits, but who also has a pension from another entity (corporation, public agency, or foreign country) which did not participate in the U.S. Social Security program (meaning that SS FICA payroll taxes weren't paid during that employment). WEP will reduce your US Social Security benefit by using a special formula to compute your benefit amount. Generally, the WEP reduction is determined either by the number of years of substantial SS-covered earnings that you have, or the WEP maximums (one of which is that your U.S. Social Security

cannot be reduced by more than half of your non-covered pension). With less than 20 years paying into the US system, you will incur one of the maximum WEP

Something else important to understand is that the current estimate you have from Social Security does not include the WEP reduction. That estimate assumes that you will continue to earn at your current level until you reach your full retirement age. You have not shared your birthdate, but from your email I assume you are now about 60 years old. If you were born in 1959, your full retirement age (FRA) for U.S. Social Security purposes is 66 years and 10 months (if you were born after that your FRA is 67, and if you were born before that subtract two months for each year before 1959). Your FRA is when you will get your "full" SS benefit. If you claim before that (age 62 is the earliest you can claim) your benefit will be reduced (even before WEP), and if you wait beyond your FRA, you will earn Delayed Retirement Credits (DRCs) which will increase your benefit amount. DRCs stop at age 70.

Based upon what you have told me, I believe that your WEP reduction will probably be limited to one of the maximums, either half of your monthly UK pension, or the maximum for your

"eligibility year" (2022?). We don't yet know what the standard maximum WEP reduction for 2022 will be, but for 2020 it is \$480. That is the most that your Social Security benefit could normally be reduced. But if your UK pension is about \$740 USD then your maximum reduction should be about \$370, because the WEP reduction can't be more than half of your non-covered (UK) pension. So, your US Social Security benefit of \$1643 will most likely be reduced by about \$370 to about \$1303. You will need to contact the UK pension system to see if any of your UK pension will be offset by your US Social Security benefits.

# Artemis – the next attempt to reach the moon and beyond

The Apollo program which put the first man on the moon has given us a legacy. The first missions to take astronauts to the Moon were called the Apollo Program. In 1961, President John F. Kennedy challenged the nation to land astronauts on the Moon by the end of the decade. The National Aeronautics and Space Administration (NASA) met that challenge with the Apollo program, landing the first man on the Moon on July 20, 1969. That program was named after a god of Greek mythology, Apollo.


But ever since, no country or a space agency has tried another manned mission to the moon. But things are about to change for the better. Artemis is NASA's new lunar exploration program, which includes sending the first woman and the next man to the Moon. Through the Artemis program, NASA will use new technology to study the Moon in new and better ways and prepare for human

missions to Mars. Only this time we are not just going to visit. We are going to stay. Just like the International Space Station, we are going to have a continuous human presence on the lunar base.


Artemis was Apollo's twin sister and the goddess of the Moon in Greek mythology. When they land, Artemis astronauts will stand where no human has ever stood: The Moon's South Pole.

NASA's new rocket is the Space Launch System (SLS). It is the most powerful rocket ever in the world. The SLS will carry the Orion spacecraft with up to four astronauts riding aboard to lunar orbit. Then, astronauts will dock Orion at a small spaceship called the Gateway. This is where astronauts will prepare for missions to the Moon and beyond. The crew will take trips from the Gateway to the lunar surface in a new human landing system, and then return to the Gateway. When their work is finished, the crew will return to Earth aboard Orion.

The Artemis mission is planned in various phases. Before Artemis carries a

crew to the Moon, NASA will test the rocket and spacecraft in flight then send a crew for a test flight:

Artemis 1 will be a test flight of the SLS rocket with the Orion spacecraft and no crew.

Artemis 2 will fly SLS and Orion with a crew past the Moon, then circle it and return to Earth. This trip will be the farthest any human has gone into space.

Artemis 3 will send a crew with the first woman and the next man to land on the Moon by 2024.

The astronaut scientists will search for the Moon's water and study the Moon to discover its mysteries, learning how to live and work on the surface of another celestial body. At the same time, establishing a base on the moon will build astronauts' confidence, as they will be just three days from home.

In the long term, the astronaut scientists will test technologies needed

before progressing on crewed missions to Mars, which can take up to three years roundtrip.

Next month's article shall cover the specific mission milestones, timelines, and overview of the Artemis mission. Stay tuned!

### First woman, next man on moon will come from these NASA 18

NASA has named the 18 astronauts – half of them women – who will train for its Artemis moon-landing program.

The first woman and next man on the moon will come from this elite group.

Vice President Mike Pence introduced the astronauts Wednesday at the close of his final meeting as chairman of the National Space Council. The announcement was made at Florida's Kennedy Space Center, beneath one of only three remaining Saturn V moon rockets from the 1960s and 1970s Apollo program.

Pence noted that the last of the 12 men to walk on the moon, the late

Apollo 17 commander Gene Cernan, wanted nothing more than to remove "last" from his title. Cernan's final lunar footsteps were on Dec. 14, 1972.

"He spent the rest of his natural life advocating for America to go back to the moon, and we are going to honor Gene Cernan's memory," Pence told the small crowd, seated several feet apart from one another.

Five of the astronauts – the only ones in attendance – walked onto the stage, waving and wearing masks.

NASA Administrator Jim Bridenstine stressed there would be more astronauts joining the group. NASA has 47 active astronauts.

The space agency is aiming for a moon landing by 2024, although the chances of that happening are growing increasingly dim. The upcoming change in administration also adds uncertainty.

Half of the NASA astronauts have spaceflight experience. Two are at the International Space Station right now: Kate Rubins and Victor Glover.

The two astronauts who performed the world's first all-female spacewalk last year made the cut: Christina Koch and Jessica Meir.

It's a fairly young group, with most in

their 30s or 40s. The oldest is 55, the youngest 32. Only two – Joe Acaba and Stephanie Wilson – flew on NASA's old space shuttles.

"The history is awesome, but we're here to look toward the future," Acaba told reporters after the announcement.

The other experienced members on the list include Kjell Lindgren, Anne McClain and Scott Tingle, all former space station residents.

"We are dreamers, but even more so, we're doers," McClain said.

She wants children from all backgrounds to take note of the diverse lunar team: ``The doors are open, come on after us.''

Among those yet to rocket into space: Kayla Barron, Raja Chari, Matthew Dominick, Woody Hoburg, Jonny Kim, Nicole Mann, Jasmin Moghbeli, Frank Rubio, and Jessica Watkins.

# Alzheimer's Association Advocacy

After finding out that my high school swim coach was diagnosed with early-onset Alzheimer's, I was devastated to watch such a jovial character diminish. Soon enough, she was unable to coach, and it seemed as though she had lost a sense of purpose. Her bewildered state has left me in great agitation, and I cannot imagine the pain and sadness her close family members endure.

In 2020, Alzheimer's and other dementias will cost the nation \$305 billion. By 2050, these costs could rise as high as \$1.1 trillion. Unless a treatment to slow, stop, or prevent the disease is developed, he cost will only continue to worsen. In California alone, Alzheimer's disease is the third leading cause of death. However, with the increasing average life expectancy coupled with the aging Baby Boomer generation, these numbers will continue to rise.

Watching my swim coach suffer from early-onset Alzheimer's has made me understand how far-reaching this disease can be. Not only does Alzheimer's affect the individual, it affects caregivers and their families as well. Currently, the 1.85 billion hours of unpaid care amounts to \$24.25 billion, indicating how much work and financial burdens are imposed on those, directly and indirectly, affected by the disease.

As a high school student, it might be strange to be concerned about something that will not affect me for another 48 years, but after realizing the severity of this issue, the younger generation needs to take a stand. The funding for Alzheimer's research is a priority that must continue.

I hope my realizations as a high school student will encourage Ro Khanna and Eric Swalwell to support an increase of \$354 million for Alzheimer's research funding at the National Institutes of Health in FY-2021.

# SpaceX capsules parked side-by-side at station for 1st time

A SpaceX supply ship bearing Christmas goodies arrived at the International Space Station on Monday, parking alongside another Dragon capsule that carried up astronauts three weeks ago.

It's the first time Elon Musk's company has two Dragons at the orbiting lab, filling both available slots.

Unlike SpaceX's previous cargo carriers, which had to be plucked from

orbit by the space station's robot arm, this larger and updated model docked all by itself a day after rocketing into orbit from NASA's Kennedy Space Center. This unusually large shipment – exceeding 6,400 pounds (2,900 kilograms) – includes experiments, equipment, Christmas presents and the makings for a holiday feast for the seven station astronauts.

The crew monitored all the action as the capsule pulled up and docked at the station more than 260 miles (420 kilometers) above the Indian Ocean. The two Dragon parking spots are just 15 feet (4.5 meters) or so apart.

NASA astronaut Kate Rubins offered "a huge congratulations" to SpaceX and everyone else involved.

"It's pretty amazing to think that less than a month ago you docked four crew members," radioed Rubins, a microbiologist and one of four Americans on board. "And now you're bringing a vehicle full of world class science for us to execute."

The crew also includes two Russians and one Japanese.

SpaceX redesigned its cargo ships to be as big as its spacious crew capsules to pack more in.

The cargo Dragon will remain at the space station for a month, before parachuting into the Atlantic with science samples and discarded gear. The crew Dragon will stay up until spring.

Today, Gutierrez and his wife Ylma are owners of a Fremont-based franchise of the nationwide Maaco Collision Repair & Auto Painting company (which has five other Bay Area locations). He opened the business in 2008 after working more than 20 years in the shipping container business. Two years later, Ylma left her work in the architecture and construction industry and joined him full time at Maaco. "It's the best decision I ever made," she said. I really love this business and enjoy it." Joining the two owners are 12 employees who work in various capacities from vehicle prep, buffing, dent repair, painting and cleaning.

Over the years their business thrived with retail work for individual customers

Inside the shop Gutierrez said all vehicles are sanitized and plastic covers are put onto seats, steering wheels and shifters. When the vehicles are done, they're sanitized again before being returned to customers. Gutierrez acknowledged that business has slowed because of COVID-19 concerns, but said most employees are still on the job except for a customer shuttle driver who was let go due to decreased business.

### **Fun and favorites**

While cars, vans and trucks make up the bulk of business, Gutierrez said they have had many fun and unusual vehicles, too. Among them is a group of kid's small racing cars from California's Great America theme park in Santa Clara, painted in bright colors with "Peanuts" cartoon characters. They also painted the floating Delta Flyer sky buckets on the park's gondola ride and the passenger boats for the park's log ride.

Gutierrez's favorite car? A rare 1969 Chevrolet Camaro Z28 they restored for a car collector in 2020 using the original bright blue and white color scheme. Ylma Gutierrez said another favorite project was painting more than 200 Tesla car frames that are shown in auto display galleries worldwide.

Over the years, Gutierrez estimates they have painted almost 17,000 vehicles at the Fremont shop. Despite the high volume, he said the focus is restoring each vehicle to make it look like a diamond again. "I remind my crew all the time, 'You guys aren't just auto body repairmen, you guys are artists.""
