Train of Lights

Train of Lights offers a rare opportunity to experience a train ride through Niles Canyon at night. With one departure from Niles at dusk and a second departure from Sunol after dark, guests can choose their favorite time to ride.

This has been an annual tradition for many Bay Area families for more than a decade. In 2020, the event was on pause, but when tickets went on sale in October this year, the response was amazing. "Because the history is so strong with this event, we really don't have to do too much. The event just sells itself," says Gail Hedberg, director-at-large for Niles Canyon Railway.

Guests ages three and up are required to wear masks while on railway property and on the trains.

On Train of Lights, guests can remove masks while eating cookies and drinking hot chocolate

available for purchase. In addition to general indoor and outdoor seating, Train of Lights also has first class parlor and dome cars with luxurious seating and more expansive views.

After a hiatus in January to undecorate the cars, Niles Canyon Railway train rides will be back for the 2022 season starting February. Trains will run on Saturdays and Sundays, the second and third weeks of the month. As with Train of Lights, ticketing will be online. Trains will depart from Sunol Station only.

A gluttony of trash, turned into treasure

For textile artist Charlotte Kruk, it's frustrating to see so much trash in today's society going to landfills instead of being recycled or repurposed. Kruk cites consumer packaging, from candy wrappers and plastic food seals to plastics and double cardboard boxing, as major offenders.

In her newest exhibit, "Consumer Couture; Wrapped in Conversation," at Fremont's Olive Hyde Art Gallery, Kruk puts recycling and repurposing consumer products front and center. The show includes a creative and colorful

Washington Hospital Outpatient Diabetes Program Offers Education and Support

Managing diabetes is challenging and discouraging at times. Diabetic patients need all the help and support they can get. Fortunately, Washington Hospital provides a comprehensive diabetes educational and support program available to anyone with a physician's referral.

The Hospital's Outpatient Diabetes Center offers programs via Zoom, according to Anna Mazzei, a certified diabetes educator and clinical dietitian with the program.

The center's educational and support programs are an essential component of successful diabetes management, Mazzei emphasizes. No one should feel that, during the current COVID-19 pandemic, they can't access the support and information they need to stay healthy.

Uncomfortable with online classes? Call the Outpatient Diabetes Center to arrange for a telephone consultation. The center's staff will find the right avenue to provide patients with the information they need to manage their disease.

Diabetes affects individuals of all ages. Mazzei says it is important to check in with a diabetes educator yearly, as well as when you are newly diagnosed. It is also important to touch base when you have been ill or hospitalized, or when you are feeling emotionally distressed. These are all conditions that can affect your diabetes and how you should manage it.

Diabetes is a complex condition which can continue to cause physical damage even when you may not have symptoms, she explains. The program's certified diabetes educators work with patients, explaining what to look for even when you are feeling well, what your numbers mean, and helping you to set appropriate targets

and goals—all information important for successful disease management.

The Diabetes Center's educational programs include:

Diabetes BASICS Program: a basic education program with individual assessments and group classes for individuals and families who live with diabetes.

Diabetes Matters: an ongoing, monthly meeting with expert speakers every other month and regular group discussions to help increase knowledge about diabetes.

Diabetes Support Group: provids support and shared knowledge with other patients; family members and friends.

Sweet Success: the California Diabetes and Pregnancy Program offers education for pregnant women with diabetes.

Medical Nutrition Therapy: intensive and focused nutrition therapy services that rely on follow-up and feedback to change behavior over time; ideal for patients who struggle with weight management. The program assists patients in fine-tuning diets and with special dietary needs such as low fiber or gluten free.

November 14 is National and World Diabetes Awareness Day and a reminder that now is a good time to sign up for new or refresher diabetes management programs, Mazzei says.

All the programs require referral by a physician and many health plans cover diabetes education. One-on-one sessions can be arranged for those who are unable to sit through longer Zoom meetings. Classes are held both during the day and in the evening for patient convenience.

The program staff includes a physician, registered nurses, registered dietitians and certified diabetes educators. The program manages 200 visits per month, on average.

When "Breath-taking" is Not a Good Thing

COPD Awareness Month Focuses on Lung Health

Breathing isn't something most of us think about. It just happens naturally. But for those with chronic obstructive pulmonary disease (COPD), taking a breath can be a real chore. November is COPD Awareness Month, a good time to focus on your lung health.

"If you get breathless easily, have a persistent cough, or experience wheezing or tightness in your chest, you could have COPD," said Jason Chu, MD, a local pulmonologist and member of Washington Township Medical Foundation. "COPD is a serious condition that can have a big impact on quality of life."

COPD is a chronic inflammatory lung disease that causes the airways to constrict, blocking airflow. It is a leading cause of disability and the fourth-leading cause of death in the U.S., with more than 150,000 deaths annually, according the National Heart, Lung, and Blood Institute (NHLBI). Nationwide, an estimated 16 million people have been diagnosed with COPD, and the NHLBI estimates that millions more have it without yet being diagnosed.


The biggest single risk factor for COPD is smoking. According to the NHLBI, 75 percent of those with COPD were smokers at some point in their lives. Long-term exposure to chemicals, smoke, dust and fumes can also cause COPD.

Dr. Chu encourages anyone who thinks they might have COPD to get a spirometry test. It's a non-invasive diagnostic tool that measures how much air you can breathe in and out of your lungs, as well as how easily and fast you can the blow the air out.

Avoiding Exacerbations

There is no cure for COPD, but you can manage the disease and slow the progression using proper treatment and lifestyle changes like quitting smoking and exercising to build up your strength.

"It's important for people with COPD to avoid exacerbations, which can exaggerate the severity of the symptoms, sometimes resulting in hospitalization,"

he said. "There are a lot of reasons that exacerbations occur, and that includes gaps in care, lack of support or education, and exposure to diseases that attack the lungs—like the flu."

According to Dr. Chu, studies show that about 18 to 20 percent of Medicare patients with COPD who were hospitalized were readmitted within a month, and about two-thirds of those readmissions were avoidable.

Washington Hospital implemented a program several years ago aimed at reducing readmissions for COPD called the Reversible Obstructive Airway Disease (ROAD) program. It focuses on providing COPD patients with the support they need in the Hospital and after they are discharged so they can avoid exacerbations. A respiratory therapist works with them while they are still in the Hospital, helping patients understand COPD, explaining their medications and how to take proper care of any equipment they use like nebulizers to avoid infections, and how to measure their oxygen level so they can see when they are getting in the danger zone and prevent problems.

"We know COPD patients are less likely to be readmitted when they see a physician within two weeks of discharge, so we make sure that happens," Dr. Chu added. "We also have excellent programs that can help people manage their COPD."

Better Breathing Support

"Washington Hospital has a very strong Pulmonary Rehabilitation program that can help people build their strength so they can actively participate in daily activities," he added.

Participants work one-on-one with a respiratory therapist, who teaches them breathing techniques and ways to better manage COPD. They use weights and exercise machines to get in shape and increase their endurance.

People with COPD can also benefit from the Better Breathing for Life group at Washington Hospital, a free support group for people with all types of lung disease and their loved ones. It provides education and gives people the opportunity to share their struggles and successes. The program is held on the fourth Wednesday of every month from 12:45 to 2:45 p.m.

"Exacerbations can be mitigated by these types of measures," Dr. Chu said. "November is a good time to start thinking about lung health. This is when respiratory season begins. It's when we start seeing an increase in diseases like bronchitis, flu and pneumonia, which can all exacerbate COPD. And of course we're still dealing with COVID-19, another respiratory condition. COPD patients are extremely vulnerable to COVID-19." As a part of protecting lung health, Dr. Chu recommends vaccination against influenza (flu shot), pneumonia and COVID-19—including booster shots.

continued from page 1 collection of unique clothes, accessories and sculptures made of candy wrappers, food packaging,

cloths and plastics.

The goal of the exhibit is to get people to notice, think about and discuss mass packaging and waste in today's consumer culture. "It was a way for me to package my own statement about mass consumption," Kruk explained."

San Jose-based artist's interest in recycling started when she was growing up and watched one grandmother package lavish Christmas gifts while the other grandmother carefully removed the tape on each gift and repurposed paper every year. "It got me thinking about trash and about repurposing and recycling," she said.

Kruk eventually started to save and repurpose her own trash – especially excess packaging -- as much as possible. "It became a narrative for me to talk about how everything we endeavor in our culture is mass packaged and produced in a way that we don't even recognize anymore," she said.

Since 1996, Kruk has been building, refining and growing her collection and had exhibits in numerous Bay Area art galleries, schools and museums. In addition to promoting recycling in her shows, Kruk tries to stimulate conversations about current events, including COVID-19 and racism.

An enthusiastic crowd turned up for the exhibit's gala opening on Friday, November 5 as part of Olive Hyde Gallery's effort to slowly reopen to in-person events following the COVID-19 shutdown. Most of the gallery's recent exhibits have been only available online.

Mingling among the crowd were high school models Kate Malysheva and Skye Dumas wearing two of Kruk's newest creations. Kate, dressed as "Lady Life Saver & The Covid Cure," wore a nurse's dress, stitched together from plastic Life Savers candy wrappers, along with a face mask, stethoscope and topped with a nursing cap covered with printed barcodes.

Skye modeled the second creation, "Caffeinate the Conversation; Racism, Let it Be Gone With the Wind." It featured a bright green hoop dress made from plastic Café La Llave espresso bags stitched together with a Black Lives Matter skirt jutting out from the bottom.

Because La Llave translates to "the key" in English, Kruk felt it was a good starting point to open a dialog about a sensitive topic. "The key to the conversation about racism is to sit down and have a cup of coffee with someone and look at them eye to eye and ask, 'why does this happen in our society?" she explained.

Rounding out the show in the gallery's two exhibition rooms are dozens of dresses, clothing accessories and items made from common wrappers including M&Ms, Barnum's Animals Cracker boxes, C&H Sugar bags and many more. Figures including Frida Kahlo and Marilyn Monroe are also included.





The human side of homelessness: Rusty

This article is a continuation to the series by Veena Kommu, a local high schooler who decided to talk to the homeless people in the Bay Area, and get their stories out to the public. Her goal is to separate their character from their circumstances.

Rusty was born in Newark, California. He doesn't have red hair like his pseudonym would suggest, but says that his dad has red hair, and somehow the name stuck to him. A stocky gentleman in his mid-sixties, he is friendly and loves reading books and talking to people.

As a teen, Rusty was in one of the first batches of students to pass through Newark Memorial High School. He has

seen rapid housing developments taking over fields in the East Bay, and the gap between the haves and have-nots increase with rapid technological developments and rising land prices.

Currently, Rusty is living in a Chevy Suburban parked immobile in a parking lot because of mechanical problems. He doesn't have the few hundred dollars it would take to fix it.

Rusty used to work at a used auto business. His wages were not steady, and depended on business performance. About four years ago, Rusty was unable to pay rent after rates went up substantially. He started living out of his Suburban. The final straw came when his employer went out of business at the onset of

COVID-19. The shop used to buy cars at auction, fix them, and resell them. However, with auctions drying up due to COVID, the shop had to shutter its business.

At the moment, Rusty gets social security benefits, but that is not enough to rent an apartment in the Bay Area. For now, he relies on food stamps, a neighborhood church for food, and a medical mobile unit for his health needs.

According to Rusty, people are like the three monkeys: They don't want to see, hear or talk about the homeless, much less acknowledge the homeless situation. They want to see all homeless people in shelters, but they don't realize that is not the solution. Rusty himself doesn't like going to shelters because of strict rules, which he thinks makes clients feel like kids. He also said that if there are forty homeless people, five would make the life of others very difficult. There could be thefts and other unwanted behaviors.

Furthermore, he doesn't think having a temporary shelter is the solution. He wants to be able to live in a stable place for a few months while he searches for a job and saves enough to rent an apartment. He is hoping to get his turn for federally subsidized housing in Hayward, and turn his situation around.

Homelessness has taken a toll on Rusty. He has developed a sepsis in his right leg which when inflamed makes it difficult for him to get in and out of the Suburban. It also makes it very difficult for him to walk a few hundred yards to a public toilet. However, it is the mental stress that he finds is excruciatingly difficult to deal with. While he was talking, a mentally disturbed homeless woman was continuously shouting unintelligibly. He said that she has been shouting like this for days and hopes that she will get proper care in a mental health facility.

Rusty hopes that people will recognize that the majority of homeless people are honest and want to have a normal life that includes getting living wages and being able to raise a family.



How to End Procrastination (Now, Not Later)

My article for Tri-City Voice is always due the first week of the month, rain or shine. Instead of starting early and working steadily at it, I find myself watching a cat video on YouTube, reading that article that popped up in my search browser (somehow it suddenly becomes super important that I read tips on how to look good on Zoom), checking my emails (even though I just checked my inbox an hour ago), cooking that elaborate recipe that takes forever, and re-organizing my kitchen. Does my procrastination story sound familiar?

I know that I'm not alone -- people from all walks of life procrastinate. One research study found that up to 95% of the college students surveyed procrastinated instead of doing their homework.

There is a price to pay for procrastination: One study found higher stress levels and more illness when people procrastinated. Higher stress levels likely act as an adrenaline rush, pushing people to complete a task. However, it's a myth that people perform better under stress. Psychology researchers have shown that

this is not actually true. You may remember the one time you pulled it off, but you conveniently forget the other times you didn't. You might also not realize that you did not produce quality work.

The good news is that you can overcome procrastination. Here are some important strategies:

First, recognize that it's our feelings, not procrastination per se, that get us stuck. Identify these feelings and work with them. Is it fear keeping you from completing your work evaluation? Or self-doubt? Do not feel like you have to conquer procrastination altogether. I do not think that is possible. But it is possible to make peace with yourself and move forward.

Identify roadblocks to the task – is it too time-consuming? Too much research needed? Too exhausting? Examine these roadblocks and think of solutions to get you started.

Break the gigantic task into small, doable chunks and tackle the smallest chunk first. I personally like to tackle the easiest, most achievable task first to give me a boost of confidence. It's too daunting to think of a vast, complex project with

the many moving parts. Doing so will likely lead to procrastination and avoidance. So, start by thinking small.

Experts recommend taking time to reflect on which small step you could take first. I like to add the adjective " pleasurable" to make that first step an appealing action as opposed to a dreaded one. Say you want to start exercising more. An appealing first step is not a goal of working out three times a week. Instead, think fun and think small. Maybe you might want to choose a cute gym outfit. Or select an irresistible workout drink. Taking this unthreatening first step can actually help you get the ball rolling. Before you know it, you might surprise yourself by working out regularly at

Celebrate each step accomplished with a meaningful reward. I now tell myself that I can do the desired procrastinating activity (e.g., organize my spice cabinet) after I've completed one step of my dreaded task rather than before the task. This feels like a win-win because I feel rewarded and in control of my procrastination.

Prof. Tim Pychyl, an expert on procrastination, advises that you think about your future self. Say you've been putting off paying a bill. What would your future self feel and say if you paid the bill right now? Your future self might feel grateful and pleased that this task has been completed.

Having support is vitally important. Get a buddy or support system if you can.

For years, I wanted to learn a new language, but did not get any traction. I recently signed up with a class that meets regularly. Voila! I am now learning the language, thanks to this support system.

Look at the task in a new, meaningful, and more positive light. Say you are putting off cleaning the leaves off your gutter. All you can think about is how onerous and unpleasant it will be to drag the ladder out and grab fistfuls of rotting, slimy leaves while perched on a rickety ladder. Thinking in such a negative way will put anyone off the task. Instead, you might want to think about how good it feels to be taking care of your house and how you're staying ahead of the next rainstorm. Or how nice it will feel to be outside breathing in the fresh air and saying hello to the neighbors.

Christopher Parker summed it up well when he said, "Procrastination is like a credit card: It's a lot of fun until you get the bill." Here's a revolutionary thought – why not make the process fun and meaningful so you don't have to procrastinate? Start small with the strategies above and see if you can set aside any guilt over procrastination. Try to do it now, not later!

Are environmentalists happy with Joe Biden?

Dear EarthTalk: Are environmental advocates happy with the Biden administration so far?

-- B.C., Philadelphia, Pennsylvania

Overall, environmental advocates are much happier with Joe Biden in the White House than Donald Trump, given his administration's interest in pursuing sustainability and climate goals. Indeed, on day one Biden wasted no time making good on several environmentally related campaign promises. He signed executive orders rejoining the Paris climate accord (Trump had pulled us out in 2017), revoking the permit for the controversial Keystone XL pipeline (green-lighted by Trump in 2017), and halting construction of Trump's infamous border wall that among other things restricted the habitat range of wildlife already struggling to hang on in the drought-stricken, warming-addled Southwest.

While Biden couldn't get everything done in a day, his administration has kept its eye on the conservation ball ever since. In early September, Biden's Environmental Protection Agency (EPA) announced it was restoring protections for Alaska's Bristol Bay. The Trump administration had blocked those protections in a shortsighted effort to pave the way for construction of a massive gold mine threatening the world's largest sockeye salmon run as

well as ecosystems for hundreds of miles around. The Biden administration has also proposed cancelling controversial Trump-era petroleum drilling leases in Alaska's Arctic National Wildlife Refuge, but it's unclear whether this provision will remain in the larger Congressional budget reconciliation bill it's currently tied to given potential Republican backlash.

Another big move lauded by greens just weeks ago was Biden's executive order restoring Bears Ears and Grand Staircase Escalante national monuments in Utah to their original boundaries; Trump had reduced them by 80% and 50% respectively. Eco-advocates also cheered Biden's move to restore federal rules designed to guide environmental reviews of major infrastructure projects that the Trump administration had scaled back in order to "fast-track" construction permit approvals. Additionally, Biden has pledged to overturn Trump-era rollbacks of endangered species protections so as to preserve the ability of the federal government to designate lands as critical wildlife habitat regardless of their development potential.

While many are pleased with Biden's actions so far, others worry they are too little too late. Activists from the grassroots Build Back Fossil Free campaign, which includes Friends of the Earth, Greenpeace and Center for Biological Diversity, among others, decry the Biden White House for not already using executive orders to stop fossil fuel project approvals and declare a climate emergency. According to a recent analysis by research and advocacy organization Oil Change International, Biden could stop at least 24 major fossil fuel

For their November film offerings, Niles Essanay is putting the spotlight on Mary Fuller, with a couple of rarities from the Michael Aus collection.

According to Imdb, Mary Fuller's entrance into motion pictures was accidental. She was with a theatrical troupe that was on its way to tour the South in 1908 when, during a short stopover in New York City, the company broke up. Stranded, Mary made her way to Vitagraph film studio looking for a job and, with her experience and attractiveness, was put to work in action and comedy one-reelers. By 1914 she had achieved enough recognition for Edison to give her the lead in a serial, which was a big hit. Universal Pictures took notice of her, and she headed west. However, two years later she just packed up and walked away from Hollywood. She made one picture in 1917, then disappeared. A magazine writer found her in 1924, living in Washington, DC, with her mother. She said that she had tired of the hard work involved in making pictures, that she had invested her money and was living comfortably.

development projects with the stroke of a pen (including the controversial Line 3 and Dakota Access pipelines) and save upwards of 1.6 gigatons of greenhouse gas emissions -- the equivalent of taking all the cars and trucks off U.S. roads for a year.

"We are out of time for the president to take his executive powers off the shelf," said Jean Su, energy justice director at Center for Biological Diversity. "Anything less is leaving a scorched future for people and our planet."

Fremont's Icon

East Bay Regional Park District (EBRPD) proposed a 25-year lease agreement for Mission Peak Park that was unanimously rejected by the City Council on November 9. There was a dispute as to whether the City imposed a closure of the park during a critical phase of the pandemic (it did, in front of the Stanford Avenue gate) and whether EBRPD was requesting unchallengeable control of the 900 acres owned by the City (it was not).

The local community around Stanford Avenue presented comments to the council requesting emphasis for the Ohlone entrance, tighter responsibilities and liabilities, and a much shorter lease; like 5 years. With 23 parking spaces for a park that gets close to 250,000 visitors, do we need better access? And will there continue to be a Stanford Avenue gate that welcomes visitors from throughout the entire Bay Area, and even internationally?

Why do we choose to hike the front of Mission Peak? It's the view. It won't go away. It's just not the same from the Ohlone back route, although that route has attractions as well. Mission Peak is a unique attribute for a city adjoining open space and wilderness - more than an icon for computer desk tops - that should remain available to tax paying East Bay residents. Granted, they can come in swarms, especially on weekends - numbers in the thousands. They sometimes cause disturbance, are unwelcomed, and pay \$82 traffic fines if parking illegally. So why not pay \$4 dollars and park at Ohlone and hike from the rear? Something about

Before, during and after the pandemic we'll love nature and the outdoors. Especially young folks who don't have the time or money to head off to more exotic locations. So hopefully a re-negotiation takes place, sparing the City of the \$400,000 cost that EBRPD currently spends maintaining 900 acres. The icon belongs to all of us. Hopefully we continue sharing it with others.

City seeks nonprofit partner

City of Hayward is seeking a nonprofit organization serving people with mental illness, substance-use disorders and experiencing homelessness that can help enhance how the City responds to 911 emergency calls.

Through a new pilot project called Hayward

Evaluation and Response Teams (HEART) Program, Hayward Police and Fire Departments are working to establish an integrated continuum of options allowing for the most appropriate responses to calls to Hayward 911 dispatch center.

The goal of the HEART Program is to improve access to medical, mental health and other support services — and reduce the need for police officers to intervene in calls for service involving people experiencing mental illness, substance-use disorders and homelessness.

The current program approach entails deploying two different mobile response teams: a Mobile Integrated Health Unit (MIHU), which pairs a Hayward firefighter-paramedic with a mental health clinician from a community-based organization, and a Mobile Evaluation Team (MET), which pairs a specifically trained Hayward Police Officer with a behavioral health clinician from Alameda County Behavioral Health Care Services.

As a next step, the City seeks to partner with a nonprofit organization equipped to bring to the HEART Program the perspectives of people with lived experiences of mental illness, substance-use disorders and homelessness to help identify and make recommendations to close gaps in the program.

Making 1,865 seed balls in two hours

Trees are a critical part of restoring our climate to its normalcy, and the time to act is now. Project Green Earth (PGE) is a volunteer team founded in Fremont, California. This team of dults and kids are trying to grow millions of trees at almost zero cost.

Project Green Earth uses a simple three-step process. First, the team gathers seeds from local trees when they go for a walk, or whenever they can. Second, they mix mud with water and make a mud ball with a seed in the middle and dry those seed balls. Third, they scatter those seed balls in places where they have acquired the permit to do so. This enables them to grow local trees in approved areas.

On November 6, the group organized a Seed-Ball Making event at Lake Elizabeth in Fremont, where local residents with their children and volunteers from PGE, Fremont Morning Rotary, Mission San Jose Rotary, Niles Rotary and other Rotary clubs, came together to create awareness, teach and make seed-balls.

The group made 1,865 seed balls in under two hours with various types of Oak acorns/seeds. California State Assembly Member Alex Lee joined this community effort to raise awareness about the importance of growing trees and support PGE's initiative.

As part of Socially Responsible Innovation, the team unveiled two different seed-maker-tools. One was built by Johnson Prabagar, Lionel Maximus and Vans Paul Wilfred. This tool allows the team to make 64 seed balls in 5 minutes, instead of 60 in an hour. The second design was from Johan and Ajith Peter. This unique seed ball maker also helped speed up the assembly process.

Seed balls can be scattered throughout the year, regardless of whether there is rain. Seeds germinate and remain dormant until it starts raining. Then seeds start to sprout and grow into trees, all without any further help from humans. This team has scattered over 12,000 seed balls in the last 10 months since kicking off Project Green Earth.

Let us all grow trees to restore and save Earth for future generations. Let us act now so that our kids can live in a greener and cleaner world!

Nine wonderful winter gardens to visit

Winter is the season when most public gardens are visited the least. Many trees and shrubs have dropped their leaves, it can be cold and wet outside, and not many flowers are in bloom. However, there are still plenty of things going on in these gardens to make it worthwhile for a winter visit. The lack of visitors means that you might have the gardens all to yourself.

There are plenty of free smaller gardens to visit in the Tri-City area, but there are also numerous larger public gardens dotted throughout the Bay Area that make nice day trips not only in the spring and summer, but fall and winter as well. Some have limited hours while others might extend opening hours into the evenings because they decorated their grounds and added holiday lights. Some are accompanied by an estate house, others with sculptures and works of art, and some with ponds and water features. All are worth seeing, whether it is sunny and hot or cold and rainy.

Cornerstone Art Gardens in Sonoma, cornerstonesonoma.com, is a series of gardens created by local and international landscape designers. Some of the 10 gardens remain for one season, while others may be in place for years. There are also five Sunset test gardens next door which feature the latest varieties of plant grown for habitat and food. Admission is free. Cornerstone, in addition to hosting winter events, is also home to two wine tasting rooms, artisanal shops, a coffee kiosk, and Folktable Restaurant which features seasonal ingredients.

Filoli Historic House & Gardens in Woodside, filoli.org, has 16 acres of formal



gardens, and an additional 654 acres which include fruit tree orchards and five distinct natural ecosystems. Their garden designers use historic photographs to produce a garden that blooms all year long just as it did when it was created by a wealthy couple in 1917. The gardens stay open late in the winter when they are decorated with colorful light pieces. The house, the café, and garden shop stay open late as well.

University of California Botanical Gardens in Berkeley,

botanicalgarden.berkeley.edu, is a 34-acre garden on the UC Berkeley campus. The site has a "What's in bloom section" that lists with photographs everything in bloom for a particular month or what is expected the next month. November will not disappoint anyone who would like to see winter blooms, because the list of flowers is long. Winter does not deter the author talks, workshops, lectures, and other events.



Conservatory of Flowers in

San Francisco, conservatoryofflowers.org, is an ornate Victorian style greenhouse that opened in Golden Gate Park in 1879. The botanical gardens inside host a wide variety of rare tropical and exotic plants and a spectacular large pond with brightly colored blooming water lilies. It is one of the few gardens that can be enjoyed comfortably even on the wettest winter days because the plants are inside a warm humid greenhouse.

Luther Burbank Home & Gardens in Santa Rosa, lutherburbank.org, is the site where Luther Burbank, the famous horticulturist, created many new species. The park contains his gardens, greenhouse, Victorian home, and grave site. The website has an up-to-date list of what is in bloom this winter and in December the Holiday Open House event has the home and garden decorated in a Victorian holiday theme.

Ruth Bancroft Garden in Walnut Creek, ruthbancroftgarden.org, has over 2,000 succulents, cacti, and drought tolerant plants and trees on a 3.5-acre site. Something is in bloom every season. There are talks and other events throughout winter with the Garden of D'Lights being their flagship fundraiser. The plants and trees bloom in the night during November and December with the aid of thousands of colorful lights

The little-known Papua New Guinea **Sculpture Garden** was created in the early 1990s when sculptors from

Papua New Guinea were commissioned to carve numerous traditional wooden carvings ranging from four-feet-tall to over 15-feet-tall. Many of the plants in the garden are native to Papua New Guinea. Directions can be found online by searching using the garden's name.

Rodin Sculpture Garden located in front of Cantor Museum [Stanford University] has about 20 bronze sculptures created by French artist, Auguste Rodin. The nice thing about visiting the garden in the winter is that if it gets too cold or wet, you can duck into the museum which is also free of charge.

Hakone Estate and Gardens in Saratoga, hakone.com, is one of the western hemisphere's oldest Japanese style residential gardens. Many of the grasses, conifers, bamboos and other traditional plants used are evergreen making them just as enjoyable to view in the winter as they would be in the summer.

An Italian proverb states "They who sing through the summer must dance in the winter." The wonderful spring and summer gardens would not exist without first readying themselves as winter gardens. However, as the proverb implies, there is no reason that visiting a garden in winter would not be just as enjoyable as in summer.

After a Year Apart, We Walk as One

THE MASONIC HOMES OF CALIFORNIA JOINS THE 2021 WALK TO END ALZHEIMER'S

AMIDST A SEA of flower petals spinning in the wind, the resounding message of hope hung heavy in the air. At the annual Walk to End Alzheimer's, held October 23 at Bishop Ranch in San Ramon, more than 1,000 participants turned out to stroll, be seen, and show that we can't and won't give in to the disease that affects so many. Sporting matching purple shirts and hoisting colored flower signs indicating their relationship to the disease—blue for those living with Alzheimer's, purple for those who've lost a loved one to the

disease, yellow for those supporting an Alzheimer's patient, and orange for those who support the cause—the crowd sent a powerful message that a cure for this disease is within our reach.

When that day does arrive, another flower will be raised: the first white flower will symbolize the first survivor of Alzheimer's.

After a year apart due to the pandemic, the 2021 Walk to End Alzheimer's was especially meaningful. The walk is the world's largest event to raise awareness and funds for Alzheimer's care, support, and research. It is held annually in 600 communities around the country. The East Bay walk included some 1,300-plus participants, who made up nearly 200 teams, and together raised nearly \$500,000 to fund critical research into and support for Alzheimer's-related issues. "One of the most important functions of the walk is to show everyone that they are not walking alone," says Joseph Pritchard, the chief clinical officer of the Masonic Homes of California. We are nearing the time of year when our caloric intake can exceed the amount needed for physical activity – specifically, at Thanksgiving. In anticipation, East Bay Regional Park District has thoughtfully scheduled a couple of post-holiday programs to address this situation.

One opportunity is "Feast Your Eyes on Nature," a moderate, two-mile hike from 9:00 a.m. to 11:30 a.m. on Friday, November 26 at Black Diamond Mines Regional Preserve in Antioch. Naturalist Ashley Adams will lead a walk over sometimes steep and uneven terrain. Meet in the park's upper parking lot at the end of Somersville Road, 3½ miles south of Highway 4.

3D printing challenge: Solving US housing shortage

A new generation of startups wants to disrupt the way houses are built by automating production with industrial 3D printers.

3D printing, also known as additive manufacturing, uses machines to deposit thin layers of plastic, metal, concrete and other materials atop one another, eventually producing three-dimensional objects from the bottom up. In recent years, 3D printers have mostly been used to create small quantities of specialized items such as car parts or prosthetic limbs, allowing consumers or businesses to produce just what they need using the machines at home or work.

Now a small number of startups around the world are applying 3D printing to home construction, arguing that it's faster, cheaper and more sustainable than traditional construction. They say these technologies could help address severe housing shortages that have led to soaring home prices, overcrowding, evictions and homelessness across the U.S.

But 3D home construction is still in the early stage of development. Most startups in this field are developing new technologies and not building homes yet. And two of the highest profile and best-financed companies - Mighty Buildings and ICON - have delivered fewer than 100 houses between them.

To move beyond a niche market, construction firms will need to significantly ramp up production and persuade home buyers, developers and regulators that 3D printed houses are safe, durable and pleasing to the eye. They'll also need to train workers to operate the machines and install the homes.

"To the extent that 3D printing can offer a faster, cheaper way to build even single-family housing units or small units, it can address a portion of the problem," said Michelle Boyd, who directs the Housing Lab at the University of California, Berkeley's Terner Center for Housing Innovation. But the sheer magnitude of the housing shortage demands many types of solutions, from loosening zoning restrictions to building more high-rise apartment buildings, she said.

Proponents note that printing houses rather than nailing them together could save huge quantities of scrap wood, metal and other discarded construction materials that are dumped into landfills every year.

Backers say 3D printing reduces the need for human labor at a time when home builders are struggling to find enough skilled workers to meeting housing demand. Many construction workers left the trades after the housing-fueled financial crisis more than a decade ago, and fewer young people are entering the field.

Jason Ballard, CEO and co-founder of a 3D printing construction startup called ICON, said its 3D printing system can do the work of 10 to 20 workers in five or six different trades. And unlike humans, the machines can work up to 24 hours a day, saving developers time and money.

"With 3D printing, we're able to print exactly what we need," said Sam Ruben, the company's co-founder and chief sustainability officer at Mighty Buildings. The process can eliminate nearly all construction waste, he said, which can add up to savings of two to three tons of carbon per housing unit.

In Mighty Buildings' factory warehouse in Oakland, Calif., a 3D printer deposits thin layers of a stone-like material that

quickly hardens under ultraviolet light and resists fire and water. Wall panels are printed one layer at a time and then filled with an insulating foam. Robotic arms finish the surfaces into various designs.

The printer can produce the entire exterior shell of a studio home or individual wall panels that can easily assembled with simple tools, the company said. Mighty Buildings is now producing 350-square-foot backyard studios, known in the industry as "accessory dwelling units," that can be used as extra bedrooms, playrooms, gyms or home offices.

So far, the company has delivered six units and has another 30 under contract, starting at \$115,000 each, which doesn't include the cost of installation and site work. Two units can be combined to make a 700-square-foot dwelling. The company's home construction costs are about 40 percent lower than that of traditional homes in California, Ruben said.

Most of the modules are assembled in the factory, transported by truck to the owner's property, then put into place using a crane. The unit size is limited by the dimensions of the truck bed and the clearance heights of tunnels and overpasses.

Backed by more than \$70 million in venture capital, Mighty Buildings is planning to build more factories with a goal of producing 1,000 housing units next year. It's also creating software that allows developers to custom design printed buildings. Ultimately, the company plans to produce townhouses and multistory apartment buildings, Ruben said.

Mighty Buildings is teaming up with a Beverly Hills, Calif.-based developer, the Palari Group, to create a planned community of 3D printed homes in the desert resort community of Rancho Mirage in California's Coachella Valley.

The solar-powered development, set for completion next spring, will have 15 lots with a 1,450-square-foot primary home plus a 700-square-foot secondary home and swimming pool in the backyard, costing around \$850,000, said Basel Starr, Palari's CEO and founder. Those lots sold out quickly and there's a waiting list of 500 homebuyers, Starr said. He's planning similar developments in other parts of California.

Austin, Texas-based ICON has used 3D printing technology to produce low-cost housing. It's printed homes for the chronically homeless in Austin as well as poor families in Nacajuca, Mexico. Instead of producing homes in factories, it brings its Vulcan printer to work on-site, squeezing out long tubes of concrete layer by layer that dry quickly to form the walls of a house.

"The factory comes to you, imprints the house right where it intends to be. We chose that method to eliminate a lot of the shipping costs and then also to give ourselves a lot of design freedom," said Jason Ballard, ICON's CEO and co-founder.

Its current technology can reduce construction costs by up to 30 percent and build a house twice as fast as traditional methods because the 3D printer does nearly all the work, Ballard said.

"The benefits that automation and digitization had brought to so many other industries with regard to speed and affordability were completely missing from the construction industry," Ballard said.

3D printing, he said, "was like the most powerful automation of all the automations we could discover."

Some philosophical discussions are circular. For example, Schrodinger's cat dilemma is often used to describe a situation in which, without direct observation, a conclusion is uncertain. In this hypothetical scenario, a cat is put in a precarious and potentially lethal environment. Without direct observation, the outcome is uncertain. Is the cat dead, alive or, theoretically both?

Another argument without resolution is the answer to the question of which came first... chicken or egg. Without the chicken, how can there be an egg? Without the egg, how can there be a chicken?

These conundrums illustrate the delicate balance between content, context and a reasonable conclusion. Complex issues that involve a multitude of factors are uncomfortable since they do not necessarily yield to a solid, incontrovertible decision. There may be no indisputable right or wrong answer, so evaluation depends on use of facts and how they are placed in an argument - for or against a specific response. If a conclusion is predetermined, then the

content will be positioned in a context that will support it. In such a case, the proverbial tail wags the dog.

There are many complex issues currently facing our communities and more to come in the near future. With community input, responses can be based on a variety of opinions and perspectives. If a limited number participate, prevailing opinions may not represent a full spectrum of thought. At this time, political boundaries of public institutions are under review and will be recalculated. Called "redistricting," these decisions will determine who represents the public within those boundaries.

Although there are rules that should be followed to balance and fairly divide community participation, choices are often open to interpretation and discussion. The public is invited to participate in this decennial (every 10 years) slicing the political pie that will determine political leverage. However, in the absence of active observation and input, Schrodinger's dilemma will prevail with no known outcome until the box of subsequent elections containing the cat is opened. Barring drastic action by the electorate through recalls, the die is cast. Poor decisions can be the result and, although regretful of prior inaction, it may be too late to influence the consequences.

Now is the time to consider: Who is representing your interests? What relationship do these people have with others in the political spectrum? Do you know how your representative voted when evaluating important issues that affect you and your immediate environment? What decisions have been made about vital infrastructure concerns (housing, streets, water, sewer, parks and open space, etc.)? Where do these people live and how visible are they in your community? Is your representative conversant with local issues or simply warming a seat, waiting for a chance to advance up a political ladder?

Very soon, an extremely active election year will begin; music for the game of political musical chairs will be heard. Already, some local politicians have announced candidacy for state office, but this cannot be a substitute for focus on local issues. Concerns about access to open spaces (e.g., Mission Peak), homeless encampments, vital resources such as water supply and recovery from the economic and personal effects of COVID restrictions need immediate attention. We all need to keep in mind that with participation, comes understanding and tolerance for disagreements. The best protection of our democratic system is through active participation, passionate discourse, recognition of the complexity of systems and the use of content and context to reach beneficial conclusions.

"More than a third of Facebook's daily active users have opted in to our Face Recognition setting and are able to be recognized, and its removal will result in the deletion of more than a billion people's individual facial recognition templates." He said the company was trying to weigh the positive use cases for the technology "against growing societal concerns, especially as regulators have yet to provide clear rules."

Facebook's about-face follows its Oct. 28 announcement that it was renaming itself Meta in order to focus on building technology for what it envisions as the next iteration of the internet -- the "metaverse." The company is also facing perhaps its biggest public relation crisis to date after leaked documents from whistleblower Frances Haugen showed that it has known about the harms its products cause and often did little or nothing to mitigate them.

More than a third of Facebook's daily active users have opted in to have their faces recognized by the social network's system. That's about 640 million people. But Facebook has recently begun scaling back its use of facial recognition after introducing it more than a decade ago.

In 2019 the company ended its practice of using face recognition software to identify users' friends in uploaded photos and automatically suggesting they "tag" them. Facebook was sued in Illinois over the tag suggestion feature.

Some U.S. cities have moved to ban the use of facial recognition software by police and other municipal departments. In 2019, San Francisco became the first U.S. city to outlaw the technology, which has long alarmed privacy and civil liberties advocates.

California attorney general puts focus on affordable housing

California's attorney general said he is putting a new emphasis on trying to alleviate the state's seemingly intractable affordable housing problem, including by creating a "strike force" to focus on tenant protections, on local governments that don't comply with state housing laws, and related issues.

The 12-member strike force will draw on attorneys from four existing sections within the state Department of Justice, said Attorney General Rob Bonta, a Democrat who took office in April and must run for reelection next year.

"This is, I believe, something unique in the history of the California Department of Justice to have the priority and emphasis and focus on housing, law enforcement, that we have" with the new approach, Bonta said.

He noted that a new law clarifies and increases his authority to enforce state housing and zoning laws alongside the state Department of Housing and Community Development. That includes added authority to file lawsuits if local governments don't boost their housing supply, including fair and affordable housing and rental properties, or meet other requirements.

'We are certainly looking at local jurisdictions' responsibilities to build more housing," Bonta said, adding later that "there will be consequences, there will be accountability" if communities willingly refuse to comply.

The department sets the number of new housing units that a region is projected to need to provide homes for all income levels, and also recently created a new Housing Accountability Unit to compel compliance. "What we've tried to do is put more teeth into these important laws that have been around sometimes for as long as 40 years, and now empowering the attorney general to take action to enforce them," said Sen. Scott Wiener, a Democrat from San Francisco and a proponent of expanded housing.

The League of California Cities, which defends local control, did not immediately comment.

In one example, the department earlier said it is investigating the San Francisco Board of Supervisors' recent rejection of a proposed 495-unit apartment building, though director Gustavo Velasquez said Nov. 3 that so far, his department is just gathering facts and seeing if the city violated state law. Bonta said his office is acting as the department's legal counsel in that inquiry.

California also just enacted two high-profile housing laws, including one requiring cities to approve up to four housing units on what was a single-family lot.

The attorney general's lawyers will also focus on tenant rights, mortgage and other consumer protection laws, Bonta said. He announced a new "housing portal" on the department's website with resources and information for homeowners and renters. Those with housing complaints or tips can send them to housing@doj.ca.gov.

Bonta said it's part of his effort to "advance Californians' fundamental right to housing," something he has long held should be a legally enforceable right. His move is the latest step in state officials' efforts to address housing affordability and the most populous state's massive homeless population.

An estimated 150,000 of the state's residents are sleeping in shelters, in their cars, or on the street, he said, while another 700,000 Californians are at risk of eviction. The median price of a single-family home now tops \$800,000, which he said has led to the lowest homeownership rates since the 1940s.

Bonta said one major emphasis will be on housing equity, noting that nearly half of the state's Black households spend more than 30% of their income on housing, in contrast to about a third of white households.

Feds block billions of public transit money for California

The federal government says California is ineligible for about \$12 billion in public transit funding because of a long-running dispute over changes to the state's public pension law that the Biden administration recently determined are Federal law says state and local agencies must protect the interests of their employees to be eligible for federal public transit grants. A state law that took effect in 2013 made changes to California's public pension system, including making pensions less generous for new employees.

The Sacramento Bee reports the U.S. Department of Labor recently determined those changes were improper because they were imposed by law instead of collectively bargained with public employee unions.

The federal government's latest decision means the state would be ineligible for about \$9.5 billion in money set aside for California public transit agencies in the infrastructure bill Congress approved last week. California would also forfeit about \$2.5 billion in grants for public transit that were part of the most recent federal coronavirus relief legislation.

"This relief funding has served as a lifeline for them, and in the absence of these federal dollars flowing to California transit agencies, we will absolutely see a reduction in service and losses in our workforce, making it more difficult for agencies to rebound," said Michael Pimentel, executive director of the California Transit Association, a nonprofit representing public transit agencies in the

State and federal officials have been arguing over this funding since the pension law was passed nearly a decade ago. After former President Barack Obama's administration blocked grant funding for two California transit agencies, the state sued and won. But that decision only applied to the Sacramento Regional Transit District and Monterey-Salinas Transit.

In 2019, former Republican President Donald Trump's administration ruled the state's pension law did not make it ineligible for public transit grants. But Democratic President Joe Biden's administration reversed that decision on Oct. 28.

California U.S. Sens. Dianne Feinstein and Alex Padilla, both Democrats, have urged the Biden administration to overturn the decision, saying it was "at odds with multiple state and federal court decisions and past Labor Department precedent."

California Gov. Gavin Newsom, a Democrat, called the Labor Department's decision "extremely concerning." In a letter to U.S. Labor Secretary Marty Walsh on Nov. 10, Newsom argued the pension changes did not impede labor unions' collective bargaining rights, noting unions have negotiated new contracts since the 2013 state law took effect.

A letter from the U.S. Department of labor says the state pension law "continues to interfere with the collective bargaining process regardless of the specific terms of workers' collective bargaining agreements now in existence."

Police bust catalytic converter thieves

White House eyes new climate change strategies

The White House is zeroing in on a package of clean energy strategies for President Joe Biden's big domestic policy bill that officials believe could reach similar greenhouse gas emission reduction goals as an initial proposal that was quashed by opposition from a centrist Democrat.

The Biden administration discussed the proposals Oct. 25 at the White House with the leaders of about a dozen environmental and justice groups, according to a senior administration official who requested anonymity to share the plans. A new approach was needed after coal-state Sen. Joe Manchin, D-W.Va., rejected the White House's earlier clean energy plan.

The emerging proposals would expand grants and loans in the agriculture and industrial sectors to help them shift to clean energy providers with fewer greenhouse gas emissions that contribute to global warming, the official said. There would also be new, refundable home improvement tax credits for tapping solar and other renewable energy sources. The official said momentum was building as the group coalesced around the new ideas.

The new strategies come as the president and Democrats in Congress are struggling to wrap up talks on Biden's now-scaledback package of at least \$1.75 trillion in social services and climate change investments before he departs later this week for two global summits overseas.

Vice President Kamala Harris visited the afternoon meeting with the leaders of some of the nation's leading environmental and justice organizations and reiterated the president's commitment to the goals of the package -- even as she acknowledged the sometimes grueling process to achieve consensus in the party.

"The president and I and our administration are unwavering in our commitment to these issues. Absolutely unwavering," Harris said. "But you know, there's an old saying, you don't want to watch sausage be made and you don't want to watch a bill being made."

A cornerstone of Biden's climate change strategy had been a clean energy plan that would have rewarded power providers that use clean sources and penalized those that don't. But that approach had to be scrapped when Manchin objected. With Republicans fully opposed to Biden's big package, the president needs the support of all Democrats in the 50-50 split Senate, with no votes to spare.

The senior administration official said the administration was not wedded to one clean-energy strategy as a "silver bullet." Instead, officials are coalescing around a new package of strategies that could potentially achieve similar emission reduction goals without adding new costs to the overall package.

A plan backed by Democrats offers tax credits and spending to boost renewable power such as wind and solar and sharply increase the number of electric

vehicles. Advocates think the plan, plus executive branch action such as a pending Environmental Protection Agency rule to curb methane emissions, and action by states, should be enough to meet or nearly meet Biden's goal to cut greenhouse gas emissions in half by 2030, compared with 2005 levels.

Biden said at a recent town hall that he expects to spend the \$150 billion that had been targeted for the clean-energy program on climate programs. Advocates say the money would most likely be used as block grants to states to pursue their own emissions cuts.

It's unclear if the new proposals would be acceptable to Manchin, whose home state is a leading producer of coal and natural gas. He has preferred an approach that does not favor one industry over the other as coal begins to be phased out for cleaner energy sources.

The new strategies appear to use more incentives to encourage clean energy use rather than penalties for failing to make the transition, which could help win over Manchin. But climate change advocates have argued that penalties are needed to get industries to more quickly turn to cleaner sources as the world races to confront the dire threats of climate change.

A major fight emerged in recent days over a proposal to include a so-called "methane fee" in the budget package. The fee would be imposed on energy companies that leak methane pollution during oil and gas

Violence threats prompt **Great Mall evacuation**

A report about a fight involving a knife near a restaurant at the Great Mall in Milpitas sent police scrambling to the scene, where later shots were reported nearby prompted a temporary evacuation from the mall.

The incidents started at 5:22 p.m. Friday, November 5 when officers responded to the call about the fight. Upon arrival they detained three suspects, including a 15-year-old male who had a large concealed knife.

A short time later, at 5:34 p.m., police received a 911 call about shots fired inside the Burlington Coat Factory store inside the mall. It was unclear if that was connected to the initial call about the fight. As a precaution, law enforcement personnel from nearby agencies arrived to assist in the search and evacuation of the Great Mall. Additionally, fire department and paramedic personnel responded and were waiting nearby in case they were needed. Stores inside the mall sheltered in place while the interior of the mall was evacuated and searched. Customers and employees were escorted out by officers, who completed their search at 7:39 p.m.

No evidence of shots being fired inside Burlington Coat Factory or the Great Mall was found and there were no injuries reported.

A record check on the 15-year-old juvenile showed he was on Santa Clara County probation for auto theft, evading a peace officer, resisting arrest, possession of an illegal weapon, and robbery. He was booked into juvenile hall for a violation of probation warrant, possession of a controlled substance and possession of concealed dagger. The other two people detained were released after further investigation.

Meanwhile, a 41-year-old man was detained based on witnesses reporting he was possibly involved in the shots fired call, but investigators determined he was not involved. However, a record check showed he was on California Department of Corrections and Rehabilitation parole for burglary. He also was in possession of a controlled substance and narcotic paraphernalia. He was arrested and booked into jail for a parole violation and narcotic related offenses.

production. Methane, the main component of natural gas, is a leading cause of global warming, especially in the short term.

"My hope is, it's going to be in," Sen. Tom Carper, D-Del., chairman of the Senate Environment and Public Works Committee, said of the methane fee. "We negotiated a methane fee, we tried to do it in a way that Sen. Manchin and his folks would be more receptive of, and we're still talking about it and continuing to work through it," Carper told reporters Oct. 25.

Manchin said on Oct. 26 he is talking to Carper and others about the methane fee, but does not want to "punish" energy companies "just for the sake of punishing" them. Some House Democrats from Texas also oppose the methane fee, saying it could cost thousands of jobs in the energy industry and increase energy costs for Americans.

Supporters called the fee a common-sense provision that only kicks in when methane pollution exceeds agreed-upon targets. The fee would give the oil and gas industry a financial incentive to

capture methane rather than burn or "flare" excess gas produced at well sites, supporters say.

Sen. Sheldon Whitehouse, D-R.I., said a methane fee is crucial to meeting Biden's climate goals as he heads to a climate summit in Glasgow, Scotland next week. "Letting corporations pollute for free is not a climate solution," Whitehouse said.

The grants and loans for the agricultural sector would help rural electric cooperatives transition to cleaner energy sources, which could be of interest to Manchin in his rural state. Similarly, industrial steel, cement and aluminum plants could tap funds to beef up their use of greener sources, the official said. There would also be expanded home improvement tax credits.

Biden's goal was to have a deal in hand before he goes to Scotland for the United Nations climate conference amid hopes to reposition the U.S. as a world leader on the issue.

James Webb Space Telescope – The next big thing in astronomy

As we are getting close to the launch date of James Webb Space Telescope (JWST) in mid-December, now is a good time to go over its salient features. JWST is a collaboration between NASA, European Space Agency (ESA), and Canadian Space Agency (CSA). James Webb Space Telescope is named after famous NASA administrator James Edwin Webb, who was in charge of the first manned space program, Mercury.

JWST will be placed in Lagrange point 2, also called L2, which is further beyond the Moon's orbit, and this will keep Earth, Sun, and Moon all on the same side of the spacecraft all the time. This will mean that the net force of gravity acting on the telescope is nullified and the telescope has a stable orbit of its own.

JWST is predominantly an infrared telescope, specifically designed to measure the infrared region of the spectrum. JWST will be maintained at around 40 Kelvin to minimize infrared radiation that is not of interest to the telescope. This includes radiation from the sun and reflected lights from the Earth and Moon. As it will be placed in L2 orbit, there isn't any chance of shadow formation on the

mirror of the telescope due to the Earth or Moon, and temperature will be kept constant.

The telescope also has a Sunshield that blocks light and heat from the Sun to reduce the background (infrared radiation and heat from the Sun and nearby planetary objects) and focus on distant objects and faint light and heat coming from them.

The diameter of the mirror in JWST is around 6.5m which is almost three times the area of the Hubble Telescope (2.4m). Because of the size of the mirrors, the effective area is distributed between 18 hexagonal mirrors. A heat shield, science instruments, and a power source make the rest of the instrumentation. JWST will unfold when it reaches space, en route to L2. This "origami" technique will help to overcome the space vehicle size

The mirrors are made exclusively of Beryllium with a thin coating of Gold, as Gold is an effective reflector for the infrared region. For the entire JWST, as little as 48 grams of Gold was used.

The Hubble Space Telescope can now measure about 1,600 nanometers of wavelength; JWST will extend this range to up to 30,000 nanometers. Since the light from distant galaxies and stars get

red-shifted due to expansion, with JWST we can probe further back into the past. Astronomers believe JWST would take us as far as the first galaxies that were formed after the Big Bang. In addition, the scientific community also hopes to uncover more information about exoplanets and find new exoplanets.

The projected cost of the mission is around \$9.7 Billion, which can grow over time. The scheduled launch time of JWST on an Ariane 5 rocket is on December 18, 2021, from French Guiana.

American Girl dolls, Risk, make it to Toy **Hall of Fame**

American Girl dolls and the strategy board game Risk were inducted into the National Toy Hall of Fame on Nov. 4 in recognition of their influence on the toy industry. Sand, which the group called perhaps the most universal and oldest toy in the world, was also inducted.

All three were honored during a ceremony at the hall after winning over a panel of experts who voted for them from a group of 12 finalists.

Also in the running this year were four other competitive games: Battleship, The Settlers of Catan, Mahjong and billiards, as well as Cabbage Patch Kids, Masters of the Universe, Fisher-Price Corn Popper, the toy fire engine and the pinata. Anyone can nominate a toy but to be considered, they must have withstood tests of time and memory, changed play or toy design and fostered learning, creativity or discovery.

American Girl dolls, the 1986 creation of educator Pleasant Rowland, were recognized for their exploration of the country's social and cultural history. The 18-inch historical dolls and accompanying books each offer insights into an era. For example, Molly McIntire is waiting for her father to return home from World War II. The Truly Me contemporary doll line, with its diversity of skin tones, hair and gender, followed in 1995, letting children choose a doll that looks like them.

Rowland, 80, called the American Girl doll's inclusion "an incredible honor." In an emailed statement, she added, "I'm so proud of the American Girl family past and present who have been faithful stewards of this brand for more than three decades, helping to capture the hearts of an entire generation of girls."

"Rowland's formula for combining doll play with history lessons worked, in her words, like 'chocolate cake with vitamins,'" curator Michelle Parnett-Dwyer said. "In an era when some education experts claimed that school curriculums paid little attention to history, this toy may well have filled a void."

Risk, based on the French game Le Conquete du Monde, was first published in the United States in 1959 and continues to influence other board games, hall officials said. It challenges players to control armies and conquer the world on a game board that is a map of continents.

"Risk became one of the most popular board games of all time, inspiring a new corps of passionate gamers, and influencing other games which began the wargaming hobby - and by extension the Euro-games like The Settlers of Catan that many enjoy today," curator Nicolas Ricketts said.

Sand was honored for its "opportunities for tactical, physical, cooperative, creative, and independent free play," according to the hall of fame, which is housed inside The Strong Museum of Play in Rochester, New York.

"Children recognize sand as a creative material suitable for pouring, scooping, sieving, raking, and measuring," it said. "Wet sand is even better, ready for kids to construct, shape, and sculpt."

"Although some playthings can only be found online or in certain stores, sand has a global reach that most toy manufacturers would envy," chief curator Chirstopher Bensch said. "It's been a vehicle for play since prehistory, and anyone who has spent the day at the beach can understand the allure of this toy."

The class of 2021 joins 74 previous honorees.

Gatik autonomous box trucks hit milestone with Walmart

Gatik, an autonomous driving startup and 2020 RBR50 winner, continues to reach new milestones in its partnership with Walmart. On Nov. 8 the company said it no longer has a human safety driver behind the wheel of two Level 4 autonomous box trucks operating in Bentonville, Arkansas, which is the home of the retail giant.

But the box trucks really aren't completely driverless just yet, however. Gatik still has a human sitting in the passenger seat of the vehicles with access to an emergency brake, and they use a chase vehicle to help remedy situations where the autonomous driving system fails.

Gatik said its vehicles make 4-6 trips per day on a route that is 7.1 miles round trip. The vehicles transport customer orders between a Walmart dark store and a Neighborhood Market. Gatik said operations without a human behind the driver's wheel began in August 2021. The company told The Robot Report that, up until press time, the human in the passenger seat has yet to pull the emergency brake. We asked a Gatik spokesperson what it will take to remove the human from the passenger seat, but we've yet to hear back.

Gatik was founded in 2017 and exited stealth mode in 2019 with Walmart as a partner. Gatik is generating revenue by helping Walmart automate its middle-mile logistics. Gatik also has a partnership with Loblaw, the largest supermarket chain in Canada with 2,400-plus locations.

"Our deployment in Bentonville is not a one-time demonstration. These are frequent, revenue-generating, daily runs that our trucks are completing safely in a range of conditions on public roads, demonstrating the commercial and technical advantages of fully driverless operations on the

middle mile," said Gautam Narang, CEO and co-founder, Gatik.

Walmart has also tested autonomous vehicles for last-mile delivery, including those from Cruise, Nuro and Waymo. Of course, early success with Walmart doesn't mean much in the world of robotics. Just ask Bossa Nova Robotics.

"Through our work with Gatik, we've identified that autonomous box trucks offer an efficient, safe and sustainable solution for transporting goods on repeatable routes between our stores," said Tom Ward, senior vice president of last mile at Walmart U.S. "We're thrilled to be working with Gatik to achieve this industry-first, driverless milestone in our home state of Arkansas and look forward to continuing to use this technology to serve Walmart customers with speed."

Gatik's box trucks always drive in the right-most lane and only take right turns. That's by design. Gatik restricts its vehicles to fixed, repeatable routes to eliminate as much uncertainty from their routes as possible. And staying in the right lane helps Gatik avoid changing multiple lanes and unprotected left turns, the latter of which is one of the harder maneuvers for autonomous vehicles. Gatik also avoids routes that drive by fire stations, hospitals and schools due to unpredictability.

Gatik has raised \$114.5 million to date, including an \$85 million Series B round in August 2021 and a \$25 million Series A in November 2020. It also recently expanded its testing into Texas.

Narang was a guest on The Robot Report Podcast back in June 2020. Clearly, a lot has changed for Gatik since then. But Narang discussed how the company landed its partnership with Walmart while in stealth mode, its hybrid approach to Level 4 autonomy, restricting its vehicles to the right-most lane and more. We also discussed the changing investment landscape around autonomous vehicles and why Level 5 autonomy is at least 10-15 years away, if it can even be solved.
