O Christmas Tree: How Christmas trees came to be

With Christmas quickly approaching, many families are pulling out all the stops for their decoration plans. Houses are embellished with bright hanging lights, warm fireplaces, large stockings and arguably the most iconic holiday accessory of all: the Christmas tree.

But just how did this concept come to fruition? How did we make a yearly tradition out of placing a Douglas Fir front and center in our living rooms and decorating it with colorful ornaments and streamers?

The history of Christmas trees spans back before the birth of Christ. Ancient Greeks, Egyptians and Romans valued evergreen plants, as their ability to survive both scorching summers and frigid winters was seen as a symbol of prosperity. Plants such as pine, spruce and fir were often used to decorate homes during the ancient Roman agricultural holiday known as "Saturnalia." Centuries later, Celtic tribes and their Druid priests would decorate temples with evergreen boughs.

Christmas trees as we know it today, like many other western holiday traditions, began in Germany. It's speculated that in the year 723, English

Winter Solstice

Tuesday, December 21 marks the Northern Hemisphere winter solstice in 2021—also known as the shortest day of the year. A solstice occurs twice a year when the earth's poles reach their maximum tilt away from or towards the sun (i.e., winter or summer). On the winter solstice, the sun will also be at its lowest daily elevation in the sky. Regions near the North Pole will experience twilight during daytime hours where there sun never fully rises.

One of the most famous structures thought to mark the solstices is Stonehenge in England. For Neolithic farmers and herders, knowing when seasons would change was important, and winter was a harsh time. The huge blocks of stone that make up the circle of Stonehenge frame sunset on the winter solstice and sunrise on the summer solstice.

Many cultures around the world have holidays associated with the winter solstice.
Scandinavians celebrated Juul (Yule) by lighting fires to symbolize the return of the sun

Communication, Planning and Respect: Keys to Successful Holiday Gatherings

For many people, the ideal holiday season is filled with joy, cheer and time spent with families and friends. But sometimes the reality of the celebration is at odds with the vision. Family gatherings can sometimes provoke unwanted conflicts and arguments, and simple misunderstandings take on a life of their own.

And this year, "the holidays" are coated with a layer of anxiety resulting from the COVID-19 pandemic. "Many people have lost loved ones to the disease," notes Wajeeha Khan, MS, LMFT. "And we've all had to modify our lives to stay as safe as possible."

Planning a holiday gathering under these conditions may require an extra touch of care to create the loving atmosphere you want. "Anxiety and depression are breeding grounds for conflict," adds Khan, who is a marriage and family therapist at Washington Township Medical Foundation.

Khan offers five tips to help you navigate a conflict-free holiday get-together.

1. Plan ahead

Take the time to map out exactly how you'll spend your day together. Indoors or out? Masks on or off? Buffet or sit-down? Plan fun activities such as games, walking

or listening to updates from each person about something of importance to them.

"When creating a plan, show respect for your guests by asking them for their ideas," suggests Khan. Which games do they like? Would the kids like some time to themselves, away from the grown-ups? "Asking for input, especially from children, shows that you value their opinions and respect their choices," Khan adds.

You can't control what everyone says or thinks, but the more you can fill the time

with enjoyable things to do, the more you'll establish a relaxed atmosphere where people are comfortable being together.

2. Communicate

As in our daily lives, communication is key to minimizing conflict. "It's important to express your needs so the other person understands your expectations and doesn't try to second-guess you," notes Khan.

For a holiday gathering, this means saying aloud what you want from the day. If you're the cook, let specific guests know

if you'll need their help in the kitchen. For children, ask them if they'd like a separate "kids" table or if they'd like to sit with everyone. Do they want to get dressed up or stay in their pajamas all day? Children need less pressure this year, not more, so ease up on your expectations for them and let them choose what they want to do.

"If someone brings up a topic you know will provoke conflict," Khan advises, "try deflecting it by listening to them and then moving to a topic that is less charged." She also recommends using a technique called "active listening," where you consider how what you'd like to say would feel if you were on the receiving end of it. "When we learn how to listen to provide support, we learn a lot about the other person and their needs."

3. Break some traditions

This might be the year to break some of your standing holiday traditions and try something new.

If you're hosting a holiday meal, consider making it a potluck so you can spend more time with your guests. Suggest that everyone bring a gift for donating to a shelter. Or perhaps you have no gifts for adults and make a donation to a charity instead.

"People are feeling very anxious this year due to the pandemic," says Khan.

Make Wellness Part of Your Holiday Preparation

Maintaining a healthy weight during the holidays doesn't mean skip the fun foods.



There are many things to celebrate this holiday season, and good health is high on a lot of people's lists. But eating right and getting enough exercise can be challenging at this time of year. It is natural to want to treat yourself to the season's special offerings, and everyone has their favorites. Whether it is fudge, eggnog and seasonal lattes, or gingerbread cookies, the calories from all the treats can really add up fast.

"A healthy goal for most people is to maintain your current weight over the holidays," says Kevin Porciuncula, MD, a family medicine specialist with Washington Township Medical Foundation who is also board certified in obesity medicine and lifestyle medicine. "It is important to be realistic. At this time of year, trying to lose weight may not be practical."

Dr. Porciuncula points to a New England Journal of Medicine study that showed that over the Christmas and New Year period, people on average gain from one to just over a pound. "Although that doesn't sound like much, the study also showed that half of the people who gained weight had not lost it by the following summer."

For maintaining weight, Dr. Porciuncula says that exercise is key. "I tell my patients to make sure they continue their exercise routines throughout the holidays to help them avoid gaining weight."

Even if you do not work out regularly, there are lots of ways to fit in physical activity. Dr. Porciuncula encourages his patients to engage in a range of non-exercise physical activities to improve their metabolism—which is the rate at which a person burns calories. The medical term for this type of energy expenditure is non-exercise activity thermogenesis (NEAT). Everyday exertions like climbing stairs, walking, and even yardwork all contribute to NEAT. "Non-exercise activity thermogenesis can happen when we mow the lawn or walk around a mall. These commonplace activities can contribute to burning calories and maintaining weight," he says.

"Try to incorporate physical pursuits into the time you spend with family and friends. Activities like walks together can build memories just like holiday meals," say Dr. Porciuncula. "For myself, being around people I care about is the best thing about the season's festivities."

Dr. Porciuncula offers these simple suggestions for enjoying the holidays without overeating:

Be mindful and slow down: When you are eating, try to be aware of when you start to feel full. "I tell my patients to stop eating before they are full. You should aim to feel 70 or 80 percent satisfied. Twenty-minutes later, you may find that you have actually had enough. But if after waiting you still feel hungry, you can eat a little bit more."

Plan ahead and make a budget for foods higher in calories: No food or drinks should be entirely off-limits for calorie reasons. The trick is to keep your portions small for dishes that are highest in calories. Before a meal starts, make a plan that includes eating plenty of low-calorie vegetables to fill you up. If you are less hungry, you will be better able to manage what you eat during the rest of the meal. "The advice I give to my patients is to have an alcohol budget that they decide on in advance. Alcohol is high in calories and drinking too much can diminish your resolve to stick to your eating plan. Usually, two drinks is a good budget, but it depends on the person."

Drink plenty of water and get enough sleep: Staying hydrated and getting enough sleep are always good for your health. Sometimes thirst can be mistaken for hunger, and coupled with alcohol can lead to over-indulging. Being tired can make it harder to manage your blood sugar. The CDC warns that when you are sleep deprived, you crave foods that are higher in fat and sugar.


Avoid skipping meals: When you are really hungry, it is harder to eat slowly and in moderation. Try to come to a meal ready to eat, but not so hungry that you mindlessly devour everything put in front of you. The same is true for cooking foods that are high in fat and sugar. It is too easy to slip up by "tasting" what you are cooking again and again. Without

intending to, you may wind up consuming lots of extra calories.

Make time to exercise: The holidays can be stressful for some, and stress can contribute to overeating. Exercise reduces stress and burns calories. Dr. Porciuncula urges people to partake in any activity that gets them moving. NEAT activities such as dancing, caroling, and backyard games like Simon Says and Musical Chairs can be fun and social, and can help you maintain your weight.

The good news is that by planning ahead, being mindful of portion size, budgeting alcohol and sweets, and engaging in physical activities, you can keep from gaining weight. But, if you do put on a pound or two over the holidays, Dr. Porciuncula says, "Don't stress out about it. Keep the big picture in mind. The holidays should be about enjoying yourself and being with people you care about. You can work on taking off the extra weight in the months that follow."

O Christmas Tree: How Christmas trees came to be

missionary, Saint Boniface was traveling all over Germany to encourage locals to adopt Christianity. He supposedly came across a group of pagans who were about to sacrifice an oak tree to the Norse god of thunder, Thor. Boniface then swung an ax at the tree and to the pagans' surprise, Boniface was not struck by lightning for what was a blasphemous action in their eyes. This led to the idea that trees were sacred representations of the divine, and by the 16th century, Christmas trees were commonplace in Germany.

Many scholars also attribute Christmas tree decorating to Martin Luther, founder of the Lutheran faith and author of "95 Theses." It's said that while walking home one winter night, Luther drew inspiration from the sight of ice on pine trees reflecting the glow of the stars above. He and his children placed candles on their Christmas tree. This began a trend of local carpenters, sculptures and other artisans decorating Christmas trees with festive shapes and figurines. In 1847, German glassmaker Hans Greiner began producing and selling glass ball ornaments known as baubles as well as others in the shape of stars, food, and needles that made their way onto the limbs of Christmas trees.





Despite the success of Christmas trees in Europe, its integration into mainstream American culture was unheard of at first. Early Puritan-centered laws in the United States actually outlawed any celebration of Christmas that wasn't conducted in a church, which included the use of trees as decoration. However, the massive influx of German and Irish immigrants in the mid-1800s normalized the use of Christmas trees, and in 1889 Benjamin Harrison was the first President of the United States to erect a Christmas tree in the White House. Since 1933, the Rockefeller Center in New York City has had a 70 to 100-foot-tall Christmas tree erected during the holiday season with a Norway spruce typically serving as the star attraction.

The classic holiday song, "O Christmas Tree" also originated in Germany based on the 1824 song called "O Tannenbaum" written and composed by Ernst Anschütz. Nearly two centuries after its creation, the song has been famously covered by artists such as the late Aretha Franklin.

This holiday season, don't just gather around your Christmas tree and see another decoration, but rather look at how an uncanny and once-controversial symbol of evergreen life has evolved into the holiday icon we all know and love today.

"Trying something new or different may help us all emerge from this state and move ahead toward normalcy," she

4. Try compassion

This year, some family members may need more emotional support than usual, so let them have their space and set their own boundaries for togetherness. You can show your compassion by being in tune with what you and your guests need, not what you expect of them.

Or maybe you show your compassion for others by reaching out to people less fortunate than you - serving at a food

kitchen, for example, or handing out sandwiches at a homeless encampment. "For younger children, this is a good opportunity to model what compassion looks like," says Khan. "By setting an example, they learn how to express in action the love they feel inside.'

5. Consider COVID-19

The pandemic is not over. To keep you and your guests safe, you need to establish boundaries in advance for acceptable behavior related to COVID-19.

When you invite your guests, ask them if they've been vaccinated for COVID-19. If they have not, discuss with them how

you'll balance their status with that of other guests who have been vaccinated. Would they like to come over for dessert only? Will they agree to wear a mask except for when they're eating? Would they be willing to be tested before the gathering? Or would they like to skip the celebration entirely this year?

"You want to show your vaccinated guests that you care about them and their safety," Khan advises. "But you also should try to show some compassion for the people who have not been vaccinated. Listen to them and show you respect their decision by asking for their suggestions about how to keep everyone safe."

Enjoy

Finally, enjoy the day! Celebrate and cherish your time together. By balancing everyone's needs, making compromises and setting realistic expectations, you'll get closer to that ideal vision of what the holiday gathering should be.

Zero Emission Transit Bus Technology

AC Transit has released the second version of our Zero Emission Transit Bus Technology Analysis (ZETBTA) study. This report tracks greenhouse gas emissions, cost per mile, fleet availability and other intelligent data spanning January through June 2021.

ZETBTA is a robust side-by-side evaluation of the predominant bus technologies in use at transit agencies worldwide: fuel cell electric bus (FCEB), battery electric bus (BEB), diesel hybrid, and conventional diesel bus propulsion systems. The initial version of our groundbreaking study was

released in July 2021. Our testing data sets are forecasted for public release every six months.

The study's data is reliable because it is captured from a control fleet using the same 25 buses, then reinforced through academic evaluation by scientists at Stanford University's Precourt Institute for Energy. 

Not-so-great resignation

We Americans pride ourselves for not being quitters. Yet, quitting seems to be the trendy thing to do in 2021. Since the pandemic hit, millions of Americans have bid their jobs a not-so-fond farewell. Some experts foresee that this trend might continue through next year. Various explanations have been offered for this mass departure, including stimulus checks, fear of contracting Covid, and a re-assessment of the meaning of work.

Certainly, a large proportion of parents (particularly mothers) have had to leave their jobs to tend to their children. In addition, front-line workers have had to work under extraordinary pressure and this had led to burnout and quitting. It is perhaps unsurprising that parents and front-line workers have been bowing out of the workforce.

However, these are not the only demographic groups quitting work. It is intriguing that all levels of work have been touched by this phenomenon, from entry-level to highly skilled professional jobs. Indeed, highly-paid, mid-career

professionals are one group of workers that have quit their jobs in record numbers. According to Harvard Business Review, resignation rates are highest among mid-career employees.

Gallup has a succinct explanation for this exodus - beneath the "Great Resignation" is the "Great Discontent." According to Vipula Gandhi and Jennifer Robison of Gallup, "It's not an industry, role or pay issue. It's a workplace issue." Findings from the Gallup poll are revealing - those who are "not engaged" and "actively disengaged" have the highest rates of leaving their jobs. What this tells us is that a healthy workplace culture and excellent management are critical in retaining employees. During the initial stages of the pandemic, the ways in which management handled employee stress and the challenges of the pandemic were telling indicators of the health of the workplace as well as the well-being of the employees.

Did the CEO take the time to ensure that the employees felt safe, or was it a "business as usual" approach that showed zero concern for the stressors of the pandemic? Were there provisions made for parents who suddenly had to homeschool or be their own home-based daycare provider, or was there dead silence on the matter? Did HR step in to make sure that workers had the equipment to work comfortably from home or were you left desperately trying to cobble together a new Ikea work desk? Were there fun events planned so that people still felt connected to each other at work, or were you marooned at home feeling like you were working in a homey silo? Were workers' concerns taken seriously when it came to returning to in-person work, or did management leave a vacuum of silence around employee worries?

The way companies managed the pandemic directly affected how employees felt about their work. Poor management around this issue resulted in people leaving their jobs. Indeed, the astounding number of people quitting indicates how many companies failed in their response to the crisis. Studies have shown that some of the common reasons employees stated for quitting during the pandemic were poor management, feeling unvalued by their organizations, and lacking a sense of belonging. Each of these reasons could be filed under the category of "employee disengagement."

Interestingly, a Gallup poll has shown that "it takes more than a 20% pay raise to lure most employees away from a manager who engages them, and next to nothing to poach most disengaged workers." Simply put, an engaged employee will be more likely to stay and a disengaged employee will be very likely to leave.

There has been tremendous fallout from the Great Resignation. Those who did not participate in the Great Resignation have had to double down on working to cover for absent co-workers. These loyal workers are now being rewarded with extra work and pressure. Employers are now racing to fill vacant positions; some have offered incentives such as sign-on bonuses. At the same time, hiring managers are also nervous about onboarding a candidate who might not stay for very long. Meanwhile, the Great Resignation continues and shows no sign of ending yet. So, stay tuned for my next column where I will cover some strategies to handle the fallout from the Great Resignation.

Housing navigation center sees success

In just over two years of operation, City of Hayward's Housing Navigation Center has moved nearly two-thirds of its formerly homeless residents into permanent housing, all the while weathering the COVID-19 pandemic.

Since its opening on November 18, 2019, 153 people have exited the Navigation Center, with 98 of them -- or 64% -- moving directly into permanent housing. Located at the intersection of Whitesell Street and Depot Road, the center provides immediate shelter, nutrition, intensive case management and housing navigation services to homeless adults.

Under its original configuration, the center provided short-term housing for 45 people at a time in dormitory settings with one meal a day, on-site restroom, shower, laundry and kitchen facilities, and intensive case management geared toward longterm housing placements.

Because of COVID-19, it was necessary to decrease operational capacity from 45 beds in two residential trailers to a total of 25 beds. In June 2021, capacity was increased to 33 beds through the addition of a third residential tailer.

French support

In September and October of 1777, the colonial army -- comprised mostly of farmers and tradesmen -- unexpectedly overwhelmed three of England's professionally trained armies at the Battle of Saratoga.

Benjamin Franklin, meanwhile, was in France soliciting support for the Revolution, which was now easier after surprise victories. Two months later, France became the first foreign government to institute diplomatic relations with America, even though the colonies would be entangled in war

According to History.com Franklin had already endeared himself and colonial America to the French nation: "Franklin, who often wore a fur cap, captured the imagination of Parisians as an American man of nature and his well-known social charms stirred French passions for all things American. He was the toast of Parisian society, enchanting salons with his wide-ranging knowledge, social graces and witty repartee."

The 'King' enlisted

Elvis Presley was a worldwide celebrity -- the "King of Rock-and-Roll" -- until December 20, 1957. On that day, Uncle Sam "appeared" with a draft notice. Presley received the news, soberly, declined the opportunities for choice assignments, and served as a "regular" GI. As he put it:

"People were expecting me to mess up, to goof up in one way or another. They thought I couldn't take it and so forth, and I was determined to go to any limits to prove otherwise. Not only to the people who were wondering but to myself."

The induction notice was a notice of mandatory enlistment in the armed services -- a law inaugurated in 1917, and rescinded in 1973, when the U.S. reverted to an all-volunteer military.

Christmas poetry

Clement C. Moore was a Hebrew scholar, and professor of Asian and Greek literature at the General Theological Seminary in Manhattan. He was also the son of Benjamin Moore, president of Columbia University, and the Episcopal bishop of New York. The elder Moore participated in the inauguration of George Washington and administered the last rites to Alexander Hamilton after his deadly duel with Aaron Burr.

Meanwhile, Benjamin's son, Clement, a relatively obscure poet, unearthed his muse on the night of December 24, 1822. While riding a horse drawn sleigh in the snow-covered streets of Greenwich Village, Moore wrote an ode, with the intent - only -- of amusing his six children, but the poem "A Visit from St. Nicholas" -- morphed into a classic called "The Night Before Christmas."

"'Twas the night before Christmas, when all through the house Not a creature was stirring, not even a mouse; The stockings were hung by the chimney with care, In hopes that St. Nicholas soon would be there; ..."

The Grateful American Book Prize recommends "The Poet of Christmas Eve, a Life of Clement Clarke Moore, 1779-1863," by Samuel White.

Efforts to protect the ozone layer paying off

Dear Earth Talk: Has anyone calculated the positive health and/or economic impacts of international efforts to protect the stratospheric ozone layer beginning in the late 1980s?

The 1987 Montreal Protocol, a landmark international agreement calling on the nations of the world to ban the production and distribution of man-made chemicals that deplete the stratospheric ozone layer, has been billed as one of the greatest examples of international cooperation to date. And while everyone party to the Montreal agreement agreed that the substance of the treaty -- banning so-called chlorofluorocarbons and related ozone-stripping chemicals -- was a big win for the environment and human health, we have had no idea how to quantify just how many lives have been saved or improved as a result.

Until now, that is. Researchers from the National Center for Atmospheric Research (NCAR), ICF Consulting, and the U.S. Environmental Protection Agency (EPA) found that the Montreal Protocol and its subsequent amendments will have prevented some 443 million cases of skin cancer and 63 million cases of cataracts in the U.S. alone by the end of the 21st century. They used computer models to plot how much ultraviolet (UV) radiation would have reached the Earth's surface through holes in the ozone layer without the ban on CFCs and other fluorocarbons, extrapolating from there.

"We peeled away from disaster," NCAR scientist Julia Lee-Taylor, a co-author of the study, told ScienceDaily. "What is eye popping is what would have happened by the end of this century if not for the Montreal Protocol." According to projections

from the researchers' modeling, without the agreement, UV radiation would triple by 2080. "After that, our calculations for the health impacts start to break down because we're getting so far into conditions that have never been seen before.'

"It's very encouraging." she added. "It shows that, given the will, the nations of the world can come together to solve global environmental problems."

Indeed, recent attempts to forge a global carbon drawdown have the potential for perhaps even bigger health impacts for the human race (and others) moving forward. The World Health Organization (WHO) considers global warming the greatest health threat ever facing humanity. This United Nations-backed international body charged with directing and monitoring global public health initiatives expects climate change to cause 250,000 additional deaths per year from a combination of factors including malnutrition, malaria, diarrhea and heat stress. Additionally, global warming will end up tacking some \$2-\$4 billion per year onto our global health care bill. And sadly, but not surprisingly, lesser developed countries and regions will fare worse given their weaker health infrastructures.

Indeed, the success of the Montreal Protocol and the urgency of the climate crisis provide all the reasons we need to encourage the leaders of the United States and other nations around the world to forge ahead with the strongest possible international climate agreement with binding and meaningful emissions reduction targets. Our future may very well depend upon it.



The end of December is a quiet time in the East Bay Regional Parks, but there are still nature-themed programs you can enjoy during the holidays.

Winter shorebirds are the focus of a bird-watching walk from 8 a.m. to 10 a.m. on Thursday, December 23 at Elsie Roemer Bird Sanctuary in Alameda. Beginning birders are welcome; bring your own binoculars. This is a free, drop-in program; registration is not necessary. Meet naturalist Susan Ramos at the sanctuary, at the intersection of Broadway and Shoreline Drive. For information, call Crab Cove Visitor Center at (510) 544-3187.

Although it is closed on December 24 and 25, Crab Cove Visitor Center will be open from 10 a.m. to 4 p.m. on Sunday, December 26. The center has a large aquarium, photos and artifacts from Alameda's history, and a California Coast and Ocean Amateur Photography exhibit. Entry is free and registration is not required. Watch the staff feed the aquarium fish between 3:00 p.m. and 3:30 p.m.

It may be the holiday season, but the animals at Ardenwood Historic Farm in Fremont still need to eat. You can help check for eggs and bring hay to the livestock during a program at Ardenwood from 3:00 p.m. to 3:30 p.m. on Thursday, December 23. The program is disabled-accessible, drop-in, and no registration is required. Ardenwood admission fee applies. Meet at the granary. The program repeats at the same time and place on Friday, December 31.

Besides feeding the livestock, there's lots to see and do at Ardenwood. Check out the tours of the Patterson House, a restored Victorian-era mansion, or the pollinator puppet show from 11:00 a.m. to 11:30 a.m. and the corn husk doll craft session from 12:30 p.m. to 2:00 p.m., both on Sunday, December 26.

Nearby at Coyote Hills Regional Park, you can join "Discovery on Demand," a range of hands-on, nature-themed activities for all ages. Cosmic light polarization and the universe

Imaging X-ray Polarimetry Explorer (IXPE), is a space observatory with three telescopes designed to measure the polarization of cosmic X-rays of the Explorer program. Each system operates independently for redundancy and comprises a 4 m (13 ft) focal length mirror module assembly that focuses X-rays onto a polarization-sensitive imaging detector. The observatory, which was launched on December 9, 2021, is an international collaboration between NASA and Italian Space Agency (ASI).

The mission will use light polarization to study magnetic fields of various astronomical objects such as black holes, neutron stars, pulsars, supernova remnants, magnetars, quasars and active galactic nuclei. Light polarization is a property of light waves that depicts the direction of their oscillations. Polarized light vibrates or oscillates in only one direction. This is in contrast to a nonpolarized light that vibrates in many directions.




Illustration of NASA's Imaging X-ray Polarimetry Explorer (IXPE)

The high-energy X-ray radiation from the object of interest's surrounding environment can be polarized – vibrating in a particular direction. Studying the polarization of X-rays can help us better understand the science behind these objects and can provide more insights into their high-temperature environments and where they are created, in support of

NASA's first science objective in astrophysics: "Discover how the universe works."

The spacecraft for the IXPE mission was built by Ball Aerospace & Technologies. While NASA was the primary space agency to drive the mission, Italian Space Agency (ASI) committed to providing X-ray polarization detectors.

The IXPE mission was launched on December 9 on a SpaceX Falcon 9 (B1061.5) from LC-39A at NASA's Kennedy Space Center in Florida. The IXPE orbit is set hugging the equator and is designed to operate in an almost exactly equatorial orbit with a 0° inclination. This is done to minimize the X-ray instrument's exposure to radiation in the South Atlantic Anomaly, the region where the inner Van Allen radiation belt comes closest to Earth's surface.

The IXPE mission is designed to last at least two years and the estimated cost of the mission and its two-year operation is \$188 million, with the launch cost alone set at \$50.3 million.

Kwanzaa celebrates community traditions and values

As the last hectic weeks of December wind down and Christmas and Hanukkah events end, many people look forward to one final celebration to close out the year:

An African American and Pan-African holiday with no religious affiliation, Kwanzaa instead celebrates the universal values of family, community and culture. The word Kwanzaa itself is adapted from a Swahili phrase for "first fruits." It is celebrated each year from December 26 through January 1.

This year's worldwide Kwanzaa theme is "Practicing Kwanzaa and the Seven Principles: Ensuring the Well-Being of the World."

For each of the seven days of Kwanzaa a different principle of life is celebrated and is called Nguzo Saba. The seven principles focus on the elements of African culture which contribute to building and maintaining community values among African Americans. They include:

- Umoja (Unity)
- Kujichagulia (Self-Determination)

- Ujima (Collective Work and Responsibility)
- Ujamma (Cooperative Economics)
- Nia (Purpose)
- Kuumba (Creativity)
- Imani (Faith)

Each of the seven symbols is represented by colored candles on a holder called a kinara, often used as a centerpiece during daily celebrations. On the final night of Kwanzaa, the event is completed with a feast, called a Karamu followed by gift-giving. A universal theme is, "It takes a United Village to Strengthen Family and Community."

While the traditions and principles of Kwanzaa aren't new, the formal weeklong event started in 1966, marking its 55th anniversary this year. Developed by Dr. Maulana Karenga, a professor of Africana Studies at California State University, Long Beach, the idea was to promote and preserve African culture throughout the world.

Kwanzaa celebrations started slowly in the United States, but over the years expanded throughout the nation and eventually to Canada, the Caribbean,



England, and Africa. Today, it's estimated that more than 20 million people celebrate the event. Starting in 1997, the U.S. Postal Service issued its first Kwanzaa commemorative stamp. New stamp designs were also issued in 2004, 2009, 2011, 2013, 2016 and 2018.

In the Bay Area, several Kwanzaa events are planned:

• MoAd Museum of the African Diaspora in San Francisco will hold its 16th annual Kwanzaa Celebration in partnership with The Village Project from 3:00 p.m. to 4:30 p.m. Sunday, December 26 on the first day of Kwanzaa. The outdoor and in-person event will include a live poetry reading in the Golden Gate Music Concourse, featuring Daniel B. Summerhill, Tiffany Banks, James Cagney and Tyanna Braswell. Admission is free. For details, visit the museum website at www.moadsf.org/.

Local Olympic Athletes recognized

"It's really incredible that some of the top ranked players in table tennis are from Assembly District 25, and really putting American table tennis on the map," said Assemblymember Alex Lee. "Our athletes are making our country and the Bay Area proud of their athletic achievements."

Kanak Jha from Milpitas who also competed in the Olympics was unable to join the event, but also received recognition from Assemblymember Lee.

Table tennis is currently one of the fastest growing sports in America and is both a physical and mental sport that stimulates the brain while improving hand-eye coordination. The low risk of injury means table tennis can be enjoyed by people of all ages and all fitness levels.

Spruce up the yard with a conifer

The first whales evolved from a four-legged hoofed land mammal called an artiodactyl about 50 million years ago. The closest land animal related to a whale is the hippopotamus. While whales share ancestry with camels, giraffes, cows, and pigs, one might never know by looking at them. Conifers are another great example of similarities below the surface. The family includes redwoods (the tallest trees), Bristlecone pines (the oldest living trees), and Giant Sequoias (the largest trees by three-dimensional volume.)

Conifers are primarily cone-bearing trees, but include some shrubs. Some are deciduous, flat scale-like leaves, but most are evergreen, which have needle-like foliage. Some grow tall and upright, while others spread out and mature at a medium height, and others grow low and flat to the ground. The majority range from dark to bright green foliage. However, a number have foliage that changes color when weather gets cold. Non-green colors include tones of silver, blue, purple, maroon, yellow, gold, bronze, pink and red.

The name conifer is derived from the Latin words conus (cone) and ferre (to bear). Each conifer has the ability to produce woody cones that contain seeds. Some conifers produce cones that mature in three to four months, while others take three to four years. Seeds are dispersed by either a cone that opens up and releases seeds to the wind, or a cone that falls to the ground and needs to biodegrade. Seeds can also be spread by animals that eat the

cones. In a few types of conifers, seeds can only be liberated after the cone burns in a forest fire.

There are hundreds of species of conifers throughout the world. Some are not suited for the Bay Area's climate. However, many are. Below are six types of local conifers and some of the more interesting specimens of the group.

Pines are one of the most iconic Christmas or Holiday trees. The pine family is the largest family of conifers, and many different species can be seen throughout the Bay Area. The Bosnian pine is an interesting variety. They are native to Italy, Greece, and mountain areas of the Balkans. They are large attractive trees with dark green needles and ash grey bark that can get over 30 feet tall. They produce colorful purple cones that mature to brown.

Redwood forests are found today only in California and a small area of southern Oregon. Redwood trees are dotted throughout Bay Area landscapes, mostly Costal Redwoods. There are far fewer Dawn Redwoods, but that does not mean they are not an interesting choice to grow. Dawn Redwoods were only known from fossil records dating back to dinosaur times up until the mid-1900s, when some were discovered in a remote valley in China. The seeds were collected by an arboretum and today they are grown all over the world. They are the only redwoods that lose their leaves in the winter.

Cedars and false cedars are common coniferous trees seen growing locally.

Many are majestic trees that have much



shorter needles than pines. Some mature to the height and width of a large shrub. Atlas cedar and Dwarf Blue Atlas cedar are two attractive choices because of their silvery blue needles.

Spruce trees are members of the pine family. They differ from other pines and conifers in that their thin pointy needles spiral around the tree's branches. There are a number of spectacular blue varieties that range in size and form. Names such as "Baby Blue," "Fat Albert," and "Slenderina Weeping Blue" make it easy to choose a tree.

Green Juniper trees, shrubs, and groundcovers were so widely used in the 1970s that many people find them boring when used in a landscape today. However, that is because they do not know of the over 400 different Juniper cultivars available. They have been bred for exciting colors, a slower growth rate, and compact



sizes. "Icee Blue" is a blue groundcover that turns purple if the temperature gets cold enough. "Sea of Gold" is a four-foot shrub that has golden-yellow foliage. Other exciting foliage colors. include bronze, white and pinkish red.

Thujas, commonly known as arborvitaes, are coniferous trees and shrubs native to North America and Eastern Asia. The most commonly used thujas throughout the Bay Area have green or yellow foliage. However, in recent years there have been many cultivars developed that offer a wider range of colors. "Ember Waves" has lacy flat foliage that transitions from green to gold with red tips when cooler weather arrives. "Pancake" has sage green foliage that changes to bright blue in winter. "Fire Chief's" bright gold needle tips slowly turn pink in the summer and deepen to red in the fall.

There are some common and not so common conifers growing throughout the Bay Area. Growing additional ones can further spruce up the region.



Ilm Academy Donation

Since the school's founding in 2010, students of Ilm Academy in Fremont have given back to the community by donating to the fire department, homeless residents, and Syrian refugees. On Friday, December 17, they held an assembly to present donations to Afghan refugee families. This effort was in collaboration with nonprofit Al-Misbaah foundation. PTA member Rizwana Khan, Principal Shazia Khanam, teachers, parents, and students in Kindergarten through 9th grade worked to make this event happen.

At Friday's assembly, Student Council President Aleena Khan also spoke about the academy's recycling efforts, and Michele Rahmani (9th grade) shared about the school's blanket drive for Afghan refugees and the homeless community in Fremont.

Local government representatives present were Fremont Mayor Lily Mei, Vice Mayor Raj Salwan, Homeless Response Manager Laurie Flores; and Muslim leaders in the community—Saleem Akhtar, President of the Islamic Center of Fremont, and Shaikh Yasir Khan, Founder of Al-Misbaah Organization.

Donation boxes collected by students and their families contained basic cooking supplies such as Afghan Green Tea, sugar, salt, oil, rice, and lentils; as well as care items like toilet paper, body wash, shampoo, and blankets. Shaikh Yasir Khan spoke on the great need among newly-arrived refugees: "Families are dropped off in empty homes; they don't own a toothpick, let alone anything to sleep on. They're dropped off in winter months... no bedding, no furniture, literally sleeping on the floor. No baby formula, no diapers, anything." His organization is settling anywhere from 40-120 families per week.

Haroon Qureshi (9th grade), spoke on the importance of giving. "This is essential to us to be a Muslim but also to be a human. Let's be honest, if we





can look out at others and see their suffering and we don't feel empathy for them, we don't do anything to care for them, how do call ourselves human?"

Mayor Mei said, "This holiday season when you're out there and hopefully celebrating the blessings that you have and the riches that you enjoy with your families, and your faith, I ask that you continue to do so by sharing the love, care, and kindness for our community by giving of your time and your heart... I commend all of you because it's a lesson that's never too easy to but one that will continue life long."



Instagram launches tool urging teens to take a break

Instagram on Tuesday, Dec. 7 launched a feature that urges teenagers to take breaks from the photo-sharing platform and announced other tools aimed at protecting young users from harmful content on the Facebook-owned service.

The previously announced "Take A Break" feature encourages teens to stop scrolling if they have been on the social media platform for a while, Instagram head Adam Mosseri said in a blog post. It rolled out to the U.S., United Kingdom, Ireland, Canada, New Zealand and Australia on Dec. 7 and would reach the rest of the world early next year, he said.

Young users will see notifications about the feature and be urged to set reminders to take more breaks going forward, the post said. It's one of the efforts that Facebook, renamed

Meta Platforms, has touted on its platforms as it weathers backlash about not doing enough to rein in harmful content and faces new legislation looking to impose restrictions on tech giants.

Former Facebook product manager turned whistleblower Frances Haugen has testified to U.S. and European lawmakers working on those measures, citing internal company research suggesting that peer pressure generated by Instagram has led to mental health and body-image problems in young users, especially girls, and in some cases, eating disorders and suicidal thoughts.

She spoke again in early December to Congress, urging U.S. lawmakers to move forward with proposals introduced after her first appearance in October. That includes restrictions on the long-standing legal protections for speech posted on social media platforms.

Haugen also has offered guidance on new online rules that are much further along in the U.K. and European Union, which has pioneered efforts to rein in big technology companies.

On Tuesday, Dec. 7 Instagram also announced that its first tools for parents will roll out early next year, allowing them to see how much time their teens spend on Instagram and set time limits.

The social media platform also said it's developing features that will stop people from tagging or mentioning teens that don't follow them, nudge young users to other things if they have been focused on one topic for a while and be stricter about what posts, hashtags and accounts it recommends to try to cut down on potentially harmful or sensitive content.

Council endangers access to parks

Parks and open space have proven to be essential for public health during the pandemic, because access to nature is a palliative and soothes our spirits. Park usage has surged across the United States and in the SF Bay area. But the lack of parking has proven to be a significant problem according to a scientific survey completed by the Fremont Community Services Department.

Vargas Plateau Regional Park has just 25 parking spaces, down from the planned 60-100 spaces. Two landowners filed suit against EBRPD on the pretext of public safety and eliminated two thirds of the parking spaces. When full, visitors park on a nearby county road but the Alameda County public works department has restricted some roadside parking. Perversely, a large event center constructed by one of the landowners at the end of Morrison Canyon Road has parking for more than 75 vehicles. It hosts groups of upwards of 150 for private and corporate events. Several years ago, the city closed Morrison Canyon Road to through traffic given the financial liability proven by the EBRPD lawsuit. But in lower Vargas Plateau, the only available parking is near residents' homes. The opportunity to expand parking exists but requires the conversion of surplus city properties into a local park with limited parking.

Coyote Hills Regional Park parking lot often fill up on weekends, forcing visitors to park on nearby streets. Mission Peak

Regional Preserve has just 42 parking spaces and street parking is restricted to 150 spaces on weekends. EBRPD operates 900 acres at Mission Peak, which are city-owned. But the city council recently declined to approve the 25-year lease extension. One councilmember criticized EBRPD for offering 42 free parking spaces. This is the same council that voted to give away 1,000 public parking spaces, by issuing free parking permits to residents for parking they neither need nor use.

During 2020, the city hired three community service officers, to hand out additional parking tickets at a cost of \$360,000 a year. They billed the new hires, falsely, as being revenue-neutral, because their total compensation was supposed to be covered by parking fines. To boost revenues higher, the city hiked parking fines by 19% in fall 2021, and 30% higher for violations of the parking restriction program. But only \$98,000 in parking tickets have been handled out near Mission Peak. To cover the ensuing financial gap, more parking tickets will have to be handed out in the coming year. The New Year will be costly for motorists in Fremont.

Regional parks are a public asset which offer access for all, rich and poor. They must be cherished, and protected from the one-sided, short-sighted policies espoused by the city council.

COVID-19 practices during winter closure

Winter break for our schools, students, staff and families is just around the corner. We appreciate that the happiest holidays include spending time with family and friends, and we want to ensure you enjoy a healthy holiday season.

As you prepare to celebrate, please be reminded that COVID-19 cases are on the rise in Alameda County, and the highly transmissible Omicron variant is making its way to our communities. We recommend multiple layers of prevention and protection that work together to keep your family - and our school environments safe and healthy.

Get vaccinated: Use winter break to get vaccines for you and your children. Vaccines have been authorized for 5-15 years-olds, and fully approved for ages 16 and older. More than 60,000 children in Alameda County in the 5 to 11 age group have already received their first dose of COVID-19 vaccine. Children are much less likely to experience side effects from the vaccine.

Get boosted: Boosters are widely available and strongly recommended for anyone who has already received two doses of the Pfizer or Moderna vaccines at least 6 months ago or the Johnson and Johnson single dose vaccine at least 2 months ago. Emerging data show that a booster dose improves the body's immune response to the virus that causes COVID-19, helping to prevent serious illness.

Wear a mask: Alameda County and the State require currently masking in all indoor spaces regardless of vaccination status. It is one of the most effective ways to stem the spread of COVID-19, not to mention the flu and other respiratory illnesses.

Get tested before traveling, gathering and returning to school: Get tested 1-3 days before a family gathering, or travel plans, even if you have no symptoms. Make a plan to seek out a COVID-19 test before you return to school after the break, whether it's a testing site, pharmacy, a home antigen test or your child's school district offering testing opportunities. If you're traveling out-of-state, follow other state and federal travel requirements and recommendations.

Take exposure seriously: If you've had close contact with someone who has COVID-19 or if you have symptoms of COVID-19, get tested right away. You should also get tested 5-7 days after exposure, even if you don't have symptoms or are fully vaccinated. Unvaccinated people and anyone with symptoms should stay home. Everyone should wear a mask for 14 days following exposure or until your test result is negative.

Stay home if ill: What applies for school also applies to family and social gatherings. No party is worth potentially spreading COVID among those you care about.

The pandemic has created significant challenges for our schools and our families over these past nearly two years. But we are much better equipped to keep our communities safe and healthy than we were back in the early months of 2020. We now know better and can do better. We hope that your winter break is full of celebration, meaning and good health

Jill Biden: being first lady is 'harder than I imagined'

Jill Biden says being first lady "is a little harder than I imagined." She tells "CBS Sunday Morning" in an interview set to air this week that her new role is a 24-hour undertaking and not the kind of job that ends at a certain hour.

"I think it's a little harder than I imagined," the first lady said after being asked if she was prepared for what her new life would be like. "It's not like a job that you do, it's a lifestyle that you live, and it's not something you leave at 5:00 or at 3:00. And it's 24 hours a day.'

In the interview, Jill Biden also scoffed at speculation about President Joe Biden's mental fitness and said she understood why he cut a proposal for free community college from a major social welfare bill he's trying to get Congress to pass.

Her observation about being first lady all the time comes from someone who has lived most of her adult life in the public eye and has watched -and worked with -- some of her predecessors.

Joe Biden was already a public figure, a U.S. senator from Delaware, when they married in 1977. Jill Biden campaigned for and with him during his many Senate reelection bids and his three campaigns for president. When Joe Biden was vice president to

President Barack Obama, Jill Biden and first lady Michelle Obama worked closely together on military family issues.

Asked about dropping the community college proposal, Jill Biden sounded like her husband when she said: "I understand compromise. And I knew this was not the right moment for it." She is a veteran community college professor who still teaches as first lady. She held out hope that her longtime advocacy for free tuition at these schools will pay off in the future.

President Biden dropped free community college and other proposals from the bill in an attempt to make the it more palatable to Democratic senators who had said they were uncomfortable with its original size.

The president, the oldest officeholder at age 79, has been the subject of unrelenting social media memes and comments from political opponents suggesting he is mentally unfit for office. His wife, who is 70, said polls questioning his mental fitness are "ridiculous."

President Biden joined a portion of the interview at the White House and was asked about sharing the experience with his wife of 44 years. "I'm a lucky man," he said. "Jill is the life of my love and the love of my life."

The victim said he had an ongoing dispute with this neighbor, and this was not the first time the neighbor had tried to run him over. Officers located surveillance video of the incident, which showed the victim was struck six times.

Homicide detectives took over the investigation and obtained an arrest warrant for the suspect. On December 8, detectives contacted Roseville Police Department, near Sacramento requested they check an address for the suspect vehicle. Roseville PD located the suspect vehicle and towed it to where FPD Crime Scene Investigators could inspect it for evidence. The next day detectives determined the location of the suspect and asked Sacramento Police Department for assistance. They arrested the suspect, identified by police as Aqweel Khan, 45, of Fremont in the City of Mather. He was arrested on charges of attempted homicide and assault with a deadly weapon, and taken to Fremont for interviews.

WHAT'S HAPPENING'S TRI-CITY VOICE

Detectives noticed Khan's appearance was similar to a police sketch made of an unknown suspect in an unprovoked battery investigation from an August 26, 2021 incident, at Central Park in Fremont. During that incident, a suspect yelled and cursed at a female victim in English and Hindi, then punched the female in the face multiple times and threw her phone into the lake. Detectives had been investigating the incident as a felony battery while also exploring the possibility of a hate crime charge. Detectives questioned Khan regarding the Central Park battery and obtained a full confession.

The case was turned over to the District Attorney's office on December 13 with various charges being filed including premeditated attempted murder, assault with a deadly weapon with great bodily

injury. An assault charge with a hate crime enhancement was also filed in connection with the August 26 incident. Kahn is being held without bail at Santa Rita Jail. Police said this is the sixth hate crime reported in Fremont during 2021.

Arrest made in shooting at Tesla

A 29-year-old Milpitas man has been arrested and charged with murder in the shooting death of a co-worker in the parking lot of the Tesla auto assembly factory in Fremont.

In a December 14 statement released by Fremont Police Department (FPD), the incident occurred at about 3:26 p.m. Monday, December 13 when Fremont firefighters responded to a medical call at the factory. Upon arrival, they found an unresponsive man suffering from a visible wound. They suspected the man was a victim of a violent crime and called police. Shortly after officers arrived, it was determined the man had a least one gunshot wound. He died a short time later at the scene. Investigators recovered several expended .223 rifle casings nearby.

FPD homicide investigators learned the victim and had just finished a shift at Tesla and was shot in the parking lot as he left. Within several hours, detectives developed leads on a suspect, later identified by police as Anthony Solima, who also worked with the victim and that they had been arguing earlier in the day, and that the suspect had suddenly walked off the job.

Solima was located by FPD detectives at 8:42 p.m. in Milpitas who began a surveillance. At 11:16 p.m.

homicide detectives, armed with arrest and search warrants, arrested Solima as he exited his vehicle. A loaded, non-serialized, .223 caliber, short-barrel rifle was inside Solima's vehicle, along with an expended casing.

Solima was initially interviewed at Fremont Police Department, then later booked at Santa Rita Jail on suspicion of homicide. Police said there are no other suspects and they don't believe there is any risk to the community. Local media identified the victim as Lee Brasier, 42.

Solima was formally charged with murder and possession of an assault weapon on December 16 at East County Hall of Justice in Dublin. Additionally, several enhancements were added to the murder charge including lying in wait, intentional discharge of a firearm causing death and personal use of a firearm. He is being held without bail at Santa Rita Jail.

Meanwhile, an investigation is continuing and police are asking that anyone with information or who may have recognized Solima from the day of the shooting to call them at (510) 790-6900 or send an email to Detective Gebhardt at mgebhardt@fremont.gov. Alameda County Supervisorial Districts Approved

SUBMITTED BY ALAMEDA COUNTY

On Tuesday, December 14, Alameda County Board of Supervisors concluded the 2021 redistricting process by adopting its final map.

As required by the FAIR MAPS Act, over the last six months, the Board engaged the public and accepted community input in multiple formats, including online comments, "Community of Interest" drawings, emails, letters and maps proposed by the public. Staff utilized a variety of outreach methods throughout the County, including direct engagement through trusted messenger

leaders and organizations, social media, ethnic media, and presentations to all of the County's Municipal Advisory Commissions. Hundreds of Alameda County residents provided input, all of which remains posted on the website: redistricting2021.acgov.org.

The adopted map united the following Communities of Interest (which had previously been split):


- Centerville (Neighborhood in Fremont, home to one of the largest Afghan communities in the United States, now fully represented by District 1)
- Sunol (Unincorporated Area, now fully represented by District 1)
- Ashland (Unincorporated Area, now fully represented by District 4)
- Fruitvale (Neighborhood in Oakland, now fully represented by District 3)
- Glenview (Neighborhood in Oakland, now fully
- represented by District 5)
 Dimond (Neighborhood in Oakland, now fully
- represented by District 5)
 Laurel (Neighborhood in Oakland, now fully
- represented by District 4)
- Palomares Road (In the Unincorporated Areas, now fully represented by District 4)

Throughout the course of eight public hearings, most of the discussion from the Board and the public focused around whether communities were better served with one or multiple representatives. The Board received conflicting testimony from the public.

"Having all the unincorporated residents in one district simply does not serve them better because the growing disparities that so many face within our County are often amplified within the Unincorporated Area. These residents are best served when they have more than one elected voice on the Board of Supervisors," said Supervisor Nate Miley.

"The new map reflects the values of this county. The County's core function is to address poverty through health and human services. Redistricting is a constitutionally required process for equal and fair representation. My focus throughout the process was to ensure the pockets of poverty in our County were fairly represented," said Supervisor Richard Valle.

These maps will be in effect for the next 10 years.

Safely storing guns

Safely storing guns can help prevent tragedies, including suicides. In the moment of a mental health crisis, more time and space between a person and a gun can make all the difference. Taking a few moments to safely store firearms can give a person acting on impulse time to change their mind and get the help they need.

Recognizing that suicide is impulsive and preventable, County of Santa Clara Behavioral Health Services Department (BHSD) launched a community awareness effort to encourage the safe storage of guns. The primary audience is middle-aged men, who account for higher numbers of suicides by firearm in Santa Clara County.

"I don't leave my chainsaw lying around so someone could pick it up and hurt themselves, and I wouldn't leave my gun lying around for the same reason," said Pete, a local gun owner. "When someone has suicidal thoughts, they may be fleeting thoughts. The few moments of the additional time it takes to spin the dial on the safe could be all that is needed. Safely storing guns could save a life.'

Free firearm safety kits are available through Project Child Safe (https://stepoutside.org/san-joseca/project-child-safe/), a program from the National Shooting Sports Foundation to promote firearm safety and education. Also, veterans can get free gun locks by request at any Veterans Administration location.

Launched on December 6th, this comprehensive effort from BHSD's Suicide Prevention Program encourages safe firearm storage to help prevent suicide. It will run for seven weeks in several formats and on multiple outlets:

- videos featuring stories from local gun owners who have experience with suicides
- local radio station ads, digital ads, YouTube video
- geofencing ads to reach people at local gun ranges and gun stores
- a webpage about safe storage, suicide prevention and resources: www.BeGunSafe.org

Hayward. As a precaution, Manon Avenue was closed in both directions between Harris Road and Shepherd Avenue during the investigation. No victims or suspects were immediately identified. An investigation is continuing.

Drinking and driving? Not a good idea

As part of a nationwide "Drive Sober or Get Pulled Over" campaign, extra officers from the Hayward Police Department (HPD) are keeping an extra keen eye out for errant drivers every day through Saturday, January 1, 2022. The public is also asked to help: anyone who sees a drunk driver should call 911. Failing to stay between the lines, swerving, driving without headlights, taking wide turns and unnecessary braking can all be signs of an impaired driver.

HPD officials are reminding the public that impaired driving is not just from alcohol; prescription medications and over-the-counter drugs can also interfere with driving abilities. Before getting behind the wheel, police are asking drivers who take medications to follow directions and read

the warning labels. Although medicinal and recreational marijuana are legal in California, driving under the influence of marijuana is illegal.

"When it comes to consuming drugs and/or alcohol and driving, there is a right and wrong choice," Sergeant Tasha DeCosta said. "Make the right choice by not driving impaired so everyone is able to enjoy the holidays.'

Impaired drivers caught and charged with a DUI can pay stiff fines and penalties: an average of \$13,500, and their driver's license privileges may be suspended. Anyone planning to drink during the holiday season, is asked to take precautionary measures like utilizing ride-share apps, having a designated driver or just staying at home.

Funding for the increased patrol holiday program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

and burning a Yule Log in the hearth in honor of the god Thor. In Ancient Rome, the festival of Saturnalia was held around the winter solstice. The time of feasting and gift giving was also an inversion of social order. Yalda night is an Iranian celebration that takes place on the longest night of the year. People gather to eat, drink and read poetry. Pomegranates and watermelon are traditional foods for Yalda because their red color symbolizes approaching dawn.

Dark days can have a negative effect on our mental health. Especially in northern latitudes where days get much shorter around midwinter, people can experience Seasonal Affective Disorder, or depression that follows a seasonal pattern. Those suffering from this disorder experience symptoms like oversleeping, daytime fatigue, increased appetite, lethargy and even hopelessness. One treatment method is a "light box" that mimics sunlight.

So maybe a little self-care around the winter

solstice is more than just a fun tradition. During this time of year, we're in more need of good food, support from friends—and lighting some candles
