

Marshaks Bid Goodbye, **Their Legacy Continues**

For 20 years, it was easy to find Bill and Sharon Marshak: in the Tri-City Voice Newspaper offices six days a week, accompanied in the last few years by their rescue dog Mocha. When they retired in June 2024, they didn't want to make a big fuss. Luckily, office staff and new management from Weeklys newsgroup persuaded them to have a retirement party on the back patio of Massimo's in Fremont. The June 21 event was well-attended by current and former staff, friends of the paper, and local city officials.

Newark Mayor Michael Hannon talked about how Tri-City Voice has grown over the years from covering Fremont, Newark, and Union City, to reaching a community of 500,000 residents across the East Bay. He also shared how crucial Tri-City Voice has been over the years. "During Covid, when cities were struggling financially, they recognized that and gave the cities discounts when it came to putting information in the paper. That's the kind of people they are. They're community driven, community focused, and that's why they're going to be so missed."

Hannon presented a commendation to the Marshaks, praising Tri-City Voice as,

"An independent, locally-owned newspaper that has grown to become the standard for local in-depth reporting." The commendation also noted, "William and Sharon Marshak offered our local communities a blend of insightful, authoritative coverage of local news, art, culture, sports, and entertainment."

Dan Pulcrano, new publisher at Tri-City Voice, also introduced himself at the event. Later he wrote in his introductory editorial (published in the June 25 issue of Tri-City Voice), "Growing a community newspaper is no small feat in the digital media era, and their accomplishment speaks to the loving tenacity they brought to the mission. It also speaks to the strength of communities in and around Fremont, Newark and Union City that understand how sectors and civic institutions work together to forge a whole that's greater than the sum of its parts."

As a guest on The Fremont Podcast (thefremontpodcast.com), Bill Marshak shared that when he moved to Fremont, "The common wisdom was, Nothing happens here." Tri-City Voice changed that perception by making people more aware of the different communities around them. This is a mission that the paper will

Washington Hospital Dedicates Its New Level II Trauma Center

No one wants to imagine themselves or a loved one sustaining a life-threatening injury. But if we do, most of us probably imagine the injured person being sped in

an ambulance to the nearest emergency room—hopefully minutes away, certainly within our city. But it may not happen that way. Severely injured patients needed to be transported to a trauma center for specialized care. For East Bay residents, the two closest trauma centers were East Bay Trauma & Acute Care at Eden Medical Center and San Jose Kimberly Hartz,

June 24, Washington Hospital in Fremont held a ribbon cutting for its new Level II trauma center, fulfilling a critical need in local healthcare.

At the event, Kimberly Hartz, CEO of Washington Hospital, shared, "When I took this job in 2019, people would come up to me and say, 'If I'm in a major accident, why can I not come to my community hospital?' They did not understand the difference between a trauma center and a Level I, Level II, Level III. I said, 'We are working on it,' and today that is becoming a reality —We know in the Bay Area the traffic patterns can be difficult and it can take 45 minutes or more to go either north or south to the to the nearest trauma center. But as of July 1st, they can come to Washington

Lauri McFadden, director of Alameda County Emergency Medical Services Agency, talked about the planning that went into opening a trauma center in the Tri-City Area. After a year-long assessment of existing trauma centers in 2021, it was determined that the population growth in the Tri-City Area called for an additional trauma center. Washington Hospital was designated as the location in June 2022, and given five years. The center was built in two.

Dr. Chet Morrisson, Trauma Program Medical Director at Washington Hospital, explained that the concept of a "trauma center" is fairly recent, dating back to 1966. "As society expanded, as the economy expanded, there was a need for hospitals that could provide the integrated care that seriously injured patients could use, that could incorporate the lessons that we learned during wartime and incorporate the latest surgical advances in terms of resuscitation and operative care." Also in 1966, a report from National Highway Traffic Safety Administration on vehicle caused injuries highlighted the need for specialized care.

There are different levels of trauma center, from Level I, providing the most comprehensive care, to Level V, providing stabilization, diagnostics, and preparation for transfer to other facilities. Washington Hospital has a Level II Adult Trauma Center, which means it has 24-hour coverage with surgeons and specialists, and can initiate care for patients, although some may later be transferred to a Level I trauma center. A Fremont couple spoke on their

experience with the life-saving care provided by a local trauma center. On June 1, 2016, Jorge, an officer with Fremont Police Department, sustained a gunshot wound to the head during a traffic stop. Fortunately, another officer was able to flag down a nearby ambulance with a paramedic on board. But the closest trauma center was San Jose Regional.

Jorge had just completed his Regional Medical Center. On Washington Hospital CEO two-year probationary period with Fremont PD, and his wife Daisy had just graduated from nursing

Finding Her Vocation Began at Home

Washington Township Medical Foundation Welcomes New Endocrinologist

Jean Huang, MD, grew up in a family of health care professionals who influenced how she chose her career in internal medicine. Her grandfather was a surgeon, her father an endocrinologist and her mother a nephrologist. "That was literally my background already," said Dr. Huang.

Washington Township Medical Foundation (WTMF) warmly welcomes Dr. Huang to its endocrinology care team where she will examine patients, determine means of testing, provide diagnoses, and decide the best treatment methods for a variety of disorders including diabetes, thyroid disorder and metabolic syndrome (or known as obesity).

Dr. Huang credits her family for guiding her along a path towards medicine, but she revealed another career-defining event in her life that happened years later.

"I went to Africa on a medical service trip," she recalled. "I thought about what happens when resources are stripped away in a third-world country and what I could do to be the most helpful. It was eye-opening. Medicine offers ways to connect with people even though we speak different languages or come from different cultural/ethnical backgrounds. I knew I wanted the opportunity to make an impact in other lives."

Dr. Huang did her undergraduate work at the University of California, San Diego, where she also earned her master's degree in biology, graduating magna cum laude. Dr. Huang is a graduate of the University of Illinois School of Medicine at Rockford. She completed her internal medicine residency at Olive View-UCLA Medical Center and went on to serve her fellowship in endocrinology, diabetes and metabolism at Harbor-UCLA, City of Hope.

As a specialist on the disorders of endocrine glands, which impact our bodies on different systems and its functionalities, she said she finds her work both demanding and rewarding. "I love to dig deep and do my research so I can really connect with a patient. I find Endocrinology fascinating because it is such an intricate system. That's a stimulating challenge."

One such challenge Dr. Huang notes is when treating a thyroid disorder where diagnostic tests cannot fully reflect a patient's symptoms, and also the management may involve more than prescribing medications. Thyroid is sensitive and responds to the stress or change of health condition/environment/life events. The treatment plan often extends into integrating lifestyle change or stress management. An endocrinologist will look beyond laboratory tests and mindfully explore collaboratively with patients on how to improve their health.

Another challenge Dr. Huang sees is the early occurrence of diabetes in young patients. It can occur earlier than some may expect.

"Diabetes can start in the very young and the trait can be genetic," she pointed out. "While so many are focused on diabetes in adults, it must be emphasized that diabetes can also affect children as young as 3 years and even infants."

An endocrinologist generally treats diabetes through a combination of medication, lifestyle changes, consistent monitoring and education. Care is individualized, depending on a patient's type of diabetes and overall health.

In her expertise as an endocrinologist, Dr. Huang has found it important to speak out on the definition, or term for obesity, a condition increasing rapidly that leads to diabetes, cardiovascular diseases and other complications which can result from diabetes. She prefers to use metabolic syndrome instead of obesity.

"We have a different name because obesity is labeled as taboo and if you look into it, it's a lot more than extra fat accumulating in our bodies due to excessive calories. Cardiovascular complications are also associated with it. It's not just calories going in and out. Stress levels come into play. Sleep disorders also can happen. The impact of the condition is also way beyond the cosmetic look."

Dr. Huang believes it is likely that more autoimmune or allergy development diseases are on the rise and that thyroid dysfunction is becoming more commonplace. Stress and lifestyle can be contributing factors. "Eventually our bodies become more and more inflamed. We know the thyroid is a very sensitive organ essential to our metabolism," she noted.

Dr. Huang has received a warm welcome at WTMF and looks forward to meeting new patients and helping provide them with a healthy future.

Heart Valve Repair and Replacement Can Be Life Changing

Interventional Cardiologist to Present on Minimally Invasive Options

More than 5 million Americans are diagnosed with heart valve disorders, also called valvular heart disease, each year. Diseases of the heart valves take many forms, but in every case, it means one or more of the heart valves are not working properly. When not treated, valvular disease can result in arrhythmias, stroke or death. While some conditions can be managed with lifestyle changes or medications, others may need to be addressed with minimally invasive procedures or surgery. A local Washington Township Medical Foundation (WTMF) physician will share his expertise on treating valvular heart disease with the community in a free upcoming online

Heart Valve Diseases and Treatments

Valvular disease can affect any of the heart's four valves, called the aortic, mitral, pulmonary, and tricuspid valves. One of the more common valve conditions is aortic stenosis, where the valve thickens and narrows so it can't open fully, limiting blood flow to the body. Over time, this extra stress on the heart leads to thickened heart walls and may cause symptoms like shortness of breath, chest pain, dizziness and fainting. Another common valvular

disorder is mitral regurgitation, where the valve doesn't close completely so blood leaks backward into the chamber instead of forward. Because blood is not being pumped as it should, this can lead to heart palpitations, shortness of breath, swelling of the feet or ankles, and fluid in the lungs.

When valvular heart disease is severe and cannot be managed with blood-thinning medications or through lifestyle changes (like eating healthy, quitting smoking and exercising regularly), a procedure or surgery may be necessary to repair or replace the faulty valve. In the past, many heart valve surgical candidates had to undergo traditional open-heart surgeries, but now minimally invasive procedures can often address the problem. Catheter-based heart valve repair and replacement provides a nonsurgical option, where an interventional cardiologist inserts a thin flexible tube into a blood vessel in the arm or groin. This catheter is then

advanced to the heart and used to repair or replace the heart valve.

Along with a multidisciplinary cardiology team, Dr. Agrawal performs these advanced minimally invasive procedures at Washington Hospital in Fremont, which include transcatheter aortic valve replacement (TAVR) and complex coronary interventions (CCI) or stenting of blocked arteries.

"Minimally invasive heart valve procedures require small incisions to access the heart, unlike open-heart surgery," explained Dr. Agrawal. "These techniques typically result in less pain, less blood loss and a reduced chance of infection for patients. Generally, this means a much shorter hospital stay and recuperation time," he continued.

Dr. Agrawal is an acclaimed interventional cardiologist who has published numerous clinical cardiology research papers. He holds an impressive eight American board certifications including internal medicine, cardiovascular medicine, interventional cardiology, endovascular interventions. echocardiography, cardiac CT, nuclear cardiology and vascular ultrasound. "Reminiscent of the dedicated and hardworking nature of the doctors in my family, I have an insatiable desire to excel in cardiac patient care," he said. "For me, there is no greater privilege than to learn from and help individuals in need of medical care."

If you or someone you know has symptoms of heart valve disease, consult with your primary care physician. You may be referred to a cardiologist for testing. Independence Day

Independence Day, also known as Fourth of July, is a day meant to commemorate American independence from Great Britain and the creation of the Declaration of Independence. This day has been celebrated since 1941 as a federal holiday. On July 4, 1776, the Declaration of Independence was approved with this document beginning with addressing the human rights with the well-known line "Life, Liberty, and the Pursuit of Happiness." Thomas Jefferson, the main writer of the Declaration of Independence, goes on to state the issues with the King and why the colonies wanted independence.

The origins of the Fourth of July go back to the American Revolution. The British government had tried to increase their tax revenue by taxing the colonies with acts such as the Stamp Act and the Tea Act. These actions caused violent clashes, the most famous being the Boston Massacre. Other forms of protests arose such as when people dumped tea into the Boston Harbor in what would be known as the Boston Tea Party. As a result of all these unrests, the first Continental Congress was called in 1774 where the delegates listed their issues to the King, especially the "taxation without representation." Since the King did not address these grievances,

on April 19, 1775, another battle took place between British soldiers and colonial militiamen (where Paul Revere famously sounded the alarm), marking the start of the Revolutionary War. By this time there was greater support for the revolution resulting in the adoption of the Declaration of Independence.

Lively celebrations for the momentous day have evolved throughout the decades. During 1776, the first time independence was celebrated, colonists held fake funerals for King George III to represent how the King was no longer the tyrant over the colonies. Other celebrations included concerts, parades, and bonfires which remain standard even today. The most iconic part of the Fourth of July celebrations is the fireworks show. This started in 1777 when cannons fired 13 shots to represent the thirteen colonies. Today as you walk down the street you might be able to hear or see fireworks, as fireworks are done in many different cities all across America. Fourth of July is a day for families to get together and remember the rich history of the United States and celebrate all that has been achieved.

SBARA's Field Day: Forming Connections All over the World

From June 22 to June 23, the South Bay Amateur Radio Association (SBARA) held their annual "Field Day" event in Fremont Central Park, where radio enthusiasts can test their skills for making contacts with other operators. The event, held in the fourth full weekend of June, was observed all through America.

While it's mainly an opportunity to test out radio equipment used in emergencies, there is also a scoring aspect where clubs try to make as many contacts as possible. While other, larger clubs across the country might have been focused on trying to get the most connections for the highest score, members of SBARA had other priorities—primarily focused on the experience.

"We're operating in one of these tents and we get into this groove of making all these contacts," said Steve Wilson, Vice President of the Association, "But, if we see someone who's looking over our shoulder, who is interested then we really make an effort to stop and answer any questions- so just being very welcoming."

Indeed, this sentiment was echoed by others in the club.

That being said, a lot of time and effort still went into preparing for the event. Preceding meetings, first beginning in April and increasing in frequency leading up to the event, were a good way of s

taying organized and making sure members knew what to expect. From bringing equipment to providing refreshments in the heat, there was always a member assigned to the job.


For many members, it was godfathers and other relatives that fostered a lifetime connection to amateur radio. There are certain tests that need to be taken before a person is allowed to use the radio, however.

"I started going through the manuals at the public library. I got my license in 2015," said Tony Monroe, President. "I haven't been licensed very long compared to some of the other people here, but I did get the Amateur Extra Class License. I'm about as licensed as you can get."

Although the club may be small, it consists of a close-knit community brought together by a mutual hobby. Since the COVID-19 pandemic, retaining membership had been difficult, but this year SBARA ended up with more stations than they had originally planned on having.

Overall, the weekend proved a success: contact was made with stations as close as the Sacramento Valley and as far away as Vermont. For SBARA members, it was a culmination of testing out communication technology, as well as a facet of emergency planning.

Amateur radio is unique in that it represents a time of communication that is slowly fading with the advent of cellular



and wireless technology. In emergencies like natural disasters, however, those newer methods of communication aren't always reliable. It is important to be aware of older methods, in case those extreme circumstances do occur.

Field Day is powered entirely through generators, imitating real emergency conditions. Radio is versatile; different communications were made in different tents at the site, all operating on different frequencies. Some tents focused on using Morse code, while others used phones and voices. Tall, broad antennas, familiarly known as "helix" or "spider-web" antennas were able to support multiple bands such that the tents didn't get their wires crossed.


Still, there were ways the club altered their operations for a better Field Day experience for all. To stay efficient, SBARA utilized a main computer that would help them record and centralize all their

contacts and make sure there were no duplicates. Each station has their own call sign; SBARA's is KU6S (Kilo Uniform 6 Sierra), referenced through NATO phonetics to remove ambiguity on the station's identity.

That's not to say that there weren't any challenges. "The equipment used to be bulkier." Monroe elaborated, "It hasn't been perfect, we have three stations running really well and fourth sort of working, doing okay."

But, those in amateur radio are nothing if not passionate, and struggling stations found a lot of help from those around them, and ended up making connections. In the end, Field Day isn't about the number of contacts, but about enriching a niche hobby among enthusiasts.





Nearly 30 people attended the celebration. The event started with attendees gathering in a circle to introduce themselves. Attendees then listened to a presentation about Malaya Union City


and the national Malaya Movement. Emcee and Malaya Union City member Isaiah then talked about current campaigns, including the push for the Philippines Human Rights Act.

Malaya Union City was first formed in 2020 just as the Philippines' Anti-Terror Act was being passed. The act implied that people who expressed dissent towards the government, such as activists and journalists, were being improperly labeled as "terrorists."

The organization advocates for human rights, sovereignty, and democracy in the Philippines. Malaya Union City also strives to support the Tri-City community, especially low wage workers.

Their campaigns include "Workers' Rights are Human Rights" and the Anti-Disinformation campaign. There is a so-called "historical revisionism" going on in the Philippines where disinformation is being spread through social media, especially Facebook. Malaya Union City and the national Malaya movement are working together to combat this.

The event continued with Solidarity Statements from different organizations, including Filipino Advocates for Justice, Malaya South Bay, and East Bay for Ceasefire.

Elections were held for active members of Malaya Union City at the event.

Member Camille was elected as the new Educational Development officer. After the results were announced, the complete executive committee stood in front holding up the Malaya organization banner. Committee member Jordan held up a fist calling for solidarity and led

several chants, including the "Makibaka!" chant. Some members of the audience responded with "Huwag matakot!" In Tagalog, it translates to "Fight!" and "Do not be afraid!" The chant was a battle cry during the fascist regime in the Philippines during the '70s and '80s.

The chants were a pivotal moment, as the chapter made calls to continue their advocacy work and campaigns to make history once again.

The event ended on a positive note, with a line-dancing workshop led by member Alan's parents. Some attendees laughed as they tried to keep up with the savvy moving elderly couple. The event ended just as the heat intensified. The weather was in the low-80s that afternoon.

DA Pamela Price launches Gender Justice Division and Advancing Justice Division

June 21, 2024 was a signature day in the history of the Alameda County District Attorney's office. DA Pamela Price is elevating the effort to keep all members of the public safe by announcing that her administration is launching the Gender Justice Division and the Advancing Justice Division.

"Shortly after I took office in January 2023, we began researching innovations in other jurisdictions to attack gender-motivated crimes and the impacts on our community," said DA Price. "Gender is often a feature of power dynamics, including the abuse of power, which can lead to assaultive behavior, sexual exploitation and violent confrontations in our communities."

In June 2023, DA Price gained valuable insights during the planning phase for the Gender Justice Division after meeting with Brooklyn District Attorney Eric Gonzalez and his Chief Deputy Michelle Kaminsky, who oversees their Gender-Based Justice Division

In November 2023, DA Price launched the Anti-Slavery Prosecution Unit (ASPU), a huge step toward tackling crimes involving human exploitation. In December 2023, the Alameda County District Attorney's office began the process of consolidating human exploitation crimes under the jurisdiction of the ASPU.

"Today, I am excited to share the features of our new organizational structure. Senior Deputy District Attorney Justin Kollar, the former District Attorney of Kauai and a career prosecutor for 16 years, will head up the DA's Gender Justice Division. The new division will include the new Anti-Slavery Prosecution Unit, Sexual Assault Unit, Family Justice Center, Victim Witness Division, and Domestic Violence Prosecution Units, which handles misdemeanor and felony cases," said DA Price.

Tiffaney Gibson, a
Senior Assistant District Attorney
and seasoned prosecutor for 28
years, including nine years in the
DA's office, will head up the
Advancing Justice Division, which
will include the Juvenile Justice
Division, Collaborative Courts,
the Civil Rights Bureau, and the
Consumer Justice Bureau.

DA Pamela Price says that she is excited to lead the Alameda County District Attorney's office forward with a focus on the future, bringing the newest features of effective and fair prosecution strategies to bear on our County's most persistent and devastating problems. "I appreciate the leadership of both District Attorneys Gibson and Kollar as they have stepped up to help us implement a new vision of justice for our office and our County, as well as the Bureau and Unit leaders who will help them lift up our office and serve the people who live, work and play in Alameda County."

July's Night Sky Notes: A Hero, a Crown, and Possibly a Nova!

High in the summer sky, the constellation Hercules acts as a centerpiece for late-night stargazers. At the center of Hercules is the "Keystone," a near-perfect square shape between the bright stars Vega and Arcturus that is easy to recognize and can serve as a guidepost for some amazing sights. While not the brightest stars, the shape of the hero's torso, like a smaller Orion, is nearly directly overhead after sunset. Along the edge of this square, you can find a most magnificent jewel—the Great Globular Cluster of Hercules, also known as Messier 13.

Globular clusters are a tight ball of very old stars, closer together than stars near us. These clusters orbit the center of our Milky Way like tight swarms of bees. One of the most famous short stories, Nightfall by Isaac Asimov, imagines a civilization living on a planet within one of these star clusters. They are surrounded by so many stars so near that it is always daytime except for once every millennium, when a special alignment (including a solar eclipse) occurs, plunging their planet into darkness momentarily. The sudden night reveals so many stars that it drives the inhabitants mad.

Back here on our home planet Earth, we are lucky enough to experience skies full of stars, a beautiful Moon, and regular eclipses. On a clear night this summer, take time to look up into the Keystone of


Hercules and follow this sky chart to the Great Globular Cluster of Hercules. A pair of binoculars will show a faint, fuzzy patch, while a small telescope will resolve some of the stars in this globular cluster.

Bonus! Between Hercules and the ice-cream-cone-shaped Boötes constellation, you'll find the small constellation Corona Borealis, shaped like the letter "C." Astronomers around the world are watching T Coronae Borealis, also known as the "Blaze Star" in this constellation closely because it is predicted to go nova sometime this summer. There are only five known nova stars in the whole galaxy. It is a rare observable event and you can take part in the fun! The Astronomical League has issued a Special

Observing Challenge that anyone can participate in. Just make a sketch of the constellation now (you won't be able to see the nova) and then make another sketch once it goes nova.

Tune into our mid-month article on the Night Sky Network page, as we prepare for the Perseids! Keep looking up!



school. He shares, "We were on high. I started my career. She was going to start hers. So things were looking up. But then that day, our whole lives changed. Luckily, the stars aligned. I was safely transported, to San Jose Regional Medical Center, the nearest trauma center to Fremont. Because our Fremont didn't have a trauma center."

Daisy spoke about the support from the trauma center staff, for Jorge during his treatment and rehabilitation, and for her as a patient family member. "Thank God my husband not only survived, but he's cognitively mostly intact. That is why, I'm

so happy and excited to see that the City of Fremont finally, has its own trauma center, that will serve the South Bay community. I think it's going to save so many lives."

The ribbon cutting was the culmination of years of planning, but for Washington Hospital it's only the start. Kimberly Hartz said, "Trauma preparation has been a journey for our health care system, but it's important to remember that this journey doesn't end on July 1st when we see our first patient. Trauma care is a continuous journey, one that requires

'America's Band,' The Beach Boys, Plan South Bay Concert

This summer, Mike Love is back on tour, leading the Beach Boys around the United States on a tour that will visit some 70 cities, including an outdoor concert in San Jose's Plaza de Cesar Chavez.

At 83, Love is the last member of the classic 1960s Beach Boys lineup still touring with the group. He owns the Beach Boys name and oversees the band's business. The only other touring member with ties to the early edition of the Beach Boys is Bruce Johnston, who in 1964 joined the group as a replacement for Brian Wilson, who retired from touring to focus on his role as main songwriter and producer of the Beach Boys music and work exclusively in the studio.

Ostensibly, the Beach Boys are touring to celebrate a pair of projects. One is the 50th anniversary of "Endless Summer," the greatest hits album that revived the band's career in the mid 1970s after the Beach Boys' popularity had waned in the years following the groundbreaking 1966 album "Pet Sounds" and the innovative follow-up single, "Good Vibrations."

"We probably do 18 of the 20 songs on that album in our concert," Love said in a late-June phone interview, noting that the tour is titled Endless Summer Gold as a nod to that anniversary.

The group is also touring behind a new documentary entitled simply as "The Beach Boys" that's now streaming on Disney+.

Directed by Frank Marshall and Thom Zimny and written by Mark Monroe, the documentary traces the Beach Boys career from its inception in 1961 in the Los Angeles suburb of Hawthorne, where Love co-founded the band with his cousins, Brian, Carl and Dennis Wilson and friend Al Jardine mainly through the mid-1970s resurgence of the band.

The documentary has been dinged in some reviews for glossing over or omitting altogether some elements of the Beach Boys history, including tensions that

existed in the group, the drug use of several members and Brian Wilson's struggles with mental health that initially culminated in a breakdown following the completion of the classic 1966 album "Pet Sounds." The deaths of Dennis Wilson from a drowning accident in 1983 and Carl Wilson from cancer in 1998 are only referenced with a note at the end of the documentary.

Love likes how the film came out and feels it touches on aspects of the group's history that some of the many other documentaries on the Beach Boys didn't highlight.

"I think it showed a bit more of my involvement than has been in other projects, and there have been some fallacies said about me, like I didn't like the 'Pet Sounds' album, which was stupid because I named the 'Pet Sounds' album and I went with Brian to present it to Capitol Records," Love said. "And they really didn't know what to do with it at the time because we had done things like 'Surfing U.S.A.' and 'I Get Around' and 'California Girls,' 'Fun, Fun Fun.' And, you know, they wanted something more along those lines, but 'Pet Sounds' was an evolution. Brian was using symphonic instruments on some of the tracks and stuff like that. But I sang on it and was lyricist on a couple of songs.

"I think this documentary really you know (depicts) how it was, how it really was, with the harmonies and the family connection and it a bit more accurately told the story of the making of the music."

What is also memorable for Love is footage from a get-together last summer with all of the surviving band members, including Brian Wilson.

"The surviving members, and David Marks and Al Jardine and Bruce Johnston, we all got together Paradise Cove, which is where we did our original album cover photo shoot," Love said, referring to the Beach Boys' "Surfin' Safari" album, which depicted the five band members on a beach in a vintage truck, carrying a surfboard. "So over 60

years later we got together at the same place and we actually sang some songs together and it was really nice to have that as the final shot of the documentary."

Wilson recently was placed in a medical conservatorship to manage his health and welfare, but Love said his long-term memory is still intact, and so are his abilities to sing and make music. In interviews following that get-together Love and Johnston both mentioned the prospect of getting together with Wilson to try writing songs.

"Getting together to do a song, that's not necessarily a priority, but what is necessary is to get together and just, you know, to visit and see how he's doing and have some positive time together," Love said. "So that that was more or less the reason for our get together at Paradise Cove in the documentary is just to get together and spend some time together and reminisce and see if we can sing together, which we can. So the possibility exists, but it's not like, there's no project or focus at the moment. But that could change."

For now, touring is the priority. And the Beach Boys Endless Summer Gold tour will celebrate the 1960s hits that had them vying with the Beatles to be the pop music's most popular band, while displaying the sun-kissed, harmony-laden sound (not to mention lyrics about surfing, cars and beautiful girls) that helped create America's fascination with the idyllic California lifestyle.

The band that performs the music, obviously, has changed a lot over the years, and the lineup, in fact, has evolved once again for this tour. Long-time musical director Scott Totten has moved on and guitarist Brian Eichenberger, a touring member since 2015 has taken on that role. The band also has a new lead guitarist in South Bay-raised John Wedemeyer and drummer in Jon Bolton. Love, Johnston, keyboardist Tim Bonhomme, sax/flute player Randy Leago, bassist Keith Hubacher and guitarist Christian Love (son of Mike Love) remain from previous lineups.

Love is pleased with this unit ("Actually, we sound better than we ever have," he said). He noted that Eichenberger, in addition to leading the band, handles the high harmony parts initially sung by Brian Wilson, while Wedemeyer is a "diversified and brilliant" lead guitarist and Bolton is "a show within a show" on drums. What's more, Bolton's vocals allow the band to perform a couple of songs Carl Wilson sang that couldn't be performed with some previous lineups.

"We're really doing more songs from more years of our band's existence these days than we ever have," Love said.

This unit is also focused on faithfully reproducing in concert the original versions of the Beach Boys material.

"We're obsessed with recreating as close as humanly possible to the recordings, and that means singing the songs in their original keys, not lowering them because you're not able to hit some of the notes anymore. We sing all these songs in their original keys. And maybe there's a little bit of something extra we put in to end some songs, you know just to be more dynamic because there is a live audience. So instead of fading a (song) out like you would on a record or a single, we've come up with an actual ending to put a little more oomph into it, a little more pizzazz, you know, like the end of 'Good Vibrations' or 'Wouldn't It Be Nice.' It is a live concert so you'll do a little bit of something different on the end that makes it more dynamic."

4h of July Fireworks Safety – Know the Law

Castro Valley

The sale and use of fireworks are prohibited.

Fremont

The sale, possession, and use of all fireworks are banned within the City of Fremont. This ban includes the "safe and sane" variety of fireworks that are legal in some other cities. Fire and Police resources will be on patrol in Fremont during the peak times of concern to maintain an active vigilance against fireworks use.

Hayward

All fireworks are illegal in the City of Hayward and Fairview Fire Protection District. Owners of properties where fireworks activity takes place, or emanates from, can be cited and face progressively increasing fines of \$1,200, \$3,000 and \$5,000 for a first, second and third incident, respectively.

Milpitas

The use and sale of fireworks are prohibited in Milpitas.

Newark

Only State Fire Marshal-Approved "safe and sane" fireworks, bearing the seal are allowed in Newark. "Dangerous" fireworks are illegal. Anyone found to be in possession of or using illegal fireworks is subject to a fine and/or arrest.

San Leandro

The City of San Leandro does not permit the use or sale of fireworks. This regulation includes a prohibition on the use of the "safe and sane" variety of fireworks.

San Lorenzo

The sale and use of fireworks are prohibited.

Sunol

The sale and use of fireworks are prohibited.

Union City

"Safe and sane" fireworks may be deployed between 8am to 10pm, July 1 - 4 on your private property. If you intend to use "safe and sane" fireworks on property other than your own, you must have written approval from the property owner. Deploy fireworks at least ten feet away from any dwelling or structure. Use fireworks under adult supervision. Fireworks are not allowed east of Mission Boulevard, in city parks, school property, or city streets. Do not deploy illegal fireworks alongside "safe and sane" fireworks. Fireworks that explode or go up in the air are illegal. This includes firecrackers, bottle rockets, aerial shells and mortars. Property owners can be fined up to \$1,000 if illegal fireworks are deployed from their property. Individuals possessing or deploying illegal fireworks from any location may be fined up to \$1,000.

Summertime Eye Health Tips

Eye health is an important factor in our overall well-being. Yet 65.3% of California children don't regularly see an eye doctor. With many kids out of school for the summer, screen time may add up quickly and potentially contribute to health issues, making it a great time to shine a spotlight on vision health.

That can include a focus on preventing or treating nearsightedness, also known as myopia, which can affect our ability to see far-away objects clearly. Importantly, childhood onset of myopia has been linked to a greater risk of developing serious eye diseases later in life, including cataracts and glaucoma.

Unfortunately, myopia is on the rise, affecting around 42% of all Americans, up significantly over the last few decades. By 2050, it is projected that 50% of people worldwide will be nearsighted.

In an increasingly digital world, it's more important than ever to be aware of this growing

issue and how to address it. This is especially true for kids. According to an international research study, children who spend most of their time on both a smartphone and a computer may have an 80% higher risk of developing myopia.

Here are some tips to support eye health:

Reduce excessive blue light exposure.

Research is showing the potential health implications of excessive exposure to blue light, including disrupted sleep cycles and digital eye strain. Nearly 60% of U.S. adults report experiencing symptoms of digital eye strain with Americans spending an average of seven hours per day interacting with screens. Make sure to spend ample time outdoors, which research has shown may reduce the risk of nearsightedness.

Watch for warning signs of myopia.

Some common symptoms include far-away objects appearing blurry while close-by items are clear, squinting to see properly, eye strain and even headaches. For parents and caretakers, it's important to remember that children may not

know they have a vision problem, so pay attention to indicators like head tilting to read or watch TV, reduced performance at school or constant blinking.

Get a comprehensive eye exam and consider myopia management if needed.

If you think you or a loved one may be experiencing vision issues or if you're a frequent computer user, make sure to visit an eye doctor and get a comprehensive eye exam. These exams can detect health problems that a simple vision screening may miss. Ideally, kids should get annual comprehensive eye exams throughout their school years.

While eye doctors can't cure myopia, they can prescribe eyeglasses or contact lenses to help you see clearly again. And if you or a family member is diagnosed with myopia, specialized treatment plans may help slow the progression.

Maintaining good eye health is an important step everyone can take to protect their overall well-being and may help prevent or slow the onset or progression of nearsightedness and other vision conditions.


Dear Earth Talk: What are the environmental impacts of the widespread legalization of marijuana in recent years?

Cannabis is an increasingly popular recreational and medicinal drug that is capable of producing psychogenic effects. As more states legalize cannabis for some medicinal and recreational uses, cannabis production is on the rise.

On average, cannabis requires double the amount of water than food staples like corn, soybean and wheat. Over 60 percent of marijuana grown in the United States originates from California. Additionally, California produces nearly 75 percent of the nation's fruits and nuts and over 33 percent of its vegetables. Californian agriculture is significantly supported by aquifers, surface water diversion, springs and rivers. The rising demand for cannabis may exacerbate water scarcity, divert freshwater from essential agriculture and municipal needs, and harm water ecosystems by altering stream flows.

A single pound of commercial marijuana product correlates to over 4,600 pounds of carbon dioxide (C02) emissions produced. Additionally, cannabis plant matter has been found to contain high concentrations of biogenic volatile organic compounds (BVOCs), especially monoterpenes, which have been linked to increases in ground-level ozone pollution and particulate matter that can lead to severe health issues. Further, cannabis cultivation is often enhanced by pesticides and ammonia-rich fertilizers that are used to supplement the plant's high nitrogen requirement. The ammonia frequently volatilizes into the atmosphere, bonding with nitrogen oxides to produce particulate matter. Runoff from these inputs also causes soil acidification, water eutrophication, oxygen depletion and harm to aquatic life.

Indoor planting facilities require significant energy for lighting, heating, ventilation and dehumidification. One 2012 study even attributed "the energy consumption for this practice in the United States at 1% of national electricity use, or \$6 billion each year." Back then, only 16 states had legalized



marijuana for medicinal use. Today, that number has risen to 38 states, suggesting that current energy consumption for indoor cannabis production is likely even

Several foundational changes could make cannabis crops more sustainable. Many states that have legalized cannabis have not established energy standards for indoor cultivation facilities. By mandating LED bulbs instead of metal halide or fluorescent bulbs, policymakers can initiate energy reduction. However, this is not always feasible. Facilities located in cooler areas sometimes rely on the heat generated by non-LED bulbs to keep temperatures warm enough for the cannabis to grow.

In the early days of the cannabis industry, it was widely believed that growers had to use reverse osmosis (RO) to remove heavy metals and sodium from water before applying it to their crops. Roughly half of the water that was put through RO was discarded as wastewater. Yet, testing showed tap water works similarly without impacting product quality, prompting a shift away from RO.

Some facilities are transitioning their root media from traditional, non-recyclable 'stone wool' to a coconut-fiber-based product. Coconut fiber offers improvements in water retention and filtration, allowing plants to maintain a cleaner root environment and reduce watering frequency. Moreover, coconut fiber promotes better aeration and drainage, preventing waterlogging that can lead to root rot.

Home & Garden

Gourd, Bitter, Best


Growing up in India, however much I disliked when my mother cooked the bitter and "boring" vegetables and put them on my plate, years later I see myself doing the same thing to my children. "Generational torture," one might chuckle, but mother knew best from generational wisdom what she was doing! Packed with health benefits and offering a multitude of flavors, these vegetables have moved from being primarily in cultural cuisines to appealing to a wider audience.

Some that I plant and which do well in Bay Area weather are bittermelon (Momordica charantia), okra (Abelmoschus esculentus L.), and opo squash (Lagenaria siceraria). Once one has developed a desire to include them in their diet and garden, the next steps involve securing a structure for vining plants and reserving the sunniest spot in the garden. If seeds and plants aren't available locally, one should order them ahead of time. Start seeds indoors about six weeks prior to the planting time. The ideal time to plant seedlings in their final spot is when that area in your garden will be consistently warm for at least three months. To start seeds indoors, soak them overnight in water and sow two to three




seeds per pot. To encourage germination, use a heat mat to maintain optimal temperature. Once seeds have germinated, they can be moved to a sunny spot like a windowsill to continue their growth before they are ready to be moved to the garden. If more germinated than needed, snip away the weaker ones.

These vegetables are heat loving and will do well in most types of soils. Mix in well-aged manure or compost at the time of planting to give them a good start. Bittermelon and opo squash have shallow roots and require frequent watering, whereas okra has strong tap roots that grow vertically down and like deep watering a couple of times a week. They all do much better when planted in the ground, but bittermelon can be planted in a pot about the size of a half-barrel. Add a structure like a trellis for the vine and fertilize during the growing period. Even bigger bittermelon fruits can be lighter than smaller opo squashes. Hence, available space and trellis size play an important role in determining what and where to plant.



While some insects like bees are desirable in our garden, not-so-desirable ones like aphids, earwigs and squash bugs all show up to the party uninvited! I wash off aphids with the hose. To tackle squash bugs, lay cardboard pieces on the ground. When bugs gather underneath, they can be collected and removed. Or you can find and crush their eggs on the underside of leaves. Planting bug-resistant varieties gives the home gardener an upper hand. Between monitoring the garden for visible signs of pests, hand removing undesirable bugs, planting resistant varieties, avoiding overcrowding, and using recommended insecticide when needed, there are many ways to grow a bountiful harvest.



Harvest okra pods when they are still tender. Size will depend on variety. About



ten pods that are three to four inches long suffice for a serving. Wipe pods with a damp towel and let them air out. Slice them into half-inch pieces. Add a tablespoon of cooking oil to a heavy bottom wok or a non-stick fry pan. Add a teaspoon each of mustard and cumin seeds. Let them sputter and then add the okra. Cook for few minutes and turn over with a spatula. Add in salt to taste and cook some more, turning pods over to make sure they don't stick or get burnt on the bottom. Add in thinly sliced onions and sauté some more. Turn the heat off and add in red chili powder, coriander powder, and dry mango powder or lemon juice. Cover let it rest for ten minutes. Serve as a side with a rice dish or with any flat bread paired with lentils. Note: Okra can become slimy if cooked on low heat.

Bittermelon can be cooked similarly to okra. To temper some of the bitterness, peel the outer layers, sprinkle salt over the sliced pieces and let them rest. Salt draws out the juices and reduces bitterness. Finishing off cooked bittermelon with tamarind sauce can also help balance the bitterness. Add in sliced Thai chilies for extra heat!



Washington High School Students receive \$11,000

Sixteen scholarships for a total of \$11,000 were awarded to Washington High School seniors by the Washington High School Alumni Foundation at the Senior Awards Night on May 23, 2024. The scholarships, which ranged from \$500 to \$1000, were made possible through the families which sponsor each scholarship along with donations from Alumni.

Students applied for scholarships during the first quarter of 2024 with information about the parameters available through the WHS Alumni Foundation website at

whsaf.org/scholarship-guidelines. After the application period closed, sponsor families and other review committees reviewed submissions. Sponsoring families chose the number of awardees and the amount of the award based on available funds.

Additionally, due to successful WHS Hall of Fame fundraising in 2023, the Alumni Foundation was able to honor each of the four Husky Award winners with a monetary award in recognition of the four years of hard work, service and leadership that led to their selection.

The Washington High School Alumni Foundation was originally organized in 1990 to raise funds to preserve the WHS main arched entrance for integration into the new building. Early fundraising activities included Foundation flea markets selling memorabilia from the main

building theater and gymnasium, all-alumni dances attended by alumni spanning eight decades, and golf tournaments. The board members eventually were able to reach their goal and present a check for \$60,000 to the Fremont Unified School District Board of Education.

After that, the Alumni Foundation changed their focus to today's goal to support Washington High School students and staff through scholarships and classroom grants. Since its beginning, the Foundation has awarded over \$150,000 in college scholarships to graduating students and over \$6,500 in classroom grants. Most recently, grants were given to the music program and the baseball program to buy needed supplies and equipment.

Independence Day

As we approach July 4th, our nation's birthday celebration, it is an appropriate time to consider how and why it came into existence. At the time of rebellion, colonists were deeply divided between those who supported continued allegiance to England and others, chafing under rules, regulations and taxes that, to them, were intolerable. The divided loyalties and subsequent outbreak of hostilities included not only battles between colonists and British - and mercenary soldiers - but local partisan skirmishes and others who sought to profit from the chaotic environment. The concept of a country governed by the people rather than a despot was revolutionary and unsettling.

Although the United States of America emerged from the struggle as a separate country, divisions between states, philosophies and economic interests remained. Discussions at the Continental Congress and subsequent emergence of the Constitution of the United States recognized many basic elements of the newly independent nation, but shied away from others such as slavery, considered too difficult to resolve at the time. To this day, many of the same divisions continue to threaten the viability of our nation. So far, national unity has prevailed and those who choose to challenge its foundational principles, are a distinct, although vocal, minority.

As some states transformed from primarily agrarian economies toward industrialized societies whose population concentrated in large cities, others due to social and economic factors, remained heavily rural. The resulting economic disparity has fueled ongoing conflicts including the Civil War, revealing festering grievances that exist to this day. At times, even with technological advances and social changes, it feels as if the schism between regions is as deep as ever. However, no matter how difficult to accept for some, demographics and attitudes have and continue to change.

Two hundred and forty-seven years have passed since that bold declaration and many divisions remain, although tempered by time. No longer an argument with a foreign power over a right to exist, much of the discussion has turned inward. Introspection and a clear understanding of our nation's birth and development brings context to current affairs. It is only through comprehensive examination of our past and present, that we can move toward a better future. Education that allows a variety of viewpoints and philosophies is critical for continuance of the "American Experiment" that subscribes to independence for our country and its inhabitants.

Independence is defined as outside others' control or support. However, the Declaration of Independence was a document that

signaled not only a desire for home rule, but also a notice to colonists and other nations of a country of laws respecting the rights of all citizens. It was understood that in order to achieve its goals, a critical element was support of others within and outside the new country. Independence was used to describe the intent to emerge as a separate entity from the British Empire, but not a declaration of isolationism. The founders recognized the strength and comfort from other countries to achieve their goals.

nation governed by the people and laws that affect all equally, is a balancing act for all of us. Its challenge is to recognize the relationship between independence and responsibility. A personal declaration of independence should include a commitment to our families and communities. As you enjoy parades, fireworks and family gatherings, it is also a good time to consider political literacy and volunteer activities as part of your declaration of independence.

Happy birthday, USA.



Assassination of Robert F. Kennedy

On June 5, 1968, Senator Robert F. Kennedy stood before an enormous crowd of deliriously happy supporters in the ballroom of the Ambassador Hotel in Los Angeles and claimed victory in the California presidential primary. At forty-two, he had been borne along by the power of his name and the public's widespread Vietnam War "fatigue." It seemed probable that another Kennedy would soon ascend to the White House.

He concluded his remarks with the declaration, "Now it's on to Chicago, and let's win there!"

Trailed by admirers and hangers-on, Kennedy walked into the hotel kitchen; he was to be driven away from there, but an assassin lay in wait: Sirhan Sirhan, a Palestinian enraged by the Senator's support of Israel, shot him in the head and body; others were also hit. A haunting image of Kennedy lying on the floor with his head supported by a stricken busboy sped around the world. Kennedy was taken to the nearby Good Samaritan Hospital, where he lingered until his death the following day.

Later, Vice President Hubert Humphrey got the Democratic presidential nomination, but he was defeated in a close election with former Vice President Richard Nixon.

Death of Michael Jackson

On June 25, 2009, the "King of Pop" died of complications from an accidental drug overdose at his Los Angeles home. He was 50. The story—broken by the gossipy TMZ, quickly spread around the world.

Known everywhere for his swarm of hits—"Billie Jean" "Thriller" "Beat It" and "Bad"—Jackson had been a child superstar since performing with his brothers as part of the Jackson 5. When he went solo, Jackson's popularity went stratospheric, and he became one of the most successful musical performers of all time.

Eventually, his reputation was tarnished by eccentric behavior, extensive cosmetic surgeries, and credible accusations of child abuse that repelled, repulsed—and riveted—some fans.

At his death, Jackson was preparing for a comeback concert tour, but in the meantime, he had become dependent on a cocktail of powerful drugs, administered mostly by Dr. Conrad Murray. He was tried and convicted of involuntary manslaughter for the singer's death.

GM invests another \$850M into Cruise as it expands manual operations

Despite a bumpy 2023, Cruise LLC isn't nearing the end of the road yet. General Motors, its parent company, said last week that it would invest an additional \$850 million into the autonomous vehicle developer. To date, GM has invested more than \$8 billion into Cruise and hasn't yet seen much of a return. In 2023 alone, the San Francisco-based company lost \$3.48 billion.

However, it doesn't seem like GM is ready to take the route that Ford and VW did when those automakers shut down Argo AI. Its additional investment will help cover Cruise's operational costs. The company also said it's looking for new external investors to help bolster its financial situation.

Paul Jacobson, GM's chief financial officer, announced the investment during the Deutsche Bank Global Auto Industry Conference held in New York City. Jacobson said that the investment will buy GM time to conduct a "strategic review" of the division's future.

Cruise faced a number of struggles in 2023, culminating in an Oct. 2 incident when one of Cruise's vehicles dragged a pedestrian 20 feet after she was hit by another driver. After the accident, the California Department of Motor Vehicles (DMV) suspended Cruise's permits in the state, alleging that the company withheld footage of it.

Cruise disputed the allegation but paused nationwide operations to reestablish trust with the public. Since then, the city of San Francisco filed a lawsuit against the California Public Utilities Commission (CPUC), the

organization responsible for regulating autonomous vehicles (AVs) in the state, to drastically reduce the number of robotaxis on the city's roads.

In May 2024, Cruise reached a settlement with the pedestrian for between \$8 million and \$12 million, according to *Bloomberg News*.

Recently, Cruise resumed manual driving in Houston and Dallas and announced that supervised driving is under way in Phoenix and Dallas. It began manual operations in Phoenix in April. The company has yet to restart driving in its home state of California. Cruise has long had its sights set on deploying its driverless robotaxis in San Francisco, where it was founded in 2013. It has said the city's difficult driving conditions will prepare its autonomous driving system for any other city.

Cruise is taking an incremental approach to rolling its robotaxis back out on public roads. Starting with manual operations, where a human driver controls the vehicles without autonomous systems engaged, allows the company to gather road information and create maps.

The company said that supervised autonomous driving, where Cruise's vehicles drive themselves with a safety driver behind the wheel ready to take over if needed, build on its data. Cruise added that safety drivers play an important role in testing AV performance on real-world roads and driving scenarios.

During this phase of operations, Cruise said it will validate its AV's end-to-end behaviors against its rigorous safety and performance requirements.

SOCIAL SECURITY MATTERS

Ask Rusty – Why is there a Social Security Earnings Limit?

Dear Rusty: I try to read your article in the Carmichael Times each week and appreciate the information you provide. I am 62 and considering my retirement options and when I should do that to get the most benefit. I understand my full retirement age is 67, but what I don't understand, and I hope you can answer, is why there is such a thing as the Social Security (SS) earnings limit? I know that if I was to retire before 67, my benefits would be reduced. But since I have been paying into SS for 45+ years, and that money is technically money I have earned, why does SS care if I make more than the earnings limit? It doesn't affect them or my benefits. Can you tell me about the reasoning behind the earnings limit? I will, for many years after "retiring," continue working in my field.

Signed: Working American

Dear Working American: This is a great question and, as a point of interest, our

parent company, the Association of Mature American Citizens (AMAC), advocates doing away with Social Security's earnings test which affects those collecting benefits before reaching their SS full retirement age (FRA). In AMAC's view, it discourages people from working and, thus, paying Social Security taxes on their earnings. It is, after all, SS taxes from the earnings of working Americans which largely pays for the benefits provided to Social Security beneficiaries. Eliminating the restriction would tend to improve Social Security revenue and help ease Social Security's current financial stress.

The reasoning behind the earnings test? Well, when Social Security was first enacted in the 1930s, the intent was that Social Security was for retired workers, meant to keep them from poverty in old age. The logic back then was that if a person worked they didn't need Social Security to sustain them, so those who worked could not collect Social Security at all. The current rule, after many adjustments over the years, says that annual earnings for those who collect early SS benefits are limited. If each year's earnings limit (\$22,320 for 2024) is exceeded, Social Security will take away \$1

in benefits for every \$2 over the limit (FYI, the penalty is less severe in the year FRA is attained).

Historical accounts suggest that the reasoning behind the wording in the original Social Security Act – that "No person shall receive such old-age annuity unless . . . he is not employed by another in a gainful occupation" - was quite controversial, except for the fundamental thought that if someone worked they didn't need Social Security. Over the ensuing decades the rule has been softened to provide that only those who collect benefits before their full retirement age (FRA) would have a portion of their SS benefits offset by their work earnings. In any case, the earnings test, in its mitigated form, still persists today. FYI, H.R. 5193 -The Senior Citizens Freedom to Work Act was recently introduced in Congress proposing to repeal the SS earnings test but has not advanced in the legislative process since introduced in August 2023.

In any case, under current rules, if you continue working after your FRA, the earnings test will not apply to you. And, if you lose any benefits before your FRA due to the earnings test, when you reach your

FRA you'll get time credit for any months that benefits were withheld, resulting in a somewhat higher monthly payment after your full retirement age.

One final point: If you continue to work after starting your Social Security benefits and your recent earnings are higher than any of those in the inflation-adjusted 35 years used to originally calculate your benefit, your entitlement will be recalculated to give you credit for those higher recent earnings.



AUTHOR FROM FREMONT TAKES PRIDE IN WRITING

an educator for 27 years, first in Fremont and then in Union City, as a school counselor and teacher for independent study and alternative education.

As much as she finds fulfillment in being an educator, Merrill knows how the job can lead to burnout. Her first foray into writing came about while she was taking a break from teaching to recover from surgery.

"I just needed some way to get the bitterness out of my head. So I started writing this story about an educator who was looking for a new job and stumbled across this mysterious job opening," she recounts, "I was trying to write myself out of a difficult situation. It took about three years of just poking at it whenever I was taking the kids to karate or the horse barn...any spare time I had."

Honing her craft and working with an editor, Merrill finished the next book in eight months. The next, in six months. Now she maintains a brisk pace, putting out new short stories, novellas, and full length books every few months. "Part of it is being a romance author," she explains. "Romance readers read voraciously. Sometimes between one and two books a day. So if you want readers to find you and connect with you, you need to provide them with a lot of stories."

Holding a Bachelor's degree in history and secondary education, and a Masters in counseling psychology, Merrill doesn't have a background in writing. "Maybe because I'm not an English major. I don't get hung up by the language because I know that I can always improve my prose or add to the story in rounds of revision. It's just getting that first draft out."

Still, Merrill had a love for reading growing up. She remembers, "I used to sit over at Centerville Library behind the Brookvale Shopping Center. My mom would take me there, and we'd get a big stack." They would also frequent indie bookstores piled high with paperbacks. Oddly enough, as Merrill notes, "I never read romance! I read horror, and I read kids' books. But when I started writing I came up with a love story. So what are you gonna do?"

A love of music is a big influence on her style, as she often "hears" her stories like a soundtrack or as voices, rather than imagining scenes playing out visually like a movie. "I'm a total eavesdropper," she admits. "When I go out I listen to people talk. So beware if you ever see the pink-haired lady!"

Her stories are often inspired by a song or genre. "Or I'm inspired by Rock history," she adds. "The next book that I have to finish this summer is inspired by the love triangle between Eric Clapton and George Harrisson and the woman they were both in love with. Sometimes I take these bits of music history and spin it into a fictional tale."

Merrill now identifies as queer, it took her a while to use the label (although she maintains her husband knew before she did). She explains, "Growing up in the 70s and 80s, you didn't label yourself." Now

she hopes her stories will resonate with people who don't often see themselves in books: "Whether it was a woman who didn't live up to the gender roles that had been defined for her, or men who were in love with other men. So I'm writing just about every kind of pairing or grouping you could possibly write."

Some of her favorite moments are interactions with parents of queer kids. "Every time I've done events, whether they're pride related or just regular book events and I happen to have my rainbow flag or rainbow something on my table, I always have parents come up to me and say 'My kid just came out as nonbinary — Thank you so much for writing books like this because I want my kid to be able to see themselves.'

"Books do so much for people," Merrill says. "They bring community, they bring

hope. They give you a bit of happiness or joy. Sometimes they scare the crap out of you, and sometimes they teach you something you needed to learn. They serve a really important purpose and I'm happy I can be a part of that."

R.L. Merrill is part of the Bay Area Queer Writers and Bay Area Romance Writers. You'll see her doing readings and book signings at conventions and at independent bookstores around the Bay Area. In June, 2024, Merrill had one of her short stories published in the anthology "Love is All." She plans to be at Books on B in Hayward for Bookstore Romance Day in August, and to have a table at Castro Valley Pride on July 20.

Block party celebrates 100 years at Dale Hardware

One hundred years is a milestone in anyone's book. And for longtime Fremont business Dale Hardware, it's a great time to celebrate the 100th birthday of its cooperative partner, Ace Hardware, with a party.

On Saturday, June 29 the store hosted a community block party, attracting hundreds of people to its retail home on Thornton Avenue in the Centerville district. Festivities included live hardware demonstrations, children's activities, family games and prizes. Guests could enjoy lumpia rolls or visit a nearby food truck for other snacks and beverages.

"This is really terrific," said KellyAnn Cahill, a Dale Hardware marketing associate as she surveyed the noontime crowd in the store's parking lot. "I'm really happy about the turnout; it's probably the best we've had so far." Visitors had a chance to ogle dozens of the latest barbecues and accessories, power tools, plants and nursery items displayed in the store's parking lot. All were on sale at discounted prices to celebrate the occasion. Additionally, representatives from popular tool and paint companies DeWalt, Milwaukee and Rust-Oleum were on hand to show their products and answer questions.

The block party was a pleasant surprise for shopper Vickie, a Newark woman. "It's fun and unexpected," she said while waiting in line to spin a wheel of fortune and possibly win a prize. She is a longtime Dale Hardware shopper who said she appreciates the store's convenience and service. "I like the wide selection of merchandise including lumber," she said, adding that she often shops for tools, "especially around Father's Day."

Inside the 100,000 square foot store the celebration continued. Hundreds of items, including popular Ace branded tools,



paints and electrical items were showcased with specially-trained Dale Hardware employees available to answer questions. But Cahill described the store's large outdoor garden section as the "crème de la crème" of the operation.

Garden section supervisor MJ Penovich agreed. About 15 years ago, she was involved in the design of the area which is a large covered greenhouse that provides a perfect place for plants to thrive under filtered sunlight and in a slightly humid environment. Like other Dale Hardware employees, Penovich knows her stuff. With a degree in horticulture, she can offer customers informed advice about plants, shrubs, trees, vegetables, grass, soils, growing conditions and even pest control.

"We have the basic stuff," Penovich said about garden supplies. But she added that what makes her garden department stand out from competitors is the variety of greenery and garden accessories they sell including ornaments, statues and sculptures. "We bring in fun and unique stuff," she said. "It thrills me when I see people walking up and down the aisles just checking everything out," she said.

While Ace is marking its centennial, Dale Hardware isn't far behind. The independent family-owned store started serving the Centerville area in 1955 and grew quickly after Fremont was incorporated the following year. In the 1960s it partnered with Chicago-based Ace Hardware cooperative which operates a robust network of distribution centers nationwide and helps independent hardware stores to collectively negotiate with suppliers.
