# New center celebrates its Fremont opening

ATTENDEES LEARN ABOUT FRIENDS OF CHILDREN WITH SPECIAL NEEDS

On Friday, August 23, a host of city and county dignitaries, together with more than a hundred guests, gathered to celebrate the grand opening of Friends of Children with Special Needs' newest center at 42080 Osgood Road in Fremont. It was also the launch of this year's annual art exhibition, "Expressions." A talented trio of musicians covering popular tunes welcomed arriving guests, and everyone was treated to an exciting performance by Harmony in Rhythm, a large all-percussion ensemble representing the Special Needs Percussion Guard Program.

FCSN's mission is "to help individuals with special needs and their families find love, hope, respect, and support through integrated community involvement" (fcsn1996.org).

In 1996, special-education teacher Shiow-Luan Chen heard of Chinese American families working to provide education and support for their special needs children. She reached out and began teaching parents about special education.

Within two years, the initial informal alliance, South Bay Integrated Family Support Group, had established a structured organization and begun publishing newsletters. By the end of 1998, "The formal structure and increasing membership firmly established FCSN" (fcsn1996.org).

Today, in excess of 800 families have benefitted from FCSN's more than 40 programs based in Fremont and San Jose. Receiving both private and government support, FCSN has taken a vital step with the opening of the new center in addressing the future needs of a rapidly expanding client base.

Board co-chair James Chiao expressed one of the primary concerns of parents with special needs children: "Parents want to feel secure that their children will become self-sufficient adults or at least have a resource for continuing education and enrichment once they leave the secondary school environment."


The existing facilities had limited capacity, but according to Co-President, CK Lee, the new center will be able to serve at least two hundred more clients. When the center becomes fully licensed later this year, it will offer an Adult Day Program, Living Services, a Supported Employment Program and Tailored Day Services.

The building was purchased in 2022, with renovations beginning in February 2023. The 18,000-square-foot, two-story building has a meeting hall, kitchen and dining facilities, classrooms, conference rooms, computer labs and offices for staff and volunteers.

FCSN sponsors a variety of Enrichment and After School programs including education in the visual arts and music. The art exhibition, which ran August 26 - 29, features more than a hundred works by FCSN artists, embracing media such as oil-painting, pen and ink, and printmaking.

FCSN is widely recognized for its dedication to serving a growing need, and many representatives from the East Bay officially came to recognize it.

# Photographer Chen captures Bay Area through birds' eyes

#### MAY CHEN'S OHLONE COLLEGE EXHIBIT SHOWS VULNERABILITY OF WILDLIFE

Nature is healing. "Being connected with nature, you have a sense that everything is going to be alright," says photographer May Chen. Her collection of birds photos from the Bay Area and beyond possess a peaceful and mesmerizing quality. However, the story of native wildlife is more complex, as nature symbolizes constancy and endurance and also the consequences of selfishness.

#### Reciprocation

This Great Heron couple made their nest right on the Fremont Ohlone campus, and the photo captures the pair adding softer materials in addition to hard branches in preparation for egg laying. "To do wildlife photography, one really needs to study and know the subject," says Chen. "Know their habitat. Know the breeding season. You almost get to know their personality."

#### The Fly Off

May Chen teaches Tai Chi, Qigong, and Mediation at Ohlone —not photography. "The Fly Off" shows some of her philosophy. This image of uncountable Snow Geese taking off over a lake and reflected in the water combines chaotic action with a meditative atmosphere. "Nature in itself is not just one direction," she says. "Along with something growing above ground, the

root is also growing and bringing nutrition." Like the concept of Yin and Yang, nature involves opposing and interconnected forces in balance.

#### Tantrum

It's easy to anthropomorphize these two images of a juvenile Great Egret, an only child, demanding food from his parent even with a full crop. Chen emphasizes the emotional depth of her bird subjects. However this photo has a darker story. In a description of the photos, Chen writes, "There were three small islands at the Lakeshore Park, Newark, CA. The heronries were a local favorite site for photographers throughout the spring breeding and nesting season. Then quietly by 2023, all [400] nests disappeared. Residents responded to the sudden site popularity brought on by mass media. The noise, parking issues, and people rudeness invading an otherwise quiet neighborhood. This loss of habitat was brought on by human behavior." "Tantrum" highlights the damage humans can do if they admire nature without respecting it. The humans annoyed each other, and birds paid

# To vax or not to vax?

#### LEARN ABOUT VACCINE AVAILABILITY AND AT-RISK GROUPS

Everyone would like to be done with COVID, but the surge this summer showed that precautions are still necessary. This fall, people are wondering when the next COVID booster will become available, whether to get a flu shot, and who is vulnerable to respiratory illnesses that tend to go around during the holiday season.

Dr. Dianne C. Martin, Internal Medicine and Infectious Diseases, Washington Hospital Healthcare System, spoke with Tri-City Voice on what people can do to keep themselves and their loved ones safe. The below facts are summarized from the information she shared.

### Why did we have such a big surge this summer?

The strain circulating Summer 2024 isn't making people as sick as some earlier strains. Martin says, "Because the symptoms are so mild, people don't really connect and say, 'This might be COVID.'" People then unfortunately go on to infect others. Heat waves have also driven more people indoors where air circulation is worse.

#### Who needs a vaccine?

Whether it's flu, COVID, pneumonia or RSV, there's a lot of overlap among those who are most vulnerable: people who are immunocompromised for any reason; those on dialysis; people undergoing chemotherapy; those with heart disease or respiratory problems, and those over 65. Even if you're not especially vulnerable, it's a good idea to get your fall flu vaccine, and a COVID booster when the new one comes out. This helps protect others. Adults usually get the pneumonia vaccine every five to 10 years, and kids before starting school.

#### When will the next COVID booster come out?

The Centers for Disease Control and Prevention (CDC) hasn't announced exactly when the next booster will be available, but according to Martin it may be as early as mid-September.

## Dispelling Misconceptions About Sepsis Infection

ICU Doctor Advises Treating Infections Early to Avoid Complications

Most people know little about an infection called sepsis and they often worry. The life-threatening condition is caused when common infections such as lung (pneumonia) or urinary tract (UTI) aren't treated and spread.

Treating infections early prevents them from developing into sepsis, advises Cyrus Shariat, MD, a critical care intensivist at Washington Hospital Healthcare System in Fremont. "Don't delay because you're afraid to go to the doctor, especially for a suspected UTI or respiratory illness," he says.

Sepsis is a severe infection that causes organ dysfunction because of a dysregulated immune response. The infection is usually due to bacteria but viruses such as influenza and COVID can sometimes lead to sepsis. Dr. Shariat explains, "An infection can travel from the source, such as the lungs, in a case of pneumonia, and affect other organs. The organs which are the most common sources of sepsis are the lungs, bladder, kidneys, blood and skin."

#### **Upcoming Presentation**

Dr. Shariat is raising awareness about sepsis, allaying fears, and dispelling common misunderstandings. He'll explain the signs, symptoms, and prevention tips in a presentation on Sept. 25, 9 a.m., "Sepsis: What Is It and How Can We Increase Awareness?" #### The signs and symptoms of sepsis include:


- Fever, chills or shaking, or a low temperature (less than 96.8)
- Shortness of breathing and/or fast breathing
- Fast heart rate (greater than 100)
- · Confusion or lethargy
- Extreme fatigue
- Lightheadedness
- Rash or mottled skin

#### People most at risk for sepsis are:

- Elderly patients
- People with compromised immune systems
- Patients with diabetes
- Patients with chronic medical conditions such as heart, kidney or lung disease
- Patients with chronic indwelling

Dr. Shariat notes, "It all comes down to organ dysfunction in sepsis. When we see an infection that is causing other organs to be affected, we immediately suspect sepsis." Emergency care doctors often are the first line of defense in sepsis, swiftly diagnosing patients who come to the Emergency Department very sick. "I take sepsis very seriously," he adds. "My motto is: A sick patient that I am evaluating has sepsis until proven otherwise."

#### **Sepsis Mortality**

Sepsis affects 1.7 million people a year in the United States and is responsible for up to one 1 in 3 hospital deaths. Depending on the severity of sepsis on presentation to the hospital, the mortality ranges from 15%-40%.

One of the signs of sepsis, is a blood pressure drop resulting from leaky veins not properly perfusing organs. Elderly patients who have sepsis from a UTI often appear confused if blood to the brain is reduced. A septic person's heart can become weak, blood may not clot, and kidneys and liver be affected, among other complications.

People often ask Dr. Shariat if they can catch sepsis from an infected person. While some infections, like certain strains of pneumonia and strep, can spread from person to person, most that lead to sepsis aren't contagious, he adds.

A common misconception is that sepsis is usually acquired in a hospital. Dr. Shariat explains, "I've seen many more patients who come into the Hospital with sepsis than people who got the infection during their stay." While the elderly, patients with long hospitalizations, and those with chronic diseases are at risk, Washington Hospital takes all infection prevention precautions.

#### **Infection Prevention Tips**

To prevent any type of infection, Dr. Shariat urges taking steps to stay healthy. He recommends eating right, maintaining a healthy weight, getting

the recommended amount of exercise, sleeping well, and listening to your primary care doctor to keep your immune system strong. Managing chronic medical conditions, like diabetes, chronic obstructive pulmonary disease (COPD) or asthma also helps. For example, having COPD puts one at higher risk for respiratory infections, which could turn septic. Also, a patient with diabetes getting a skin infection that doesn't heal is more at risk of sepsis.

Good hand hygiene is also important in infection prevention, and Dr. Shariat urges washing often. He also recommends washing any cut thoroughly and applying antibiotic ointment.

"Sometimes there's nothing you can do to prevent infection, but always remember to get medical attention early. If you present at a hospital late in the sepsis process with multiple organs not functioning, your outcome will be worse," he emphasizes.





# September is Atrial Fibrillation Awareness Month

Keep Your Heart in Rhythm for Cardiovascular Health

"Since atrial fibrillation can be a silent condition for some people, it's important to get regular checkups with your physician, especially if you have the risk factors for AFib." -Sangeetha Balakrishnan, MD

Nearly 3 million Americans live with a heart condition called atrial fibrillation (AFib) and the CDC says that number could rise to 12 million by 2030. A normal heart rhythm sounds like a steady drum, but AFib sounds like a chaotic drumbeat. People with this condition may be at greater risk of blood clots, heart failure and stroke. September marks National Atrial Fibrillation Awareness Month—the time to learn more about AFib risk factors, symptoms and treatment options.

Sangeetha Balakrishnan, MD, a cardiologist with Washington Township Medical Foundation, sees patients in Fremont with AFib and other cardiac issues. In addition to board certifications in internal medicine, cardiology,

and nuclear cardiology, her medical training included a fellowship in cardiac electrophysiology, which is the study of heart rhythm disorders.

"Some patients with atrial fibrillation can feel it, and some cannot," explained Dr. Balakrishnan. "Generally, they will experience symptoms like palpitations, dizziness, shortness of breath and fatigue. I also see patients in AFib with a pulse in the 130s who do not realize their heart is beating at too high a rate or out of

#### **AFib Risk Factors, Diagnosis** and Treatments

AFib can be dangerous because it may cause the heart to work harder, weaken the heart muscle, and lead to other medical problems like heart failure and stroke. The risk of AFib increases with age, and one in 10 people over the age of 80 have it. Other risk factors include heart disease, diabetes, high blood pressure, sleep apnea, hyperthyroidism, and kidney or lung disease. Lifestyle risk factors for AFib include obesity, smoking and alcohol use.

The process of diagnosing atrial fibrillation usually includes a physical examination along with an electrocardiogram (EKG), ultrasound of the heart, and lab work to check levels of electrolytes, thyroid hormone, potassium, cholesterol, hemoglobin A1c and other AFib indicators found in blood samples.

"Some patients experience sporadic episodes of atrial fibrillation which can make it difficult to diagnose with an EKG. These patients may wear a long-term heart monitor patch, usually for two weeks, so we can track whether the heart goes into AFib, and if so, for how long and often," said Dr. Balakrishnan.

Treatments for AFib vary because the condition is complex and has many different causes, but generally they fall into two main categories: rate control and rhythm control. Rate control medications, like beta blockers, allow the heart to beat irregularly but at a slower pace. Rhythm control, called cardioversion, stops the atrial fibrillations so the heart can beat regularly again. Electrical cardioversion involves giving the heart an electrical

shock through paddles or patches on the chest, while drug cardioversion calls for taking antiarrhythmic drugs. Other AFib treatments include a minimally invasive procedure called catheter ablation, and sometimes blood thinning medications are used to reduce the risk of stroke.

"Since atrial fibrillation can be a silent condition for some people, it's important to get regular checkups with your physician, especially if you have risk factors for AFib," advised Dr. Balakrishnan. "If you experience symptoms, request a referral to a cardiologist so you can be tested and treated if needed. It's important for your heart health, can make you feel better, and may improve your quality of life."





# Hayward PD response to Hayward High School assault

On August 26, 2024, at about 1:22pm, officers responded to the report of an assault at Hayward High School on 1633 East Ave. Witnesses advised that three students were involved in a physical altercation, and that at least one student may have sustained injuries from a knife.

Officers arrived on scene and located two of the three students that were involved in the altercation.

One of the students, a 15-year-old male, was found to have injuries that appeared to have been caused by a knife. He was transported to a local medical facility and was treated for non-life-threatening injuries.

A second student, a 14-year-old male, was contacted and appeared to have minor injuries as a result of the confrontation.

The third student, a 15-year-old male, was located a short time later after a family member transported him to a local hospital. The student received treatment for non-lifethreatening injuries that appeared to have been caused by a knife.

The Hayward Police Department is in the process of investigating this incident, which includes the collection and processing of evidence, speaking with the involved parties and witnesses, and supporting the Hayward Unified School District (HUSD) as they address this incident administratively. No arrests have been made. The circumstances leading up to this incident are currently under investigation and we are not releasing any further information at this time as all of the involved parties are juveniles.

Student safety is and will remain a priority for the Hayward Police Department. We will continue to provide support to the Hayward Unified School District (HUSD) as they work to maintain an environment conducive to learning and one in which students and staff feel safe.

# Shooting suspect apprehended after extensive search

On August 7, 2024, at approximately 7:30pm, Fremont Officers were dispatched to the area of Isherwood Way and Chaplin Drive to the report of a shooting. The victim, a Fremont resident, reported being shot at with a handgun by an unknown male suspect after a brief argument. The suspect then fled the scene and was last seen running into a nearby homeless encampment. The victim was unharmed and provided a picture of the suspect to officers on scene. The suspect was soon identified by police as David Becerra, 50 years old, out of Fremont.

Fremont Officers coordinated with East Bay Regional Park District PD, Union City PD and Newark PD K9 Officers to establish a perimeter. After an extensive ground search and with assistance from a California Highway Patrol Air Unit and Fremont PD drones, officers located and arrested Becerra as he attempted to break the perimeter. Becerra has a lengthy criminal history in Alameda County, including arrests for making criminal threats, resisting arrest, attempted murder and multiple arrests for assault with a deadly weapon.

The case was subsequently presented to the Alameda County District Attorney's Office, and Becerra was charged with assault with a semi-automatic firearm, discharge of a firearm with gross negligence and felon in possession of a firearm.

# Police activity highlights

Over the course of several weeks, commercial burglaries occurred at and around the 29300 and 29500 block of Kohoutek Way.

Patrol conducted the initial investigations and were able to recover video surveillance depicting the suspects and vehicles. A consistent Modus Operandi involved the suspects using a red Chevrolet Colorado to back into the business roll-up doors to force entry, then two suspects would enter and take property. There were several thousands of dollars in property loss and damage to the affected buildings.

Patrol, Investigations and the Special Services Unit developed a potential suspect who was known to be associated to a red Chevrolet Colorado. Additional investigative tools that were extremely helpful in this investigation were Flock cameras, physical surveillance by

SSU and electronic surveillance.

During physical surveillance operations, two suspects were seen "casing" neighborhoods and later seen discarding open packages. The packages were recovered and were linked to a Union City package theft case.

The Chevrolet Colorado was a stolen vehicle out of Hayward. This vehicle contained license plates that belonged to another vehicle. Two additional vehicles were also identified as suspect vehicles. An additional suspect has been identified via video and physical surveillance.

After obtaining arrest and search warrants for all involved suspects, arrests were made and the warrants served. Stolen property from the burglaries was recovered at two locations. A third suspect was arrested, and his residence was searched pursuant to a search warrant with loss located at his residence.



## Don't be lax: Protect to the max!

"Get your vaccines. Be safe. Protect yourself. Protect your family." - Dr. Dianne C. Martin, Internal Medicine and Infectious Diseases, Washington Hospital Healthcare System

#### Will I have to pay for my COVID booster?

Unfortunately, COVID vaccines are no longer free across the board. However, most insurances, including Medicare, will cover them.

#### Can I get a COVID and flu vaccine at the same time?

Yes, just get them on different arms. Patients may experience more severe side effects such as headache, fatigue and injection site reactions. These are temporary. Martin advises, "You may want to [get both vaccines] on Friday afternoon when you're not going to do anything on Saturday.'

#### Is the COVID vaccine safe for pregnant people?

Yes! In fact, because the COVID vaccine isn't available for infants under six months old newborns can gain some immunity from their mothers who take the vaccine while pregnant.

#### Who should get a flu vaccine?

Adults and kids over six months old. Intranasal vaccines are available too. It's strongly recommended that seniors get a special high dose flu vaccine that's more effective (ask at the pharmacy).

#### I have an egg allergy. Is the flu vaccine safe for me?

The vaccine Flucelvax has no egg products and is safe for those with severe allergies.

#### Can I get the flu from the

No, you can't. Either the viruses

are killed or the vaccine doesn't include flu viruses.

Flu shots are made using killed flu viruses (for inactivated vaccines), or without flu virus at all (for the recombinant vaccine). So, you cannot get the flu from a flu shot.

#### What do I do if I get COVID?

Stay home to recover, and take fever reducing medication such as acetaminophen—or aspirin or non-steroidal anti-inflammatories if prescribed by your doctor. Paxlovid can help with the symptoms, so check with your doctor even if your case is mild. Paxlovid can interact with some common medications. such as cholesterol meds, but it's usually safe to stop taking those for a week.

#### If I'm sick, can I still access medical care?

Martin advises those who have tested positive for COVID, or who are experiencing symptoms like cough or fever to do a phone or video consult. She explains, "We don't want our staff to get infected or other people sitting in the waiting room to get infected. If you're sick, contact your doctor to see what you can do and stay home until you feel better."

#### What other precautions can I take to stay healthy?

Martin says, "Your best protection is A) the Vaccine and B) If you're sick, stay home." Masking in crowded settings and indoor settings also helps. Masks are safe to reuse for four to five

days, as long as they aren't wet from droplets. Just hold the mask by the straps to avoid touching contaminated areas and keep the mask in a clean paper bag when not in use.

#### Where can I go for accurate information?

The CDC website is reliable and user friendly. It updates information often: www.cdc.gov/covid/index.html

#### I feel bad for flaking on people when I'm feeling mostly OK....

It can feel awkward to bring up topics like infectious disease when planning social gatherings. But it's important to take care of each other. Martin says, "You don't want to call your friend and say, 'I can't come, I'm sick. But if that was my friend I'd say, 'Thank you very much for staying home to take care of yourself and not share infection!"

Overall, the things people can do to avoid illness are simple. But they do require intentionality. Martin summarizes, "It's accepting responsibility that if you're sick and you're going to be with someone else, you might pass it on. And you might have a mild illness, but maybe they have something they haven't told you about-they've just started chemo therapy, or something-and they might get sicker. This is not rocket science. Everybody's immune system is different. And what gives one person a 1% mild case, the next person may be more severe."

## PROTECT YOURSELF FROM WEST NILE VIRUS

West Nile Virus is an uncommon viral disease transmitted from infected birds through mosquito bites to humans. Most cases are mild and only one in 200 will develop severe symptoms. Usual symptoms include headache, fatigue, back pain, muscle aches and rash. Symptoms can last a few days. Some people have persistent symptoms for 12 -18 months, especially if immunocompromised—such as people with diabetes, people on cancer-treating medications, dialysis patients or HIV+ people.

There are more cases on the east coast compared to California, but cases have

been reported in humans in Contra Costa and Alameda County. Most are very mild and do not require hospitalization. There is no known medical treatment for West Nile Virus infection, although some trials are ongoing.

Prevention is key: Avoid mosquito-infested areas, wear long sleeves if outdoors, and use mosquito repellant frequently. At home, drain any areas with standing water as these are common areas for mosquitos to breed. Cases of West Nile Virus are more common in summer but can extend into early September.

If infection is suspected, report to Alameda Public Health or call the Centers for Disease Control at 800.311.3435. To report dead birds, call 877-WNV-BIRD or visit Westnile.ca.gov.

## September's Night Sky Notes: Marvelous Moons

September brings the gas giants Jupiter and Saturn back into view, along with their satellites. And while we organize celebrations to observe our own Moon this month, be sure to grab a telescope or binoculars to see other moons within our Solar System! We recommend observing these moons (and planets!) when they are at their highest in the night sky, to get the best possible unobstructed views

#### The More the Merrier

As of September 2024, the ringed planet Saturn has 146 identified moons in its orbit. These celestial bodies range in size—from smallest at a few hundred feet across, to Titan, the second largest moon in our solar system.

Even at nearly 900 million miles away, Titan can be easily spotted next to Saturn with a 4-inch telescope, under urban and

suburban skies, due to its sheer size. With an atmosphere of mostly nitrogen with traces of hydrogen and methane, Titan was briefly explored in 2005 with the Huygens probe as part of the Cassini-Huygens mission, providing more information about the surface of Titan. NASA's mission Dragonfly is set to explore the surface of Titan in the

Saturn's moon Enceladus was also explored by the Cassini mission, revealing plumes of ice that erupt from below the surface, adding to the brilliance of Saturn's rings. Much like our own Moon, Enceladus remains tidally locked with Saturn, presenting the same side towards its host planet at all times.

#### **The Galilean Gang**

The King of the Planets might not have the most moons, but four of Jupiter's 95 moons are definitely the easiest to see with a small pair of binoculars or a small telescope because they form a clear line. The Galilean Moons – Ganymede, Callisto, Io, and Europa – were first discovered in 1610 and they continue to amaze stargazers across the globe.

Ganymede: largest moon in our solar system, and larger than the planet Mercury, Ganymede has its own magnetic field and a possible saltwater ocean beneath the surface.

Callisto: this heavily cratered moon is the third largest in our solar system. Although Callisto is the furthest away of the Galilean moons, it only takes 17 days to complete an orbit around Jupiter.

Io: the closest moon and third largest in this system, Io is an extremely active world, due to the push and pull of Jupiter's gravity. The volcanic activity of this rocky world is so intense that it can be seen from some of the largest telescopes here on Earth.

Europa: Jupiter's smallest moon also

happens to be the strongest candidate for a liquid ocean beneath the surface. NASA's Europa Clipper is set to launch October 2024 and will determine if this moon has conditions suitable to support life.

Be sure to celebrate International Observe the Moon Night here on Earth September 14, 2024, leading up to the super full moon on September 17! The successful renovation of Washington High School's (WHS) Husky Garden was celebrated with a ribbon cutting ceremony on August 13.

WHS Principal Bob Moran presided over the event, which was attended by many school staff, student leadership, Fremont Unified School District (FUSD) leadership including Superintendent Erik Burmeister and community partners who made the transformation of the garden possible.

"The reconstruction of the Husky Garden began prior to 2020 and was completed this summer," said Moran. "It was a collective effort of many teachers, students, programs, volunteers and industry partners."

The Home Depot became a key partner in the recent overhaul of Husky Gardens when its corporate offices responded to a request to help make the garden—which is in the heart of the WHS campus bounded by a row of lockers and a row of classrooms on either side—a place for instruction, relaxation and all manner of growth.

noticed the community-focused work The Home Depot was supporting in neighborhoods across the country, and she saw an opportunity.

"I was watching TV over winter break and saw the new Home Depot commercial promoting their new 'Path to Pro' campaign—and it resonated with me," said Burns. "I wanted to spin off it for a FUSD project and thought what the heck? I'll email their corporate offices and see if anyone responds."

The Home Depot Corporation connected Burns to its Bay Area leadership and Lucretia Heath, Regional Pro Account Sales Manager for The Home Depot. Heath visited the site in early 2024 to meet with Burns and other WHS educators to explore the potential of the space and how The Home Depot could help the school reach its goals.

Heath helped Burns with initial planning and applying for a \$10,000 grant to purchase supplies from The Home Depot to complete the project. Beyond providing funding, The

Home Depot also supported the overall design and provided an incredible crew from the Fremont and Newark stores that helped deliver and install materials, improve and beautify the garden and haul away waste.

Over many years, many WHS educators and students have contributed to efforts to build and maintain the garden. Students and staff in Special Education and AVID created and nurtured plants and aesthetic features throughout the garden over many years, and partnered with the Boy Scouts of America to construct planter boxes and benches. The school's MultiMedia Art Academy (MMAA) alumni started a "living mural" in 2022 that will continue to grow with the garden. Ceramics teacher Jake Rodenkirk and his students provided a Husky solar fountain for the garden, plus ollas that slowly release water to the plants—in addition to a drip irrigation system.

Steve Olson from Centerville Middle School joined the effort to relaunch the Husky Garden by designing and building a beautiful redwood sign that hangs outside its entrance. Swagelok Northern California provided funding for this sign, and other garden tools.

Burns is continuing her work to coordinate upkeep of the garden by students and colleagues through a Garden Committee. Farmers' Market Fridays will be scheduled soon, and the space is open now as a productive and tranquil place for WHS students and staff.

As Moran proclaimed at the ribbon cutting: "Husky Gardens is officially open!"



#### YOUNG ENTREPRENEURS SHOWCASE THEIR WARES

On Saturday, August 24, 30 young entrepreneurs gathered for the 1st Annual Fremont Children's Business Fair. Weekend shoppers at the Fremont Hub were pleasantly surprised to find a small village of tents and tables arrayed in rows along the entrance courtyard, each manned by pint-sized, local innovators ages 6-14, hawking their wares to attendees and the general public.

On display were products and services that could only come from the minds of youngsters—homemade cotton candy sold by Fluff 'n' Puff, balloon sculptures by Creative Creations, and cute little charms by RubyOpal Crafts, to name a few. But don't be fooled by these childish titles—these kids mean business.

The event challenged budding creators to come up with a product or service, develop a brand, build a marketing strategy, interact with customers, and handle setup, display and sales, all on their own. Of course, many proud parents were in attendance, but could only watch from the wings as their genius kids took center stage, processing orders through Venmo and PayPal with ease.

Said event organizer Dr. Najwa Javed, "Kids are always underestimated. They have great ideas and so this is a way to showcase them in a very accessible way. We're so excited!" As a certified podiatrist running her own practice and founder of E'MAR Italy, a luxury footwear brand built with patent-pending medical technology, Javed knows first hand what it takes to become a successful business owner.

Javed's husband, Fahad Rizqi, a software developer, acted as emcee for the fair. "This whole experience is a great way to boost their confidence," he said. "It teaches them how to speak to people, how to market, how to sell, how to get their value proposition out there, and how to work with different types of people. This will help them so much later on in their career."

In fact, it was their 14-year-old son, Aydin Rizqi, who came up with the idea of hosting a children's business fair, having experienced a similar event in Dublin. He thought, Why not Fremont? Readers may remember Aydin from a previous TCV article. He is the author of ten books currently selling on Amazon and Barnes & Noble.

Of course, not to be outdone, younger sister Rayah, age 12, has created her own unique business selling custom perfumes under the brand name Petals & Potions. She won Best Young Entrepreneur at the event.

The Rizqi family, as talented as they are, could not have hosted such an incredible fair on their own. They are grateful to all of the volunteers and family friends who chipped in to help, and to the Fremont Hub property group Kimco Realty for providing the perfect space. Crucial to the success of the event was their partnership with

Acton Academy, a national nonprofit that helps communities host their own children's business fair by providing guidance with sponsorships, marketing material, tent and table placement, applicant criteria and prizes.

All participants received an Excellence in Business Award, handed out by Fremont Council Member Teresa Cox, who has served as a Trade Adviser for the United States Department of Commerce under the past three Presidents. Said Cox, "There's a lot of things that we need to do as a community to support our youth, and fostering young entrepreneurs in a safe environment is one of them. Every student can shine if we work to embrace diversity, equity and inclusion. We're highlighting the positives, and I couldn't be more excited!"

A panel of judges evaluated each business and handed out some bonus prizes, including an Outstanding Leadership Certificate awarded to Shiven Balaji for his Chess Adventure Books, and an Excellence in Business Certificate awarded to Naiel and Punhal Chaudry for their business, La Jawab Treats. Local foodies may remember Naiel from The Food Network's Kids Baking Championships, Season 11, which he won.

Ashar Rizqi, CEO of Bounti.ai, was one of the judges (yes, another Rizqi - Fahad's brother), "What's so incredibly powerful about events like this is that they create a sense of community where young entrepreneurs can learn to love their business, where they can learn from each other and improve. It doesn't always have to be competitive. These kids are gaining valuable life skills, and I'm sure many will go on to become future job creators of America."

The fair is also a way for those just starting out to test their products and gauge interest, a safe way to conduct market research. That's what appealed to 9 year-old Kiran Vinayak, whose business, Kiki's Magical World, is all about spreading positive messages. "I want to inspire young

opportunities for members in the Bay Area.

By all accounts, the first Fremont Children's Business Fair was a resounding success, with over 50 applicants on the waiting list. The Rizqi Family is already thinking about doing it again next year, when Aydin will probably be finishing up his 20th book and directing a movie, and Rayah will be selling her perfumes on QVC.







## Managing weeds in the garden

No matter the weather, weeds seem to thrive and reproduce, and if left unchecked, they can overwhelm the garden and gardener. These unwanted plants find their way into your garden as seeds, roots, rhizomes or whole plants. Seeds can be carried in by the wind, birds, and other animals, or on the soles of shoes. Roots, rhizomes and even plants hitch a ride in the soil or with plants that we move into the garden.

Start early managing weeds in your garden. Smaller weeds are easier to pull and removing them before they flower and form seeds can prevent hundreds of weeds in next year's landscape.

This is not always possible. Weather and busy schedules often limit gardening time, allowing these vigorous plants to overtake the garden.

It is never too late and always worth investing time in managing weeds in the garden. Weeds are adaptable and vigorous, outcompeting your desirable plants for water and nutrients. Many serve as host plants for insect pests and diseases that may also

attack your garden plants. Carefully dig or pull weeds, removing the top and roots. Established weeds may have a deep tap root or extensive root system that may be difficult to remove. Depending on the weed, any part left behind has the potential to start a

Find the tool that best works for you. A Dutch or action hoe works well on small weeds where there is space between plants. Glide the cutting edge just below the soil surface to cut the roots. Many gardeners find a weed knife to be a useful tool. It allows you to dig right next to the weed and pop it out of the ground with minimal impact on surrounding plants.

If bending is an issue, you may opt for one of the standup weeders. There are several types available. Most have tines you insert into the soil surrounding the weed. A hand or foot-operated action causes the tines to tighten around the weed roots before you lever it out of the ground.

Perennial weeds are a bit more challenging. Many have extensive roots that are nearly impossible to remove entirely. Repeatedly digging up the plants can

eventually manage these weeds, but it can take years. Cutting the plants back to the ground as soon as they appear can help "starve" them, prevent reseeding and help contain and even eliminate some perennial weeds.

If weeds begin to take over the garden, tackle those flowering or setting seeds first. Do not compost these or perennial weeds. Most compost piles don't get hot enough to kill the seeds or perennial weeds. Contact your local municipality to find out your options for disposing of these as well as invasive weeds.

Once weeds are out of the garden, spread a layer of organic mulch over the soil surface. The finer the mulch, the thinner the layer needed. Pull the mulch away from tree trunks, shrub stems and the crowns of your other plants.

Mulching helps suppress weeds by reducing seed sprouting and making it easier to pull the seedlings that get through the mulch. Increase your success by placing a couple of sheets of newspaper or a piece of cardboard beneath the mulch. Mulching won't stop existing perennial weeds like

quackgrass and bindweed. Keep managing these until all the roots have been removed.

Shredded leaves, evergreen needles, and other organic mulch also conserve moisture, moderate soil temperatures, and add organic matter to the soil as it breaks down. Mulch also helps protect the soil from compaction and erosion during heavy rains. As many places experience more intense rainfall and higher-than-normal summer heat, mulching the soil becomes even more beneficial.

Consider the benefits when you head out to tackle the weeds in your garden. You will improve the health and beauty of your garden while burning between 200 and 400 calories every hour you weed.

The grant, awarded through the NSF's Division of Undergraduate Education, will support the project titled "Expanding Opportunities

and Instructional Innovations for English Language Learners in Computer Science."

"This grant is a significant step forward in our mission to broaden participation in STEM fields by providing innovative and inclusive educational opportunities for our diverse student population," Dr. Silverman stated. "We are grateful to the NSF for recognizing the potential impact of this project, and we look forward to empowering more students to pursue their dreams in computer science."

Dr. Emily Dilger, CEO of Ignited, also shared her enthusiasm for the collaboration, stating, "We are thrilled to be a part of this groundbreaking project. The fact that this initiative was faculty-driven and grew out of the passion of educators who have previously participated in our programs is a testament to our shared dedication to making a meaningful impact. The three-year project began on September 1, 2024, and is expected to serve as a national model for enhancing STEM education at two-year colleges. ## Labor Day

#### **EDITORIAL FROM** WILLIAM MARSHAK, **EDITOR-IN-CHIEF EMERITUS**

What else would we run this week, but an editorial on labor day? In this article that originally ran on August 31, 2010, Bill Marshak discusses the importance of workers rights, an everrelevant issue. I did a stint in retail nearly 10 years ago, and even a few months opened my eyes to how service workers are treated as disposable both by their companies and by customers. During the 2020 pandemic, it turned out many of the lowest paid and least respected workers were essential to the supply chain. When there's demand for the results of labor (for example In-N-Out burgers), the workers deserve respect too. - Stephanie Gertsch

The Federal holiday most closely associated with the end of summer is not related to length of days except in a tangential manner. Labor Day is recognition of the chaotic and often adversarial nature of business. As a free and capitalistic society, we pay homage to entrepreneurial initiative which, in theory, recognizes the fruits of hard, honest labor. In practice however, at times there is little

distinction between the amount of wealth and

In the quest for money, power and prestige, historical and contemporary examples abound of worker abuse even though such employment was and still is critical to the creation of wealth. Long hours and poor compensation are a legacy filled with sweatshops, child labor and poor working conditions. These business practices were common leading up to the establishment of unions in the United States. The struggle between "haves" and "have-nots" is often disruptive and unruly; unions offer powerful representation for working people. Those in power, enjoying wealth and luxurious lifestyles, have been reluctant to relinquish their position while others, striving for an equitable piece of the action, find strength through the power of consolidation... a union.

The birth of unions in this country has been a brutal and uneven process but one that brings a degree of balance to the workplace. Attributes of war have been present in this struggle; Labor Day was declared to lessen the intense pain of the particularly bloody and brutal Pullman strike in 1894. There is nothing foreign about unions. Our nation is based on the concept of a union formed to defy existing social, political and military structures. The Preamble to the United States Constitution states:

We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this

While many societies throughout the world limit movement through economic and social class by birth, skin color, religion and other external factors, in our celebration of Labor Day, the United States recognizes the ideal of strength and fairness through group actions. Those who achieve economic power through the labor of others may accumulate wealth, but must recognize the contribution of partners in the enterprise—labor—to achieve their goals.

Labor unions are not perfect, suffering internal problems of corruption and greed, but throughout the struggle between labor and management, they have been a voice that cannot be ignored. In an increasingly complex world in which business challenges are constantly changing, balance at workplaces is essential. Labor Day is a time to reflect on the formation of our nation and the value of those who continue to be world leaders as a productive

Constitution for the United States of America.

# Ask Rusty—Federal Retiree Asks About His Social Security

Dear Rusty: I retired with a (gross) \$4,600 per month Civil Service Retirement System (CSRS) annuity from the US Postal Service in December 2022. I am 66 and will attain full retirement age in November of this year. I know at that point I will not be subject to the "earnings" test, but I will be affected by the dreaded "government offset." I have earned enough quarters and will be eligible for a small Social Security benefit. First question: will my SS benefit just be reduced, or will it be eliminated? Second: will it make a difference if I apply in November or when I turn 70? I am currently working part-time and paying Social Security FICA taxes. Third: if my SS is being eliminated, do I even have to apply? Fourth and last: I am married, filing jointly and my wife is currently receiving SS benefits (only). Could I also be affected by the "windfall" provision if my wife predeceased me? Signed: Upset to Offset and Downfall to Windfall

Dear Upset: You are correct that when you reach your full retirement age (FRA) in November you will no longer be subject to Social Security's "earnings test," which limits how much you can earn while collecting early benefits. But if you apply for your Social Security to start in November, your SS benefits will be affected by the Windfall Elimination

Provision (WEP) due to your non-covered CSRS pension (because you didn't pay into SS while earning your CSRS pension). As you may know, only those federal employees who retired under CSRS (Civil Service Retirement System) are affected by WEP; newer Federal employees who retire under the more recent FERS (Federal Employee Retirement Program) program are not affected.

Because of your CSRS pension, your Social Security benefit will be reduced, but not eliminated. The amount of reduction will be based on the number of years of nongovernment employment you had (where you paid into Social Security). Usually, those who have spent a lifetime earning a pension without contributing to SS, but who have a separately earned SS pension, will see their SS benefit cut approximately in half.

To answer your second question, your benefit will, indeed, continue to grow if you wait until you are age 70 to claim Social Security. Benefits taken after one's full retirement age earn "delayed retirement credits" (DRCs), which add to your final benefit amount. Your benefit will still be reduced by WEP, but your final amount will be more because you waited longer to claim.

Re your third question, your SS benefit will only be reduced (not eliminated), so it's always worthwhile to apply. Otherwise, you are forfeiting Social Security money you are entitled to.

And lastly, if your wife dies before you, your CSRS pension will also cause another provision called the Government Pension Offset (GPO) provision to apply. The GPO will reduce your surviving spouse benefits by 2/3rds of the amount of your government CSRS pension, which will likely eliminate any spousal benefit you are entitled to (except the so-called "death benefit" – which is a one-time lump sum \$255 benefit paid to a surviving spouse).

## A second elephant calf in 2 weeks is born at a California zoo

The second elephant calf in two weeks has been born at a California zoo.

African elephant Amahle gave birth early Monday morning, according to the Fresno Chaffee Zoo. The event came 10 days after Amahle's mother, Nolwazi, gave birth to another male calf.

The new additions are the first elephants born at the zoo, about 150 miles (240 kilometers) southeast of San Francisco, which has embarked on a program to breed elephants in the hope that they can be seen by zoogoers in years to come.

"To have two healthy calves is a historic milestone," Jon Forrest Dohlin, the zoo's chief executive, said in a statement Tuesday. "We cannot wait for the public to see the new additions to our herd and share in our excitement."

The elephants and their calves will continue to be monitored behind the scenes for now, Dohlin said. While the zoo expanded its exhibit in anticipation of growing its herd, some animal activists have opposed the breeding program, saying elephants shouldn't be in zoos because of their complex needs.

In 2022, the zoo brought in male elephant Mabu hoping he'd breed with the two females. The future of elephants — which have relatively few offspring and a 22-month gestation period — in zoos hinges largely on breeding.



# Ask Rusty—Does Some of my Social Security Payment Include Repayment of my Contributions?

Dear Rusty: I have a question about my Social Security benefits. Would I be correct to assume that part of the monthly Social Security income I get is a repayment of what I contributed to the fund while I was working? If so, how much of my monthly benefit payment is my own money coming back to me? Signed: Curious Beneficiary

Dear Curious: I'm afraid that is not how Social Security works. The money you contribute to Social Security during your working years does not go into a special account to be repaid to you. Rather, the Social Security taxes you pay while working are used to pay benefits to all those currently receiving Social Security benefits. The system is, in effect, a "pay as you go" program where all those currently contributing help pay benefits for all those now receiving. What your contributions do, however, is earn you "quarter credits" and, when you have enough credits, you become eligible for Social Security retirement benefits for life. Generally, someone must have about 40 quarters (about 10 years) contributing to Social Security to be eligible for SS retirement benefits.

How much you receive monthly is determined not by how much you contributed but, rather, by how much your work earnings were over your lifetime. You will get a percentage of your average pre-retirement work income as your monthly Social Security payment, but that is also affected by your age when you claim benefits. It is your average lifetime earnings (adjusted for inflation) which determines your "Primary Insurance Amount" (or "PIA"). Your PIA is what you get at your Social Security full retirement age (FRA), but your age when you claim benefits determines if you get more or less than your PIA. Claiming SS before your FRA means a smaller monthly benefit, while waiting longer than your FRA means a benefit higher than your PIA. (SS benefits reach maximum at age 70). FYI, each person's FRA is different based on the year they were born, but full retirement age today is between age 66 and 67. When you claim benefits relative to your FRA determines how much of your PIA you will receive each month.

So, your contributions to Social Security aren't used to determine your monthly benefit amount, but your average lifetime work earnings and age when you claim are. Nevertheless, you may be interested to know that most people get back everything they have personally contributed to Social Security within about three to five years of collecting their benefits. In that sense, Social

Security is an exceptionally good deal, since most Americans now collect benefits for about two decades. And therein lies much of Social Security's financial dilemma—people are now collecting benefits for many more years than the current program is designed to support. And that is what Congress needs to fix as soon as possible. The Social Security trust funds (which now provide supplemental money to pay benefits) are projected to be depleted around 2033, which will mean a cut in everyone's monthly Social Security payment, unless Congress acts soon to reform the program and restore it to fiscal solvency.

## How Green is JD Vance?

Dear EarthTalk: Where does J.D. Vance, Trump's V.P. pick, stand on climate and environmental issues? -- Robert O., Bowie, MD

As the political climate intensifies, understanding the environmental stance of key political figures like Vance, author of "Hillbilly Elegy" and an Ohio Republican Senator, becomes crucial. His position on environmental issues and climate change could significantly influence future policies and regulations.

Vance's public statements indicate a distrust of climate science and a preference for policies that favor economic growth over environmental protection. He often criticizes what he sees as environmental regulation overreach, saying it stifles economic opportunities, particularly in traditional energy sectors.



25 pairs in the entire Bay Area. This is a severe demise of the species." The owls in the photo are all banded, as the species is federally protected under the Migratory Bird Treaty Act.

#### Freedom and the World

Two young Osprey siblings venture out of the nest for the first time—only to land on razor barbed wire. "They learn," Chen laughs. "They learn, next time I'll go a little farther." She expands, "This is freedom in reality. There's always something where you need to compromise or get used to it." This is an image of conservation success. Migratory birds, Ospreys, had been declining in numbers due to the pesticide DDT. After the U.S. Environmental Protection Agency banned DDT (www.sfbayospreys.org), Ospreys rebounded and their numbers have been increasing in the Bay Area over the past 10-15 years.

Birds are often a measure of the health of the overall environment—they feel the effects of pollution before we humans do, and by studying and protecting them, we can protect ourselves. "The whole message is we're all part of nature. I can see year by year the numbers of these birds decreasing," says Chen. She adds, "I want people to see how beautiful, how funny, how neat [birds] are. And then do
