# BayPhil Youth Orchestra welcomes new music director

PROGRAM KICKS OFF 24/25 SEASON WITH FOCUS ON MUSICAL EDUCATION AND COMMUNITY

Dr. Carlos Hernandez is a case for keeping music education in public schools. As a drum major and through learning orchestral instruments, he developed a passion for both music and education that has guided his life. "I got to pretty much teach a class my senior year of high school," he shares. "And then that set the tone for what happened in college. I knew I wanted to get into education. I wanted to conduct, even before. I couldn't wait to get to college—I couldn't wait to finish college—I was just so ready." Since May of 2024, he has worked with Bay Philharmonic as artistic administrator and youth orchestra music director and conductor, taking on the latter roles from Judy Lam and Marcella Schantz. (According to BayPhil's website, Lam and Schantz will continue with the organization and provide support.)


Dr. Hernandez teaches young people with a style that's detail-oriented but also gentle and playful. Among his own mentors and teachers, he mentions Cathy Benedict, who taught him at Florida International University (and now works as a music education professor at Columbia). "From the beginning of my undergraduate studies with her, we spent a lot of time talking through things." He laughs, and admits, "Or I should say, she spent a lot of time listening to me talk!"

Benedict challenged Hernandez to be aware of broader contexts of social-emotional development and social justice. "[I] was coming into the kind of educator that I actually wanted to be. And it opened me up to the different ways that this could be done," he says.

# Local events celebrate Día de los Muertos

DAY OF THE DEAD MEXICAN HOLIDAY HONORS ANCESTORS WITH COLORFUL DISPLAYS

Día de los Muertos, or Day of the Dead, is a Mexican holiday traditionally observed on Nov. 1 and 2. It's believed to be a time when spirits of the dead return home to spend time with loved ones. To welcome and honor their ancestors, families build ofrendas, or altars, and place flowers, candles, photos and artwork on them, as well as offerings of food and drinks.

Day of the Dead has its origins in the rituals practiced by the Indigenous Peoples of the Americas, and is believed to date back over 3,000 years. It's a special tradition that acknowledges the symbiotic relationship between life and death, a celebration filled with laughter, love and honest reflection.

The marigold, or Flor de Muerto (Flower of Dead), is the traditional flower used to attract the spirits. Altars are also decorated with papel picado, a Mexican decorative craft made by cutting elaborate designs into sheets of colored tissue paper. Toys and trinkets are also offered, as is food like candied pumpkin, Pan de Muerto (Bread of Dead) and sugar skulls.

Day of the Dead festivities can include hosting special meals where tamales are often the main dish. Drinks are also an important part of the celebrations. Historically, the main alcoholic drink was pulque, or agave wine, a sour beverage that looks like milk.

A fun Day of the Dead tradition is the writing of short poems called Calaveras Literarias. These rhyming epitaphs are usually dedicated to friends and family, or sometimes public figures, both living and dead, and are often filled with light-hearted humor.

Day of the Dead is primarily celebrated in Mexico and Latin America, and in countries with large Latino communities. It became popular in America during the Chicano movement of the 1970s and 1980s, with the

phrase "Día de los Muertos is not Mexican Halloween" becoming an important rallying cry.

In 2008, Day of the Dead was inscribed into the Representative List of the Intangible Cultural Heritage of Humanity by UNESCO, thereby protecting this cultural celebration as an authentic Mexican holiday.

# Think Pink for Breast Cancer Awareness Month

WASHINGTON HOSPITAL HOLDS 16TH RESOURCE FAIR

September 28th's Walk / Run / Yoga fundraiser from HERS Breast Cancer Foundation represented a starting point for Breast Cancer Awareness Month in October, a time for Bay Area organizations to hold events to connect the community to education and resources. One such event was the 16th Think Pink resource fair organized by Washington Hospital and held at Washington West on Oct. 17. This year's theme was "The Heart of Healing."

Attendees swapped stories of their own journeys if they were survivors, or the journeys of loved ones they came in solidarity for. The setting acted as an ice breaker so that people frankly discussed types of cancer and treatments with none of the shame that usually comes with discussing a potentially terminal illness.

Community booths lined the walls, including local businesses such as Fremont Botanicals and Haller's Pharmacy, and nonprofits such as BRAVE Bay Area and HERS Breast Cancer Foundation. The booths were well trafficked both for information and merch. The raffle for a choice of gift baskets was also popular.

Event sponsors Guardant, AstraZeneca, WHEA, Penguin Cold Caps, Redwood Hospice and New Age Chiropractic hosted tables as well.

For the speaker portion, cancer survivor Melody Fielder Wong shared her story via video, thanking Washington Hospital for their care and for treating her like family.

Kimberly Hartz, CEO of Washington Hospital Healthcare System, shared that as of September 2024, a planned expansion to the hospital's Cancer Center is going forward. The Center was established in 2017 in partnership with University of California San Francisco (UCSF). The expansion will add more services such as a research program with clinical trials, in-house pharmacy, and more treatment stations.

Several healthcare professionals spoke on resources for cancer patients at Washington Hospital and beyond.

# Same-day Discharge for Hip Replacement?

Orthopedic Surgeon Offers Seminar on the Benefits

You've been told you need a hip replacement and you're concerned about what that means in terms of recovery and time away from home and work. You are surprised when your doctor says you can come home the same day as your surgery—no need to even go to a hospital.

Today's hip replacement surgery is very different from that of several years ago. Same-day discharge from ambulatory surgery centers (ASCs) has replaced overnight or longer hospital stays, according to Dr. John T. Dearborn, orthopedic surgeon, founder and co-medical director of Washington Hospital's Institute for Joint Restoration and Research (IJRR).

Several studies have shown that hip replacement performed at an ASC is as safe—and potentially safer—than the same surgery performed in a hospital. Improved surgical techniques and postoperative pain management have made the ASC the preferred location for most patients.

Dr. Dearborn will discuss hip replacement surgery and recovery

Wednesday, Nov. 20, with an online Health & Wellness seminar. The 9 a.m. seminar, titled "Safely Home After Hip Replacement," can be accessed on Facebook.com/WashingtonHosp and on YouTube.com/whhsinHealth.

"Most of my patients, up to the age of 80 or so, qualify for outpatient hip replacement surgery," Dr. Dearborn notes. Certain health conditions, such as severe heart, lung or kidney issues, may dictate surgery in the hospital setting. He adds, "But for most hip replacement candidates, surgery at an ASC is at least as safe as having the procedure performed at the hospital."

Of course, all patients will need some assistance at home initially and may require physical therapy to regain strength and flexibility in the hip. Most patients can resume modest activity—working at a desk, light housework, walking, etc.—within two weeks of the surgery, Dr. Dearborn says. At least six weeks is required to resume heavier physical work and longer for most sports.

The major shift to same-day discharge at Washington Hospital started in 2020, at the beginning of the COVID-19 pandemic. Patients needing hip replacements did not want to spend the night at a hospital, preferring to spend the first postoperative night in their own bed in the safety of their own homes. In response to this rising demand, Peninsula Surgery Center (PSC) was developed during the early pandemic, recreating the already successful program at Washington Hospital into a purely outpatient model. Same-day discharge hip replacement is now performed at both Peninsula Surgery Center in Redwood Shores and at the Washington Outpatient Surgery Center in Fremont. To date, every hip replacement patient at PSC has been successfully discharged home the same day.

Keys to successful same-day surgeries include thoroughly defined pre- and post-surgery plans. The pre-surgery plan should be focused on a balanced protein-rich diet to promote wound healing, muscle tone/cardio exercises to build up arm and leg strength, and a thorough pre-operation examination with

one's primary care physician. A post-surgery plan should include someone to assist the patient at home for a few days, postoperative home-based physical therapy, and a next-day follow-up call from a nurse.

Same-day hip replacement surgery is a safe route to a smooth and quick recovery. "Continued improvement in surgical techniques and perioperative pain management ensure better outcomes and faster recoveries now and in the years ahead," notes Dr. Dearborn. "I encourage anyone facing hip replacement surgery to consider having their procedure at an ASC."

# San Jose Breast Cancer Survivor Exudes Positivity and Gratitude

"A Mammogram Saved My Life"

OCTOBER BREAST CANCER AWARENESS MONTH

Ramona Lione moved from Fremont to San Jose many years ago but continued going to Washington Hospital Healthcare System (WHHS) for her mammograms. She liked the continuity of care she had always received at the Women's Center and knew her previous mammogram images were on file in case a comparison or follow-up mammogram was ever needed. That's exactly what happened in February of this year when Ramona was called back after her annual mammogram for additional imaging of a suspicious-looking area in her right breast.

Ramona was diagnosed with lobular carcinoma after another mammogram, ultrasound and biopsy of the area. Lobular carcinoma makes up a small portion of all breast cancers as it is found in the milk-producing glands of the breast (called lobules), instead of more common ductal cancers. Lobular carcinoma is curable if detected and treated before it spreads from the breasts to nearby lymph nodes. Luckily for Ramona, her cancer had not spread and she had a lumpectomy to remove the small, 5 millimeter tumor in early May.

"That mammogram definitely saved mv life," said Ramona. "The tumor I had was very small and is nothing any medical professional or I would ever have found with a manual breast exam."

Ramona's lumpectomy was performed by Washington Township Medical Foundation surgeon Kranthi Achanta, MD. Her surgery went smoothly and she did not experience pain afterward. She did, however, develop a seroma, which is a pocket of clear fluid that sometimes results from breast surgery. Despite being aspirated three times the seroma refilled, but is now healing.

Next up in Ramona's treatment plan was radiation therapy, a common treatment for breast cancer that uses high-energy rays or particles to destroy cancer cells. The Washington Radiation Oncology Center (ROC) in Fremont is part of the WHHS cancer care affiliation with UCSF. But since Ramona lives in San Jose and was facing what she thought would be daily radiation treatments for several weeks, she chose to have her radiation done closer to home. Fortunately, since her tumor was small and found early, her radiologist said she only needed five sessions. She tolerated the treatments well, except for some resulting fatigue that is a common side effect.

"Now that the treatments are done, I feel terribly lucky about my cancer journey," Ramona recalled. "So many women face more trauma and heartbreaking results following their breast cancer diagnosis. From the start, I was very optimistic and just knew this was not going to be a terrible thing. I believe a positive attitude helps when you are facing cancer."

Ramona is now on a five-year course of anti-estrogen medication to prevent the cancer from returning. As her fatigue improves, she is back to enjoying retirement from her 30-year career as a clinical researcher. She loves gardening with California native plants, birdwatching, and getting outside with her two corgi dogs.

"I would tell other women facing breast cancer to lean on the support of family and friends to keep you strong," Ramona advised. "Stay positive and hopeful because there has been so much progress in cancer research. Today, we have more ways to reduce risk, raise survival rates and improve outcomes. I highly recommend the Washington Hospital Women's Center and UCSF - Washington Cancer Center, which are fantastic. Everyone, from the physicians, staff, imaging techs and



outpatient surgery team members, go out of their way to be super helpful, kind, patient and supportive."





Now Hernandez describes the atmosphere he tries to cultivate as chamber music. "It's all a small group of people getting together and doing their thing, where everyone's equal and everyone's voice is heard... That's my approach with people of all ages I get to work with."

One interesting aspect of Bay Philharmonic is that often students of different levels will learn and play side by side, and student musicians will even perform alongside professionals. Hernandez explains, "The hope is that there's a camaraderie that goes with playing with someone that's older than you, more advanced than you, and allowing that to be motivating."

In addition to their own season opener "Music for the People" on Saturday, Nov. 9, the Bay Philharmonic Youth Orchestra (BPYO) will also perform at this Year's Bay Philharmonic Holiday

Spectacular on December 15 alongside the professional orchestra.

Hernandez knows that his students pursue music at different levels and for different reasons, so he tailors his approach rather than taking one authoritarian stance toward the whole group. "Something that we've been making part of our rehearsals is time to develop socially, so that we're also nurturing our EQ [Emotional Intelligence] and not just our performance abilities on instruments." The orchestra happens to include many homeschooled students. For them, the program is an especially meaningful chance to socialize with other kids of different ages and backgrounds in a shared music community. Hernandez says, "Getting to know each other... Social development is important to nurture. Especially when some folks are not in a school setting."

For the future, Hernandez sees a Bay Philharmonic that expands its educational offerings (in addition to pro orchestra and youth programming) to include a "community chamber orchestra"

which will create an outlet for amateur community musicians to participate and perform, which calls back to Bay Phil's roots as a community orchestra.

He encourages those interested in learning more about Bay Philharmonic, or even participating in some capacity, to reach out. "The same way we are sharing our stories and our music, we would love to hear about everyone, their stories, and the music of their individual lives."

As Hispanic Heritage Month comes to a close, the recognition of

Latino contributions continues in Newark, where Mayor Michael Hannon honored the Promotoras, a group of Latino community health workers. During the October 10th city council meeting, the mayor issued a proclamation declaring October

2024 as Promotoras Month. The Promotoras, many of whom are immigrants, have faced significant challenges before becoming trusted figures in the local healthcare system. Mayor Hannon highlighted the need to support marginalized groups, emphasizing that when all voices are heard, communities grow stronger.

"Once we start recognizing folks that don't feel like they had a voice, it encourages others within the community," Mayor Hannon said.

Promotoras, made up of Spanish-speaking men and women, are trained to advocate for solutions to community healthcare issues. Their work, the mayor says, plays a crucial role in making Newark a welcoming place by connecting the Latino community with healthcare services, social programs and educational institutions. They provide valuable resources such as information, referrals and training to ensure access to these services.

Grounded in cultural values, the Promotoras focus on building strong personal relationships and supporting one another in their new surroundings. They act as an extended family, offering both social and emotional support. Mexican-American councilmember Sucy Collazo praised the group for their dedication, reflecting on her years of collaboration with them.

"I'm proud to say as we close out the celebration of Latin heritage, our Promotoras are all Latin angels," Collazo said.

### HOSPITAL HOSTS CANCER AWARENESS FAIR

Emily Gentry, a physician assistant at Washington Hospital, shared about the hospital's Women's Center and its resources for cancer patients, including a newly added second 3D mammography machine.

Dr. Bogdan Eftimie, a hematologist-oncologist, spoke of the negative effects of anxiety on the body and the benefits of meditation: Namely, improving sleep which improves overall health.

Dr. Seema Sehgal, a specialist in psychiatry and behavioral sciences, spoke on the psychological effects of cancer, saying, "Mental health

treatment should be part of routine treatment of cancer. It should not be considered a luxury or an add-on."

She pointed out that this type of cancer often affects women in their prime, dealing a blow to self image as well as a physical one. "We can't talk about the breast without talking about what this organ symbolizes. It symbolizes femininity, beauty, motherhood, sexuality. I really feel that the breast as an organ almost lives in the public domain. Everybody has something to say about the breast." Societal discourse ranges from how much cleavage should be shown to whether mothers should breastfeed in public.

Dr. Sehgal continued, "When this organ is affected by cancer, it really is a hit on a woman's femininity, womanhood, attractiveness and fertility." The psychological impact can be as great as the physical. This is why patients need informed care that considers the whole person.

There is much work to be done, but many doctors, volunteers and allies are doing it. And their work is appreciated.

# Keep the vampires away!

GROWING GARLIC AT HOME IS EASY AND REWARDING

Planting garlic has become a ritual in my home garden. It started as a garlic plant showing up in the compost pile, and then there was no looking back. It is now one of my favorite crops to grow for many reasons—seed garlic is available almost everywhere, planting is easy, and plants do not require a lot of attention and care, store for a long time and can be used in many ways. Most importantly, garlic does not require structure for support or climbing.

Garlic, Allium sativum, belongs to the family Amaryllidaceae. The bulb is made up of individual segments called cloves. There are two main types of garlic—hardneck (Allium sativum var. ophioscorodon) and softneck (Allium sativum var. sativum). Hardneck varieties have a woody stalk in the middle around which the cloves are arranged, and have more pungency, but have a shorter storage life of about four months. The hardneck varieties also produce a green stalk, called the scape, which can be used in cooking. Softneck varieties are less pungent, have more cloves, and have a longer shelf life of up to eight months under optimal storage conditions.

Some of my favorite softneck varieties to grow are Inchium Red and California Early. For hardneck varieties, I like Music, Spanish Roja and German Extra Hardy. Fun fact: Elephant garlic (Allium ampeloprasum var. ampeloprasum) is not a true garlic. It is a close relative of the leek and its bulb has very large, mild-flavored cloves.

Although growing garlic in a raised bed or in the ground has better chances of producing bigger bulbs, if a home gardener is limited by space, growing garlic in a container is equally rewarding. I always add a lot of compost to garlic beds or the containers, and fertilize again in about three months with a granular fertilizer.

To prepare for planting, gently open the garlic bulb and separate the cloves, keeping skins intact and avoiding damage to the root callus. Plant the largest cloves, as they will produce the largest bulbs. Plant with the pointy sides up. I like to plant garlic anywhere from mid-October to November before the ground is too cold to be worked in. Space each clove six to eight inches apart and plant about two inches deep in a location that receives at least six hours of strong sun. The cloves sprout anywhere from two to three weeks. During the initial weeks I like to hand water to give the sprouting enough moisture. Once t start, I let them take over until spring. I stop watering two weeks prior to the harvest time.

The time to harvest garlic depends on the variety, planting time and local climate, but is generally around June to July. When the bottommost leaves on the stalk start to turn brown, garlic is about ready. Rather than pulling up the stems, using a trowel or gardening fork, gently lift the garlic bulb along with surrounding soil and brush off excess dirt. Harvest all bulbs that look ready and cure the garlic in a well-ventilated location sheltered from direct sunlight.

There are many ways to cure garlic. Some gardeners prefer to wash dirt off, while others like to remove the outermost layer, and still others swear by cutting the stems and roots right away. My approach has been to not wash the garlic, and not cut the stems or the roots for the first four weeks while they are curing. I remove any leaves that are dry and look diseased and let the garlic bulbs cure in a single layer on a surface like a wire rack. I like to inspect the garlic once a week for pests or rotting bulbs and remove dirt that's dry and falls off easily. After curing for about five weeks, cut off the tops and trim the roots to finish the curing process.

There are many ways to use and store garlic. It can be made into paste and frozen as cubes, cloves can be peeled and frozen, or garlic can be dried and stored as powder. Homemade garlic bread and sweet potato fries sprinkled with sauteed minced garlic and parsley are a couple of my favorite indulgent foods.

### Garlic soup

In an oven-safe container, roast 15-20 peeled cloves of garlic at 225 degrees Fahrenheit for about 45 minutes, making sure they are covered in oil. In a heavy bottom pan, add a few tablespoons of olive

oil or butter. As soon as it warms up, add half a cup of diced white or yellow onion, and a few minutes later, add half a cup each of diced celery and carrots, with about 10 cloves of minced garlic to add pungency. Add salt to taste and sauté on medium heat until vegetables look translucent. Add the roasted garlic cloves to the pan, incorporating everything together. Roasted garlic adds creaminess and sweetness to the soup. Adjust the total amount of garlic to your liking.

Turn the stove to low and add in stock or water. Bring to a boil, and let it simmer for 10 minutes. Use a blender to blend the mixture well. Don't prefer to blend? No problem. One can add in butter or heavy cream to make the contents more luscious. Add freshly ground black pepper, adjust salt to taste and garnish with any herbs your garden has to offer. Enjoy with sourdough croutons or a grilled cheese sandwich for a comforting evening meal.

### New Building Appeals Board for Fremont

On September 17, the Fremont City Council adopted a new ordinance for Fremont that creates a Building Appeals Board to hear and decide appeals of orders, decisions, and determinations made by the City's Building Official and Fire Marshal related to building and fire codes. This is in response to a court ruling that determined that the City's existing appeals process—which is currently managed by a single hearing officer—does not comply with the California Building Code.

The ordinance allows for a three-member Building Appeals Board appointed by the City Council. Members do not have to be Fremont residents. They are required to have special knowledge of state and local building and fire codes. The City's Building Official or designee serves as the secretary to the board but does not have voting rights. A fee of \$2,101 is associated with any appeal to the board, and the fee becomes effective November 18, 2024.

The ordinance also establishes the City's Planning Commission as the hearing body for post-entitlement appeals pursuant to California's Housing Accountability Act.



they have outscored their opponents by a staggering 229-36. Irvington's Head Coach, Anthony Jackson, believes this success is primarily because of Irvington's ball security. Irvington has had very minimal turnovers on the offensive side of the ball and many forced turnovers on the defensive side. Another key factor, according to Coach Jackson,

is the team's chemistry. He states, "[The] players have camaraderie, they feel loyal to one another, and they feel brought into what is going on." The chemistry has been very evident on the field this season, and Irvington hopes to continue their winning streak.

Focusing on the offensive side of the ball, Irvington has

been on an absolute tear. In a recent interview, Coach Jackson mentioned that the offense starts with the run game to open up options downfield and control the clock. Star running back Matthew Forbes, one of the team's captains and the head of the offense, has scored seventeen touchdowns in six games. Irvington's run game has been very dominant so far. When Irvington needs to turn to the passing game, senior quarter back Angel Perez has been delivering. With an exceptional passer rating of 135.4 on the season, Irvington's passing attack is slowly becoming

just as effective as the run game. On the defensive side of the ball, Coach Jackson highlighted captain Tommy Chang, a middle linebacker who is "an extension of the coaching staff." His deep understanding of the game and leadership qualities make him a key asset to the team.

Although Irvington has been winning, there are still weaknesses they hope to address. The biggest one so far has been tackling. Coach Jackson admits, "I still think we need to tackle better, be physical on both sides of the ball and improve attention to detail." He also stated that many of the kids on the team did not grow up playing football, so technique still needs to be taught to many of the players.

Ultimately, Coach Jackson's goal for the season is to win a playoff game. However, it's very early in the season and playoffs are still in the far future. Coach Jackson states, "Our goal is to go 1-0 every week. We're not putting much emphasis on the total picture yet. We're just putting one ingredient in at a time." If the team continues refining these ingredients--- sharp execution, strong chemistry and attention to detail--- Irvington could be in for something bigger than just a great start. The right mix might just lead them to a playoff run that no one saw coming.



### ZOO'S LAST ELEPHANT FINDS **NEW HOME AND FRIENDS**

Osh (male), Oakland Zoo's last African elephant, has settled in his new home at The Elephant Sanctuary in Tennessee (The Sanctuary), an accredited Association of Zoos and Aquariums (AZA) facility. Accompanying him on his almost 46-hour-long road trip to Tennessee were his Oakland Zoo Animal Care Team members and a Zoo Veterinarian. The Zoo announced Osh's departure in July and the decision to relocate to The Sanctuary, a decision made from commitment to caring for animal wellbeing and providing a home that meets companionship needs.

Moving an elephant is challenging, Osh's Animal Care Team worked with him several times a week through voluntary training to help him get used to his custom air-conditioned trailer, which was built to accommodate his 15,000 lb. weight and 11'2" height. Osh's keepers described him as highly adaptable, calm, and resilient. The Zoo's Veterinary Hospital staff conducted foot and tusk radiographs, blood tests, and physical and visual exams. When loaded onto his trailer last Wednesday morning, he was prepared and healthy.

The journey to Tennessee was smooth, and Osh remained calm throughout. The team, consisting of two of Osh's Oakland Zoo animal care keepers and an Oakland Zoo veterinarian, stopped every three hours to check on Osh and feed him. He ate celery, beet pulp, and many watermelons during his drive. The team could also monitor him closely with cameras in his trailer. After his long drive, he felt tired but was eager to explore his new home in Tennessee. He joyfully began clearing trees, eating, and roaming his new habitat.

"After caring for Osh for almost twenty years, I've had the privilege of seeing him grow and build a bond. After only a few days at The Sanctuary, he continues to be a rambunctious and resilient being, joyfully exploring his new habitat. My heart is so full seeing Osh at his new forever home," says Gina Kinzley, Zoological Manager at Oakland Zoo.

Two new 3,000-square-foot bull barns have been added at The Elephant Sanctuary for Osh and his new companion, Artie, a 41-yearold male African elephant. Osh has begun interacting with Artie through fence lines.

The dedicated care team at The Sanctuary visited Osh in August of this year to get to know him better. They also discussed and received a comprehensive background on Osh's medical history from the Oakland Zoo's Veterinary Hospital staff.

The Sanctuary staff have helped Osh settle into his new home and provided comprehensive support during his transition. Once he is fully settled, they will consistently update the public on his progress through social media. His community can continue to follow his journey online through The Sanctuary's Elecams.

The elephants at Oakland Zoo, including Osh, have been beloved icons in the community for many years, serving as animal ambassadors for their counterparts in the wild.

"It is undeniable that Osh and the other African elephants who have lived at the Zoo have made a deep impact in Oakland. They have left a mark on our staff and zoo community, who love them. We know this is the right decision for Osh, and we are celebrating his future, his ability to be with other elephants, and the next chapter of his life," says Nik Dehejia, CEO of Oakland Zoo

To honor the special relationship between the elephants and the community, the Zoo has been showcasing guest elephant memories online and hosting events to see Osh before he left, including a Farewell Party held last week.

The Zoo has maintained an elephant program for 75 years, which has evolved into the innovative and industry-leading program it is today. In 1991, Oakland Zoo was the first institution to broadly adopt the "protected contact" methodology with our male and female elephants. This methodology places barriers between zookeepers and elephants and incorporates cooperation through rewards rather than discipline. The standard at the time was to share space with elephants and use a tool called the bullhook to control and punish elephants.

Through community donations, the Zoo raised \$500K to fund Osh's move and to fulfill its elephant conservation and welfare commitment for the year With Osh's move, the Zoo will be without elephants for the first time in 75 years. This provides the opportunity for the Zoo to reimagine the future of the elephant habitat. As the Zoo continues to assess its Long-Range Plan, more updates on the future of the elephant habitat will be available in 2025.

- 3. You can create your own healthy work culture. Say goodbye to toxic bosses, disagreeable co-workers maneuvering for power and office politics.

# Authors Needed—Animal Welfare Legislation

Most state legislators decide in Oct/Nov upon which bills to carry in the coming session. Here are four in need of an author: 1. Amend state rodeo law, Penal Code 596.7, so as to require ON-SITE veterinarians at all rodeos and charreadas—the "on call" option isn't working, and animals are suffering needlessly. Racetracks, horse shows, endurance rides and the PRCA all require on-site vets-so should all rodeos; 2. Ban tie-down calf roping, allowing "breakaway" roping only. Some vets claim the calves are injured EVERY time they are roped/thrown/tiedmere babies, and terrified; 3. Ban the charreada's brutal "steer tailing" event (already outlawed in Alameda and

Contra Costa Counties and Nebraska). The steers' tails are routinely stripped to the bone ("degloved"), even torn off; 4. Ban the rodeo's non-sanctioned events, as Alameda County has done: "wild cow milking, the children's "mutton busting" event, and all animal "scrambles"—cruel and dangerous for all. 

# Classic horror story remade in 1915 San Francisco

### AUDIENCES CAN SINK THEIR FANGS INTO CHANTICLEERS THEATRE'S 'DRACULA'

Victorian-era suspense and horror gets a more modern twist at Chanticleers Theatre's production of Dracula. Written by John L. Balderston and Hamilton Dean and drawing inspiration from the 1897 novel of the same name by Bram Stoker, director Christine Plowright's rendition transports audiences to San Francisco during the 1915 Panama-Pacific International Exhibition.

Audiences follow the story of up-andcoming socialite Jonathan Harker (played by Will Thompson) and the plight of his sickly lover Lucy Seward (played by Hannah Chylinski). When Harker and his soon-to-be father-in-law Dr. Seward (Connor Biondi) struggle to find the causes and treatment for Lucy's strange condition, they conjure the aid of the eccentric traveling explorer Abraham Van Helsing (C. Conrad Cady). As the occupants of the Seward manor [also serving as a sanatorium] race against time to save Lucy, all evidence

The standout performances of the show include (but are not limited to) that of Thompson, Biondi and Cady as the core trio of Harker, Dr. Seward and Van Helsing. well-timed physical acting is testament to the

Count Dracula (Jim Woodbury) and his

authenticity of the performances. Other notable performances include Chylinski's portrayal of Lucy Seward, Tara Navarro as Miss Wells (the Sewards' maid) and Tony Parham as Dr. Butterworth. Through the character of Lucy Seward, Chylinski expertly utilizes facial movements and physical cues to sell Lucy's transformation from an archetypal "damsel in distress" into someone with much more autonomy over the situation than those around her realize.

Aiding this performance are the tertiary storylines regarding Miss Wells and Dr. Butterworth. They serve as surrogates for the audience through their reactions to the events unfolding around them but it is also their comedic timing that provide moments of much-needed levity during an otherwise macabre story.

In playing the titular character of Count Dracula, Jim Woodbury shines as he juxtaposes the character's charm and charisma with his (literal) thirst for blood and power. While serving as a compelling antagonist, it is also Calico Dant's depiction of R.M. Renfield. Dant's mannerisms and neurotic behavior establish the character's plight as themes of loyalty and duty clash with morals and self-respect.

In her director's note, Plowright has stated that setting the play in 1915 San Francisco (as the city hosted its world famous exhibition only nine years after the horrific 1906 earthquake and fire) is allegorical to Bay Area playhouses such as Chanticleers coming back after the 2020 pandemic. Transporting audiences to San Francisco at the turn of the century is a large feat that is most certainly achieved by lighting designer Mark Decker, stage manager Miranda Bumstead and the rest of the Chanticleers stage crew.

The use of painted backdrops resembling actual lithographs of the 1915 Panama-Pacific International Exhibition, antique furniture and rotating setpieces aid in transporting the audience from the Seward manor/sanitorium down to Count Dracula's lair with San Francisco Bay prominently in the background. Sound designer Tony Parham and his team's use of voiceovers and background sounds also aid in the suspension of disbelief and in establishing Dracula's powers of hypnosis and mind control.

For fans of the 1931 Dracula film starring Bela Lugosi (as well as all other Dracula films/shows released over the years), Chanticleers Theatre's *Dracula* is sure to please teenage and adult audiences just in time for Halloween.
