# Fremont native rediscovers his artistic passion

NILES WELCOMES
GALERIE ARTAX, WHERE
ART AND COMMUNITY MEET

Have you ever fantasized about quitting your day job to follow your passion? Fremont native, Ben Vose took that brave leap and did just that to open Galerie Artax—Niles' new art gallery and studio. Vose said, "I don't want to be an old guy and wish I would have spent time pursuing something that I thought was really worthwhile, so I'm giving myself a year and then we'll see what happens from there."

Vose graduated from Washington High School and then went back to teach physical education at his alma mater. He loved to create art as a child but quit as a teenager because his brother became a professional artist, and he didn't want his brother to outshine him. In retrospect, he thinks that was a bad decision.

His passion for art resurfaced about five years ago when he started sculpting whimsical figures. Vose joined an art group and became part of the local art scene. As he worked alongside other artists, he envisioned a space to bring artists and the community together through workshops and other events.

"Community has always been a big part of my life in different aspects, and I loved art, so I wanted to combine the two," Vose said. He also wanted a space for artists to showcase and sell their art. Galerie Artax is the culmination of that dream. The name is a nod to Artax the horse from the book and film *The Never Ending Story* which had a profound effect on Ben and has inspired his art.

Ben hosted a holiday market at his studio on Dec. 14 that brought together Bay Area artists whose unconventional creations came in a variety of art forms, such as crochet, stationery, screen printing, books and jewelry—sting ray earrings, anyone? There was even a claw machine with key chain prizes made by a local artist that was a popular attraction.

Galerie Artax offers art workshops for all ages, special events, art exhibitions and event space rentals. An array of art is on display at his studio; from humorous and cute items like children's books, colorful stationery, cartoon prints and pug drawings; to fantastical pieces like dragon sculptures and original paintings of ethereal women and unicorns. A unique offering at his studio are sculpture kits that

# St. Joseph Chapel opens at mission

HISTORICAL BUILDING WELCOMES PILGRIMS AND TEACHES LOCAL HISTORY

On Sunday, Dec. 15, about 200 attendees witnessed the blessing of the newly opened St. Joseph Chapel of Healing at Mission San Jose. The chapel occupies the main hall of the building housing the Mission museum and gift shop, which was closed early September for renovations. Mission San Jose Catholic Church's pastor Fr. Anthony Le gave a warm speech, led the attendees in prayer, and expounded on his vision for the new chapel and its potential as the Diocesan Shrine of St. Joseph to become a beacon for spiritual pilgrims across the

Bay Area and beyond. The building housing the chapel, museum and gift shop is the oldest intact structure in Alameda County. Erected in 1809, it housed the Franciscan friars who established the Mission in 1797. The area occupied by the chapel was formerly designated as a screening room for an instructional video introducing museum visitors to the Mission's history. A wall supporting the screen separated the viewing space from a storage area, but now the wall has been removed, and the storage space has become the chapel's sanctuary where the altar and apse house both old and new furnishings, including the Mission's treasured reliquaries. Many of the items were retained on the Mission property when the old wooden church was removed to San Mateo in the early 1980s.

Several of the artworks on the chapel's freshly painted wall were commissioned especially for the site. The freshly refurbished interior features several rows of wooden pews whose polished surfaces gleam beneath a white-washed ceiling supported by rough-hewn beams.

The renovations substantiate
Fr. Anthony's view of the site as a beacon to draw and welcome those on pilgrimage to engage in prayer and celebrate mass.
The spiritual purpose of the chapel is complemented by the instructional purpose of the adjacent museum. Carefully curated exhibits lead visitors on a journey from Old Testament times, the life of St. Joseph, the Holy Family's flight and the Nativity of Jesus, to the Franciscan period and the contributions of Ohlone to the economic and spiritual life of the Mission from the Franciscan period to today.

The Ohlone exhibit has special significance for Andrew Galvan, Ohlone descendant and Native American consultant to the Mission. When Father Fermin Francisco de Lasuen founded the mission in 1797, the location was an Ohlone village called Oroysom. Galvan and his family are long-time members of the community served by the Mission, but his strong sense of history meant that he didn't always feel that the story of the Ohlone stood out against the backdrop of Spanish "missionization" and Mexican domination of the lands surrounding the mission after 1833. "When I was brought in [to curate the Ohlone exhibit in 2008]," says Galvan, "it felt like a door that had been closed to me had opened."

Over the last year Galvan has worked in partnership with Fr. Anthony designing the current restoration. The result is an experience for museum goers and pilgrims alike that not only focuses on St. Joseph, but also pays homage to the rich history of the local native people. "I'm happy with the direction of the museum," says Galvan.

The current restoration is the latest of several significant developments on the site. The original 1809 adobe church was destroyed by the Great Hayward Quake of

# New housing ordinance causes rift in Fremont

CITY COUNCIL PASSES TOUGHENED RESTRICTIONS TARGETING HOMELESSNESS DESPITE PROTESTS

On Tuesday, Dec. 17, Fremont Police Chief Sean Washington introduced a controversial ordinance targeting homelessness to the city council. The proposal ignited heated debate among the council and residents, ultimately passing despite sharply divided opinions. While some attendees expressed hope for change, others left feeling disheartened and frustrated.

"I've listened to what some residents are saying, and they're saying is that what we've implemented so far isn't working," said Mayor Raj Salwan, who voted in favor of the ordinance.

Building on last month's RV crackdown, the new ordinance significantly broadens its scope, targeting the removal of personal property left on any public space—including buildings, parks, streets, open areas and waterways. It also allows authorities to enforce the abatement of belongings left unattended on public property for 24 hours or more.

Police Chief Washington spoke to the complex nature of homelessness solutions, saying it's important to solve the crisis with compassion and dignity while also maintaining law and order. One of the goals of the ordinance he outlined was seeking voluntary compliance by giving offenders warnings before implementing enforcement.

"I do not believe as a police chief that we can arrest or cite our way out of this problem," Washington said. "But I also need to have those tools for those in our community that may defy lawful orders."

But the police chief's attempt at presenting a balanced approach didn't assuage some residents' concerns. Resident Terry King took to public comment and pleaded with the council to sit on the issue before passing a motion, saying she believes it only criminalizes homelessness.

"It is cold and rainy tonight," King said.
"Do we really want to be kicking people out of their tents? Where is our humanity"?

Council member Kathy Kimberlin voiced her concerns, warning that the ordinance would strain the city's already overburdened police force, while Vice Mayor
Desrie Campbell argued that investing in shelter beds for the homeless would be a more effective solution. However, with the mayor and council members
Raymond Liu, Yajing Zhang and Yang Shao backing the measure, Fremont seems to be taking a tougher stance on homelessness.

# Washington Hospital Service League Offers Academic Scholarships

Applications accepted now through April 2025



The Washington Hospital Service League has been in existence for 69 years longer than the Hospital itself. During that time, countless community members have been introduced to Washington Hospital through the efforts of these volunteers. In addition to hours donated at the Hospital, the Service League contributes to the youth of the area through educational and scholarship opportunities.

The Service League's scholarship program has awarded nearly \$391,905 in scholarships since its establishment in 1961. The first scholarship of \$150 was awarded to a nursing student training at Highland Hospital in Oakland.

Today, the Service League grants two \$1,000 scholarships annually, which are renewable for three additional years, based on the student's academic performance and continued focus on health care. A

one-time scholarship of \$1,000 for a Washington Hospital volunteer is also awarded. This year, the Service League will also offer two memorial scholarships

These scholarships are available to students in the Washington Township Health Care District—which includes Fremont, Newark, Union City, and parts of South Hayward and unincorporated Sunol—who are pursuing studies in a health-related field. Students who currently volunteer at Washington Hospital are also eligible. The scholarships are awarded each year to graduating high school seniors and/ or current college students.

By providing scholarships, the Service League hopes to help students with their education and career goals, and also hopes that in turn, those student may someday be able to give back to the community

by providing health care. Service League Scholarship Chair Dian Zarzycki notes the pleasure they receive by giving assistance and support to budding doctors, nurses and other health care professionals in the local community.

# **Qualifications for the Washington Hospital Service** League scholarship include:

- U.S. citizen/permanent resident.
- Resident of the Washington Township Health Care District or be a current volunteer at Washington Hospital.
- Age 22 or younger as of December 31, 2025.
- Accepted into an accredited school, college, or university offering a bachelor's or higher degree in a health-related field.
- Full-time student, able to provide required transcripts.

- Contributor to the community with at least 100 hours of volunteer service or working in a health-related field.
- Three letters of recommendation from the Director of Volunteer Services, employer, counselor/advisor, or teacher.
- Not have been previously awarded a WHSL health career scholarship (see application for detailed requirements).

# Patient-Centered Physician Joins Fremont Warm Springs Clinic

New WTMF primary care provider focuses on preventive, geriatric care

Washington Township Medical Foundation recently welcomed Magin Alexander, MD, to its Warm Springs Family Practice Clinic in Fremont. A primary care physician with a special interest in preventive and geriatric care, Dr. Alexander combines evidence-based medicine, compassion and partnership to provide patient-centered care. Her practice spans various medical services, placing emphasis on preventive care services and management of chronic medical conditions.

Dr. Alexander values strong communication and collaboration with her patients. She strives to create a partnership where patients feel comfortable sharing their concerns, knowing they will be met with empathy and understanding. This collaborative approach fosters a supportive environment that promotes better health outcomes and patient satisfaction.

"Each of my patients is a valued individual," Dr. Alexander explained. "I want to make sure they feel heard and understood."

Dr. Alexander graduated in 2013 from Calicut Medical College in Kerala, India. After practicing there in the primary care sector for five years, she moved to the United States in 2018 to complete an internal medicine residency at the University of Nevada, Reno. During her residency, Dr. Alexander spent significant time at the VA Sierra Nevada Health Care System, where she developed a strong interest in geriatric patients and managing chronic medical conditions. Her areas

of interest include managing chronic conditions such as diabetes, hypertension, gastrointestinal and thyroid disorders, among others. She is board certified in Internal Medicine.

"Our population is aging," Dr. Alexander noted. "Establishing a relationship with elderly patients can present unique challenges. Many elderly patients face physical limitations, cognitive decline or memory issues that can impact their ability to communicate effectively. Additionally, they may have deeply ingrained beliefs about health care or past experiences that have shaped their expectations of care. Socio-economic, ethnic and cultural barriers often come into play. Building trust often requires extra time and patience to address these barriers and create a safe, supportive environment."

When dealing with complex medical issues, Dr. Alexander ensures patients are not overwhelmed. "When a patient has a complex medical issue or multiple conditions, I reassure them that our journey together begins with this first appointment," she said. "We focus on addressing the most pressing concerns initially, while planning follow-up visits to ensure every issue is thoroughly managed

Dr. Alexander also highlights the importance of comprehensive health care. "Care includes sharing knowledge, a proactive approach to preventive care, integrating lifestyle modifications, patient education and personalized treatment plans," she explained. "Empowering

patients with the right tools and information is key to helping them take control of their health."

Dr. Alexander is a strong advocate for preventive care, particularly when it comes to early cancer detection. She believes routine screenings play a crucial role in identifying potential health issues before they develop into more serious conditions. For instance, she stresses the importance of regular breast cancer screenings, colorectal cancer checks and skin examinations, all tailored to each patient's age, family history and individual risk factors.

"I educate my patients about the significance of mammograms, colonoscopies and other cancer screenings," she explained. "I highlight early detection, which can lead to more effective treatment and better health outcomes. By incorporating cancer screenings into my overall approach to preventive care, my patients are equipped to take proactive steps in managing their health, ultimately contributing to the reduction of cancer incidence and the improvement of long term well-being."

Dr. Alexander is a South Asian, fluent in English and Malayalam and with a working understanding of Tamil and Hindi. She understands her patients' culture and lived experiences and recognizes some of the major challenges in the medical conditions they bring to her arise from lifestyle concerns. With a prevalence of chronic diseases including diabetes, high blood pressure, high cholesterol, heart disease, kidney disease and stroke in

East Bay residents, she noted she will be working proactively with her patients to address their concerns. Regular follow-up and lifestyle modifications are pivotal in managing chronic medical conditions, alongside pharmacological management.

"For instance, in diabetes management, I take a multifaceted approach with my patients that includes detailed patient education, dietary counseling, and close monitoring of glucose levels and potential complications," she said. "I emphasize the importance of lifestyle changes such as increased physical activity and balanced nutrition, while also tailoring pharmacological treatments to each patient's unique needs. This comprehensive strategy ensures patients feel empowered to manage their condition effectively and improve their overall quality of life."

Dr. Alexander and her husband, a software engineer, recently moved to Fremont from the South Bay. She's excited about her new role at Washington Hospital Healthcare System.



# RISKS OF ALCOHOL AND WAYS TO DE-CENTER AT HOLIDAY GATHERINGS

In the Bible, the first miracle Jesus performs is turning water to wine at a wedding—at the behest of his mother Mary no less. Although Jesus initially balks at the request, all involved agree that the festivities would be in danger if the booze ran out. This familiar religious story underlines the connection between alcohol and human social ties.

Felipe Bolivar Rincon, M.D., an addiction medicine specialist and primary care provider with Kaiser Permanente, explains that ever since humans tried fermented fruit and learned how it could lower inhibitions, alcohol has played an important cultural role. "We have a sense that this will heighten the experiences of our social gatherings... It opens up more conversations and some of us will find more enjoyment, maybe enjoy a little bit more the music and the food. It also will decrease that feeling of satiety so we want more and more."

We need strong ties with fellow humans to survive and

thrive; alcohol can encourage even the naturally shy to get out and party and have more positive experiences with others. However, alcohol comes with great harm that can destroy the benefits it brings in moderation.

The National Institute of Alcohol Abuse and Alcoholism (NIAAA) defines a standard drink as 14 grams of alcohol. The physical amount varies greatly depending on the concentration in a particular alcoholic drink. For women and the elderly, an unhealthy level of drinking is any more than three drinks in one sitting or more than seven in a week. For men, it's more than four in a sitting and 14 in a week. However, for many this limit may be lower.

People tend to underestimate the risks of alcohol, and 5 to 10% of the population suffers from alcohol-use disorder. Alcohol can lead to a long list of health issues, including insomnia, anxiety, and depression, liver damage, high blood pressure, heart problems, memory loss, impaired cognitive function and cancer. Alcohol is the fourth most common preventable cause of death in the U.S., and it's associated with about a third of violent deaths, motor vehicle accidents, suicide and homicide.

The scale of the risks can come as a surprise when alcohol is framed as a harmless and even healthy lifestyle choice.
Bolivar Rincon says, "A lot of my patients say, 'But Doc, didn't we used to say that a glass of wine per day was healthy?"
However: "Whatever low-dose protective mechanism

alcohol can have on the heart, it's completely offset by its harm in other systems." People can start drinking to deal with insomnia, stress or anxiety, but alcohol itself exacerbates those symptoms, so people drink even more and end up in a destructive cycle.

Over the holidays, conscientious hosts can find themselves in the dilemma of the Biblical Mary—how to throw a celebration without wine's help.
Bolivar Rincon advises hosts to make alcohol "pull" rather than "push." Let guests ask for alcohol rather than offering it proactively, and certainly respect a no.

"We're in a very pushy culture," Bolivar Rincon says. "Oh, just have one. Enjoy it with all of us. Have a toast.' No. Let's refrain from doing that." Conversely, present nonalcoholic options with flair. "The alternatives [should be] centralized and visible and hopefully very attractive. Because you're competing against alcohol. Ideally it should be sparkling water with flavors, mocktails, beautifully [displayed]."

Hosts can also plan games that break the ice and encourage socializing, getting everyone's energy up and lowering inhibitions without the help of alcohol—no drinking games. Ideally, gatherings can strengthen bonds among friends and family, preventing people from becoming isolated and drinking alone, but without leading guests into heavy social drinking.

Similarly, guests should attend with a plan in mind and stick to it. Bolivar Rincon says, "Know what triggers you. Know at what limit you go overboard. Know what happens when you feel very happy, or very depressed or very anxious, what's going to happen to your levels of alcohol. And be comfortable with saying no." People can give reasons for abstaining such as "I'm trying to be healthier," or "I want to get up early tomorrow," but even "I'm not drinking tonight," should be enough. Ultimately it's no one else's business.

Those with substanceabuse disorders can take medications prescribed by a physician to decrease cravings before social events. These won't cause an extreme reaction like throwing up, but they decrease the attraction and reward of drinking. "In our field we're very aware that this can be a tough season," says Bolivar Rincon.

While Jesus transformed water to wine, and even used wine as the symbol for his blood, he also compared himself to light, bread, a vine, a shepherd and water, and each has a different significance. Wine is only one part of the human experience, and humans can flourish without it. Even around Jesus' official birthday.

As 2024 comes to a close, Downtown Hayward prepares to step into 2025 with a revitalized look and feel. Over the past year, the Downtown Hayward Improvement Association (DHIA) has been hard at work implementing projects that elevate the neighborhood's charm, convenience and sense of community.

### Finishing touches for a new chapter

With Downtown Hayward growing through new residents and businesses, the neighborhood has undergone upgrades. Colorful planters now line the streets. At night, newly installed strand lights along Foothill Boulevard create a cozy ambiance.

The City of Hayward is also nearing completion of its Main Street Complete Streets

project. As a vital thoroughfare, Main Street has undergone extensive upgrades to better connect housing, retail and transit hubs like BART. Designed to prioritize safety and accessibility, the project includes new bike lanes, ADAcompliant curb ramps, sidewalk repairs and sustainable landscaping.

1868. A wooden structure built to replace it stood until the early 1980s when a religious group bought the building and moved it to San Mateo. That move made way for the current mission north of the museum. That iconic structure replicated the original adobe and was completed in 1985. It was

renovated in 1997 as part of the bicentennial celebration of the Mission's founding. The next major change came in 2008 when Galvan redesigned the Ohlone room of the museum. Sixteen years have now passed; as Galvan notes, the present changes come "as a breath of fresh air" in keeping

with recent changes to the administration and Father Anthony's infusion of new life into the Mission's purpose of spreading the Gospel.

Father Anthony acknowledges the "ups and downs" of history, but believes the fundamental call of the Church remains

the same: "to welcome all people, regardless of background or circumstance, and accompany them on their journey of faith...The Pilgrim Center is designed to be a beacon of hospitality, embracing travelers from all walks of life."

As in years past, the City of Fremont will be implementing a Holiday Closure for many non-public safety City services. Some City offices will be closed from Tuesday, Dec. 24, 2024, through Wednesday, Jan. 1, 2025. City Holidays are observed Dec. 24, 25, and 31, 2024 and Jan. 1, 2025, while limited City services will be offered Dec. 26, 27, and 30, 2024. City offices and facilities participating in the Holiday Closure will re-open for business on Thursday, Jan. 2, 2025. This closure will not affect police and fire services.

**During the Holiday Closure:** Parks and Recreation Registration Desk, 3300 Capitol Ave., Building B is open for walk-in registration of recreation programs from 8:30 a.m. to 5 p.m. on Dec. 26, 27, and 30.

Parks and Recreation Division will offer camps and other programs at some facilities. Visit RegeRec.com for more info.

Human Services will provide limited services for Youth & Family Services and Family Resource Center.

Healthy Start Program will provide limited services.

Afghan Elderly Association will not be providing services.

Youth & Family Services will have on-call crisis counselors to respond to youth referred from the Alameda County Crisis Receiving Home.

The Fremont Police Department and Fremont Fire Department will continue to provide public safety services.

A minimum number of City staff will be available in an on-call status to provide emergency maintenance services such as responding to storm-related issues.

Regularly-scheduled street sweeping will occur on Dec. 26, 27, and 30, 2024; weather permitting. No street sweeping on Cityobserved holidays. (We will make every effort to provide service on a different day.)

Addressing Services will be suspended starting Dec. 23, 2024. Addressing services will resume on Jan. 2, 2025.

The Tri-City Animal Shelter at 1950 Stevenson Blvd. will be closed on City-observed holidays: Dec. 24, 25, and 31, 2024, and Jan. 1, 2025. Shelter staff will still be onsite caring for the animals, but the shelter will not be open to the public. # **Holiday Tree Collection Guidelines for Fremont**

Republic Services is offering FREE curbside holiday tree collection from Mon., Dec. 30, 2024, through Fri., Jan. 10, 2025. No need to call to request this service. Simply use one of the following methods for curbside collection or drop-off:

• Green Compost Cart: Cut the tree into pieces to fit loosely in your compost cart with the lid closed. Place the cart at the curb on your scheduled collection day.

• Black Landfill Cart: This option is for trees that are flocked, contain fire retardant, or have decorations or tinsel. Please cut up your non-compostable tree so pieces fit loosely in the trash cart with the lid closed. Place the cart at the curb on your scheduled collection day.

Non-compostable trees can also be collected as part of a bulky pickup.

• Curbside Collection: For trees under 6 feet in height, place the entire tree in the gutter on your collection day. If your tree is over 6 feet in height, cut the tree in half and place both halves in the gutter on your collection day. Please ensure your tree is in the gutter, not on the sidewalk, and free of all decorations.

• Drop Off at Republic Services: Between Thurs., Dec. 26, 2024, and Fri., Jan. 31, 2025, take your tree to the Republic Services customer center at 42600 Boyce Rd. in Fremont (Monday through Friday, 8 a.m. to 5 p.m.). Please speak with the office personnel first. Compostable



trees may be dropped off for free, and non-compostable trees may be dropped off for a \$5 charge payable via cash or credit/debit card.

• Bulky Trash Pickup: Schedule a bulky trash pickup by calling Republic Services at 510-657-3500.

# California's New Daylighting Law Provides Another Tool for Safer Streets





# Intersection Daylighting

Leaving a clearance of 20 feet provides a greater field of visibility for all roadway users (as shown in scenarios #3 and #4), whereas not providing that clearance greatly reduces the visibility (as shown in scenarios #1 and #2).

The new Daylighting Law (AB 413), which was implemented at the beginning of this year, makes it illegal to park within 20 feet of the approach of any marked or unmarked crosswalk, even if the curb is unpainted. The goal of the new law is to improve the safety of all roadway users by increasing visibility at intersections.

Removing the obstruction of parked vehicles will allow drivers to have a clear view of pedestrians waiting to cross the street while at the same time allowing pedestrians to see approaching

cars without having to step into the intersection to see past a parked vehicle before crossing. Forty states currently have similar laws in place, and while this new law won't be enforced in California until Jan. 1, 2025 (unless signs already restrict parking), there's no reason not to start leaving at least 20 feet (or the length of one large car) between your car and a marked/unmarked crosswalk.

# Pomegranate: ornaments on a tree

While I become exhausted from a long summer, my pomegranate trees love the heat and can go on and on without breaking a sweat. Requiring relatively little care and upkeep, pomegranate is fairly easy to grow into a tree, shrub or a bush. It can be planted as a bare root, a young plant or from cuttings. As a home gardener, I do not have any personal experience in growing a pomegranate tree from seed, although I've heard it can be done, and I might experiment with that someday.

Pomegranates grow well in zones 8-10 but some labels include zone 7 too. They need a location that gets full sun for over eight hours per day. Ones that receive less than this amount of sunlight will still grow but might not fruit well, if at all. Young pomegranate plants need consistent watering and a balanced fertilizer, but once established, they don't bother the gardener much. Pomegranate trees are generally pest-resistant, and I have easily been able to take care of any issues they encountered. If I spot aphids, which can typically be seen in an over fertilized plant that has lots of new growth, I simply wash them away with a water hose every few days. If your plant is set up to be watered by drip irrigation, make sure that the emitter is not sitting too close to the base of the trunk to avoid rot.

Pomegranate trees can either be ornamental or fruit-bearing. Ornamental cultivars have showy flowers and may also produce inedible fruit. Both types of trees are either self-pollinating or cross-pollinated by insects or hummingbirds. Planting multiple trees nearby can improve fruit setting. Once the fruit has set, it takes six months or so to be ready. One indication of readiness that some gardeners go by, is the fruit beginning to crack open. Although this method is easy, it can reduce shelf life. I utilize cracking to determine readiness for the first few fruits and then harvest the rest, definitely before any rain. However, the fruit can also crack prematurely due to inconsistent watering or excessive rain before the fruit is ready.

I have two kinds of pomegranate trees in my backyard: eversweet and cranberry, which require similar care and upkeep. When I first planted them, I amended the naturally occurring clay soil in my backyard with compost. Initially, the plants needed to be watered regularly, but once they had established, the rains took care of the irrigation in the winter. In spring and summer, deep watering once every week was all I did. The years I gave them fertilizer, the trees put on lush leaves, but the years I did not fertilize, I didn't notice any difference in fruit quality. It appears that the trees did not mind some neglect as long as they were getting enough sunlight and water.

Pomegranate can be trained as trees, espalier, or as arching shrubs. Training them to grow as trees requires skill and patience and could result in reduced harvest depending upon what needed to be pruned away for the desired shape. During pruning and harvesting, be sure to wear protective gear to protect against the plant's big woody thorns. Once the fruit has been harvested and the tree has shed its leaves, the tree can



be pruned. I have kept mine at a height where the fruit is accessible without a ladder.

Upon harvesting, the fruit can be enjoyed right away, stored at room temperature for a week or two or stored in the refrigerator in a paper bag for about four weeks. If storing the fruit, don't forget to check for any fruit that is developing mold or rotting. The extracted arils can be frozen and used as desired. To open the fruit, slice off the top and bottom ends with a sharp knife. Then slice it along the sides and pull apart to reveal the juicy arils, gently separating them from the pith. The arils can pop open and squirt out juice. Some people suggest taking out the arils under water, but I prefer to just be careful.

When it comes to the recipes with pomegranate, an important ingredient is patience. It takes time to open the fruit to take the arils out. While I can eat the pomegranate arils as is or in salads and smoothies, making a salsa takes it to the next level for an upcoming get together or ups the game for an ordinary menu. Mix together


pomegranate arils, finely diced white onions, mangoes, finely chopped mint leaves, salt and pepper to taste and a squeeze of lime or lemon. Serve with freshly baked tortilla chips. If raw is not up your alley, then you can juice pomegranate or make syrup. Other than fruit dishes, pomegranate also makes the best fall gifts for family and friends. Our family also shares with the local food banks and at places of worship that accept such donations.

Note: This article gives an overview of growing plants, sun and soil requirements, moisture needs etc. Plant health and growth will vary based on various factors. This article is intended for gardening and culinary inspiration only. Please consult your healthcare provider should you have any questions or concerns about adding any new foods or ingredients to your diet. Also, I have used the term "tree" to refer to a pomegranate plant, tree, shrub or bush for ease of reading.

# PUBLIC NOTICES

AN ORDINANCE OF THE CITY OF NEWARK AMENDING CHAPTER 3.16 OF THE NEWARK MUNICIPAL CODE RELATING TO THE TRANSIENT OCCUPANCY (HOTEL)

WHEREAS, pursuant to section 7280 of California Revenue and Taxation Code, the legislative body of a city may levy a tax on the privilege of occupying a room or rooms, or other living space, in a hotel, inn, tourist home or house, motel, or other lodging for a period of less than

WHEREAS, Chapter 3.16 of the Newark Municipal Code establishes a transient occupancy tax ("TOT") which, through resolution, is set at ten percent (10%) within the City of Newark (the "City"); and

WHEREAS, the City seeks to continue to exercise local control over local funds for local needs – allowing the City to be self-reliant and requiring any new local funding approved by its voters are spent for Newark residents and cannot be taken by Sacramento; and

WHEREAS, for victims of heart attacks, strokes, accidents and other emergencies, seconds can make a difference, and a measure supporting local funding will help ensure fast 911 emergency

WHEREAS, additional local funding is needed to repair potholes and maintain streets on more than 105 miles of streets in the City; and

WHEREAS, for any additional local funding, the City will continue its high standards of fiscal accountability and transparency by requiring that any money generated must be spent only on the community priorities, and not for any other purpose; and

WHEREAS, through an engagement effort and discussion around the City's budget, residents identified City service funding priorities such as repairing potholes and City streets, maintaining neighborhood police patrols, fire protection and 911 emergency medical response, upgrading fire stations to ensure rapid response times, accommodate modern firefighting and life-saving emergency equipment, improving emergency dispatch for rapid response during an earthquake or major disaster and enhancing parks and recreation programs and maintaining sports fields and children's play structures as priorities for any future spending; and

WHEREAS, additional local funding from a TOT (hotel) measure will ensure that visit to Newark contribute towards City services they use and that the burden will not fall homeowners as only hotel and lodging guests pay this tax; and

WHEREAS, the People of the City of Newark desire to increase the TOT rate. NOW, THEREFORE, the People of the City of Newark do ordain as follows:

### Section 1. Recitals

The above recitals are true and correct and made a part of this Ordinance.

### Section 2. Municipal Code Amendment.

Chapter 3.16, "Transient Occupancy Tax" of the Newark Municipal Code is hereby amended to read as to read as set forth in Exhibit A, attached hereto and incorporated herein by reference (deletions in strikethrough; additions in underline).

### Severability.

If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, the remainder of the Ordinance, including the application of such part or provision to other persons or circumstances shall not be affected thereby and shall continue in full force and effect. To this end, provisions of this Ordinance are severable. The People of the City of Newark hereby declare that they would have passed each section, subsection, subdivision, paragraph, sentence, clause, or phrase hereof irrespective of the fact that any one or more ections, subsections, subdivisions, paragraphs, sentences, clauses, or phrases be held inconstitutional, invalid, or unenforceable.

### Section 4. <u>Amendment or Repeal</u>.

Chapter 3.16 of title 3 of the Newark Municipal Code may be repealed or amended by the City Council without a vote of the People. However, as required by Article XIII C of the California Constitution, voter approval is required for any amendment provision that would increase the rate of any tax levied pursuant to this Ordinance or impose the tax on a person not currently subject to the tax. The People of the City of Newark affirm that the following actions shall not constitute an increase of the rate of a tax:

- The restoration of the rate of the tax to a rate that is no higher than that set by this Ordinance if the City Council has acted to reduce the rate of the tax;
- B. An action that interprets or clarifies the methodology of the tax or any definition applicable to the tax so long as interpretation or clarification (even if contrary to some prior interpretation or clarification) is not inconsistent with the language of this Ordinance;
- C. The establishment of a class of person that is exempt or excepted from the tax or the discontinuation of any such exemption or exception other than the discontinuation of an exemption or exception specifically set forth in this Ordinance; and,
- D. The collection of the tax imposed by this Ordinance, even if the City had for some period of time failed to collect the tax.

# Section 5. Codification.

Upon adoption of this Ordinance pursuant to the voter approval referenced above, the City Clerk, in consultation with the City Attorney, is hereby authorized and directed to codify this Ordinance in the Newark Municipal Code.

# Section 6. <u>Publication and Effective Date.</u>

Within fifteen (15) days from and after adoption, this Ordinance shall be published once in a newspaper of general circulation printed and published in Alameda County and circulated in the City of Newark, in accordance with California Government Code Section 36933. If this Ordinance is approved by a majority of the voters voting on the issue at the November 5, 2024, election, pursuant to Elections Code Section 9217, this Ordinance shall become effective ten (10) days after the Council declares the results of the election.

# Chapter 3.16 TRANSIENT OCCUPANCY TAX

MICHAEL K. HANNON

# 3.16.010 Definitions

Except where the context otherwise requires, the definitions given in this section govern the construction of this chapter:

- A. "Hotel" means any structure, or any portion of any structure, which is occupied or intended or designated for occupancy by transients for dwelling, lodging or sleeping nurnoses and includes any hotel inn tourist home or house motel studio hotel bachelor hotel, lodginghouse, roominghouse, apartment house, domitory, public or private club, mobile home or house trailer in a fixed location except a mobilehome located within a mobile home park where the tenant is an employee of the owner or operator of the mobile home, or other similar structure or portion thereof
- "Occupancy" means the use or possession, or the right to the use or possession of any room or rooms or portion thereof, in any hotel for dwelling, lodging or sleeping purposes
- "Operator" means the person who is proprietor of the hotel, whether in the capacity "Operator" means the person who is proprietor or the notel, whether in the capacity of owner, lessee, sublessee, mortgage in possession, licensee, or any other capacity Where the operator performs his functions through a managing agent, such person shall also be deemed an operator for the purpose of this article and shall have the same duties and liabilities as his principal. Compliance with the provisions of this chapter by either the principal or the managing agent shall, however, be considered to be compliance by both.
- "Person" means any individual, firm, partnership, joint venture, association, social club, fraternal organization, joint stock company, corporation, estate, trust, business trust, receiver, trustee, syndicate, or any other group or combination acting as a unit
- "Rent" means the consideration charged, whether or not received, for the occupancy of space in a hotel valued in money, whether to be received in money, goods, labor or otherwise, including all receipts, cash, credits and property and services of any kind or nature, without any deduction therefrom whatsoever.

### "Tax Administrator" means the director of finance. "Transient" means any person who exercises occupancy or is entitled to occupancy by

eason of concession, permit, right of access, license or other agreement for a period of thirty consecutive calendar days or less, counting portions of calendar days as full days. Any such person so occupying space in a hotel shall be deemed to be a transient until the period of thirty days has expired unless there is an agreement in writing between the operator and the occupant providing for a longer period of occupancy. In determining whether a person is a transient, uninterrupted periods of time extending both prior and subsequent to the effective date of the ordinance codified in

# this chapter may be considered **3.16.020 Tax imposed.**

For the privilege of occupancy in any hotel, each transient is subject to and shall pay a tax ent (14%) of the rent charged by the operator. The tax constitutes a debt owed by the transient to the city which is extinguished only by payment to the operator or operators of the hotel at the time the rent is paid. If the rent is paid in installments, a proportionate share of the

tax shall be paid with each installment. The unpaid tax shall be due upon the transient's ceasing to occupy space in the hotel. If for any reason the tax due is not paid to the operator of the hotel, the city council may require that such tax shall be paid directly to the  $\frac{1}{100}$ 

No tax shall be imposed upon:

- Any person as to whom, or any occupancy as to which, it is beyond the power of the city to impose the tax provided in this chapter;
- Any federal or state officer or employee when on official business;
- Any officer or employee of a foreign government who is exempt by reason of express provision of federal law or international treaty.

No exemptions shall be granted upon a claim therefor made at the time rent is collected nder penalty of perjury upon a form prescribed by the <u>city clerk</u>Tax Administrator

Each operator shall collect the tax imposed by this chapter to the same extent and at the same time as the rent is collected from every transient. The amount of tax shall be separately stated from the amount of the rent charged, and each transient shall receive a receipt for payment from the operator. No operator of a hotel shall advertise or state in any manner, whether directly or indirectly, that the tax or any part thereof will be assumed or absorbed by the operator, or that it will not be added to the rent, or that, if added, any part will be refunded except in the manner provided in Section 3.16.060 of this chapter.

### 3.16.050 Registration

Within thirty days after the effective date of the ordinance codified in this chapter, or within thirty days after commencing business, whichever is later, each operator of any hotel renting occupancy to transients shall register said hotel with the eity clerk Tax Administrator and obtain from him them a "transient occupancy registration certificate" to be at all times posted in a conspicuous place on the premises. Said certificate shall, among other things, state the

- The name of the operator;
- В. The address of the hotel:
- The date upon which the certificate was issued; C.
- "This Transient Occupancy Registration Certificate signifies that the person named on the face hereof has fulfilled the requirements of the Uniform Transient Occupancy Tax Ordinance by registering with the City Clerk Tax Administrator for the purpose of collecting from transients the Transient Occupancy Tax and remitting said tax to the City ClerkTax Administrator. This certificate does not authorize any person to conduct any unlawful business or to conduct any lawful business in an unlawful manner, nor to operate a hotel without strictly complying with all local applicable laws, including but not limited to those requiring a permit from any board, commission, departmen or office of this city. This certificate does not constitute a permit."

### 3.16.060 Reporting and remitting.

Each operator shall, on or before the last day of the month following the close of each calendar quarter, or at the close of any shorter reported period which may be established by the <a href="https://eichetTax.Administrator">eichetEmax.Administrator</a> make a return to the <a href="https://eichetTax.Administrator">eichetEmax.Administrator</a>, on forms provided by <a href="https://eichetTax.Administrator">eichetTax.Administrator</a> and a received and the amount of tax collected for transient occupancies. At the time the return is filed, the full amount of the tax collected shall be remitted to the city-clerkTax Administrator. The city-clerkTax Administrator may establish shorter reporting periods for any certificate holder if he deems it necessary in order to insure collection of the tax and he may require further information in the return. Returns and payments are due immediately upon cessation of business for any reason. All taxes collected by operators pursuant to this chapter shall be held in trust for the account of the city until payment thereof is made to the city clerk Tax Administrator.

### 3.16.070 Penalties and interest.

- Original Delinquency. Any operator who fails to remit any tax imposed by this chapter within the time required shall pay a penalty of ten percent of the amount of the tax in addition to the amount of the tax.
- Continued Delinquency. Any operator who fails to remit any delinquent remittance on or before a period of thirty days following the date on which the remittance first became delinquent shall pay a second delinquency penalty of ten percent of the amount of the tax in addition to the amount of the tax and the ten percent penalty first imposed.
- Fraud. If the <a href="https://distriction.org/line-right-number-12">distriction.org/line-right-number-12</a> determines that the nonpayment of any remittance due under this chapter is due to fraud, a penalty of twenty-five percent of the amount of the tax shall be added thereto in addition to the penalties stated in subsections. A and B of this section.
- Interest. In addition to the penalties imposed, any operator who fails to remit any tax imposed by this chapter shall by interest at the rate of one-half of one percent per month or fraction thereof on the amount of the tax, exclusive of penalties, from the date on which the remittance first became delinquent until paid.
- Penalties merged with tax. Every penalty imposed and such interest as accrues under the provisions of this section shall become a part of the tax required to be paid by this chapter.

### 3.16.080 Failure to collect and report tax.

If any operator fails or refuses to collect the tax and to make, within the time provided in proceed to determine and assess against such operator the tax, interest and penalties provided for by this chapter. The city council shall fix a time and place for hearing such appeal, and the city clerk shall give notice in writing to such operator at his last known place of address. The findings of the city council shall be final and conclusive and shall be served upon the appellant in the manner prescribed above for service of notice of hearing. Any amount found to be due shall be immediately due and payable upon the service of notice

# 3.16.100 Records.

It shall be the duty of every operator liable for the collection and payment to the city of any tax imposed by this chapter to keep and preserve, for a period of three years, all records as may be necessary to determine the amount of such tax as he may have been liable for the collection of and payment to the city, which records the <a href="eity-elerkTax Administrator">eity-elerkTax Administrator</a> shall have the right to inspect at all reasonable times.

- Whenever the amount of any tax, interest or penalty has been overpaid or paid more than once or has been erroneously or illegally collected or received by the city under this chapter, it may be refunded as provided in subsections B and C of this section, provided a claim in writing therefor, stating under penalty of perjury the specific grounds upon which the claim is founded, is filed with the  $\frac{\text{city clerk}}{\text{Tax}} \frac{\text{Administrator}}{\text{Administrator}}$  within three years of the date of payment. The claim shall be on forms furnished by the city clerk Tax Ac
- the person from whom the tax has been collected was not a transient; provided, however, that neither a refund nor a credit shall be allowed unless the amount of the tax so collected has either been refunded to the transient or credited to rent subsequently payable by the transient to the operator.
- A transient may obtain a refund of taxes overpaid or paid more than once or erroneously or illegally collected or received by the city by filing a claim in the manner provided in subsection A of this section, but only when the tax was paid by the transient directly to the eity clerk Tax Administrator, or when the transient having paid the tax to the operator establishes to the satisfaction of the city clerk Tax Administrator that the transient has been unable to obtain a refund from the operator who collected the tax.
- No refund shall be paid under the provisions of this section unless the claimant established his right thereto by written records showing entitlement thereto

Any tax required to be paid by any transient under the provisions of this chapter shall be deemed a debt owed by the transient to the city. Any such tax collected by an operator which has not been paid to the city shall be deemed a debt owed by the operator to the city. Any person owing money to the city under the provisions of this chapter shall be liable to an action brought in the name of the city for the recovery of such amount.

The East Bay Regional Park District proudly announces the release of Special Events, the fourth and final Martin J. Cooney photo collection released this year to celebrate the Park District's 90th anniversary. This historic four-part digital photo collection was researched and curated by Park District

Archives staff and volunteers. The collection includes People in Parks, Park Landscapes, Park Workers, and the latest, Special Events. All four Martin J. Cooney photo collections are available to view on the Park District's Celebrating 90 Years webpage.

The photo collection focuses on events ranging from media photo opportunities, public and staff events to groundbreakings and dedications between the mid-1960s to 1981.

"At the culmination of our 90th anniversary year, it gives me great pleasure to share this final time capsule of photos

documenting the milestone events and activities during this important era of the District's growth," said Archives Program Supervisor Brenda Montano. "We are so fortunate to have this treasure trove of photos to share with the public."

In 1934, the Park District was able to garner 71% approval from Alameda County voters during the Great Depression, when the public may not have been focused on parklands. During the campaign for the vote the Park District sparked public enthusiasm through events like the ones represented in these photos.

Martin J. Cooney's family donated over 15,000 negatives taken from the 1960s to the 1980s to the Park District. Cooney's commercial studio provided professional photography services to the Park District during that time. While Cooney took some of the photos, most were taken by Nancy McKay, who became his apprentice in 1968 while working in the Park District's Public Affairs Department and served as its primary photographer for more than 37 years. Additional Cooney photo collections were donated in association with the Oakland Tribune

# Glass recycling woes: Is it even worth it?

Dear EarthTalk: Is it true that glass recycling isn't worthwhile and that some municipalities are stopping doing it?

Glass recycling has long been touted as a

sustainable way to reduce waste and conserve resources. But in recent years—while glass remains theoretically recyclable and environmentally friendly—a growing number of municipalities have been discontinuing glass recycling, citing various challenges.

The high cost of transporting and processing heavy and fragile glass is one such challenge. Recyclers complain that the expense of managing glass outweighs the potential profits. Also, the market for recycled glass has declined due to the availability of cheap virgin materials, as reported by the American Chemical Society (ACS). Tacoma, Washington, is one city that

suspended glass recycling due to its costs.

Glass recycling also faces significant challenges due to contamination. When glass is mixed with other recyclables in singlestream systems, shards can contaminate paper and plastics, rendering entire batches unrecyclable. And sorting and separating

different types of glass-such as colored and clear—adds to the complexity and cost of the process. Glass recycling does

save energy and reduces landfill waste. Producing glass from recycled materials consumes significantly less energy than doing it from raw materials. Furthermore, recycling reduces the need for extracting raw materials like sand, which has its own environmental footprint.

When recycling programs are halted, glass waste often ends up in landfills, where it can take hundreds of years to decompose. This not only increases environmental pollution but also undermines public confidence in the broader recycling system. To address these challenges, investment in better recycling infrastructure is needed. Technologies that can separate and process glass more effectively can make recycling programs more viable. Additionally, expanding bottle redemption programs could incentivize consumers to recycle glass responsibly.

Government incentives could encourage manufacturers to incorporate more recycled glass into their production processes, creating a sustainable market for these materials. Collaboration between public and private sectors can also help reduce costs and increase the economic feasibility of glass recycling.

The environmental benefits of glass recycling make it worth preserving. Improved infrastructure, market reforms, and responsible recycling practices can work together to make it a viable solution once again.

LAND BACK MOVE MARKS BITTERSWEET RESOLUTION TO RUBY MEADOW CONFLICT

In the fall of 2023, a Castro Valley neighborhood bid farewell to most of Ruby Meadow, a patch of nature left untouched when the Caltrans Foothill Freeway project was canceled. Most of the space was purchased by Eden Housing and repurposed for affordable housing, amid resident concerns about pollution of San Lorenzo Creek, displacement of wildlife and felling of old growth trees.

One point of contention was that Eden Housing

did not conduct an Environmental Impact Report (EIR) and evaluate alternate sites, which might have forced them to move the planned development to a different area. Sidewalks and a bus stop within half a mile were requirements for the Bond Measure A1 funding used to build the development. (Sidewalks have been added.) No tenants have moved in yet, but when they do limited street parking may also become an issue.

A year later, residents are finding a bright spot in the giving of three acres of land to Indigenous group Sogorea Te' Land Trust. This portion of Ruby Meadow was a Caltrans conservation easement for environmental damage done elsewhere. According to Sogorea Te's website, the site will be maintained and managed

under a conservation easement funded by a perpetual endowment from Caltrans. The title was transferred to Sogorea Te'.

Earlier in 2024, the same Native group was able to purchase a site in Berkeley that's currently a parking lot, but historically was a massive shell mound. In that case the group paid \$25.5 million dollars to acquire the paved over land. And building a planned park and cultural center will cost more. The three-block area could have been developed into housing and retail, which highlights an interesting parallel between Berkeley and Castro Valley: Housing and environmental advocacy tend to get pitted against each other when most care about both.

Ann Maris, board director of Friends of San Lorenzo Creek, remembers the Caltrans Class Action lawsuit of the '70s. The same failed freeway project that left Ruby Meadow untouched was set to displace lowincome tenants living along the proposed route until a lawsuit blocked the project.

"Castro Valley is officially an environmental justice priority population that needs help. That means residents are impacted more by pollution than the average Californian," Maris said. She also pointed out that the site did not pass inspection as a conservation easement, and Caltrans will need to do two additional years of restoration. However, to Maris, a Native group knowledgeable with local flora and fauna is a good choice to take charge of the

habitat restoration. Still, trees and bushes on either side of the creek have been removed, even in the conservation area. Where before residents couldn't see across the creek, now the new housing on the opposite side is plainly visible. Western Red Bats living in the trees have likely been displaced. Eden Housing did leave felled trees in place for a day or so to allow animals to migrate away from the meadow. Maris is encouraging pro-deer neighbors to grow plants

Even with this loss, the transfer of the land is a win in several ways. It's the first waterway that has been given back to the Ohlone people and the first land given back in Hayward or in unincorporated Alameda County. This move could encourage further land back moves in Hayward to Sogorea Te' or similar groups. Maris mentions 10

empty acres near her house designated not for housing. There are more sites that can benefit from Native stewardship.

"Most everyone I've talked to is really happy that this historic event has happened in our neighborhood in the middle of such a sad loss," said Maris. "It doesn't take away the loss, but it gives us some hope for the future."
